Everyday Heroes

hat makes a hero? Putting the interests of others above one's own. Some die in the process, and are immortalized for their sacrifice: national hero Jose Rizal, peasant revolutionary Andres Bonifacio, Benigno "Ninoy" Aquino Jr. Other heroes are less known and even unnamed, like the thousands who fought and died in defense of the nation during World War II.

From fighting invading armies, standing up to tyranny and corruption and defending basic freedoms, the nation has its heroes. There is also another type of heroism. This is shown by those who face challenges big and small every day, dedicating themselves to making life a little better for others.

Teacher **Efren Peñaflorida** just in careers that call rose from abject poverty and decided to empower those like him to overcome the accident tary and police, but in all



of impoverished birth, in the best way he could: by bringing them basic education on a pushcart. Peñaflorida has been recognized as a hero by CNN and his organization now has a school building with about 60 students in Cavite.

There are other Filipinos like Peñaflorida whose lives are defined by service to others. These heroes can be found not just in careers that call for putting one's life on the line, such as the military and police, but in all

walks of life. Those who brave threats and ostracism by colleagues to blow the whistle on the theft of public funds are heroes. So are those who lead by example in delivering honest and efficient public service. There is heroism in exercising civic responsibility in day-to-day affairs.

Today the nation observes a special day for honoring its heroes. The best tribute that can be paid to them is by emulating their dedication to interests other than their own.

Elusive peace
Filipinos may be puzzled to nam at 45th, Indonesia be ranked a notch lower than at 54th, Timor Leste at

be ranked a notch lower than Libya and, in Southeast Asia, ahead only of Myanmar in terms of peace. The Global Peace Index, however, rates countries not only in terms of wars and armed extremism but also external threats and violence arising from crimes and politics.

In the 2014 index drawn up by the Australia-based Institute for Economics and Peace, culled from data provided by the Economist Intelligence Unit, the Philippines ranked 134th out of 162 countries in peace indicators. It was a fivenotch slide for the country, and a long way from the rankings of its Southeast Asian neighbors.

Singapore, not surprisingly, garnered the best regional ranking at 25th, followed by Malaysia at 33rd, Laos at 38th, Viet-

nam at 45th, Indonesia at 54th, Timor Leste at 69th, Cambodia at 106th and Thailand at 126th. In the Asia-Pacific, New Zealand was rated the most peaceful nation, followed by Japan and Australia.

The Philippines slid in ranking despite the signing of a framework agreement for peace with the separatist Moro Islamic Liberation Front. With the index also basing assessments on "patron-client" relations, the country could slide further as the 2016 elections approach and political violence escalates as usual.

ery election season and the seemingly unending violence in the conflict areas of Mindanao. People are also used to daily reports of violent crime all over the country. We are reminded only that this is not supposed to be the usual state of affairs when foreigners complain about threats to their safety when they are here.

Those threats keep away tourists and investors, disrupt economic activity, derail development efforts and hamper poverty alleviation. Filipinos have to stop believing that the current level of violence is normal and tolerable. The problem calls for more resolute action and combined efforts by the government and citizenry.


e marked another cultural milestone Sunday night when the big winner of a local television show that claimed to celebrate and proclaim everything authentically Pinoy (thus the title of the show Pinoy Big Brother) was... a non-Pinoy! Japanese-Brazilian model Daniel Matsunaga snatched the million-peso prize money and the title of being the ultimate Pinoy na nagpakatotoo (most authentic Pinoy). There was much rejoicing... and as people came to their senses, the usual attempt at justifying and explaining what just happened.

I like Daniel Matsunaga. In the few episodes of the show that I watched, he did seem like the most amiable and the most mature person on the show although it can certainly be argued that he probably had the most experience in dealing with different - and difficult - people as a model who had worked in countries not his own. He was also, I think, older among those that were left in the Big Brother house. And okay, the chiseled abs and the handsome face weren't liabilities, either. My reservations about his victory have nothing to do with Matsunaga the person. I also don't blame his fans and supporters.

But I am not sure ABS-CBN, the network that makes such a big to-do with being supposedly in the service of the Filipino people, should be commended for imposing on the Filipino psyche a tenuous definition of Pinoy identity for the sake of commercial considerations. As today's kids would say, anyare ABS-CBN (what the heck happened here)?

happened here)? Matsunaga was supposed to have won on the merits of having manifested Pusong Pinoy (Pinoy at heart), an affectation that people grabbed and tossed around so conveniently, as if becoming Filipino or having the temperament and social identity of being Filipino was something easily accomplished. I've always thought being Filipino was something even naturally-born Filipinos, have to live up to every day of our lives. But like I said, it's not Matsunaga's fault; he probably does love being Filipino



and genuinely wants to belong. But we shouldn't be so careless in ascribing national traits on public television. More importantly, our media networks should be more discerning particularly when it comes to matters that have far-reaching implications on our fragile sense of nationalism. PBB is a business project, but commercial considerations cannot be the only agenda. There is more to television shows than just ratings and profit-making. Even business needs to have a con-

The result of the voting Sunday night was a classic case study on how Philippine democracy works. People were encouraged to vote based purely on emotional considerations and on commercial values that ABS-CBN promoted; the odds were heavily on Matsunaga's favor. As an international model, he clearly knew how to package himself. Those in advertising would attest that a more direct link to the show's title was afforded by the label given to him. Someone with a Pusong Pinoy clearly had a more direct tie-in to the search than the shallow labels given to the rest. In short, Matsunaga was a superbly crafted media creation. And in this country, a media creation always triumphs in any election. Someone with a better story creates greater emotional appeal, and media are more than happy to keep things at the emotional Why bother with level. making people think, why go to great lengths poking people's consciences, why make people struggle with difficult ethical dilemmas

when there is an easy way out? Media are content with promoting the easy way out which is to encourage people to simply vote with their hearts and guts, long-term consequences be damned! So what if there were three equally-deserving others and probably more needy Filipinos in the slate, Matsunaga was Pusong Pinoy anyway, right? The simplification rankles because matters of national interest are not as uncomplicated.

Those who insisted that PBB was just a television show missed the bigger picture. What happened last Sunday has far-reaching implications on matters of national preference, taste, and affections and those who should have known better in this country missed a great opportunity to deliver a powerful lesson on civics.

I maintain that media networks have a strong responsibility to propagate a strong sense of national identity and nationalism. I don't mean that we should exclude foreigners and become xenophobic – but we must learn to strongly value our roots over global influences. We must teach our kids to appreciate a more diverse and inclusive perspective, but we must make sure that we do not lose affection, and subsequently, preference for our own. As a way of illustration, it is okay to make our kids appreciate foreign pop culture provided we go out of our way to show that our own pop culture is not necessarily inferior. Given a slate of equal choices, we must teach our kids to pick Filipino, particularly when the Filipino choices are just as deserving and worthy.

Stop the negativity, unite instead – Aquino

On National Heroes Day, President Benigno Aquino III slams detractors, encourages Filipinos to be more constructive rather than negative.

MANILA, Philippines -Teachers, soldiers, Overseas Filipino Workers

This is the image painted by President Benigno Aquino III of heroes on National Heroes Day - ordinary Filipinos, he said, who serve as proof "that our nation is indeed a nation of heroes."

On Monday, August 25, Aquino cited heroic actions of various Filipinos like Noli Dela Cruz, who rescued 36 of his neighbors during Super Typhoon

Yolanda by roping clothes together - and encouraged Filipinos to imagine what 100 million Filipinos can achieve together.

'On days like this, I cannot help but think and ask myself: What can achieved when a hundred million Filipinos work arm-in-arm towards a single goal?," he said.

These heroes, he said, have one thing in common: "Instead of hurling criticism or spreading negativism, which some of our countrymen have grown accustomed to doing, these remarkable Filipinos chose to empower their fellowmen.'

Aquino encouraged Filipinos to be more constructive rather than negative, and reminded them that "even if our society had made progress, it is clear that our battles continue.

The days of colonizers, of wars, of Martial Law are long gone. Yet there are still a select and selfish few who remain determined to bring back the old and abusive political systems," he said.

"This is the fight that confronts us today: to remain vigilant against those who seek to sow doubt and lies; to stand firm and refuse to allow ourselves to be manipulated by those who only pretend at reform; to reject the crooked, and resolve to stay on the straight path."

Slamming detractors, he also called attention to the achievements of his administration.

'We have been treading the straight path for more than 4 years now. The seeds of change we have sown are already bearing fruitand, seeing this, those who want to take advantage of the people are becoming desperate," he said.

As the president delivered his speech in Taguig, militant groups gathered in Manila to protest all forms of funds allotted to lawmakers or pork barrel, and called for Aquino's ouster. They also decried charter change and the possible lifting of term limits for presidents.

Charter change became a hot topic recently after Aquino said in an interview that he is reconsidering his views on the touchy subject.

Latest surveys show a steep decline in Aquino's satisfaction ratings after the Supreme Court struck down as unconstitutional parts of the administration's Disbursement Acceleration Program (DAP), the government's so-called economic stimulus package.

Hope in the youth

During his speech, Aquino also cited an article written by a 13year-old student tom Bacolod, Maria Francesca Santiago, who he said at her age, "already exhibits more discernment than some who are much older than her.'

The president said Santiago noticed that "the latest trend is to hurl

criticism, even at those who are doing everything in their power to uphold the interests of the people" and "in the face of the challenges our country has experienced, instead of remaining open-minded and searching for the truth, there are some who choose to spread baseless accusations.'

Aquino expressed optimism and hope for the youth, based on Santiago's observations.

"If this is the caliber of thinking of the youth today, I am certain that we are indeed facing a brighter future," he

He called for unity and encouraged Filipinos "not [to] waste the opportunity we have today," and "to make certain that we will bequeath to coming generations a Philippines freer and more progressive still rests on our shoulders.""This is the only way for us to ensure that, when the next generations commemorate National Heroes Day, they will remember, express their gratitude for, and reflect on this chapter of our history, and they will say: This was indeed the time when all Filipinos decided, as one people, to become heroes," he

Rallyists against pork sparse, but spirits high

The number of rallyists was sparse but fervor was high as thousands of people gathered at the Rizal Park (Luneta) in Manila on Monday to seek an end to all forms of pork barrel, which the National Council of Churches of the Philippines (NCCP) described as "a reprehensible form of thiev-

Members of religious, civic, youth and militant groups were one in saying that the pork barrel system should not continue as they joined a nationwide campaign that seeks to gather six million signatures to be used for a People's Initiative against pork.

Monday's gathering came a year after the so-called Million People March held on August 26, 2013, a series of protests for the abolition of the Priority Development Assistance Fund (PDAF) or the pork barrel of lawmakers.

Fr. Rex Reyes, the general secretary of the NCCP, called on the people to stop President Benigno Aquino 3rd from continuing his wrongful acts and abusing the democratic system of government.

"Ang illegal na pondo na nasa kamay ng ating Pangulo ay hindi lamang isang karumal-dumal na porma ng pagnanakaw at paglalapastangan sa mga taong kaniyang pinangakuang paglingkuran. This is a travesty of the democratic system because through this scheme, the personal interests of politicians are sustained and the

abusive powers of dynasties are further entrenched]," he said.

The protesters noted that Monday's rally showed the people's dwindling trust in the Aquino administration and in Congress.

"President Aquino has provided the basis for the people to unite and exercise their sovereign power. The sign-up is itself a form of protest, a stinging indictment of the failure of the Aquino regime and the administration-dominated Congress to abolish the corrupt pork barrel system. The rally is a call for accountability in the pork scam as well as an expression of opposition to amend the Charter and perpetuate Aquino in power," Renato Reyes Jr., Bayan secretary general, said.

Anakbayan, meanwhile, said that contrary to Malacanang's claim that the national budget has been rid of pork barrel, the illegal system continues.

"One year has passed since the last Million People March, and until today pork schemes still exist under the corrupt administration of [Aquino]. The administration sustained the pork schemes from the presidential level to the congressional level," Vencer Crisostomo, Anakbayan national chairman, noted.

The College Editors Guild of the Philippines (CEGP) President, Marc Lino Abila, said the Luneta rally showed that Filipinos no longer trust the legislative

Ex-Makati exec: VP Binay benefited from BIR on Pacman's tax reprieve: 'overpriced' parking building

MANILA, Philippines A former Makati City official claimed on Tuesday that Vice President Jejomar Binay benefited from the alleged overpriced construction of the Makati City Hall II parking building.

Ernesto Mercado, Binay's former vice mayor from 2006 to 2010, admitted during the televised Senate Blue Ribbon sub-committee hearing that he benefited from the phase 1 and 2 of the project.

Tayo namang mga politiko alam natin ang sagot doon e. Kung ang vice mayor po ay nakinabang, aba'y siguro higit na nakinabang po ang mayor dito," Mercado said at the televised Senate hearing.

"Kung ako ay nakinabang, imposibleng hindi nakinabang ang aking mayor," he added.

With the latest allegation, the Blue Ribbon Committee should now invite the Vice President to the hearings, according to Senator Antonio Trillanes IV, who called for the Senate investigation into the controversy.

"The vice mayor has directly mentioned the involvement of Vice President Jejomar Binay into the corruption and the anomaly that is the Makati carpark building," Trillanes said.


MANILA, Philippines - The Bureau of Internal Revenue (BIR) has not given up despite the recent legal setback to its efforts to run after Sarangani Rep. Manny Pacquiao, saying the fight is not over until the boxing icon settles his tax liabilities amounting to more than P2.65 billion.

The Supreme Court (SC) issued a temporary restraining order enjoining the Court of Tax Appeals (CTA) from implementing its order last July requiring Pacquiao to post a cash bond of P3 billion or surety bond worth P4.95 billion for unpaid taxes in 2008 and 2009.

The SC also stopped the appellate tax court and the BIR from implementing garnishment orders and tax lien on Pacquiao's assets.

BIR Commissioner Kim Henares said they would ask the SC to reconsider its deci-

Day of the pig

n the face of it, the antipork marchers had a couple of advantages.

One was that they explained their beef, so to speak, better. Or far more intelligibly. "Pork barrel is a lump-sum public fund with sole discretion given to the President, legislator or group of legislators, or any public officer on how it will be spent. The exercise of discretion by public officers relates to the allocation, release or use of these

public funds, the identification or selection of projects, implementers or beneficiaries, or any or a combination of or all of these."

Compare that to Butch Abad's statement: 'The Supreme Court defines pork barrel as lump sums in the budget that require postenactment intervention of legislators during budget execution, except in the exercise of their oversight function. Do they accept that definition? If not, how do they define pork barrel?"

Government's disconnect is patent, which gives you an idea of why it has been losing the communication war on DAP/pork these past months. Unless you're an accountant or a lawyer, you won't understand what the hell the Budget Secretary is talking about. The antipork marchers have figures as well to support their claim that pork, as they define it, continues to this day. Under the Grassroots Participatory Budgeting Process, another concoction of Abad's, they say, the Department of Interior and Local Government has gotten a lump sum of P1.37 billion, the Department of Agriculture P1.7 billion, and the Local Government Support Fund P2.78

You start resorting to legalese or "technicalese," and you will be perceived as trying to hide something. That was what Renato Corona resorted to when he was being tried for corruption among other things, and he was a juridical entity. And that was what doomed him. Serafin Cuevas' "Objection, your 'heuneur," made for an interesting meme, but not much else.

Two is that the antipork marchers seem to have made a proprietary claim on National Heroes Day as their day for seeking redress for grievances. Not a bad symbolism, particularly with its usual message of "Everyone can be a hero," or "Every Filipino is a hero." It's an invitation for people to go out of themselves, to be larger than themselves.

Last Monday's rally, however, also suffered from a couple of disadvantages.

One was that it wasn't quite the march it was last year. The power of last year's march was that it was spontaneous, amorphous, anonymous. It arose from the bowels of the earth, or quite literally from several (young) people in the social media expressing their disgust over pork while poverty raged across the land and calling on the populace to do something about it. Someone suggested a Million People March at the Luneta and the populace responded.

The authorities would later estimate the crowd to be only 75,000 to 100,000, a far cry from the million optimistically projected for it. But I don't know that you can pin it to that number; the crowd, perfectly in keep-



ing with the spontaneous, amorphous, anonymous nature of the exercise, kept flowing in and out of the square throughout the day. It wasn't confined to it for any long period at a given time. But whether 100,000 or a million, it was representative of a crosssection of the population, from poor to middle-class to even rich.

Last Monday's rally had nothing of that. It wasn't spontaneous, amorphous, anonymous; it was orga-

nized, definite and strident. Where last year's rally drew in a "united front," this one had a largely leftist composition. Driven home by the bulk of the marchers marching down Mendiola afterward, a ritual that has lost a great deal of its power over the years. With not unexpected results: Where last year's rally was rich in quantity and quality, drawing in a multitude of people or varying persuasions, this one drew in a sparse and pretty much like-minded crowd.

Two was that last year's rally focused on an issue, this one focused on a personality. And the sublimely ironic thing is that for the first time in our political life, issue trumped personality.

Last year's rally was all about pork, its informal organizers kept saying it wasn't about destabilizing government, certainly it wasn't about ousting P-Noy. You needed no further proof of it than that Corona made an appearance there and got booed for his pains. The marchers' message was simple: Don't use this for your political

This year's was completely different. Its chief point was ousting P-Noy, specifically by way of impeaching him. That's what made it largely forgettable. The news on TV last Monday uniformly had it as fourth or fifth story of the day. It was nowhere close to headline stuff, despite the advertisement that had been leading

Frankly, I don't know why government's enemies persist with that tack. -Noy's vulnerability is not himself, however his numbers have been falling over the past year. His vulnerability is the people around him, notably Abad, Mar Roxas, and the top officials of the Liberal Party, or the growing perception that he is boxed in by them, that he is resting the fate of the nation on them. That's what's bringing his numbers down. That's what's causing members of his official and personal families to abandon his unofficial "anointed" and go for Jojo Binay. Their mantra is: "I trust P-Noy absolutely, I distrust the people around him absolutely.'

The efforts to demonize P-Noy—one placard in the rally last Monday put him side by side with Marcos-won't demonize P-Noy, it will demonize the people doing it. Certainly, it will alienate them from the same people who attended last year's rally. It won't get them heard, which is a pity as their point about hidden pork in next year's budget is an interesting one, is a hear-able one.

That was the day that was, the day of the pig.

Power corrupts P-Noy

fter repeatedly denying it in the past, President Benigno "P-Noy" Aquino had let the cat out of the bag: He wants a second term! And he wants it for a strange reason: To curtail the power of the Supreme Court. Whoa! What happened?

Going back to Day One of the Aquino presidency, it reminds us of the promise of hope and pagbabago (change) that P-Noy made to the people whom he called "boss." He promised in his inaugural speech that there would be no more "wang-wang" and the bosses roared in approval.

But what was really the centerpiece of the mandate his bosses gave him on Election Day was predicated on his campaign promise of "Walang korap, walang mahirap" (No corruption, no poverty). Yes, there will be no more corruption, no more poverty! That pumped the people up. Finally, here is a man who would deliver the poor from their hellish lives. Hope... Pagbabago... No more pagpag for food. How sweet.

For the next four years, the poor experienced the taste of sweetness. But it was not the sweetness of progress. It was artificial sweetener to keep them contented from day to day. And for as long as they get a taste of "sweetness' they'd be out of harm's way. Indeed, feeding the poor has always been the ultimate act to pacify the malcontents. Feed them and everything would just be sweet and sassy.

The "sweetener" that P-Noy gives to the poor is called Pantawid Pamilyang Pilipino Program or 4Ps, a form of conditional cash transfer (CCT). Its goal is to

eradicate extreme poverty and hunger by implementing health and education programs for households that have children ages 0-14. It operates in 79 provinces covering 1,484 municipalities and 143 cities. Currently, the program has more than four million registered households.

Plunder


But no sooner had the program been implemented than allegations of "ghost" beneficiaries were made triggering demands for investigation. However, the Aquino administration had repeatedly denied the re-

But nothing is more serious than the plunder of pork barrel funds, which were intended for projects that would have benefitted the people – particularly the poorest of the poor and the hungry or "food-poor." Instead they were diverted to bogus non-government

organizations (NGOs) controlled by Janet Lim Napoles - the "Pork Barrel Queen" - who, with the connivance of elected officials. had siphoned off at least P10 billion from Priority Development Assistance Fund (PDAF) allocations to lawmakers. In exchange for the lawmakers' "cooperation," Napoles gave them kickbacks anywhere between 40% and 70% of the scammed funds. Napoles pocketed the rest.

Prominently involved in the pork barrel scam was Department of Budget and Management (DBM) Secretary Florencio "Butch" Abad who issued the Special Allotment Release Orders (SAROs) approved and signed by the President authorizing the National Treasury to release the funds from PDAF.

In 2011, P-Noy set up the Dis-

bursement Acceleration Program (DAP) – a brainchild of Abad drawing funds from purported 'savings" in budget items and funneling them into a huge "piggy bank." Since its inception, more than P150 billion were transferred to DAP. But what was anomalous was that DAP funds were spent without congressional authoriza-

Double whammy

Then the unthinkable happened! On November 19, 2013, the Supreme Court by a unanimous vote of 14-0, declared the PDAF unconstitutional. Seven months later, on July 1, 2014, it ruled that three parts of DAP are unconstitutional.

It was a stunning setback for P-PDAF but he stood his ground on bosses [the people].'

DAP insisting that it was le-"war" against the Supreme Court, which he treated with contempt. He swiped at the Judiciary for "meddling" too much into the affairs of the other two co-equals, the Executive and the Legislative branches.

In my article, "Is DAP worth fighting for?" I wrote: "P-Noy's tirade against the Supreme Court is like a little boy throwing a tantrum, making unreasonable and foolish demands. He knows better that the Supreme Court's ruling, once it became executory, is final and there is no appeal. Perhaps his legal staff should give him advice on the legality – and futility – of what he's doing.

admitting guilt. It was brilliant! Indeed, there is nothing more profound than admitting a mistake. It's the best defense.

Charter change

Then the unexpected happened! Last August 14, a Manila news-paper reported: "President Aquino is now amenable to amending the Constitution and extending his term apparently to check the power of the Supreme Court, a coequal of the executive branch. The President said the judiciary appeared to be using its power to check the executive and legislative branches without restraint. 'When I took this office, I recall that it was only for one term of six years,' he said. 'Now, after having said that, Noy. He accepted the ruling on of course, I have to listen to my


But the following day, P-Noy gal. This set the tone for his backed off after a tsunami of opposition flooded the airwaves, the broadsheets, and the social media. Ninety percent of those who commented in the social media were against a second term for P-Noy. Many commented that his mother, the late President Cory Aquino, had opposed former presidents Fidel V. Ramos and Gloria Macapagal Arroyo's attempts to amend the Constitution allowing them to run for a second term, which begs the question: Would Cory have opposed her son's attempt to stay in power longer than what the 1987 Constitution allows him?

Judicial independence

But regardless of whether P-Noy would extend his term or not, it has become apparent that his hubris was born out of the power that he amassed during the four years What he should have done of his presidency. Now that he was do a mea culpa routine has full control of both houses of Congress and had placed generals loyal to him in key positions in the military, only the Judiciary remains independent, which had demonstrated in the PDAF and DAP unanimous rulings that "judicial independence" still reigns supreme.

Indeed, the Supreme Court's judicial oversight and review which P-Noy objects to -- and the checks and balances inherent in our trilateral form of government, guarantees that our country shall be governed by the rule of law and not by the rule of man. I must also add that for as long as we have an independent Judiciary, nobody - not one man or group -- should ever have absolute power. And as Lord Acton had once said: "Power tends to corrupt, and absolute power corrupts absolutely." This is a mantra that should always remind our leaders that corruption thrives on power.

In search of the country's 'National Hero'

Dr. Jose Rizal is considered by many as the greatest among Filipino heroes. But officially, he isn't even a national hero.

In fact, the Sampaguita and Narra, the national flower and national tree, respectively, have a more canonical place in the pantheon of Philippine national symbols (which include national heroes) than the great polymath Rizal or even the equally admired and revered revolutionary leader, Andres Bonifacio.

RIZAL SHRINE — The early morning sun provides a perfect backdrop for the Rizal Shrine, perched on a hillside in Barangay Casat, Bayombong, Nueva Vizcaya. While Jose Rizal is widely recognized as the country's national hero, the National Commission for Culture and the Arts said that no law, executive order or proclamation has ever been enacted or issued officially proclaiming any Filipino historical figure as a national hero. (Ceasar M. Perante) Unlike Rizal or Bonifacio, the Sam-paguita and the Narra tree are backed by

two Commonwealth-era Executive Proclamations that explicitly declare them as the national flower and national tree. Both declarations were made in February 1934 by Governor-General Frank Murphy.

Technically, it can also be said that the Philippine Eagle, declared as the national bird through Proclamation no. 615 under President Fidel Ramos in 1995, has a more lawful basis to being a national symbol than any de facto Filipino hero.

According to the National Commission for Culture and the Arts (NCCA), no law, executive order or proclamation has ever been enacted or issued officially proclaiming any Filipino historical figure as a na-

Even Rizal, whom we've been taught in school growing up as the Philippine national hero, has in fact never been given that official title. To borrow the term of Bohol 1st district Rep. Rene Relampagos, this has made the venerated novelist-artistnationalist our "colorum" national hero. But how could that be? In providing an

explanation, the NCCA states that "Heroes, according to historians, should not be legislated. Their appreciation should be better left to academics. Acclamation for heroes,

they felt, would be recognition enough."
However, the Commission does note that laws and proclamations have been made in honor of Filipino heroes.

These include the declaration of the year 1996, which is the centennial of the Philippine Revolution, as the "Year of Filipino" Heroes" and the last Monday of August as National Heroes Day.

The latter, celebrated today, marks the anniversary of the Cry of Pugad Lawin, which signaled the start of the Bonifacio's Katipunan-led revolution in 1896.

Last February 17, Relampagos filed House Bill no. 3926 or the proposed "Philippine National Symbols Act of 2014," which seeks to declare Rizal as the sole Filipino national hero. "[Rizal] is the most well-known advocate for reforms in the Philippines during the Spanish Colonial era," Relampagos argued.

The measure, filed during the 16th Congress, likewise seeks to officially recognize other national symbols like adobo as the national dish, the jeepney as the national vehicle, bangus as the national fish and mango as the national fruit.

WHAT MAKES A NATIONAL HERO?

The Philippine government, through the academe, has actually made an attempt in

the past to identify and officially recognize Filipino heroes. In 1993, Ramos created the National He-

roes Committee (NHC) specifically to evaluate and recommend Filipino national personages/heroes "in due recognition of their sterling character and remarkable achievements for the country.

Dr. Onofre Corpuz and Dr. Alfredo Lagmay came up with a six-item criteria, which was adopted by the Technical Committee of the NHC. These are the following:

- 1.) Heroes are those who have a concept of nation and thereafter aspire and struggle for the nation's freedom.
- 2.) Heroes are those who define and contribute to a system or life of freedom and order for a nation.
- 3.) Heroes are those who contribute to the quality of life and destiny of a nation.
- 4.) A hero is part of the people's expres-
- 5.) A hero thinks of the future, especially the future generations.
- 6.) The choice of a hero involves not only the recounting of an episode or events in history, but of the entire process that made this particular person a hero.

After two years of deliberations, the Committee, which included the country's top historians, selected nine individuals and recommended their declaration as "national heroes.'

The shortlist was made up of Rizal, Bonifacio, Emilio Aguinaldo, Apolinario Mabini, Marcelo H. del Pilar, Sultan Dipatuan Kudarat, Juan Luna, Melchora Aquino and Gabriela Silang.
Unfortunately, the NHC recommendation

made way back on November 22, 1995 to the Department of Education, Culture and Sports (DECS, now DepEd or the Department of Education) was

never acted upon.
Again, the NCCA provides a possible explanation: "This was probably because it might trigger a flood of requests for proclamations. Another possibility is that the proclamations

can trigger bitter debates involving historical controversies about the heroes


Apparently there is wisdom in the NC-CA's assessment, given that some of the historical exploits of even Rizal, Bonifacio and Aguinaldo for that matter, continue to stir up controversy decades after their

'IMPLIED' NATIONAL HEROES

Where does this leave us Filipinos then? As it is we are not hero-less, since the Commission mentions the existence of "implied" national heroes of the basis of the national (nationwide) holidays commemorated in their names.

There are three Filipinos who fall into this category, namely Rizal (honored every December 30 on Rizal Day), Bonifacio (November 30, Bonifacio Day) and the late Senator Benigno "Ninoy" Aquino Jr. (August 21, Ninoy Aquino Day).

Ninoy Aquino is the husband of the late former President, Corazon "Cory" Aquino and father of the incumbent President Benigno S. Aquino III. As to whether or not Ninoy belongs in the same breath as the two Philippine revolution icons is a topic



for another day.

For what it's worth, there is an imposing figure over in Luneta Park (which by the way, was declared a national park by President Ramon Magsaysay in 1955) aside from Rizal's own monument. That figure belongs to Lapu-Lapu in the form of a 31-foot statue at the Teodoro F. Valencia Circle of Luneta Park.

Conspicuously missing from the NHC list, Lapu-Lapu has been imprinted into the minds of pupils as the first Filipino hero ever, being the first to rise up against for-eign invaders. He gained fame for leading local warriors in the Battle of Mactan, Cebu which led to death of Portuguese explorer Ferdinand Magellan on April 27, 1521.

Since the 14th Congress, legislative measures have been introduced to declare April 27 as "Lapu-Lapu Day," therefore making it a national holiday and in effect giving the Mactan datu the implied title of na-

Lapu-Lapu's silhouette currently figures prominently in the seal of the Philippine National Police and the Bureau of Fire Protection.



Rosary, Novena, and Mass **The First Filipino Saint**

The following information was derived from a novena to San Lorenzo Ruiz at St. Charles Borromeo Parish:

"Lorenzo Ruiz was a Pilipino, although his father was a Chinese and his mother, a Filipina. He was born in Binondo, Manila between 1600 and 1610.

According to the documents cited to proclaim him "Blessed", his parents were devout Catholics. He was christened "Lorenzo" after a martyr during the 3rd century persecution of Christians. His last name Ruiz was taken from the last name of his godfather.

In his younger years, Lorenzo served at the convent of Binondo church as a sacristan. Since he lived there together with Dominican priests, he learned from them not just Spanish but also catechism.

After several years, Lorenzo Ruiz earned the title of "escribano" or notary. He became an active member of the Confraternity of the Holy Rosary, an organization devoted to the Blessed Virgin. This group was organized in the Philippines in 1587

Lorenzo was married. He confessed before he was convicted that he was a family man - having a wife with three kids, two boys and a girl.

In 1637, a grave crime was committed in Manila. Authorities conducted a manhunt for Lorenzo because they believe he knew something about it or was involved in it. When Lorenzo learned of some missionary priests leaving for Japan, he asked if he could be allowed to join them. And he was allowed aboard the ship bound for Japan, along with the Dominicans, safe from fear of being implicated in a crime.

According to www.chapelofsanlorenzoruiz.org, In "Nagasaki, Japan, where feudalism was fanning the flames of Christian persecution. Lorenzo Ruiz found himself headed straight into the arms of death. He was arrested almost immediately upon his arrival in Japan in 1636, and subjected to torture by his Japanese captors for more than a year. Tied upside down by his feet and dropped into a well where sharp stakes lined the bottom, his torturers would stop just before he would be impaled, and thereupon try to convince him to renounce his faith.

Deny your faith and we will spare your life," his persecutors said.

To which Lorenzo Ruiz answered, "I will never do it. I am a Catholic and happy to die for God. If I have a thousand lives to offer, I will offer them to God."



Solar Panels for Your Roof -Saving Money on Your Electric Bill

Many companies now offer variousplans to put solar panels on your roof. The idea is for solar panels to generateenough electricity to provide for youraverage consumption at a cheaper ratethan your utility (SMUD, PG&E, Edison, etc.) When the solar panels producemore than your usage, the extra poweris fed back to your utility and youaccumulate credits that will be appliedagainst your power consumption whenthe sun is not shining. Your home will therefore be supplied electricity from two sources: first from the solarpanels and second any demand above what solar provides (say, on cloudy days) is takenfrom your accumulated credits. Your home will at all times be connected to both the solarpanels and to your utility company.

The main selling point is that solar can provide less expensive power per kilowatt-hour thanyour utility company, whose rates will more than likely continually increase. Current powerplant equipment are mostly old and will need upgrade or replacement in the very nearfuture. Meantime, these power plants are incurring increased maintenance costs.

Residential Solar plans fall into two general categories: (a) you buy the system or (b) youpay for power only. Variations in plans are available with different companies. All figuresbelow are only examples.

YOU BUY THE SYSTEM (you pay upfront for the whole system using your funds)o You contract a company to install a suitable size solar system on your roof. o You pay the com-



permit, materials and labor to install, test,etc. o You ally your home should qualify for a Federal tax credit of 30% on the cost of the system. Other statesmay offer other incentives. If the whole system costs \$20,000, you will receive a taxcredit of \$6,000, so your net cost will only be \$14,000. 
Dream ship was primarily built for families who want to go on vacation, celebrate birthdays and anniversaries, and spend quality time together.

Basketball won't distract Pacquiao from Algieri, says Roach

Freddie Roach says Pacquiao will not be sidetracked by his basketball dreams as he prepares to fight a 'tough' Algieri who has yet to taste defeat in boxing

Freddie Roach has grown accustomed to Manny Pacquiao's insatiable desire to conquer new horizons.

Since taking over head trainer duties for the General Santos City, Philippines native in 2001, Roach has seen Pacquiao evolve from a comebacking former champion at 112 pounds to an eight division champion who has won a congressional seat in his home country, released a soft rock album, starred in several movies and become the most recognizable face of his nation.

Now, as Pacquiao (56-5-2, 38 knockouts) prepares to defend his WBO welterweight title against unbeaten New Yorker Chris Algieri on November 23, Pacquiao has added a new title: player-coach in the Philippine Basketball Association.

Pacquiao, 35, became the oldest rookie ever drafted in Asia's first play-for-pay when the Kia Motors expansion squad he coaches picked him with the 11th pick on Sunday, August 24.

At that very moment, Roach was settling into his suite at The Venetian Resort in Macau, China, where the two-continent promotional tour kicks off on Monday afternoon. Roach acknowledges that juggling multiple responsibilities is part of who the Pacman is, but says he has made assurances with Pacquiao that boxing comes first when it's time to fight.

"He's a congressman, he's always stayed busy, he used to do concerts after his fights. He gets bored very quickly, I don't think it's a problem," Roach, a six-time Boxing Writers Association of America (BWAA) Trainer of the Year, tells Rappler.

"The thing is with basketball, we stop 4 weeks before because of injuries with finger jams and twisted ankles. He's a grown man, I can't tell him what to do but if we negotiate a deal, it's a done

Roach, like Pacquiao's promoter Bob Arum, thinks of Pacquiao's foray into basketball, which is the Philippines' true passion, as more of a side hobby than a career, saying "That's not real. He's not good enough to play in that league, I know that."

Roach won a battle over basketball by having Pacquiao train in his hometown of General Santos City, where they've prepared for their last two wins over Brandon Rios and Timothy Bradley, instead of in Manila, where Pacquiao could train close to the Kia team.

"He's comfortable there, he's at home with his family," said Roach. "He gets to spend more time with his family there, he does have a basketball court there. He flies in teams to play against his team. The best

part about it is its only 3 hours away from China and it's on the same time zone and there'll be no jet lag whatso-

Serious threat

Roach has probably studied the 30-year-old Algieri (20-0, 8 KOs) more stringently than any other coach, hav-

ing trained Ruslan Provodnikov for his fight in June, which Algieri won by split decision to take the WBO junior welterweight title.

The 5-foot-10 Algieri rose off the canvas from two first round knockdowns to outbox the slower, shorter power puncher from Russia en route to victory, and Roach isn't discounting the lesser-known fighter's threat.

"He's tough, he's got a big heart, he's got a good jab and he moves very well," said Roach of Algieri. "His height and his reach advantage and his jab could give us some problems."

Still, Roach remains confident that Pacquiao will eventually break Algieri down for his first stoppage win since a 12th round TKO of Miguel Cotto in 2009.

"Algieri is very hittable," said Roach. "People don't realize how fast [Pacquiao] is until they get in the ring with him, he does put his punches together very well. I think Algieri will get knocked out somewhere along the way.

"Ruslan had good early rounds, he had success with the one punch and he was looking for that one punch all night long. Manny's not a one punch fighter, he's a combination puncher, plus he's much faster. He probably doesn't hit as hard but he does have power and he's so fast with his combinations, he's a completely different kind of fighter.'





Path to Citizenship Now Available to Family of Active and Non-Active Military

While we have had high hopes for change to our immigration system under the current administration, little has been done by way of comprehensive legislation that benefits undocumented residents in the United States. 




