## Reversal of fortune

n the 29th anniversary of people power, the reversals of fortune can make a movie good enough for the Oscars:

The other half of the conjugal dictatorship is an "honorable" member of the House of Representatives, still living it up and with all her relatives back in power. Her only son and Ferdinand Marcos' namesake is in the Senate and is seriously considering a run for the presi-

Meanwhile, EDSA hero Juan Ponce Enrile is under "hospital arrest" without bail for large-scale corruption. His RAMboys members of the Reform the Armed Forces Movement linked to coup attempts during the post-EDSA Aquino presidency – have broken up in an ugly squabble reportedly over rebel amnesty money.

Billions in assets have been seized by or turned over to the Philippine government after being legally declared ill-gotten, but no one is in prison for accumulating the vast wealth illegally.

Several of the biggest Marcos cronies are fully rehabilitated, with their wealth and influence not only intact but also greater.

Many victims of human rights violations during the dictatorship have yet to receive several thousand pesos each as compensation for their suffering. The amount, though small, is considered symbolic and the payment precedent-setting. Meanwhile, Pinoys continue to vote for unapologetic human rights violators who present themselves to be tough on crime.

Twenty-nine years after the people power revolt, there are groups trying to resuscitate the coup virus and are calling for the ouster or resignation of the only son of Benigno and Corazon Aquino. Their numbers are negligible, but the personalities are an interesting mix. They include Cory Aquino's younger brother and his wife plus a smattering of Catholic bishops.

Justice is elusive in this country under normal circumstances. Trying to make a regime account for its abuses during 14 years of authoritarian rule is even more complicated.

The fact that the quest for justice is difficult, however, should not mean giving up on it, which is what it looks like in the pursuit of accountability for abuses during the Marcos regime. After recovering several pieces of prime real estate in the United States and getting back millions of dollars in Swiss bank deposits, we have given up on the accountability part. Who deposited the ill-gotten funds in Switzerland? How come we're not going after the account holder/s?

We've kicked out a chief justice for failure to disclose dollar accounts. The Swiss bank deposits, including accumulated interest while in escrow, amount to a whopping \$683 million. The deposits were declared ill-gotten by Philippine courts, and Swiss authorities agreed. Why isn't any account hold-



er behind bars, without bail, for plunder?

Our government has seized priceless original artworks of the masters from the Marcoses and is still running after more. How come no one is being summoned for a probe or charges being filed for possession of such treasures only a billionaire collector can afford? Were these assets declared? Did anyone ever explain how public officials in a developing country could afford to buy such treasures?

The most enduring legacy of EDSA is undeniable: democracy was restored, warts and all, and there's no going back to authoritarian rule. This is a remarkable feat worth celebrating every year. Young Filipinos will never live in fear of hearing a knock on their door at 3 a.m., of being dragged from their home and driven to unknown destinations where their worst nightmares await.

But building on the gains of people power and making democracy work have been a difficult slog. There is no magic wand for progress and inclusive growth.

People denounce the "kleptocracy" during the Marcos regime, but no one has been punished for corruption on a scale so vast a new word had to be invented for it.

No human rights violator went to prison either. And whoever ordered the assassination of P-Noy's father Benigno Aquino Jr. is home free; not even two Aquino presidencies could give Ninoy justice.

Seeing everyone getting away with double murder, torture and enforced disappearances, world-class cor-

ruption and flouting of unexplained wealth is the biggest reason for the persistence of these abuses, 29 years after the Marcos regime finally collapsed.

The failure to make anyone account for the sins of the dictatorship has bred impunity. It has given rise to a common reaction when public officials are indicted and arrested for similar offenses: others are doing it, why pick on me?

When those occupying high positions in government are setting the example in stealing from taxpayers, they lose the moral authority to demand honest service from their subordinates. Economic growth does not trickle down to the grassroots in this country, but corruption does.

Failure to curb political dynasty-building has abetted corruption and brazen disre-

gard of laws against nepotism. The 2013 elections showed dynasty-building reaching shameless proportions, with clans wanting to corner not only all elective seats in their turfs but also in any place where they can claim some ancestry or early residency.

Dynasties also perpetuate patronage politics. P-Noy, as well-meaning as he is, belongs to the old rich and can only do so much to try to transform an entrenched system. When his countdown to noon of June 30, 2016 finally ends, he can say he did his best. But as the song goes, the best still wasn't good enough.

He would end his term four months after the 30th anniversary of the people power revolt The EDSA movie could be a blockbuster, and it would leave many Pinoys in tears.

## Aquino: Purisima lied to me

anila, Philippines— Alan Purisima may have lied to him. but President Aquino apparently has no regrets entrusting to his close friend, although under suspension on corruption charges, the police operation in Mamasapano on Jan. 25 that cost the lives of 44 Special Action Force (SAF) commandos.

"I didn't hear or see anything in him [Aquino] showing anything regarding regret," Communications Secretary Herminio Coloma said Tuesday as the Senate wound up its inquiry into the tragic affair, during which Purisima himself finally admitted that he was in fact the "overall commander" of the project to take out a Malaysian terrorist nicknamed, "Marwan."

"What I saw during the past month has been the determination of the President to find out the whole truth so that his understanding would be complete and this would guide him for future actions," Coloma told reporters.

Purisima was under suspension as Philippine National Police director general when he gave "advice" to Director Getulio Napeñas, the SAF commander who was Marwan (real name: Zulkifli bin Hir), who had a \$6-million bounty from the FBI, in the Maguindanao province marshland.

In a meeting with a group of congressmen on Monday, the President said that Purisima, who has resigned as PNP director general, after the Mamasapano debacle, lied to him about the unfolding tragedy in besetting "Oplan Exodus" in Mamasapano in their exchange of text messages in the early morning of Jan. 25.

#### Transcript of text messages

Aside from saying he was deceived, the President said that his orders to inform the Armed Forces

of the Philippines and Deputy Director General Leonardo Espina, the PNP officer in charge, before the jump-off were not followed, according to select lawmakers who were present during the four-hour meeting in Malacañang.

Antipolo City Rep. Romeo Acop, a former general, said Aquino showed him and other lawmakers led by Speaker Feliciano Belmonte Jr. a transcript of the text messages between him and Purisima, who was in his rest house in Nueva Ecija at that time and getting his information from Napeñas.

Purisima also disclosed the same document to senators looking into the Mamasapano slaughter, which showed Aquino was being fed inaccurate information during the crucial hours of that fateful Sunday morning after the SAF troopers reportedly succeeded in killing Marwan and were battling for their lives against forces of the Moro Islamic Liberation Front and its breakaway faction, the Bangsamoro Islamic Freedom Fighters.

### Lack of urgency

Acop asked the President whether he was being given inaccurate information and quoted the President as replying: "They are not only inaccurate, they are lies. Don't you think these are not lies with

Acop said that the most striking subsequently sacked, to take down things about Purisima's messages to the President were his lack of urgency in getting military reinforcement for the retreating SAF troops and what he was relaying did not "jibe with what I knew was actually happening on the ground.'

> Acop, however, did not ask the President when he realized he was being deceived.

Cagayan de Oro Rep. Rufus Rodriguez surmised that the President probably knew the dire situation of the SAF troops between 4 p.m. and 6 p.m. when reports of the death toll started streaming in. Aquino was in Zamboanga City at the time, ostensibly to look into a bombing incident earlier in which House delegation was "too polite"

### 'Too polite'

"The President felt he was lied to by Purisima because the one texting him was Purisima, not Napeñas. He also said they did not follow orders," Rodriguez said.

House Minority Leader Ronaldo Zamora said: "The President did not say Purisima or Napeñas were during the meeting and that the President was "being careful with his words."

Zamora said that while the President was able to clarify his participation in the Jan. 25 mission, he left unanswered why he was getting the information from Purisima who was more than a month into his six-month suspension from the Ombudsman at that point.

"He (President) did not go through Zamora also noted that the regular channels, through the regular chain of command of the PNP.

He got everything from Purisima who was in Nueva Ecija, which was a strange place to be if you are directing a major operation. Why was a major operation done so casually? (The mission) fell apart because nobody knew how to deal with it," Zamora said.

Both Zamora and Rodriguez agreed that the President should speak to the nation again and elaborate on his role in the mission. In his two previous national speeches, the President blamed the Mamasapano massacre on the lack of coordination and he even spoke of the difficulty of firing Purisima, his longtime friend.

Rodriguez said it took hours before the President knew of the real situation because he proceeded with his schedule in Zamboanga City that Sunday afternoon.

"He thought everything was going on course because the text said the Armed Forces were already supporting them," Rodriguez said.

### 'I need to stay calm'

Aquino on Tuesday defended his actions in the aftermath of the Mamasapano fiasco, reiterating his call for sobriety from a public furious over how authorities handled-or allegedly mishandledthe Jan. 25 operation.

On the eve of the 29th Edsa People Power anniversary when he also feted 10 outstanding youth organizations, the President cited his efforts to live by the lessons of the bloodless revolution: The need to promote the "interest of the majority, freedom from the crooked ways of the past and a better tomorrow for the next generation.'

He described as a "challenge" the Mamasapano incident.

"As President, I am doing everything as I face and attend to the problems of the nation," he told his audience in Malacañang, citing problems such as the Mamasapano debacle

"I cannot give in to my emotions because I might only make the problem worse. Each time, I need to stay calm and remember for whom these efforts of ours are," he added, reiterating the same call for sobriety he made in a televised address on Feb. 6.

## Iqbal: AFP, PNP members sold us weapons

MANILA, Philippines - The Moro Islamic Liberation Front (MILF) bought some of its weapons from members the Armed Forces of the Philippines (AFP) and the Philippine National Police (PNP), **MILF** chief negotiapeace Mohagher Iqbal revealed on Wednesday.



The Moro Islamic Liberation Front (MILF) used to have a weapon factory but abandoned it for the sake of the peace process, MILF chief peace negotiator Mohagher Iqbal said. The MILF also used to buy weapons from gun smugglers and some members of the military and police.

ABS-CBN News Channel, Iqbal explained where the MILF acquired its weapons.

"Tatlo ang pinanggagalingan ng armas namin - unanguna, binibili namin sa labas, sa mga gun smugglers... pangalawa, 'yung armas na binili namin, karamihan diyan nanggagaling sa Armed Forces of the Philippines at saka PNP... binenta ng tau-han ng PNP, AFP," Iqbal

Iqbal clarified that the MILF only bought firearms from AFP and PNP members during the term of former President Gloria Macapagal-Arroyo.

In an interview with the they abandoned after the peace agreement with the government.



## EXCLUSIVE: Did Bongbong Marcos lie about Oxford, Wharton?

At A Glance

Senator Ferdinand Marcos Jr lists in his resumé an undergraduate degree from Oxford and an MBA from Wharton Oxford University and Wharton School records do not show any Marcos Jr in their lists of graduates.

Marcos Jr declines to be interviewed

MANILA, Philippines - During his presidency, Ferdinand Marcos sent his only son and namesake, Ferdinand Jr or Bongbong, to prestigious schools in England and the

Now a senator, Bongbong Marcos lists in his resumé the results of his overseas education: a bachelor of arts degree in political science, philosophy and economics from Oxford University (1975-1978) and a master's in business administration (MBA) from the Wharton School of the University of Pennsylvania (1979-1981).

29 years after EDSA 1, when his father was deposed by a popular rebellion, Marcos Jr is mentioned as one of the possible candidates in the 2016 presidential elections. If his mother Imelda were to be followed, Marcos Jr would run for president and bring the family back to Malacañang.

Our fact-checking shows, however, that Marcos Jr's claims are false. Oxford University and Wharton School records do not show any Ferdinand Marcos Jr in their lists of graduates.

A visual timeline, posted on Marcos Jr's website, details milestones in his life. It is

interesting that his grade school years at La Salle Greenhills (1963-1969) are complete with report cards and class photos, but his college and post-graduate years in Oxford and Wharton School, respectively, are empty, except for a single picture of him, in a beret, in the Oxford campus. (READ: What's so special about Oxford, Wharton?)

'Unequivocal fraud'

At Oxford, Marcos Jr attended St Edmund Hall, one of its colleges, starting October 1975. He claims to have graduated in 1978 but the 1977-1978 university calendar, which contains the names of all those sitting for their final exams in each subject, does not include him. The calendar, which is filed at the University's Bodleian Library, is accessible to the public.

We sent e-mails inquiring about the status of Senator Marcos to two persons, Produring an academic year. fessor Keith Gull, principal of St Edmund Hall, and Philippa Machin of the Development and Alumni Relations of the same college. Gull did not reply.

Machin referred our e-mail to Robert Wilkins, a senior tutor of St Edmund Hall, who, in turn, referred us to the university calendar. He wrote us: "Data confidentiality concerns mean that we cannot discuss individual students of the Hall, but Class lists for Final Honour School examinations were historically published in the University Calendar. Past copies of the Calendar are on open shelves in the Lower Reading Room in the Bodleian Library and can be freely consulted there.

Our sources, who commenced at the same college as Marcos Jr in 1975, say that he stayed for only a year. One of them wrote in an e-mail: "It is my understanding that he was sent down (expelled)...Having failed his Prelims (first year exams), Ferdinand Jr never completed his Bachelor degree at Oxford. It is possible that he might have received a face-saving diploma, which is not the degree that he claims."

Marcos Jr's claim of a bachelor of arts in political science, philosophy, and economics, the same source wrote, is an "unequivocal fraud.

**University calendar** We asked Carla Montemayor, a Rappler contributor who lives in London, to check the Oxford University calendar. She visited the Bodleian Library and found printed volumes published annually by the Oxford University Press. Among a calendar's con-

Montemayor explained: "The class list is the roll of students who successfully completed their degrees. This means they have complied with course requirements and passed their final examinations. Each course has Class I, Class II, and Class III students, where Class I (first-class honours) names the students who achieved the highest marks possible in their course.

All Oxford students who are awarded their degrees and qualified for honors at the end of an academic year are included in the class lists of the university calendar.

The class list format goes this way: course, Class I, Class II, Class III, alphabetical list of students in each class: surname, first and second initials, college. Marcos Jr does not appear in any of these 3 classes.

#### No MBA from Wharton

The case in Wharton School is similar. Professor Justin McDaniel of the University of Pennsylvania personally checked Marcos Jr's status after we were informed of the university's strict privacy rules. He spoke with the director of the MBA program and this is what he sent us via private message on Facebook:

Marcos Jr entered the MBA program in 1979 and attended until the fall of 1980. However, he withdrew sometime during this period or early spring in 1981 and never graduated. They do not know why. However, Wharton confirmed that Marcos went there but never graduated

Before we obtained this confirmation, we had already gained access to a comprehensive alumni database of the University of Pennsylvania, as of 2012, and did two searches, one by first name, and the other by surname. The name of Marcos Jr did not

appear in both searches.

We then sent repeated queries to the alumni office of the University of Pennsylvania but we received this puzzling reply: "Mr Marcos graduated from our Wharton Graduate program in 1981, unfortunately due to privacy rules I am unable to give any further information." The e-mail was sent by a Stephanie Stapleton.

It was then that we asked Professor Mc-Daniel to make inquiries – thus the confir-mation from the MBA program director of Wharton

One question remains unanswered: how did Marcos Jr get accepted to Wharton School without an undergraduate degree from Oxford, as he claimed?

In the Philippines, Marcos Jr is an accepted member of the Wharton-Penn Club, composed of alumni. In 2010, the Club, then led by Peter Coyiuto, honored 4 alumni, including Senator Marcos.

To a certain extent, Marcos Jr's false claims are reminiscent of his father's World War II medals which turned out to be fake. US government documents showed that these had no basis, as extensive research by historian Alfred McCoy and Marcos opposition leader Bonifacio Gillego showed

Senator Marcos declined our repeated requests to be interviewed, either in person or by telephone. He, however, released a statement Tuesday night, saying his educational records at Oxford and Wharton are 'accurate.

He said, "I earned a diploma in political science at St. Edmund Hall, Oxford University in England in 1978." He did not specify it to be a bachelor's degree.

He also said, "I thereafter did post-grad-

## Cavaliers Lead Investigation on Mamasapano Massacre

ebruary 11, Wedesday, was the first day for the House of Representatives to investigate the tragic death of 44 Special Action Force (SAF) on Jan 25, 2015, in the town of Mamasapano in the province of Maguindanao.

The main actors in the investigation of Mamasapano massacre are graduates of the premier military institution of the country - Philippine Military Academy (PMA), known Academia Militar in 1898. Some of the legislators who are interested in knowing the truth on the incident are also alumni of PMA.

Who are these Cavaliers?

#### PHILIPPINE NATIONAL PO-LICE

Police Director General (four star) Alan Purisima (PMA 81) is the former chief of the PNP who resigned after Mamasapano massacre.

Police Deputy Director General (three star) Leonardo Espina (PMÀ 81) is the Officer-in-Charge of PNP who was out of the loop on "OPLAN Exodus". Espina is a mistah (classmate) of Purisima. He was informed Time-On-Target (TOT) by Dir. Napenas on Oplan Exodus

Police Director (two star) Getulio Napenas (PMA 82) is the relieved director of Special Action Force (SAF) who has direct hand in the capture and death of international terrorist Zulkifli Bin Hir known as for his capture.

Police Director (two star) Benjamin Magalong (PMA 82) is the current head of Criminal Investigation and Detection Group (CIDG) of the PNP. Magalong is in charge of the Board of Inquiry (BOI) to investigate the Mamasapano incident.

#### ARMED FORCES OF THE PHILIPPINES



General (four star) Gregorio Pio Catapang (PMA 81) is the AFP chief of staff. Catapang is a mistah of Purisima who was informed by Purisima on Oplan Exodus "Time-On-Target" (TOT).

Lieutenant General (three star) Rustico Guerero (PMA 81) is the commander of Western Mindanao Command (WestMinCom) based in Calarian, Zamboanga City. WestMinCom has direct military control of Region 9, part of region 10, and part of Region 12. Lt. Gen.

Marwan. Marwan has \$5M bounty Guerero is a mistah of Purisima and Espina.

Major General (two star) Edmundo Pangilinan (PMA 83) is the 6th Infantry Division commander based in Odin Sinsuat, Maguindanao. 6ID has military control over Mamasapano.

Brigadier General Carlito Galvez (PMA 85) is the chair of the Coordinating Committee on the Cessation of Hostilities (CCCH), an agency that coordinates and fa-

cilitates actions between MILF and GPH. Galvez holds the record the AFP's youngest brigade commander age 47.

LEGISLATORS Congressman Rodulfo Biazon (PMA 61) is a former chief of staff of the

Armed Forces of the Philippines (AFP) and a former senator of the republic.

Senator Gregorio Honasan (PMA 71) was a former Commandant of Special Forces School (Airborne) based in Fort Magsaysay, Palayan City in Nueva Ecija. Honasan was military aid of Defense Minister Juan Ponce Enrile during EDSA I revolution, bloodless revolution in the world. Enrile is under hospital arrest due to non-bailable crime of plunder. Honasan led several

coups against the Cory Aquino administration (1987-1992). The famous coup was named God Save the Queen.

Senator Antonio Trillanes IV (PMA 95) is a former navy officer who was the spokesperson of the Magdalo Group during the Oakwood Mutiny against former president Gloria Macapagal-Arroyo (GMA) in 2003. Former president GMA is currently under hospital arrest due to corruption charges. Congressman Gary Alejano (PMA 95) is a mistah of Sen. Antonio Trillanes IV. Cong. While most of the legislators are interested and sometimes 'blaming" PNP and AFP on the Mamasapano incident, Congressman Alejano was interested on the actions and behavior of the members of the Moro Islamic Liberation Front (MILF) in which the Government of the Philippines is in Peace Talk.

MILF is accused of the overkill of 44 SAF troopers. Some of them were still alive but were executed and finished by MILF. Video on this incident was uploaded in social media.

Cong. Biazon lambasted resigned Police Director General Alan Purisima on violating the chain of command. Purisima, on his speech before the members of the august body, negated the theory of Biazon saying the Philippine National Police (PNP) is a civilian organization and the chain of command does not apply to PNP. He further said the chain of command is only applicable to military organization like the AFP.

Panfilo Lacson (PMA 71), former PNP chief and former senator of the republic said that Chain of Command is applicable in PNP. Lacson, on his interview with Pinky Webb at ANC on Thursday explained that the chain of command refers to the vertical and horizontal relationship of officers and men in the organization.

January 12, Thursday, was the 3rd day for the senate to investigate the above mentioned incident. If I'm excited to hear mind boggling comments and questions coming from the legislators and am also interested in listening to the testimonies of resource per-

Mohagher Iqbal, MILF chief negotiator, is in the senate for the first time to shed light on the Mamasapano incident.

Lastly, I am also interested to read comments of the people in tri-media, including social media, who considered themselves expert after the fact.

## Give Peace a Chance —

indanao, the second biggest island out of 7,100 islands of the archipelago, is located in the southern part of the Philippines. Mindanao, also known as the Land of Promise, has been crying for a solution to its decades old rebellion problems with the Moro groups.

One of the solutions for a lasting peace in Mindanao is the creation of a comprehensive peace agreement between the government of the Philippines (GPH) and the Moro Islamic Liberation Front (MILF). MILF is the biggest threat group in Mindanao.

In 1996 the government, under the Ramos administration, enacted a law that created Autonomous Region in Muslim Mindanao (ARMM) with Nur Misuari, chair and founder of the Moro Liberation Front (MNLF), as the governor of ARMM however the autonomy failed to address the needs of its people. Misuari was a professor at the University of the Philippines before he founded MNLF on March 18, 1968.

Misuari was accused of corruption and rebellion that led to the collapse of his leadership. Warrant has been issued for his arrest. Misuari has been in hiding ever

The people living in Mindanao are longing for a lasting peace in the island. Mindanaoans are tired

and sick of the protracted war between the government and the rebel groups.

One of the courses of actions to attain this elusive peace in Mindanao is to bring together the government and the rebel groups to a table and talk peace.

MILF, a break-away group of MNLF, was founded by an Egypt educated Hashim Salamat of Cotabato province in 1977. MILF is the largest rebel group in Mindanao with a strength of 7,000 armed personnel. Mohagher Iqbal, MILF chief peace negotiator, claimed the group has hundreds of thousands of supporters.

GPH and MILF did agree to talk peace. Framework agreement was approved. Bangsamoro Basic Law (BBL) was created and more than halfway in the process of making it into reality.

What are the factors and the basis for the creation of an autonomous region?

The 1987 Philippine Constitution provides that there must be an autonomous region for Muslim Mindanao and the Cordilleras. Mindanao has ARMM but it failed to address the demand of the people. People in the Cordilleras voiced via plebiscite their opposition to autonomy thus they have Cordillera Administrative Region (CAR). (N.B.: CAR is an Administrative, not Autonomous Region).

Local government code of 1991

or Republic Act 7160 talks about people empowerment thru decentralization and devolution of power and services. R.A. 7160 is Federalism" Philippine style.

Mindanaoans need not be afraid of BBL because there is an electoral process that must be followed to hear the voices GIVE of the people by virtue of a PEACE plebiscite

Strong opinions are circulating saying the BBL is unconstitutional. For a law to be rendered unconstitutional, the Supreme Court has to decide on it. However the SC cannot rule on its

constitutionality because the law shall be enacted first. BBL needs to be enacted to determine its constitutionality.

Truth hurts. The truth is that ARMM is the poorest local government unit in the entire Philippines. On the other hand, revenues coming from Mindanao goes to imperial Manila and more or less a third of it comes back and trickles down to selected few lucky hands

Development won't happen when there is war. Stereotype says Mindanao is a war zone. The fact is local and foreign investors are afraid to put business in Mindanao particularly in Muslim dominated province, cities, towns, and barangays (villages) because of skirmishes between government security forces and the rebels

The constitution promotes and protects social, cultural, and religious beliefs of the people provided those are in consonance with law of the land. Social development happens when people are empowered. People empowerment can be achieved when

people are given autonomy and are free to participate in nation building.

Infrastructures are vital to development. Farm to market roads and technological infrastructures such as constructing, power plants and lines, high speed internet connection, etc., are needed to be competitive.

We see in tri and social media the video of gun making activities in the ARMM. We need to legalize this gun-making technology to provide livelihood for our Muslim brothers. Once legalized, Bangsamoro people don't need to hide their talents and they can sell their products locally and to international market. Gun making is a big business.

Local autonomy exist when there is international recognition. Tripoli Agreement is one of the basis of the creation of ARMM. Presently, third party monitoring team spearheaded by Malaysia has been active in making peace agreement come into fruition.

The Mamasapano massacre is the turning point of and considered a major obstacle of BBL. On Janu-

ary 25, 2015, 44 troopers of the Special Action Force who killed international terrorist Zulkifli Bin Hir, known as Marwan, a Malaysian bomb-maker expert, were allegedly massacred by members of the MILF, BIFF (Bangsamoro Islamic Freedom Fighters, a break-away group of MILF), and other armed groups operating in the province of Maguindanao. Marwan is the main suspect in the 2012 Bali, Indonesia bombing where 202 people died. He has a bounty of \$5M.

Government's quick and proper handling on the investigation and finding solution of this tragic Mamasapano massacre will make or break the Bangsamoro Basic

I believe in peace as the ultimate solution to Mindanao problem and for the island to pole-vault into and attain stable politico-legal, socio-cultural, technological, and international development. Please give peace a chance.

Putin came to power in 1999 when then President Boris Yeltsin appointed him as Prime Minister. On December 31, 1999, Yeltsin abruptly resigned and Putin became Acting President. He was elected President in 2000 and reelected in 2004. Constitutionally prohibited to run for a third term, Putin stepped down. Dmitry Medvedev was elected in 2008 and he appointed Putin as Prime

wrong message not only to Syrian President Bashar al-Assad but also to the entire world, particularly to al-Assad's benefactor and protector, Vladimir Putin. Putin saw Obama's wishy-washy hesitancy to act as an opening to engage him in geopolitical brinkmanship. And thus far, Putin is ahead in the game.

#### Round 1

Their fight began when Putin sent Russian soldiers — with no identifying insignia on their uniforms who came to be known as 'little green men'' – to Crimea. It didn't take long for Putin to annex Crimea, which stunned the U.S.

for Putin because he could now deploy land-based nuclear missiles as well as missile-firing warships and submarines in the Black Sea that could reach NATO's southern flank from Turkey to the Balkans, Italy, Spain and Portugal.

Russia's Crimean territorial grab diminished the U.S.'s credibility as the world's superpower. For the first time since the end of World War II, the U.S. failed to protect her geopolitical interests since the Cuban missile crisis in 1962 when the Soviet Union attempted to deploy nuclear missiles 90 miles from U.S. mainland. Simply put, with Putin breathing down NATO's southern flank, it

the U.S. and NATO had a chance to react with force to the Russian incursion - or as some say, "invasion" — but instead they stood down and allowed Putin to grab Crimea. This was a major victory

and her NATO allies. However, puts the 28-member Atlantic alliance on notice that Russia is a power - economically and militarily — to be reckoned with in the Mediterranean Basin.

It did not then come as a surprise when it was announced that Russia is holding bilateral negotiations with Greece, Cyprus, and Egypt that could establish Russia's military presence in the Mediterranean. Right now, Russia and Greece are in the midst of negotiating a financial bailout, which could result in Greece getting out of NATO and the European Union (EU). If that happens, it would break NATO's defenses on her southern periphery.

Russia is also holding bilateral negotiations with another EU member, Cyprus, which is having financial problems. Russia is offering financial aid; however,

she also wants to station air and naval assets on Cypriot ostensibly for "humanitarian" reasons. These Russian bases would be located near the Akrotiri Air

base where British personnel are stationed to support ongoing operations in the Middle East, which makes one wonder: What would Cyprus do in the event Russia and NATO went to war? The specter of the tiny island of Cyprus becoming one bloody – and possibly nuclear — battlefield should be a good enough reason for Cyprus to reject Russian military presence on her territory.

Meanwhile, not too far away, Egyptian President Abdel-Fattah el-Sisi gave Putin a "hero's welcome" in Cairo. They discussed a slew of economic and military deals including the purchase of MiG-29 fighter jets and attack helicopters worth \$3.5 billion. But the irony of this is that the U.S. had been sending billions in military aid to Egypt for the past three decades! Last year, the U.S.'s military aid to Egypt was \$1.5 billion, which makes one wonder if the U.S. were indirectly subsidizing Egypt's arms deal with Russia?

### Round 2

Last February 12, after a marathon 17-hour summit of Putin, German Chancellor Angela Merkel, French President François Hollande, and Ukrainian President Petro Poroshenko in Minsk, Belarus, they agreed on a ceasefire and a number of measures to achieve peace in Ukraine But no sooner had the ceasefire agreement been signed than Russian tanks, missile systems, and troops crossed the border into Ukraine.

Apparently, Merkel, Hollande, and Poroshenko had played into Putin's game. The ceasefire called for heavy weapons from both sides to be withdrawn from a line drawn dividing the country into two regions - the governmentoccupied region on the western side and the Donbas region in the east controlled by the rebels. They agreed to establish an "exclusion zone" – 200 kilometers long and 50-70 kilometers wide - separating the two sides, which would be policed by observers from the Organization for Security and Cooperation in Europe (OSCE) and

a "joint contact group" of Russian and Ukrainian military personnel. Heavy weapons would be withdrawn from the exclusion zone; however, the ceasefire agreement allowed armed combatants to stay within their side of the exclusion zone, which is not unlike the demilitarized zone (DMZ) that divided North and South Korea since 1953 when the Korean War Armistice was signed.

But the way Putin played his game is that whether the ceasefire would hold or not, he wins. A stalemate would result in a "frozen conflict," just like what happened in Georgia and Moldova when Putin sent Russian "peacekeepers" – or occupation troops? — to preserve "peace" between these countries and the self-proclaimed republics that broke away.

Evidently, Obama lost Round 2 because he had a chance to take the bull by the horns when the Ukrainian government forces had the upper hand in fighting the Donetsk and Lugansk separatists. But due to Obama's refusal to send lethal weapons to Ukraine to defend her territory, Poroshenko had to 'surrender" the Donbas region to the Russian-backed separatists.

#### Round 3

After Ukraine, what is Putin up to next? There are strong indications that Putin would try to reclaim the Soviet Union's three former Baltic republics - Estonia, Latvia, and Lithuania – and force them to join the Eurasian Economic Union (EEU), which Russia, Belarus, and Kazakhstan formed as an economic union similar to the EU.

Interestingly, at the time the EEU was formed in January 2015, Russia made a proposal to Europe: "Dump the U.S. and join the Eurasian Economic Union.' While it may sound ludicrous, the way Putin had been playing his game of "deceive and conquer," it may not be long before some European countries particularly those near Russia's border would consider joining EEU as a means of self-preservation... unless the United States overcomes her fear of a resurgent Russia — whose unpredictable leader Vladimir Putin is bent in reclaiming Mother Russia's glorious past – and use her might to stop Russian imperialism. But does Obama have the coiones to lead?

So far the scorecard shows 2-0 in favor of Putin. Can Obama survive Round 3?

## **Enduring Freedom or Enduring War?**

I would like to share here the article "Why the US Wants to Stay

in Afghanistan" by Jack A. Smith (Global Research, January 07, 2014) he writes: "Afghanistan is especially important to Washington for two main reasons.

The obvious first reason is to have smaller but elite forces and surveillance facilities in Afghanistan to continue the fighting when necessary to protect U.S. interests, which include maintaining a powerful influence within the country. Those interests will become jeopardized if, as some suspect, armed conflict eventually breaks out among various forces contending for power in Kabul since the mid-1990s, including, of course, the Taliban, which held power 1996-2001 until the U.S. invasion.

The more understated second reason is that Afghanistan is an extremely important geopolitical asset for the U.S., particularly because it is the Pentagon's only military base in Central Asia, touching Iran to the west, Pakistan to the east, China to the northeast and various resource-rich former Soviet republics to the northwest, as well as Russia to the north.'

A Dec.30,2014 report in Foreign Policy by Louise Arbour noted:

'Most countries in [Central Asia] are governed by aging leaders and have no succession mechanisms in itself potentially a recipe for chaos. All have young, alienated populations and decaying infrastructure... in a corner of the world too long cast as a pawn in someone else's game.'

The first reason is identical with the presence of the Joint Special Operations Task Force - Philippines (JSOTF-P) in Mindanao. The Task Force was organized around a headquarters element, temporarily located at Camp Navarro, Zamboanga City, and 3 subordinate regional task forces. Camp Navarro is an Armed Forces of the Philippines facility. These Task Forces are: Task Force Archipelago, based at Camp Navarro, Zamboanga del Sur Province; Task Force Mindanao, based at Camp Siongco, Maguindanao Province; and Task Force Sulu, based at Camp Bautista, Jolo Island, Sulu Province.

A handful of JSOTF-P personnel also worked in Manila to coordinate activities with the US Embassy Country Team and AFP General Headquarters. JSOTF-P also includes a Joint Special Operations Aviation Detachment (JSOAD) to ensure special operations forces are able to move freely in country. The JSOAD maintains a small fleet of PC-12 and C-12 fixed-wing aircraft, complemented by Bell 214 helicopters for use in the jungle areas where U.S. and Philippine forces are collocated.

All US forces supporting Operation Enduring Freedom – Philippines operate under the Kapit Bisig Framework, a mutually agreed US and Government of the Republic of the Philippines accord by which JSOTF-P accomplishes its mission through and with its partner forces. JSOTF-P does not engage in combat operations and does not operate from independent locations. Their efforts include intelligence sharing, support for mission preparations and rehearsal, civil-military and military-information support operations, casualty evacuations, and logistics. Wikileaks through the report by Jojo Malig, abs-cbnNEWS.com posted at 09/14/2011:

US Special Forces troops have been directly involved in hunting down suspected terrorists in Mindanao, several diplomatic cables released by anti-secrecy group WikiLeaks revealed.

Cable 06MANILA3401, classified secret and sent August 14, 2006 in the name of US embassy deputy chief of mission Paul Jones, said US Special Forces troops and ships gave "intelligence, surveillance, and reconnaissance support to the 87-plus maritime interdictions" in Jolo, Sulu during an Armed Forces of the Philippines (AFP) campaign in the said year against Jemaah Islamiyah (JI) and Abu Sayyaf Group (ASG) leaders on the is-

It added that this was made possible because the US Navy's Joint Venture and Joint Special Operations Task Force-Philippines' (JSOTF-P) Mark V special operations crafts and rigid-hull inflatable boats are already fully integrated into the Philippine Navy. The US embassy, however, wanted to hide this from the public.

In the cable's "if asked – press guidance" section, US officials are told to say that "US forces are not directly involved in this operation, but are providing support. Our forces, in a support role, advise, train, and share information with AFP forces."

Another cable, 06MANILA4439, said US troops also helped their Philippine counterparts intercept terrorists fleeing from Jolo in

"US and Philippine forces worked seamlessly to intercept two vessels (one of them highspeed) attempting to flee Jolo for Basilan," said the confidential

uate studies at the Wharton Business School, University of Pennsylvania, USA, taking up Masters in Business Administration. I was, however, unable to complete the course because I was elected Vice Governor of Ilocos Norte, and had to return home to serve my provincemates (1980-1983)."

### 2016 candidate?

Marcos Jr, who is on his first term in the Senate, is among those included in the surveys of Pulse Asia and Social Weather Stations (SWS) on presidential preferences, although he is consistently at the lower end. In a November 2014 poll of SWS, only 3% of the respondents named him one

of the "best leaders to succeed Pres. Noynoy Aquino in 2016." Similarly, a Pulse Asia poll also of the same month showed that 4% would vote for him as president "if the elections were held today.

He is also on the radar screen for vice president, although he is not a top choice. The Pulse Asia poll of November 2014 showed him to be the 5th choice (8%), tied with Senator Antonio "Sonny"

In the same survey, Marcos Jr is in the magic 12 for senatorial preferences, ranked anywhere from 4 to 10. 40% of the respondents said they would vote for him.

On the 85th birthday last year of Imelda Marcos, the former first lady stressed that her senator son was "qualified" to contest the presidency.

When asked by reporters, Marcos Jr dismissed his mother's statement as a "dream" and said it was "too early to think about it." – with a report from Carla Montemayor in Oxford, Rappler.





The final stop of the cable car at the end of Powell Street could also be viewed from the same window. Arriving passengers got off the cable car looking exhilarated while departing passengers waited patiently for their turn to ride. When in America has long been it was the departing passengers turn to get on, everyone was accommodated. Nowadays, it takes minutes stretching to an hour of waiting to get on a cable car. fond memories. Woolworth, Back then people can hop in San Francisco. To the boy, Emporium, Macy's for Men, on the cable car anywhere it was stopped.

Watching the lively people enjoying the downtown vibe outside, walking seemed like a good idea after a hearty lunch. Being practical, the family decided to do the walking in Chinatown where they could also shop for items needed for dinner. The route to Chinatown included driving through a tunnel. Wow (the boy thought)! He never experienced riding a

car driving through a long tunnel in Manila. He thought of the new pedestrian underpass in Quiapo. Arriving in Chinatown, the boy and his big brother were instructed to stay near the parked cars as the elders left for some serious shopping. Excited to be left on their own, the two started to wander around

on its route as long as the nearby alleys. Before they knew it, they were lost walking through the tunnel where they had driven through an hour ago. Where do we go from here (the boys wondered)!

The family somehow tracked down the lost brothers and rescued them from the clutches of the darkness descending upon the strange new city. Next stop, the Avenues. A three story Victorian house, complete with a garage, seemed like a mansion to the newcomers. In the back of the house, a narrow backyard stretched so deep that if it were in the old neighborhood of Manila, two more houses would occupy that space. The time to enjoy the comfort of the house was short lived though, because it was just a stopover for the newcomers.

The final destination was still hours away. In the boy's calendar, the first day in America spent in San Francisco was the beginning of his journey in life as a Filipino-American. Frisco is a vertical city in more ways than one with giant skyscrapers, monolithic bridges, Twin Peaks, Coit Tower, Embarcadero, a windmill, cable car hills and more thrills. In a way, the verticality of the city represents a leap of faith like the growth of the boy in this country.

In music by artists such as Tony Bennett, Otis Redding, and Scott Mackenzie, among others, the rhythm of the city is legendary.

Almost 50 years later, that first day rhythm of the city by the bay is still vividly remembered by this writer.

## The Good In Us

hen we were conceptualizing what was to become the most successful and long-running children's show, "Batibot," on Philippine TV in the early '80s, we had a lot of discussions on what being Filipino really means. "Batibot," which was created under the guidance of the Children's Television Workshop, producer of "Sesame Street," was an educational program, not just an enter-

taining one. As such, all segments were written to us to ask what gender that person prefers. We just meet curriculum goals, foremost of which was to inspire children to take pride in being Filipino.

We had meetings and consultations with academics, media practitioners, psychologists, writers, artists, parents, even children, on what being Filipino meant to them. The answers we got spanned a broad spectrum of opinions and observations, from the mundane to the heretical, from the pious to the irreverent. I wish I had kept my notes from those sessions because I remember being awe-struck by the realization that our culture our sense of being – is so much richer and broader than what we thought we knew when we started our research.

I remembered all these when I was chatting with some old friends and someone opined that with millions of our countrymen now scattered all over the globe, we should start redefining being Filipino beyond geography or nationality and look at ourselves as global citizens. This got us to thinking, what traits or behavior do we carry with us even as we leave our native land and integrate ourselves into entirely different societies and assume changed personas? What makes a Filipino still a Filipino even as he speaks a new language, acquires a different citizenship and changes the way he sees his future?

Yes, we will always be hospitable to strangers and respectful to elders. No matter where our psyches may stray there will always be a part of us that submits to a Higher Power. Throughout our lives there will always be a select few we owe an unending debt of gratitude to. The parents among us will do anything to give our children a good education. We are generally a happy bunch and we smile probably more than most people of other ethnicities. But there are other traits or instinctive behavior that may or may not be uniquely Filipino but are so ingrained in us that it isn't a stretch to claim them as our own.

We have a natural tendency to greet people we haven't seen for some time by commenting on their body shape. Tumataba ka yata, you seem to have gained weight, or payat ka ngayon, you have lost weight. Someone told me that before we were "Americanized" (i.e., became too conscious about body weight), being plump was considered a sign of prosperity and health. Thus when someone says you have added pounds, you ought to be flattered. Among us, we take such greeting lightly, but say that to a non-Filipino (especially one trying to lose weight) and he'd feel insulted.

We're irrepressible matchmakers. When we find out that someone is unattached, the Rolodex in our mind starts whirling, trying to find a good match. We don't bother to find out whether that person is interested in meeting someone or if he/ she even wants a partner. It doesn't even occur to

assume that he/she is lonely and dying to meet someone, anyone of the opposite sex, even that rogue who has been discarded by all the other singles we know.

We're just as irrepressible as gift-givers. We invented the balikbayan box and keep discount stores in business. Whenever we travel, we spend a lot of time shopping for pasalubong, souvenirs for almost everyone we know, even those who had no idea that we went away. I will not even venture into the whys and wherefores of this endearing but often impractical tendency of ours. I prefer to think that we are always conscious of sharing our bounties in whatever way we can.

We're probably the world's ultimate snackers and food figures in everything that smacks of a good time or even a sad time among us. A few years ago, we visited Ho Chi Minh City during the Tet (Lunar New Year) festival. We joined the throngs of revelers that packed the major boulevard of the city. There were flowers all around and parades and street dancing. The collective energy was intoxicating. But we couldn't fathom why, other than the traditional tasteless Tet rice cakes and a few stalls selling soda and water, there were no food vendors around. Can you imagine a street festival in the Philippines without the bananaQ, the barbecue, fishballs, peanuts frying in oil, corn on the cob wrapped in burlap, taho (sweet tofu) and balut (duck egg)? Neither can we.

Establishing kinship with a fellow Fiilpino we have just met is instinctive for us. After we find out each other's full names, we ask which province the other guy is from, where he went to school, whom they are related to. Pretty soon, we would be able to dig out a nugget of information that connects us (as in my sister-in-law's cousin went to the same school as your brother) no matter how flimsily, and somehow that transforms the stranger into a friend. Among Filipinos, two degrees of separation is often enough. The concept of intruding into another's privacy by asking prying questions is too alien for us.

Many lament our "crab mentality," how we pull others down and tear each other apart with our cattiness and petty jealousies. But these negativity are not ours alone. Other cultures complain about this too. What we often forget is that, notwithstanding the criminals and evildoers among us, we common folk look out for each other. For as long as our lives and families are not threatened and our sense of self is not compromised, we are naturally friendly and generous especially to our compatriots. If you don't believe me, try speaking in Filipino to the girl behind the counter at a pastry shop. With a gesture of kinship, chances are you'll get an extra éclair.

## Early Action Favors Pacman In Superfight With Mayweather

Thile the unblemished record and pound-for-pound king of the ring moniker belong to the loquacious and flamboyant Floyd Mayweather, Jr. (47-0, 26 KOs), the initial wave of betting action for the undisputed champion's May 2 bout with Manny Pacquiao (57-5-2, 38 KOs) has heavily favored the Filipino sensation riding a three-fight win steak

Officially announced to the world on February 20, the welterweight super-fight scheduled to take place May 2 at the MGM Grand Garden Arena in Las Vegas between the most recognizable fighters on the planet hit the board at the Westgate SuperBook with the undefeated Mayweather listed as a -275 favorite and Pacquiao posted as a +235 underdog. But an early onslaught of Pacquiao money forced a quick adjustment to the betting lines.

"The early action has been heavily weighted in favor of Pacquiao," Westgate sports book assistant manager Jeff Sherman told The Queensberry Rules. "We took limit bets [\$10,000] on Pacquiao at +235 and +225 to drive us to the current price of Mayweather -240 and Pacquiao +200.

Sherman went on to state that 90 percent of the betting slips the Westgate sports book has already written were in support of Pacquiao.

Similar betting activity to what the Westgate has experienced took place offshore as

"My boxing staff had this line out for years, but when they made it official, our action went ballistic," Peter Childs, the Head Supervisor of Risk Management at Sportsbook.ag told The Queensberry Rules. "We had Mayweather installed as a decent favorite of -300, but since the official announcement it's been all Pacman money over the past three days. We've been steadily going down on our odds from -285 to -280, -275 all the way down to where we're at -245 on Mayweather and +205 on Pacquiao."

While there are a variety of reasons why Pacquiao is feeling the love at the betting windows this far in advance of the fight, the most likely is that sophisticated bettors are taking advantage of the fact that the wagering public has a strong distaste for Mayweather. This hatred generally manifests itself in bets against the undefeated fighter on fight night, which forces sports books to alter their lines in an effort to balance out the action by enticing more Mayweather action. As a result, these sophisticated bettors are wagering on the idea that a price of Pacquiao at +235 or higher is the best the market will have to offer, meaning there will never be a time the "Filipino Flash" offers more betting value than now.

'From all early indications, the public is going to hammer Pacman in this fight, but we believe Mayweather is the side the wiseguys are going to support," said Childs. "I believe sharp money is just waiting for the betting public—who love betting the underdogs in major fights—to drive this price even further down. I'm not sure how much lower this price gets, but the one thing we do know is that we'll be going into this fight needing Mayweather.'

Approximately six years in the making, the long-anticipated showdown between two of boxing's most legendary superstars will result in a financial windfall for the city of Las Vegas, with the cheapest tickets going for no less than \$1,000 apiece and ringside seats expected to fetch in the neighborhood of \$5,000, grossing the host property a gate of roughly \$40 million. Additionally, hotel rooms located elsewhere on the Las Vegas Strip that would normally command \$300 on a Saturday night are currently going for \$800.

"This the most action I've ever seen this far in advance of a fight," said Sherman. "Along with breaking economic figures for the city, this fight will break records in the sports books as well."

Top Rank Founder and CEO Bob Arum told ESPN 1100 in Las Vegas on Monday that only those with a credit limit of \$250,000 or more at the MGM Grand would be eligible for comped tickets to the

Those priced out of attending this historic showdown in person can anticipate spending in the neighborhood of \$90-\$100 to watch Mayweather and Pacquiao square off on pay-per-view.

## Floyd Mayweather-Manny Pacquiao: Three Reasons Why Mayweather Will Win

Floyd Mayweather will surely beat Manny Pacquiao when the two finally meet in their long-awaited matchup May 2 in Las Vegas. Of that, we can be sure — unless, of course, you read something that says the exact opposite.

Though Mayweather, who's long been considered the best fighter in the world, has been accused of being frightened to put his 47-0 record (with 26 knockouts) on the line against Pacquiao (57-5-2, 38 KOs) who is still a legitimate top-five poundfor-pound fighter — he's finally signed his name to a fight that will be one of the biggest, most-hyped and most-lucrative fights in boxing history.

Make no mistake, though. Three months after meeting for the first time in person at a Miami Heat basketball game, a meeting which helped lead the two to finally agree to this fight, Mayweather will beat Pacquiao (probably by unanimous decision). Here are three reasons why.

1. He's faced all different kinds of fighters and never lost: Mayweather has faced heavy punchers. He's faced boxers. He's faced boxer-punchers. He's faced unconventional fighters. He hasn't lost to any of them. Pacquiao has a bit of all of the above in him. He has a heavy punch (though it's been nine fights since he actually scored a knockout). He can box or brawl, and the way he throws his punches is rather unconventional. Maybe Mayweather hasn't seen the kind of package of skills Pacquiao will throw at him, but that doesn't mean he can't figure out Pacquiao by the middle rounds. The Mayweather ring intelligence and his crafty defense will help him win the day here.

2. Mayweather is still too slick in the ring: One reason Pacquiao supporters believe their man will give Mayweather his first

loss is because it appears as though the 38-year-old Mayweather is slowing down. His reflexes on defense have always been outstanding — they're what have helped make him one of the most-impressive fighters in boxing history — but he also was hit hard by Marcos Maidana in their two fights (Shane Mosley and Miguel Cotto also briefly hurt Mayweather in their bouts against him). Mayweather's chin has never let him down, but if Pacquiao can connect with something hard or better yet, a combination of something hard — he could put Mayweather on the floor. But he won't, because Mayweather is still simply too slick to get hit solidly by Pacquiao. He's always known how to avoid danger, and though Pacquiao is probably the most dangerous opponent of his career, Mayweather will keep himself

3. This is for Mayweather's legacy: Although this fight probably should have occurred a half-decade ago when both men were in their primes, this matchup is still significant for Mayweather's legacy. If he would have retired without facing Pacquiao — even if he retired with an undefeated record- his career always would have carried an asterisk. If we're talking about how Mayweather will be viewed in boxing history and if we know that's important to Mayweather himself, it's hard to see him losing to Pacquiao at this point in their careers.

But don't take my word for it. Here's what Mayweather's father and trainer, Floyd Mayweather Sr., had to say about the matchup: "Floyd is smarter than him, Floyd is quicker than him, has more knowledge, and I'm going to tell you this right here: Floyd can't lose to him."

All of which means Mayweather certainly will win. Unless the EXACT OPPOSITE happens.

### **ROACH IS 'TRAINER OF THE YEAR" FOR A RECORD 7TH TIME**

## You Can Go Home Again

ne disadvantage of coming over as an adult to live in the US is that it makes adjusting to a different culture just a tad difficult. When you grow up to be a certain age, you get used to doing certain things and dealing with certain people in a certain way. Moving to live in a different country throws everything off. That is why emigrating (whether it's to the US or elsewhere) is not for everyone. It takes a particular breed of people to thrive in new surroundings.

One advantage of coming over as an adult to live in the US is that you don't miss the Philippines too much. This is how I feel. I came here when I was in my early thirties, and by that time I had done much traveling in the Philippines—though, truthfully, not enough. But the thing is, when it comes to traveling—whether it's in a different country or the homeland-it's never enough. I doubt if anyone can visit all the places worth seeing in any one country. Well, maybe if you did that full time, you could—but tell me, who can afford to do that? Even hosts of travel shows on TV must move

### But, yes, the Philippines.

I consider myself lucky to have woken up each day of my life until I graduated from high school next to a window that looked out to the beautiful Mayon Volcano, said to be the world's only perfect-cone volcano. It's easy to see why. On a clear day, it really does look like a perfect cone. Although a 1984 eruption left a deep gash on its eastern slope, from certain angles, it has retained its signature shape and ability to take one's breath

This was the view from my hometown of Daraga, Albay, a small but bustling municipality about 15 miles from the foot of the volcano. The town is far enough that it doesn't have the large boulders spewed out by the volcano onto closer towns during past eruptions, but it's close enough to get a sprinkling of ash whenever Mayon wakes up from a slumber. And it's close enough for one to see at night the glow of a lava flow, still one of the best sights anywhere.

And as if that weren't enough, just a hop over to Legazpi City; there's a hill famous in the community because it offers an even closer and higher vantage point for looking at Mayon. It's called Lignon Hill.

Looking back, it really does seem serendipitous that the city that offers the best view of the volcano would also have a hill, the only one for miles in any direction, that provides the perfect viewing platform for sightseers—as if it had all been preordained. It's as if nature said: Here, if you want an even better view of this volcano ("Mayon," by the way, comes from "magayon, the Bicolano word for beautiful), just climb this hill. And bring all vour guests, too.

I climbed this hill with my friends when I was young, and a majestic view of the volcano waited for those hardy enough to make it all the way to the top. Incidentally, this hill, since the idyllic days of my youth, has been developed into a fully functioning tourist attraction. A winding road has been carved all the way to the top, where now there is not only a café, but also a zip-line for the "adventurous."

I was there in 2010, during a trip to see my hometown, and I thought, Lignon Hill as it stood now, was a far cry from the muddy, lonely hill I climbed in my youth. But then I thought it was but a sign that many things have changed since those days long gone. Another was that I was there not as a young scraggly boy looking for adventure, but a man fully grown, visiting from a distant land.

But the view up to now is the same. Finely chiseled, blue-gray, and majestic in its sheer size, Mayon enchants all lookers and turns them into admirers in a splitsecond. Incidentally, it's often said that Mayon doesn't just show it-

self to anyone. True enough, like the Golden Gate Bridge in San Francisco, there are days when it sits shrouded in clouds, and tourists wish they would have more luck the next day.

Another nice thing about growing up in the little corner of Bicol that was my hometown was that I was never too far away from the beach. But, of course, almost anyone living in the Philippines can say that because the Philippines is an archipelago: One is never too far from the beach no matter where one is (with the exception, maybe, of the Mountain provinces). I was not too surprised when I first learned that it actually has a longer coastline than the US It may be hard to believe, but it's

I practically grew up on the beach. There's a picture of me as a toddler, standing in the sand in Bacacay, Albay. I am about two years old. That photo could've been taken on any Sunday of that year or the year before or after because that was about how often we went to the beach in those days. The resorts of Bacacay, only about a half-hour drive from where we lived, were a quick and easy getaway from our humdrum

When I was growing up, my family—by which I mean my extended family: my grandparents, aunts, uncles, cousins, parents, siblings and whoever else happened to be living in our houses at the time (they were all considered family)—was always finding an excuse to drive out to the beach on Sundays. And since we were a large family, that wasn't very hard to do. There was always an occasion to celebrate—someone's birthday or anniversary or graduation—and there were the holidays. And sometimes we went for no reason at all. All it took was for someone to say "Let's go!" and we went. And once it was agreed that we were going, we all knew what to do. Each household would prepare a dish for 15, 20 or 25 people for that was how many of us usually went. And someone would bring rice and soda too and ice. And fruit in season.

Looking back, though, I remember a time—this must've been when I was in college in Manila and would spend the summer back in Bicol—when I went to the beach with my cousins with little more than some snacks and soda or water. But this was no longer the large family outings we had when I was younger, but just a bunch of cousins out for a "joyride." Since there was no place else to go, we went to the only place we knew: by the water's edge, where we could all be carefree for a while.

Back in town and back in school. our skin had varying degrees of sunburn year-round-except maybe during the heavy monsoon seasons, when we didn't go swimming as often ("We'd get wet," someone was always joking).

The nice thing, too, about the Philippines' beaches is that the water is always a nice warm temperature, unlike the ocean water in much of the US even here in sunny Southern California, where it could be nice and warm out, but in the water, just a tad too cool; where really the time for swimming is just a few weeks out of the whole year. Someone here who'd been to the Philippines described the ocean water there best: He said it's "bath" water. That's it: The Philippines is surrounded by bath water year-round.

In high school, when we were old enough to drive, my friends and I often went to the beach too, this time without our parents and that was where most of us smoked our first cigarettes, drank our first beers, and heavens know what else we did. And once we almost got into a fight. And we kept going back. Though it wasn't always easy to get hold of a car in those days, we kept going back whenever we could because, well, the beach wasn't school, it wasn't church, it wasn't our everyday

And that's probably why I've never passed up a chance to go to

the beach, even now. I'll probably forever associate it with freedom, with the utter lack of things you have to do.

In Rosario, Cavite, where my mom is from and where my brother, sisters and I were sometimes dispatched during the summer when we were growing up, I was lucky to have an uncle who was as crazy about the water as I was. When he wasn't busy he would round up all of us kids, gather some snacks, and we headed off to a nearby beach.

We simply had to cross a river on a bangka to get there so we went three or four times a week sometimes. And we never got tired.

When I was much older and living in Manila you could say I took this beach-going business to a higher level. I went to places like Dumaguete, Batangas, Bataan, Subic and, of course, the mother of all beaches—Boracay.

Here in the US, now that I think about it—I've gone swimming only in the waters off Los Angeles and the nearby cities (Crystal Cove state beach is my favorite) and in icy Lake Tahoe and Yosemite's Mirror Lake. But I have been all over the California coast, from San Diego and Oceanside in the south, up to Malibu, Santa Barbara, Pismo Beach, Morro Bay (where, incidentally, it's said the first "Filipinos" to step in the United States made landfall), Big Sur, Carmel, Pebble Beach, Monterey Bay, Half-Moon Bay, and as far north as Point Reyes National Seashore. My favorite stretch of the coast is where the Pacific Coast Highway looks out to the ocean crashing against the cliffs. For a picture of the sheer rawness of nature, it's hard to

When I go through these places and look at the great blue Pacific, I can't help but think that just on the other side is the Philippines. I've never seen the Atlantic or the Gulf of Mexico, the two other great bodies of water that surround the US. They're definitely on my to-see list.

But after all these years, the beaches of Bicol still have a special place—yes, I'll say it—in my heart. Its sands may not be as white as the sands of Boracay in fact, when I was there last in 2010, I thought they'd become even darker, soot black. But I know that was just my memory playing tricks on me. When you go away you idealize things. So when you think of the beaches of your childhood, you think of the white sands of other beaches, you think of luxurious, gleaming resorts. And then you go back and find reality is nothing at all like your memory. But it doesn't bother me. Those dark, drab beaches of Bicol, with their pedestrian resorts—just a jumble of huts, really—will always be home.
