## **Editor's Note**



## PNP recovers 49 bodies of slain cops

The Philippine National Police recovered 49 bodies of slain members of the Special Action Force (SAF) in Maguindanao, according to the regional police headquarters of the Autonomous Region in Muslim Mindanao (ARMM).

In a text message sent to reporters Monday, January 26, the operations center of the PNP-ARMM said that as of 11:54 am on Monday, the "actual body count of PNP SAF [killed] is 49." The report added: "The cadavers

The report added: "The cadavers were brought to 6th ID, PA headquarters, for proper disposition," referring to the headquarters of the Army's 6th infantry division in Cotatato City.

Military sources said that 10 more SAF members were reported missing and that at least one civilian was killed.

American soldiers based in Cotabato under a Philippine-US defense agreement assisted Philippine troops in carrying the dead and the wounded.

The Sunday, January 25, clashes in Mamasapano town, Maguindanao, tested a nearly one-yearold peace accord between the Aquino government and the Moro Islamic Liberation Front (MILF). An MILF spokesman earlier said they suffered 5 casualties.

The SAF's target was alleged Malaysian bomb maker Zulkifli Abdhir, better known as "Marwan," who survived a 2012 military airstrike that was meant to kill him in Sulu. (READ: Dead or alive? Top terrorist was cops' target)

But Mamasapano is an MILF bailiwick, and the MILF said the SAF attacked the area without co-

ordinating with them.

It is the first major encounter between the MILF and government troops since the signing of the Comprehensive Agreement on the Bangsamoro last year. Advocates are hoping that the incident will not affect the talks.

The cops sought for reinforcement but the military did not get involved, based on reports, until it has coordinated with the Coordinating Committee on Cessation of Hostilities (CCCH) and the Adhoc Joint Action Group (AHJAG). These are the bodies that help maintain the ceasefire between the government and the MILF. The MILF area is also diffi-

cult to penetrate. It is a marshy area that is some 15 kilometers away from the highway.

The carnage happened on the eve of the 24th founding anniversary of the PNP on Monday. – with reports from Karlos Manlupig and Carmela Fonbuena

## Did Binay use Boy Scout funds for 2010 bid? After a hiatus, Vice President Jejomar Binay's demons continue to haunt him. He is accused of getting close to

P200 million in 2010 from a deal between Alphaland and BSP, of which he is national president.

MANILA, Philippines – There is a "rule" that Vice President Jejomar Binay follows when speaking to the media: whenever he's wearing his Boy Scouts of the Philippines (BSP) uniform, he prefers not to discuss politics or recent allegations of corruption.

It appears that Binay, national president of the BSP for nearly two decades, would rather keep the BSP away from the dirty world of politics.

But if Ernesto Mercado, Binay's estranged bosom body, former Makati vice mayor, and former BSP vice president is to be believed, the vice president does not have the organization's best interests in mind.

On Thursday, January 22, Mercado is set to reveal during a Senate Blue Ribbon subcommittee hearing that Binay negotiated for the BSP a deal that resulted in millions of losses for the organization and millions in gains for him.

Unaccounted for cash from the deal allegedly turned into kickbacks for those involved, and in Binay's case, supposedly went to his piggy bank for his 2010 vice presidential campaign.

As early as 2008, Binay declared on his birthday that he wanted the presidency but chose to slide down when survey numbers indicated he had a better chance at the vice presidency.

Binay supposedly pocketed around P188.98 million (US\$4.23 million), according to Mercado, the star whistleblower in the subcommittee's probe into allegations that Binay, during his stint as Makati mayor, also earned from city coffers.

But in an interview with dzRH on Wednesday January 21, Binay's spokesman for political affairs lawyer Rico Quicho downplayed Mercado's scheduled testimony, accusing him of being the one who wanted to profit from the deal

(Alphaland has said on record that their transaction with the BSP is clean and above board. free from anomaly. Alphaland is an institution. They won't allow themselves to be used in Mercado's foolishness. Turns out it was Mercado who was asking for kickbacks but Alphaland said

In another interview with Rappler on Thursday, Quicho challenged Mercado to come out with documents to prove his "lies" and not to rely on hazy conclusions. All transactions and deals were approved by the BSP's national board, not just Binay.

no.)

"That's what they (Binay's accusers) do - Vice President Binay builds and they destroy," said Quicho, who also emphasized that the BSP was an apolotical organization that should be not dragged into the "circus-like" Senate probe.

It was also Mercado who accused Binay of hiding his wealth through dummies and secret bank accounts

The January 22 "revelation" is a first in the subcommittee's 4-month-long history: it's the first time a whistleblower has accused Binay of corruption beyond his nearly 20-year stay as Makati mayor.

#### Land, money lost

Mercado said Binay sourced the money through a web of deals and negotiations between the BSP and private companies - all of which were done under his reign.

In 2004, Binay stepped in negotiations between BF Goodrich Philippines (now called Sime Darby) and the BSP over a one-hectare Makati property that was "donated" by the former back in 1976.

Based on the deal sealed by Binay in 2005, the BSP would get 60% of the property, while Sime Darby would get the remaining 40%. By this time, the land was already worth a whopping P1 billion

With the division of the property settled, the BSP moved into talks to develop the land. In 2007, the BSP began negotiations with former Marcos crony Roberto "Bobby' Ongpin of Alphaland Corporation for the project. (READ: Ongpin vs Ashmore: The real deal)

Alphaland, a controversial luxury property developer, was delisted by the Philippine Stock Exchange in September 2014 due to, among

others, its repeated failure to submit full, fair, accurate and timely disclosures of material information

At the time of the BSP deal, Alphaland owned Silvertown (later renamed Alphaland Makati Place Inc), the local arm of Sime Darby, and along with it, the company's shares in the BSP property. As a foreign company, Sime Darby was not allowed to own land, that is why it needed Silvertown.

Who is Mario Oreta?

President and CEO of Constrant Builders and Development Corporation

Allegedly bought a Tagaytay property from Binay in 2008 Donated some P2M to Senator Nancy Binay's 2013 campaign Close friend of Binay's; the vice president was a principal sponsor during his 40th wedding anniversarv

According to Mercado, Binay, the BSP's Jose Rizal Pangilinan, and Silvertown/Alphaland Makati Place Inc (AMPI) President Mario Oreta were part of the negotiating panel.

Based on the deal forged between BSP and AMPI, the former would still own the land while the latter would be the "developer/investor" for a 15%-85& split between BSP and AMPI.

Mercado, then senior vice president of the BSP, said he opposed the deal because he wanted 20% for the BSP.

It was Binay's finance whiz and alleged bagman Gerry Limlingan who convinced Mercado to accept the deal. Limlingan, who has also been subpoenaed to the Senate, allegedly told Mercado 20% really went to the BSP but that 5% would "be for Binay" - in particular to fund his presidential campaign in 2010.

Benigno Aquino III, son of slain democracy icon Ninoy Aquino and Binay's close ally former president Corazon Aquino, eventually ran and won as president in 2010.

# AMLC: Jinggoy has hidden multi-million dollar account

First, the mansion being constructed in the gated Wack-Wack subdivision. Now, there are indications he also did not declare multi-million peso and dollar bank deposits in his asset statements.

What else is Senator Jinggoy Estrada not saying in his State-ment of Assets, Liabilities and Net Worth (SALN)?

A report submitted by the Anti-Money Laundering Council (AMLC) to the anti-graft court Sandiganbayan showed that Estrada underdeclared his cash assets from 2006 to 2012 and did not include in his SALN dollar time deposits and life insurance policies amounting to millions.

He also withdrew a total of P76.446 million in 4 bank accounts in September 2013, at the height of the exposé on the pork barrel scandal.

The scion of the Estrada political family, under trial for plunder and graft over the alleged misuse of his Priority Development Assistance Fund (PDAF) or pork barrel, might as well add violation of Republic Act 6713 or the Code of Conduct and Ethical Standards for Public Officials and Employees for failing to be truthful in his SALN

SALN declarations are made under oath, and giving false information has led to several government officials in jail or meted with penalty.

#### Cash in SALN and actual cash in banks

With the green light of the Court of Appeals, the AMLC began looking into Estrada's bank accounts in May 2014, a month before the senator was ordered arrested by the Sandiganbayan over the pork barrel scam. Thirty-one accounts under his name in different banks were examined for coverage.

Using multiple account analysis, the AMLC probers analyzed

> Estrada's bank records vis-a-vis his SALNs from 2004 to 2012. They also looked into significant transactions in 9 of his active bank accounts and related accounts.

> On the SALN analysis, the probers stated the following observations:

> There is "absence of indications" that the "significant investments" which Estrada declared in his SALN "were sourced from his assets/liabilities declared in previous years.

> Estrada underdeclared his cash in his SALNs for the years 2006 to 2012. "Cumulative under declaration amounted to P238.6 million.'

> Estrada did not declare in his SALN a foreign currency deposit unit (FCDU) time deposit in Chinabank amounting to \$280,000.

> "Dollar denominated life policies totalling \$75,000 for the years 2005 to 2010 and \$134,000 for the years 2011 to 2014 were not declared in his SALN."

#### **Questionable investments**

The AMLC, in its report, observed that Estrada's net worth (assets minus liabilities) jumped by 138% from 2004 to 2012 while his total cash on hand and in banks polevaulted by 330%, from P3.7 million to P15.87 million.

Notably, from zero investment since 2007, his SALN-declared investments surged to P92.305 million in 2011. This climbed to P119.305 million in 2012.

The increase in Estrada's investments perplexed the AMLC.

"Despite the huge leap of investment, it would not show that it came from his other assets since the cash balances are increasing; the unloading of real estate in 2011 and 2012 are not substantial and there is no significant change in the balances of liabilities." the report said.

One possible explanation for the growth of Estrada's investments could be due to the fact that Estrada expanded his business interests, from only one company in 2008 to 7 companies by 2011, the AMLC said.

"Ironically, his 2012 investments based on his SALN increased, yet the listed businesses decreased from 7 to 4," the report said.

breaks to persuade Macy's to move into part of the shuttered Campbell Soup factory on Franklin Boulevard in south Sacramento The county is offering Ma-

cy's a sales-tax reimbursement of up to 50 percent, depending on employment levels and the volume of sales generated out of the facility. The reimbursement can't exceed a total of \$5 million over the 10-year life day morning approved of the lease, said Lori Moss, a package of tax and fee the county's director of com-

munity development. The county would waive another \$112,650 in permit fees.

The board voted 4-1 in favor of the plan Tuesday. Supervisor Roberta MacGlashan, who represents the north and east parts of the county, including Folsom, said she voted against the incentives because she opposes sales tax rebates.

Macy's says it plans to occupy about a third of the sprawling Campbell complex with a distribution hub

for shipping orders to online customers. The retailer says the new center would employ about 175 people, but 72 of those jobs would replace existing positions at a Macy's distribution center in West Sacramento that would close. Campbell's closure in

2013 after 66 years of soupmaking dealt a blow to the working-class neighborhood, where the factory offered relatively high-wage, blue-collar jobs.

## Holiday Vacation in the Philippines

t was rainy afternoon of Friday, Decem-ber 19, 2014, when I drove my family to San Francisco International Airport (SFO) for our holiday vacation to the Philippines.

I was supposed to work that day but thanks to my fellow RN who allowed to switch schedule with me so I can leave early to SFO and to avoid monstrous afternoon traffic in the bay Area. There were two flights from SFO to Manila (MNL) on holidays. We were on the first flight scheduled that night.



It was also aimed to promote communication within family circle.

This time our numbers surpassed the previous record and the head count significantly increased. It was my parent's first time to attend in this clan reunion which I initiated and sponsored. I made sure my mother, who is the most senior among the relatives present, could deliver her Christmas message to all. Welcome remarks from Barangay Captain Triniah Canizares was read by one of the counselors present. Pastoral message was delivered by my cousin Davy. The program was prepared by cousin Liezle. Security personnel were provided by Captain Canizares.

Relatives whose names were picked during raffle draws were lucky to bring home some Christmas goodies and home appliances. Everybody went home happy and reinvigorated with additional stories to tell in the next couple of days, weeks, and even months.

Lo and behold, we found a good one. Can you believe it? The price of one plate in Marco Polo Hotel is equivalent to the total price of the food good for seven persons in Kambingan. We left Davao for Manila at 5:00a via PAL that smoothly landed at NAIA II couples of minutes ahead of scheduled arrival time on Friday, December 26th.

**Police corruption and torture chambers**

nce respected for its professionalism and dedicated service to the country, the Philippine National Police (PNP) is faced with the biggest challenge in its existence. Formed in 1991 when the Department of the Interior and Local Government (DILG) Act was enacted, it merged the Philippine Constabulary and the Integrated National Police into national law enforcement force under one command, the PNP Director General (DG) who reports to the DILG Secretary. However, the appointing authority is the President of the Philippines. A graduate of the Philippine Military Academy, the DG carries the rank of a four-star general.

Currently, PNP has about 150,000 personnel, which makes the DG one of the most powerful officials in the country. Although, the PNP

is under the administrative control of the DILG Secretary, the DG exercises great amount of autonomy and discretion in running the PNP.

Since its creation, the PNP had been beset with charges of anomalies and irregularities including allegations of protecting gambling lords, smuggling syndicates, and other criminal activities There are

also allegations of police officers involved in extortion and kidnapping for ransom, which is colloquially called "hulidap." It was coined from "huli" (arrest) and "dap" (kidnap). Typically, a hu-

lidap operation involves a police officer arresting someone on bogus charges and then keeping him or her for ransom.

One of the police's most brutal methods used in extortion or to extract confessions for crimes is the use of torture and other cruel, inhuman and degrading punishment.

#### Above the law

AI-Above-The-LawLast December 4, 2014, Amnesty International (AI) released a 120-page report titled "Above the Law: Police Torture in the Philippines." According to the report, the police use an array of torture methods, including: electric shocks; beatings, punching

and kicking; striking with wooden batons or metal bars; burning skin with cigarettes; waterboarding; near-asphyxiation with plastic bags; forcing detainees to assume stress positions; stripping detainees naked and tying and pulling genitalia with a string; hanging detainees upside down; mock executions; shooting; and rape.

Recently, AI's Secretary Gen-eral, Salil Shetty, was in Manila to launch the "Stop

Torture" campaign. He said that although the Philippines had enacted the Anti-Torture Act five years ago, not a single official has been convicted. "The single, most important reason why there is torture in the Philippines is they [police] get away with it," he said.

#### 'Wheel of Torture''

One method of torture that AI exposed was the "Wheel of Torture" game, which the police used for fun. The wheel is divided into sections like a pizza pie. Each section is labeled with the kind of torture to use. One section is labeled "20 seconds Manny Pacquiao." If the wheel landed there, the officers would punch the detainees - mostly suspected drug traffickers — for 20 seconds. Another section is labeled "3 minutes Zombies" and another "30 seconds Duck Walk."

The "wheel of torture" was allegedly stationed at a secret torture chamber in Binan, Laguna.

According to the Commission on Human Rights (CHR), the secret torture chamber was not an official detention center. At the time it was exposed, about 40 prisoners were illegally detained there.

AI said the torture of suspected criminals by the police has thrived under the administration of President Benigno Aquino III. Shetty accused Aquino of not doing enough to reform the PNP. According to CHR records, there were 457 torture cases reported from 2001 to the middle of 2014. In 2013 alone, there were 75 cases reported, the highest in a single year.

Attempts by AI to establish dialogue with Aquino, the DILG, and the PNP to discuss the report were ignored. However, presidential spokesman, Herminio Coloma, told the media: "The government is pursuing its efforts to prosecute those violating the anti-torture

law." The PNP also issued statement а contradicting AI's findings and insisted that major reforms on human rights had been successfully implemented. But the truth of the He sought a meeting with Aquino; however, Aquino told him that he had to comply with the suspension order." Meanwhile, the search is on for the next PNP chief. Purisima is due to retire in November 2015

With the police torture scandal and the suspension of the PNP's top honcho, the PNP's image may have been irreparably damaged. Indeed, it would be virtually impossible to restore its good name.

Gone were the days when the PC was looked upon as the defender of the people. But as it turned out, it's quite the opposite – the people fear that it has become a predator preying on those they were sworn to protect. Surmise it to say, a majority of police officers are honest and incorruptible. However, many see them as a band of hoodlums in uniform

#### **Disbanding PNP**

What is sad is that Purisima, who is one of Aquino's trusted friends, has digressed from the "daang matuwid" (straight path) that Aquino set to follow when he assumed the presidency. And Aquino's initial reluctance to enforce the Ombudsman's suspension order gave the impression that Aquino was too protective of his friends in government.

Police torture and the Purisima scandal have brought to the fore the issue of disbanding the PNP. Many are of the opinion that the PNP has outlived its usefulness and something should - nay, must! - be done about it. Either it is reformed, overhauled or disbanded. Some people even suggested that it should be surgically bisected into its original compo-



PNP had entered into with a courier service in 2011. The graft complaint against Purisima and 11 other PNP officers — including three generals — involved in the transaction stemmed from a contract with WERFAST Documentary Agency for the delivery of firearms licenses even without proper accreditation.

Initially, Purisima refused to comply and turned to his friend President Aquino for guidance.

# Hiding the poor

he main facts are uncontested, and uncomfortable. From Jan. 14, the day before Pope Francis arrived in the Philippines, to Jan. 19, the day he left, some 100 poor families were treated to an "outing" by the Department of Social Welfare and Development. In all, there were 490 men, women and children who took part in the DSWD "training camp" in Chateau Royale, a resort in Nasugbu, Batangas, and they had one thing in common: They were homeless people who lived on Roxas Boulevard.

Since Roxas Boulevard was one of the thoroughfares used by the papal motorcade, and since the schedule of the outing coincided exactly with the papal visit, the social welfare department has been asked the obvious question: Were they hiding the poor from the Pope?

A DSWD official said the timing was pure luck. "It was only a coincidence," Assistant Secretary Javier Jimenez told Radyo Inquirer. "This has been planned even before [the papal visit]."

And Social Welfare Secretary Dinky Soliman categorically denied there was any attempt to hide poor families. In the first place, she said,

"You cannot hide poverty. When the Pope landed, the first thing he saw were the shanties by the river." From Malacañang, deputy presidential spokesperson Abigail Valte said no attempt to hide the poor would have even worked. "It would be an insult to our visitor to say that [if] we hide [the poor], he would not know about them."

It does in fact seem unreasonable to expect that a government hosting the state and pastoral visit of a religious leader coming to the country precisely to be in solidarity with the poor, especially those victimized by Supertyphoon "Yolanda," would launch an initiative to sweep the homeless under the rug, so to speak.

The main argument in the DSWD's favor is that from simple arithmetic. To quote Jimenez: "I mean, there are more than that number of street families in Metro Manila." If the government really wanted to "whitewash poverty," as a familiar and strident critic immediately alleged, why stop at 100 families?

But the arguments against the DSWD are numerous, and many of them proceed from basic questions.

First, timing. It may be that the department scheduled the activity beforehand, and that at least two such orientation outings had previously been conducted. Still: Why time the training program for Jan. 14 to 19? The schedule of the Pope's visit was set several months ago; when did the DSWD decide to set the third outing for January? There's also a little detail that nags at the conscience, even of those who would like to give Soliman and her hardworking crew the benefit of the doubt.

According to some of the homeless themselves who went on the outing, they received the invitation to take part only one or two days before the activity was scheduled to start. This detail

adds to the growing perception that the outing was in fact a clearing operation.

Second, venue. While it is unreasonable to classify a resort or a hotel based on the price of its most expensive room (apparently, as much as P24,000 in the case of Chateau Royale), it is only logical to ask where the first two outings were conducted. Even if the government did not pay full price on the standard room rate of about P4,500, the DSWD must explain whether the rate it did pay was more or less the same as those it paid in the first two sessions. Participants have volunteered information that they ate as much as five times per day during their stay in the Nasugbu resort. "They also fed us frequently. It sometimes felt a bit too much," one of them told the Inquirer. Again, we must ask: Did the government pay more this time around?

Third, program. According to one participant, the government-paid vacation followed a regular schedule, including group exercises plus a talk per day. On the face of it, however, this seems like rather a loose schedule, not enough to meet the objective of the outing, if that objective were, as officials said, to "assess" the homeless' suitability for the Modified Conditional Cash Transfer Program. If the objective, however, were to remove those "vulnerable to the influx of people coming to witness the Pope" (Soliman's words) out of harm's way, then the program would have more than sufficed.

There are more questions needing to be asked. A congressional investigation is called for. (Inquirer.net-Editorial)






we left the hotel and proceeded to the airport for our flight back to SFO via PAL.

Floyd Mayweather: Is the 'Money' man's stock free-fallin' faster than a Tom Petty melody?

And while interpretations of the song's meaning vary, I think it describes Petty's changing feelings about an ex-girlfriend he broke up with awhile back.



Floyd Mayweather: Is the 'Money' man's stock free-fallin' faster than a Tom Petty melody?

At first, perhaps too consumed by his burgeoning success, he felt no remorse. But now, years later, his realizes he made a mistake and is lamenting decision, knowing he'll never get her back.

If Floyd Mayweather doesn't fight Manny Pacquiao this summer, will he, like rocker Tom Petty in the above scenario, regret his decision years later?

His reputation is already beginning to 'free fall' (pun intended) pretty quickly.

In addition to the \$50-80 million he'd be turning down for not agreeing to partake in what would be the biggest fight in history, Mayweather stands to lose the respect and credibility he's work so long and hard to attain.

The public has been clamoring for Mayweather vs Pacquiao since 2009 and, regardless of who is to blame, the masses view Floyd as the biggest deterrent to this fight happening. And in their defense, Mayweather continues to make demands and excuses.

Yesterday, the consensus pound-forpound champ hinted Pacquiao wasn't payper-view worthy, insisting two of Manny's last three fights have woefully under-performed at the box office, perhaps suggesting Manny wasn't a large enough draw to receive 40 percent (or perhaps even 30 percent) of the purse split.

But fight fans, including many of Floyd's supporters, are getting tired of the 'old song and dance' routine. As a matter of fact, Floyd Mayweather's reputation is even taking a beating among non-fans of the sport.

Several of my friends who don't follow boxing or have any affinity for the sport, have called or sent emails, chastising Mayweather for his apparent refusal to fight Pacquiao.

Even my doctor, who doesn't know who

## **Carlsen Wins Tata Steel Chess 2015;** Wesley So tied for 2nd place

The 77th edition of Tata Steel Chess Tournament also popularly known as Wijk aan Zee in chess that took place in 3-locations for the Master's Group (A-Group): Wijk aan Zee (R1-R4,R6-R9,R11-R13), Rotterdam (R5) and The Hague (R10 ) from 10-25 January 2015 was won as expected by the reign-

ing World Champion(WC) Magnus Carlsen of Norway. But it was not a walk in the park for the World Champion as he has to at least draw his final round (R13) to win the championship which he did after some tense moments against his 2014 Olympiad tormentor GM Ivan Saric of Croatia. WC Carlsen completed a clear first with 9.0/13 score from his 6-wins, 6-draws & 1-loss record, a half point lead to four others who tied for 2nd place namely GMs Maxime Vachier-Lagrave(FRA), Anish Giri(NED), Wesley Šo(USA) and Liren Ding(CHN) who all scored 8.5/13.

Carlsen had a slow start, drawing with Giri(R1) & So(R2). He lost to Wojtaszek in R3. But starting R4 he made a fantastic 6-win streak until R9 against Van Wely, Aronian, Caruana, Hou, Jobava & Radjabov respectively. He had drawn the last 4 rounds (R10-R13) versus Ivanchuk, Vachier-Lagrave, Ding and finally Saric to score +6=6-1 equivalent to 9/13 points with a Tournament Performance Rating (TPR) of 2878 and had gained +3.2 in FIDE rating points to bring his Live Rating to 2865.2 or 2865 come Feb 2014 FIDE rating publication.

It was the 4th time that Carlsen won "A-Group" in Wijk aan Zee. The other three were in 2013, 2010 and 2008 (tied with Aronian).

was 2746 (Category 20). The Top 11 seed players had ratings of 2800+/2700+.

Wesley So tied for 2nd place (4th overall).

Filipino GM Wesley So who now represents U.S. Chess Federation (USCF) since 28 October 2014, a second timer in this prestigious, strong Category 20 (2726-2750 ELO/rating range)] tournament, this time submitted a very much improved results than last year with his +5win=7draw- $1\log(+5=7-1)$  scoring 8.5/13 points had a 4-way tie for 2nd place but after tiebreak GMs Maxime Vachier-Lagrave(FRA) @ 2nd place, Anish Giri(NED) @ 3rd place, Wesley So(USA) @ 4th place and Liren Ding(CHN) @ 5th place overall. As for the prizes the four shared the 2nd-5th prizes equally.

Wesley So's Tournament Performance Rating (TPR) was 2854, and had gained a +16.8 in rating points. Summing this



up with his Total ELO gained a +8.7 rating points @ North American Open 2014: resulted to a Live Rating of 2787.5 that propelled him to #7 in the World Chess rating list. Come February 2015 FIDE ratings his rating in Standard/Classical would be 2788 just 1.7 points shy of Bobby Fischer's highest rating of 2789.7 (4 August 1972) and 12 points away from breaching the 2800 mark. He will also be listed as USCF #1 player ahead of GM Nakamura.

GM Wesley So Tata Steel 2015 'Masters Grp' Results:

In R11, Wesley So registered his highest ever Live Rating of 2788.5 (Jan 23, 2015) when he defeated 2014 Tata Steel Chess challenger("B-Group") champion GM Ivan Saric in the 28th move,

Wesley So started on a high note on the earlier rounds (R1-R4), when in R2 he drew with black pieces with the top seed & World Champion Magnus Carlsen(2862). In R2, he surprised everyone by defeating the Nr-3 seed & defending champion GM Levon Aronian(2797). R4 was another high profile draw with the Nr-2 seed Fabiano Caruana(2820). After only 4 rounds,

Wesley So registered an amazing TPR of 2901.

His R8 win versus Vasily Ivanchuk produced another milestone when he registered a live rating of 2785.3 that ranked #6 in the World's Live Rating List on 18-19 January 2015.

round (R12), in 111 moves that practically denied his shot for the title. It also ended his streak of 54 No-Loss record in Standard or Classical chess that started in R4 @ 2014 Bill Wright St. Louis Open dtd 13 April 2014 until R11 @ 77th Tata Steel Chess dtd 23 January 2015.

Overall, it was a very successful event for HGM Wesley So and a BIG START for CY-2015.. His goal for 2015 of reaching 2800+ is just a few blocks away. With more invites in elite tournaments in the coming days & months ... that goal shall come to pass !

There are also some very beautiful island getaways where there is no hot water at all. I really need hot water for showers – I just can't get used to cold showers; I don't care what the outside temperature is.

I have overheard, on more than a few occasions, tourists complaining about the service, or the fact that things are not as efficient as it is in their country. To them I say, stay home. I mean, come on - you're traveling in a foreign country to see and experience new things. If you want things to be the same, then stay home.


There are many more places in the Philippines I want to visit and experience, and it seems I just never have enough time. I guess that means more trips in the future.

**Beans** – They may just be the best plant-based food ever: protein, fiber, amino acids, vitamins, even healthy fats. And get this: beans and legumes slow the release of glucose (thanks to all the fiber), making them excellent in preventing blood sugar spikes.

**Tomatoes** – Nothing tastes as scrumptious as a fresh, vineripened-right-in-your-garden tomato, right? And it turns out, it's also one of the healthiest foods that lower blood sugar too. Gazpacho, anyone?

Vinegar – It's not just for salad dressing (or cleaning your house!). Vinegar has been shown to reduce blood sugar levels, particularly if consumed just before a meal. Mix 1-2 tablespoons with warm water and drink 30 minutes before a meal.

**Berries** – As sweet as they are, berries are an excellent source of quercetin, which has been shown to reduce blood sugar levels. They're also loaded with lots of other delicious nutrients.



Enjoy them fresh or frozen, but never canned.


**Apples** — An apple a day may not only keep the doctor away but also the insulin. Another quercetin-loaded fruit, apples can reduce the risk of diabetes and heart disease.

Cinnamon – This may just be the blood sugar miracle food. Studies have shown that eating just a ½ teaspoon of cinnamon a day can make cells more sensitive to insulin and convert blood sugar into energy more easily.

**Bell Peppers** – With more vitamin C than an orange, studies have pointed to a correlation between low vitamin C levels and diabetes.

**Citrus** – For the same reason as bell peppers—adding C rich citrus fruits can aid in reducing blood sugar levels.

**Chocolate** – This may seem counterintuitive—chocolate is often associated with being sweet—but research shows that cacao (raw chocolate, unsweetened) improves insulin sensitivity. And that is pretty sweet. Look for raw cacao beans, nibs or powder. Blend in a smoothie with fruits like berries for a natural sweetness that will help you keep your blood sugar goals.


He also is very keen on meeting some of the cast, saying, "Sana makapunta na rin sila dito para sa pre-"Sana makapunta miere.'
