# Time to move on

ow much can be accomplished in two years? A lot, considering the enormous powers given to the president of the republic.

For those who dismiss President Aquino as a lame duck in his fifth year, it's good to remember what Gloria Macapagal-Arroyo did in her own 'last two minutes" at Malacañang. She wielded full power even when a winner had been proclaimed in the presidential race, appointing a new chief justice and many others to positions high and low in government.

Undoing GMA's appointments, notably for the chief justice, required the investment of political capital that has brought the daang matuwid administration to where it is now: on the defensive for its utilization of public funds.

In his fifth State of the Nation Address (SONA) this afternoon, President Aquino should avoid nagging his "bosses" again about the good faith that went into the design and implementation of his Disbursement Acceleration Program. That unctuous, seven-hour hosanna to DAP at the Senate last week was cloying enough.

P-Noy's defense of the DAP has become Pavlovian: he sees a microphone and camera and he can't resist singing praises about his stimulus program, and lambasting those nasty Supreme Court (SC) justices, particularly his traitorous appointees, for their inability to

see his point.

In fact no one - not even the SC justices in their unanimous decision – is disputing that useful projects were implemented through the DAP. No one is accusing P-Noy of pocketing any public funds either.

But the system is flawed and must be stopped, according to the SC. P-Noy can seek a supplemental budget for interrupted DAP programs – which he is doing – while an improved system of budgeting is drawn up.

People need not be told over and over that unlike the Priority Development Assistance Fund (PDAF) or congressional pork barrel, even notorious crooks in Congress did not skim funds from the DAP through bogus nongovernment organiza-tions. Yes, P-Noy, even the math-challenged get it: the DAP is not PDAF.

By all means the budget overhaul should include judicial funds, whose utilization must be injected with transparency. The executive and legislative branches - designers and beneficiaries of the DAP and pork barrel - need not be shrill or petty about it. Slashing the judiciary's budget is infantile.

P-Noy is risking a significant amount of public goodwill in his bratty insistence that the SC is wrong on DAP.

Even investors are spooked. I've heard concerns raised in business circles about the possible impact of this ugly battle between Malacañang and the judiciary on the rule of law, weak enough as it is.

There's life after DAP. Its loss shouldn't hijack P-Noy's agenda in his last two years in office.

The prohibitory norm public and to contribute to service is set out in Section

59, Book V of the Revised Administrative Code of 1987 (also known as E.O. No. 292). Section 59 reads as follows: Nepotism. - (1) All appointments to the national, provincial, city and municipal governments or in any branch or instrumentality thereof, including government owned or controlled corporations, made in favor of a relative of the appointing or recommending authority, or of the chief of the bureau or office, or of the persons exercising immediate supervision over him, are hereby prohibited.

Under the definition of nepotism, one is guilty of nepotism if an appointment is issued in favor of a relative within the third civil degree of consanguinity or affinity of any of the following: a) appointing authority; b) recommending authority; c) chief of the bureau or office; and d) person exercising immediate supervision over the appointee.

There have been so many who practice such acts who have never been punished for this abuse of power. It should be stopped. This pernicious evil continues to obstruct the civil service and the efficiency of its personnel. People are employed not because they are qualified for the position but because they belong to the "kamag-

# Aquino tears up in his 5th Sona

MANILA, Philippines-President Aquino choked up, surprising his audience, and left not a dry eye in the house as he wrapped up his fifth State of the Nation Address (Sona) talking about his parents who fought for democracy, the legacy they left, and how he would not let his administration's detractors take away the gains his presidency had achieved the past four years.

Aquino's celebrity sister, Kris Aquino, was seen crying in the VIP gallery and wiping away her tears.

The President was optimistic that his program, dubbed "daang matuwid," could extend far beyond his six-year term so long as the public would choose the path of "transformation" and pick his rightful successor in 2016.

"To my bosses: You gave me the chance to lead our country's transformation. If I refused the challenge you laid before me, it is like saying I will help prolong your agony and my conscience cannot take that. If I turned my back on the chance given to me, it is like turning my back on my father and mother, and everything that they sacrificed for us. That will never happen," the President said in Filipino.

And then his voice cracked. Regaining his composure, the Presi-dent continued: "As we tread on the straight path, you chose what is good and what is right; you remained true to me-and I remain true to you."

Some of the people in the audience stood up in one of the most loudly applauded parts of his 91-minute speech.

"The transformation we are enjoying now can become permanent with the help of the Lord. As long as our faith and trust is complete, and as long as we become each other's strengths, we will continue to prove that 'the Filipino is worth dying for," "the Filipino is worth living for," and I will add: 'The Filipino is worth fighting for," Aquino said.

The President's late parents, assassinated opposition leader Sen. Benigno Aquino Jr. and President Corazon Aquino were the country's icons of democracy, toppling the 20year conjugal dictatorship of the late

President Ferdinand Marcos and then first lady, now Leyte Rep. Imelda Marcos.

The late senator famously declared, as he continued to oppose Marcos that "the Filipino is worth dying for."

Three years after his death, his widow, Corazon, was swept to the presidency in a four-day bloodless uprising now known as the Edsa Revolution.

President Aquino faces his toughest year yet in office, facing three impeachment cases stemming from the outlawed Disbursement Allocation Program (DAP) and the Philippine-US security pact, the Enhanced Defense Cooperation Agreement (Edca) meant as a deterrent in the country's territorial dispute with China, and the lowest approval rating in four years.

#### 'Second life'

Aquino spoke of a "second life" after surviving a gunshot wound in the 1989 coup against his late mother, then President Corazon Aquino.

He said he could not help but think about the gravity of the nation's problems. He said there were times on his speaking engagements the thought came that taking the stage would be his last day. He said he had thought about someone successfully exploding a bomb, or someone with dark thoughts would return the nation to the old corrupt ways.

"Should those times happen and I am on my second life, can I tell myself I am happy with what I had accomplished?

"I am satisfied that when I am gone, many will pursue the path we have taken. Maybe that is my role, to get things going," he said.

Filipino worth fighting for In seeking to inspire the public to-

ward sustaining the "transformation" achieved under his administration, the President recalled the words of his late father who said, "The Filipino is worth dying for." "I would like to add: The Filipino

is worth living for. The Filipino is worth fighting for," he said.

Unlike in previous Sonas, the President was relatively less combative and was more sentimental on how the gains of "daang matuwid" were now manifested in Philippine society.

Aquino opted not to assail the Supreme Court in his biggest speech of the year, despite three recent public addresses lambasting the magistrates for declaring his DAP unconstitutional.

Instead, he spoke of the need to stop certain DAP-funded projects "to ensure that we follow the decision of the Supreme Court" against the economic stimulus program.

He urged Congress to pass a supplemental budget for 2014 to fund such projects, plus a joint resolution that would "clarify definitions and concepts" apparently on the pooling and realignment of government savings.

Prior to the Sona, he attacked the magistrates and warned of a "collision" between the executive and the judiciary, which might require the "intervention" of the administration-controlled legislature.

### Party-list groups to block impeach moves vs PNoy

MANILA, Philippines - A party-list coalition in the House of Representatives is determined to block the impeachment complaints against President Aquino endorsed by party-list congressmen.

Ako Bicol Rep. Rodel Batocabe, among the 48 members of the coalition, said Monday that holding an impeachment proceeding will drain the time of Congress in fulfilling various technical requirements under the Constitution.

"Hindi basta-basta ang magimpeach ng presidente," Bato-cabe said in an interview with reporters on Monday, ahead of the opening of Congress and Aquino's State of the Nation Address.

Three impeachment complaints have been filed against Aquino this month, two of which are connected to the administration's controversial Disbursement Acceleration Program and another on the Enhanced Defense Cooperation Agreement between the Philippines and the United States.

Batocabe said that Congress should instead discuss issues

and channel its resources and attention on the government's agenda, including the drafting of bills that would boost the country's economy.

He explained that impeachment complaints will take months under the House Committee on Justice and a few more months in the plenary. If the complaints get pass the House of Representatives, it will be endorsed to the Senate for the trial.

Batocabe added that there is no use to have Aquino ousted through an impeachment process, since the President's term would end in two years or in 2016.

"So bakit mo pa kailangan iimpeach kung aalis din naman?" the lawmaker said.

KUALA LUMPUR, Malaysia - Any airline would struggle with the devastating impact of losing one jet full of passengers, especially if it had already been bleeding money for years.

But losing another just months later is pushing crisis-hit Malaysia Airlines (MAS) to the brink of financial collapse, airline experts said, spotlighting whether it can steer its way out of extended turmoil as once-troubled carriers such as Korean Air and Garuda Indonesia did before.

The flag carrier needs an immediate intervention from the Malaysian government investment fund that controls its purse strings, and likely deep restructuring, to survive the twin tragedies of flights MH370 and MH17, analysts added.

MAS was already struggling with years of declining bookings and mounting financial losses when MH370's mysterious disappearance in March with 239 people aboard sent the carrier into free-fall.

The July 17 downing of flight MH17 over Ukraine, which killed all 298 people on board, deeply compounds those woes.

"The harrowing reality for Malaysia Airlines after MH17 is that if the government doesn't have an immediate game plan, every day that passes will contribute to its self-destruction and eventual demise," Shukor Yusof, an analyst with Malaysia-based aviation consultancy Endau Analytics, told AFP.

Shukor said MAS was losing "one to two million US dollars a day," and has "the bandwidth to stay afloat for about six more months based on my estimates of its cash reserves.'

#### Image is everything

While the MH17 disaster was beyond the airline's control - pro-Russia separatists in Ukraine stand accused of shooting it down with a missile – bookings are expected to take a further significant hit, as they did in MH370's wake.

"I'm not considering going to Malaysia in the next few years. Not unless Malaysia Airlines acts or does something in the future that will allow people to feel on the table but all involve more relaxed about travel-

Lumpur International Airport in Sepang on July 18, 2014. ing there," said Zhang Bing, a Chinese national in Beijing.

Jonathan Galaviz, a partner at the US-based travel and tourism consultancy Global Market Advisors, said "perception is key in the airline industry."

"Unfortunately for Malaysia Airlines, potential international customers are now going to link the brand to tragedy."

The airline already has announced refunds for ticket cancellations following MH17, which Galaviz said would cost millions of dollars.

Speculation is rife that state investment vehicle Khazanah Nasional, which owns 69% of the airline, will delist its shares and take it private, which could set the stage for painful costcutting measures and other reforms.

Analysts have long blamed poor management, government interference, a bloated workforce, and powerful, reform-resistant employee unions for preventing the airline from remaining competitive.

MAS lost a combined 4.1 billion ringgit (\$1.3 billion) from 2011-13. It bled a further 443 million ringgit in the first quarter of this year, blaming MH370's "dramatic impact" on bookings.

Khazanah declined to comment on future plans for the airline.

But writing in Britain's Sunday Telegraph on Sunday, Hugh Dunleavy, Malaysia Airlines' commercial director, stated that the carrier "will eventually overcome this tragedy and emerge stronger.'

The Malaysian government had begun to speed up its review of the airline's future - started after the disappearance of MH370-following the second tragedy, Dunleavy wrote.

#### **Rising from the ashes**

Other airlines have risen from the ashes, lessons that could be instructive for MAS, experts said.

Indonesia's state-owned Garuda Indonesia was plagued by a series of problems in the 1990s and early 2000s, including heavy debts and the murder of a prominent human rights mid-air campaigner in 2004.

Safety problems also blighted its image, including a 1997 crash on Sumatra island that killed all 234 aboard and remains Indonesia's deadliest air disaster.

Former banker Emirsvah Satar was appointed in 2005 to turn around the airline, and he undertook a massive exercise to nurse it back to health. In 2010, it was named the world's most improved airline by Londonbased consultancy Skytrax.

Korean Air was in trouble after a period during the 1980s and 1990s when several accidents left more than 700 people dead.

It embarked on a major reform push, bringing in retired Delta Air Lines vicepresident David Greenberg in 2000, who subsequently revolutionized its safety and operational practices.

Korean Air is now widely respected worldwide.

Shukor said Malaysia's government and Khazanah face a "mammoth task" but that the airline could learn much from carriers that have faced similar challenges.

# Bangus frenzy in Pasig River

Manila, Philippines - The Pasig River, considered dead by ecologists, roared back to life yesterday when schools of milkfish, locally known as bangus, were spotted in Guadalupe, prompting many Makati residents to brave the murky water and join the frenzy.

Jesus Corrompide, a resident of Barangay Poblacion, said he noticed neighbors catching bangus while monitoring the flow of the river. He rushed home to get a pail and net, plunged into the river and returned a few minutes later with a pail full of large bangus.

Corrompide brought his catch home and went back to the river to get more bangus. He started selling bangus for P50 per kilo to pedestrians and motor vehicle drivers on J. P. Street.

A kilo of bangus sells P165 in the market.

Luis Doroha, a construction worker, also became a fish vendor for the day.

Doroha, decided not to report for work Thursday to catch milkfish and sell them. He hopes to collect P3,000 from the bangus he caught.

The MHD, through City Health Officer Dr. Jocelyn Vaño, issued the warning after residents from the city and neighboring localities were seen flocking to the Pasig River.

The city health office said fish and other marine life from the said river may contain a number of toxic chemicals, including methyl mercury, which have been found to be harmful to the nervous system and can cause mental and physical retardation in children, and other diseases like cancer.

### **CHICAGO MAN PLEADS GUILTY TO SEX TRAFFICKING OFFENSE** WITH UNDERAGE GIRL IN SACRAMENTO AREA

Sacramento, Calif. - Marquist Piere Brad- recovered the victim in this case. ford, 28, of Chicago, pleaded guilty to sex trafficking of children by force, United States Attorney Benjamin B. Wagner announced.

According to court documents, in early 2012 Bradford recruited a 15-year-old girl to travel from Fresono to Sacramento where she was used by Bradford as part of a prostitution business from January 18 through February 5, 2012. According to court documents, Bradford maintained an apartment in Rancho Cordova, which he used as base of operations for a prostitution business that spanned to Sacramento and Bay areas, as well as cities outside California. At least two of Bradford's victims were under the age of 18. Bradford fled from Sacramento to the Chicago area after law enforcement

This case was the product of investigation by the Sacramento County Sheriff's Office and the Sacramento FBI Innocence Lost Task Force. Assistant United States Attorney Matthew G. Morris is prosecuting the case.

Bradford has remained in custody since his arrest in Springfield, Ill. in April 2012. He is scheduled to be sentenced by the United States District Judge Morrison C. England, Jr. on October 23, 2014. Bradford faces a maximum of statutory penalty of life in prison and a \$250,000 fine. The actual sentence, however, will be deter-mined at the discretion of the court after consideration of any applicable statutory factors and the Federal Sentencing Guidelines, which take into account a number of variables.

### Stockton Barrio Fiesta - Commemorating the 41st Anniversary of the Filipino Center Plaza



### San Francisco rally – 'Destroy China military bases,' 'UN ruling against China invasion now'

FRANCISCO, SAN California - Shouting "China out now!", Filipino Americans in the Bay Area on July 24 joined their counterparts in other part of the United States and other capital cities in the world in denouncing what they called the invasion of the Philippines by China.

Carrying inverted Philippine flags, the San sia, Thailand, Vietnam, Indonesia, Saipan the United Nations Plaza with placards, plained .. condemning China for its alleged "bullying" tactics in dealing with the Scarborough Shoal conflict.

At a program detailing continued "harassments" against Philippine sovereignty, speakers denounced the Chinese government's incursions in the disputed territory.

"We march with our Philippine flag with the red color on top as the Philippine is in distress because China is building a military base on Mabini reef with a mile-long air strip and a Marina for their ships to dock," Rodel Rodis, President of US Pinoys for Good Governance (USPGG) told protesters.

"They could go all over the Philippines with the range of their rockets and their ships and this is a very dangerous development worse than if they set up oil rig," Rodis added.

He explained that when China set up an strated against Chinese businesses in their country, forcing the Chinese to send back 3,000 of their workers back to China. Rodis urged Filipinos to do the same because what China is doing in the Mabini Reef is "worse than what they did in Vietnam."

#### Mabini's oil and gas

Mabini Reef is one of the contested islands and reefs in the West Philippine Sea that also include the Ayungin shoal, considered as the gateway to Recto Bank, which is 85 miles from the Philippine coast and was estimated by the U.S. Energy Information Administration to contain 213 billion barrels of oil and two quadrillion cubic feet of natural gas.

"Now we have to start getting the word out. In the Chinese consulate in Los Angeles, as in New York, Washington, DC, all over Canada, all over Europe and in capitals all over the world, Filipinos are organizing and mobilizing like us because we keep educating our communities to make sure that China does not invade the Philippines, to make sure that we are able to stop the intrusion." Rodis announced.

With over 12 million overseas Filipinos all over the world, it is believed that Filipinos can mobilize and educate not only themselves, but also citizens of over 200 countries where Filipinos are based.

"Once the bases are established, it is almost impossible to take them off, and we will become a slave nation. So we are urging the Philippine government, the US government, Australia and Japan to immediately destroy these bases, because if we allow them to be embedded there, they will threaten the nabut also the neighboring countries Malay- the world," Benipayo stated.

He added, "There is a need for world condemnation to exert stronger pressure on China, which is acting like a rogue nation by not respecting international laws. We have informed so many in the world, we have turned public opinion against China in many, many ways. The more we inform people what China is doing, the more we gain in terms of having China condemned by world opinion."

With his "battalion" of World War II veterans in tow, Rudy Asercion, executive director of West Bay Pilipino Multi-Service Center, insisted that the rallyists compel the United Nations to make a ruling on the Philippine case brought before the UN International Tribunal on the Law of the Seas (IT-LOS), so that China may be stopped from building their military bases in maritime waters so important to commerce.

I introduced Robert's Rules of Order to be used as a reference in committee meetings. Two other distinguished members of the committee are familiar with the rules of order but the rest were not. The two committees accepted and incorporated Robert's Rules of Order in its charter. Robert's Rules of Order was written by Henry Martyn Robert. It is the most widely used manual and

authority of parliamentary procedure in the United States and throughout the international community. H.M. Robert was born on May 2, 1887. He was from Robertville in South Carolina, named after his grandfather. His father was a medical doctor and a baptist minister. H.M. Robert graduated at

the United States Military Academy in West Point, New York, He finished fourth in his class in 1857. After his commission in the U.S. Army he joined the Corps of Engineers. H.M. Robert was later appointed Chief of Engineers. In 1901 retired with a star rank – Brigadier General. Two important principles that guide Robert's Rules of Order.

> The first principle is one thing at a time which means that one agendum needs to be discussed or debated ina given period of time. The second principle is one

speaker at a time which means that one person is allowed to speak and then followed by another one and so on andso forth.

The main purpose of these principles is to have orderly meeting. It also mitigate chaos in any kind of meeting. Important points to know in parliamentary procedure are setting the agenda, who will be the Chairperson to facilitate the meeting and takes order from the membership, who will be the Secretary to literally write and records the discussion every minute which is popularly called the minutes of the meeting, and how to make a motion which usually follow a standard "I move that". A motion needs to be seconded and then the discussion. The mover of the motion goes first. Talking about something aside from the agendum is out of order. The time limits for debate can be extended by 2/3votes from the membership. Amendment to the amendment cannot be further amended. Point of order is done to clarify the chair's decision. The members can challenge the chair and go for a vote.

The vote of the assembly is the final word. A delegate of the winning side can make a motion to change the decision. Motion to adjourn is ending the meeting to be voted by the majority. The chair has atie-breaking vote. Membership are the final decision maker in democracy.







the Supreme Court justices. But would he go to that extent? If he did, that would be the end of the legacy of his father, Ninoy Aquino, whose martyrdom had broken the Marcos dictatorship. Is P-Noy too bull-headed that he would dismantle the democratic institution his iconic mother, Cory Aquino, had built from the rubble of martial law? No! P-Noy wouldn't dare do that.

But to accept defeat after all that hullabaloo of attacking the Supreme Court, P-Nov faces the inevitability of becoming a lame duck too soon. Normally, a sitting president doesn't become a lame duck until his successor was elected, which is about 60 days prior to the end of his term. But when a president lost his political power due to diminished influence, he becomes a de facto lame duck, which begs the question: Will P-Noy's influence wane as a result of his ignominious defeat at the hands of the Supreme Court justices?

At the end of the day, there's nothing harder a president could swallow than being a lame duck for the last two years of his presidency, which makes one wonder how history would treat P-Noy? The last things that he'd like to be known for are: lame mind, lame excuses, and lame duck.

# Dear Juan Ponce Enrile

I hope that after your conviction, all those you intimidated and harmed before, during, and after martial law will find the courage to tell their stories. I hope that you live to hear those stories.

ast year, the 41st the anniversary of the declaration of martial law, I wrote a long post about you ending with, "Old as you are, you may never be brought to justice. And I doubt your conscience bothers you, enamored as you seem by unearned wealth and the pomp of your dishonorably gained positions. But I remember and will remember, with the hope that history will, like me, condemn."

How much has changed in less than a year.

And now, as you, a 90-year-old, are confined to a hospital under arrest, let me charge you with what has been in my heart all these years. Because I do accuse you. And not just with the plunder charges the government has filed against you.

#### I accuse

I accuse you of torture and murder. Not just of people unknown to me, but also of my friends. I accuse you of having committed the crime of plunder long before you stole your PDAF as a senator.

I do this not out of vindictiveness, but out of a need for healing that you owe me and all those who passed through martial law. I do not do this in anger, but in order to share with those who did not go through those years. They need to understand why you and those like you should never ever be allowed to have power again.

Now is a good time. If we did not learn our lesson then, it is time to look back now – time to realize that those who betray the nation are likely to betray it again. As you have done after martial law.

Ah, what catharsis to write this! What a relief to be able to call you names. I remember how you would punish people who criticized you, Marcos, and your cabal. This is what you did to my friend and former Philippine Collegian editor, Abraham Sarmiento, Jr. You imprisoned him for writing editorials critical of martial law. You released him only after you personally expressed displeasure over the editorials. I know because he told me. He stuck to his principles after release. You imprisoned him again and kept him in a cell until his health had so deteriorated he died shortly after his second release. Even as you seemed to recover your career, I often comforted myself with the thought that at least the sacrifices of those who fought the dictatorship allowed me the freedom to criticize you. That I did not do so daily was merely because of my limitations and not out

of new-found respect for you. Do you think I have forgotten my mother's years of excruciating worry as she watched me go deeper and deeper into the anti-dictatorship struggle? Oh, how her friends would comfort my mother, "Don't worry, Rita. If she gets caught I will agree to his advances and spend the night with him in exchange for your daughter's freedom." Yes, even then we knew that you were a predator as well. You were so lascivious my humble family knew of two people whom you had propositioned. You abused power to the maximum. You made us see with clarity what Hannah Arendt calls "the banality of evil."

#### Detention, torture during martial law

And I, like many who lived through those years, knew of your evil as a daily reality. My first job as a young doctor was with a health and human rights organization. I worked with those who had been tortured. Those days, detention and torture were almost a sure-fire combination. So I and a couple of colleagues would make the rounds of the detention centers with every new report of an arrest, hoping that, with a quick response, people would be tortured less, not killed.

We would present ourselves at the detention centers to any officer who would see us. (They never had a real system for us. That would mean some form of accountability.) We had to be brave because we knew at once this marked us as communist enemies. But they also had to have a semblance of regularity. So our requests would be considered. If the officer was a tough psychopath, he would just say "no" outright. But this would give us ammunition to go squealing to international human rights groups.

So we would often have to wait for hours for someone from the Judge Advocate General's Office (JAGO) to make a decision. I never met anyone from JAGO then. I did often get turned away by that office. If the JAGO turned us away, we would write you. Very rarely, for reasons unknown, you or JAGO would agree to our visit, often after weeks of delay. We always thought the delay was to ensure the torture would continue. Marcos, you and your military believed in torture as an investigation technique. After the torture, you would have us wait a few more days un-til the physical evidence of torture had disappeared. If there was enough international pressure; if you wanted us off your backs; if our seeing the detainees would not cause you any harm, you let us see them.

But they would tell us their stories. A detainee was lucky if all he or she got was getting beaten within an inch of their life. (I guess they left that for the amateurs called fraternity boys.) Electrocution, water boarding, rape and other forms of sexual harassment, sleep deprivation, hearing your wife being raped, hearing your comrades being tortured, being asked to sit on a block of ice while naked – your minions were so depraved in what they created

Six weeks ago, labor leader Romy Castillo died of lung cancer. In 1984 your military electrocuted his testicles, put a barbecue stick up his penis, repeatedly submerged his face in a feces-filled toilet bowl. They beat him and played Russian roulette on him. I cannot forget the day, shortly after his ordeal, when I visited him in detention. I will not let you forget his story nor escape your liability for it

get his story nor escape your liability for it. Your military killed my childhood friend Lorenzo Lansang when he was only 19 years old. He was summarily executed in a field in Quezon province. Your hands are smeared in his blood and I will always point out how bloody they are.

I blame you and Marcos for the corruption and brutality of the military and police today. I still keep abreast of the torture situation. And it looks like the police and military have no idea how to interrogate and investigate without varying degrees of torture and intimidation thrown in. They have become addicted to it. All those recent reports of human rights violations by state authorities? Your face is on the logo.

And I remember that your wealth came from the thievery of the martial law years. It does not therefore surprise me that you stole your pork barrel funds.

You find me too dramatic? I could fill entire pages with more stories. And I am not alone. How lucky that I am much younger than you. I and my cohort will live after you and tell our tales.

Karma Dear Johnny boy, I bet you miss the days when you could have imprisoned me for this. When you could have had your military rape me as revenge. I, on the other hand, am so glad you are under arrest now. Defanged, at last. Hopefully forever.

Unlike you, however, I would not wish torture upon those I truly think are enemies of the people. In short, I would not torture you. I would not deny you seeing your lawyers or doctors or relatives as you did to so many during martial law. It is fitting though that you may suffer in detention more than usual. I do note that you may be experiencing pain because you are old and infirm. I note it.

Your conviction will be so good for our country. It will show that such diabolical behavior will not always be rewarded. That somehow power can end and then a price will have to be paid. It may deter future wrongdoing. It may convince a few more people not to value the things you value.

The only thing I am afraid of is that you are morally incompetent. So much of your record indicates "sociopath." I fear that it does not matter to you what people think or will remember. It isn't right that your punishment will be so short because you're not likely to live 20 more years. That was the amount of time you kept our people subjugated to martial law. So I can only hope that you at least care enough so that the last days of your life can be lived in regret.

I am hoping you care about how history will remember you. You did write and spend for the publication of that lie of a memoir. So I hope that you live to see your conviction. That after your conviction, all those you intimidated and harmed before, during, and after martial law will find the courage to tell their stories. I hope that you live to hear those stories.

But for now, this is my story. And before you go, I want you to know that the other stories will come. It's called History. It's called karma.

## **10 Foods to Eat so You Never Have to Diet**

These powerhouse foods help keep unwanted pounds at bay, and it has nothing to do with counting calories and fat grams.

#### By Amy Capetta

#### Garlic

This herb does more than just give meals extra flavor and scent--it can also help keep your tummy flat through its naturally occur-


ring chemical allicin, says registered dietitian and Nutritious Life founder Keri Glassman. "Allicin kills off harmful bacteria in your digestive tract to keep your gut healthy and functioning, which means less bloat." Also, Korean researchers discovered that this member of the onion family may have an anti-obesity effect thanks to proteins being stimulated in the liver. Toss garlic in almost any poultry, pasta, or veggie dish, or add it to dressings and sauces.

#### Beans

When you're craving carbs, look no further than the legume family, says registered dietitian and food and nutrition consultant Rachel Begun. "Beans are unique in that they offer significant amounts of both fiber and protein in one package--one cup of black beans has a whopping 17 grams of fiber and 14 grams of protein. We're learning that fiber and protein are invaluable for weight management because both are highly satiating, meaning they leave us feeling full for longer and prevent overeating later in the day." A recent study published in the journal Obesity found that extracts from white kidney beans can reduce the absorption of calories from carbohydrates and tame sweets cravings, thanks to certain enzymes that inhibit starch digestion.

#### **Pistachios**

"In-shell pistachios are one of my go-to snacks for weight management," says Katherine Brooking, a registered dietitian and cofounder of Appetite for Health. A oneounce serving has 6 grams of protein and 3 grams of fiber, but their real power is felt more in your eves than your stomach. "Needing to de-shell helps you munch more slowly, and the discarded shells may also provide a visual cue to remind you of how much you've eaten, which helps put the brakes on out-of-control snacking," adds Brooking. In fact, in a study conducted at Eastern Illinois University, participants who snacked on in-shell pistachios consumed 41 percent fewer calories compared



country has one of the lowest obesity rates in the world, says registered dietitian and Appetite for Health cofounder Julie Upton. One of their staples is wakame, a type of nutrientand protein-rich seaweed. "Compounds isolated from wakame, [known as] fucoxanthin, have been shown to help increase fat burning in animal model studies," says Upton. "More studies are currently looking at other compounds in seaweed, like alginates, that form gels in the stomach to enhance feelings of fullness." Toss seaweed into soups and salads or use it instead of lettuce in wraps and sandwiches.

#### Jalapeños

Good news for those who like it hot. "Jalapeño peppers contain an antioxidant called capsaicin, which acts as a powerful antiinflammatory and metabolism booster," says Glassman. "Some studies have found that people who eat pepper-packed meals feel less hungry and burn more calories later." One such study conducted at Purdue University discovered that volunteers who infrequently consumed this spicy, nutrient-dense vegetable reaped more of its weight-loss benefits, a result of experiencing less hunger, especially for fatty, salty, and sweet foods. According to researchers, sprinkling red pepper on a meal "may be sustainable and beneficial in the long run, especially when paired with exercise and healthy eating.'

#### White potatoes

Who said all white foods are offlimits? "White potatoes are actually a slimming food," says Glassman. The reason: They're full of rich resistant starch, a compound that ferments in the gut and creates butyrate, a fatty acid that may spur your body to burn more fat. A study published in the journal Diabetes found that butyrate also improved insulin sensitivity and increased energy expenditure in mice.

#### Mangos

While these juicy stone fruits are

to those who ate naturally filling due to their fiber the shelled vercontent--a medium one contains 3 grams--that's not the only rea-

son they help peel off the pounds. "New research from Oklahoma State University indicates that mangoes may lower blood sugar, which can help to control cravings, especially for carbs, thus keeping your willpower intact." says Brooking. And good news: Since mangoes are grown in tropical climates all over the world, they're available year-round.

#### Yogurt

It's more than just a low-cal standby. "The calcium in yogurt may help lower calcitrol in the body, which helps turn on fat burning and turn down fat storage," says Brooking. "Plus, the beneficial probiotics in yogurt feed your gut, and we now know that gut microbes in those who are a healthy weight are different than in those who are obese." The way yogurt is made, which includes fermentation, also gives it higher concentrations of protein, B-vitamins, calcium, potassium, and magnesium compared to milk. making it the ultimate dairy food.

#### Avocado

More than 80 percent of the calories in avocados are from fat-but they're still incredibly good for you, says Upton. "Research shows that people who eat avocados have lower BMIs, and a recent study of overweight men and women found that adding avocados to lunch increased satisfaction by 22 percent. It also reduced desire to eat over the next three hours by 24 percent." The study authors suggest that the fiber, unsaturated fat content, and a bloodsugar-lowering sugar called Dmannoheptulose may play a role in helping steady blood sugar levels and keeping appetite in check.

#### Artichokes

These veggies are rich in fiber, with each medium-size one packing 6 grams. "Fiber is valuable if you're trying to lose weight because it actually slows digestion so that you feel full longer," says Glassman. "It also means more volume for fewer calories." And artichokes promote good gut health. They contain indigestible nutrients, called prebiotics, that help support the good bacteria in your digestive system, which can deflate belly bloat and flatten your tummy.

Ever the patriot, Julaton never passes up a chance to represent the Philippines. "I was in New York for the Philippine Independence Day parade and that was an amazing experience! The PIDC and the Consul General, Mario Lopez De Leon and his entire group were so welcoming and they made

Osman lost a close split decision to Singapore's Sherilyn Lim at ONE FC: TOTAL DOMINATION last October, 2013 in one of the most memorable fights the organization has put on. It was a total back and forth war of attrition, one that could have gone either way. Even in defeat, Osman showcased her wares and made it clear that she was a force to be reckoned with.

When Julaton collides with Osman next month, fans can be sure to get their money's worth of action and excitement. Women's mixed martial arts has recently gained steam with the prominence of stars in America like "Rowdy" Ronda Rousey and actress Gina "Conviction" Carano.

Julaton and Osman, despite there being only one winner at the end of their matchup, are both certified action stars in their own right regardless of the outcome.

If Ana Julaton can pull out another victory and impress fans with her improved fight game, she could become a breakaway star in MMA and a bright light for the sport in the Philippines.

MANILA, Philippines – Is Floyd Mayweather finally mulling to face Manny Pacquiao in what could turn out to be the richest fight in boxing history?


An online report claims the undefeated boxer's father confirmed that his son is indeed pushing for a clash with Pacquiao in May next year.
