More lawyers back Poe on citizenship

More legal experts have come to the defense of Sen. Grace Poe against the view of Supreme Court Associate Justice Antonio Carpio, head of the Senate Electoral Tribunal (SET), that she is a naturalized and not a native-born Filipino citizen.

A lawmaker, however, insisted on Sunday that Poe should explain why she abandoned her Philippine citizenship in the first place when she could have lived, worked and raised a family in the United States and still remained a Filipino.

"Since Sen. Grace Poe is now running for President no less, she has to deal with the reality that she has put herself and her family under a microscope," House Deputy Minority Leader Arnel Ty said in a statement.

Carpio's stating his opinion, based on international law, during oral arguments on Sept. 21 on a

43 years after the fact

hen someone does you grievously wrong, an apology is the least you expect. When you are bludgeoned and bloodied by an assault done on your personworse, by one who had sworn to protect you and keep you safe at all times an apology becomes not just an emotional salve but a towering requirement of elementary justice, the first step toward righting the crime. Implicit in that apology is the recognition that the culprit understands the enormity of his or her offense, and thus—and more importantly—will not do it again. Absent that acknowledgment, you have every right to remain angry, to demand redress at every turn no matter how long the wheels of justice would

But that's life. History and politics, particularly of the Philippine variety, are an altogether different reality. In other countries, leaders who ran their country to the ground were punished for it. Nicolae Ceausescu of Romania was hanged by his own people. Pol Pot's henchmen were tried and sentenced to imprisonment for the Cambodian genocide, decades after the fact. South Korea jailed two of its former prime ministers for corruption. And so on.

In Haiti, the lavish living of the Duvaliers amid the squalor and poverty of the rest of the country would lead to a popular uprising that drove the family into exile.

Substitute Haiti for the Philippines narrative would be simi-

lar-a dictator and his family living splendidly off the nation's coffers, eventually chased out of the country by an enraged populacebut for a crushing twist. When Jean-Claude Duvalier returned to Haiti after two decades of living in France, he was promptly arrested for his crimes in office, and clapped in jail where he died of a heart attack. In the Philippines, the family and cronies of the dictator Ferdinand Marcos returned to the country they had ravaged and fled not too long ago-and were welcomed and feted and given back their sinecures in society and politics, as if the long dark night of martial law had not happened.

The primary victims of Marcos misrule—70,000 people arrested, 34,000 tortured, and 3,240 killed by the military and the police, according to a report by Amnesty International—have been justifiably the loudest in calling for an apology from the dictator's heirs. But why should Imelda and her brood apologize? The local justice system has failed so far to extract any official accountability from them; it was a foreign court that took cognizance of the charges of human rights violations against the Marcos regime and to impose a compensation fund for them, the P10-billion fund to be sourced from a Swiss account holding millions of dollars the Marcoses had stashed

The human rights abuses are well-documented, the court judgment is a fact, and the Swiss account has a paper trail. They are but the tip of the historically verifiable criminal enterprise that undergirded the Marcos years, all



accessible to anyone who knows how to Google. But 43 years since the imposition of martial law, the dictator's son and namesake rejects any notion of apologizing for his family's excesses, thinks it's high time the nation moved on, and considers himself a worthy successor for the old office in Malacañang with which he had at most a glancing familiarity as a callow party boy in the high noon of his father's rule.

And why should Sen. Bongbong Marcos think otherwise, when his colleague, Sen. Chiz Escudero, a declared vice presidential candidate, apparently thinks the electorate wouldn't mind if he spat on the graves of martial law victims and other genuine heroes of the republic by calling for the elder Marcos' burial at the Libingan ng mga Bayani—on the 43rd anniversary of Proclamation No. 1081 at that? Or when Vice President Jejomar Binay, once a human rights lawyer who made his name jousting with Marcos' kangaroo courts, is now warm to the idea of holding hands with him on the campaign trail, all the old pesky issues forgotten in an effort to win the 2016 polls at all costs?

What has made these political animals so confident as to flirt with the idea of trivializing the memory of martial law? Simple. They've been enabled—by an astounding forgetfulness, a sentimental softheartedness, an inability to be angry for long and to demand justice for wrongs done. Forty-three years after the fact and still no apology. For shame. @inauirerdotnet

Pope expresses 'closeness' with **Muslims**

New York - Pope Francis expressed "closeness" with the world's Muslims on Thursday after 717 pilgrims were killed and 863 others were injured in a stampede outside the Islamic holy city of Mecca in the worst disaster to strike the annual century.

evening prayer service at at the St. Patrick's Cathedral in New York City. New York's St. Patrick's Cathedral, the Argentine Pope said he wanted to express "my sentiments of closeness in the face of the tragedy that their people suffered today in Mecca.'

"In this moment of prayer, I unite myself with you all in prayer to God, our father, all powerful and merciful," Francis added.

Pope Francis arrived in New York on the second leg of his sixday US tour, and was greeted by cheering crowds of thousands who lined Fifth Avenue to catch a glimpse of him in his popemo-

Thursday marked the Muslim feast of Eid'l Adha in America, where more than 1,800 public schools in New York closed for the first time in honor of a Muslim religious holiday.

KING ORDERS PROBE

Meanwhile, as blame shifted toward Saudi authorities over the tragedy, Saudi King Salman said he had ordered a review of the kingdom's plans for the annual hajj pilgrimage.

King Salman, speaking in a live speech broadcast by Saudi-owned al-Arabiya television, also said he had asked for a swift investigation into what he described as a painful

> caused by pilgrims failing to follow instructions from authorities shepherding the world's largest annual gathering of people.

> In a statement posted on the ministry's website, the minister, Khalid al-Falih, said an investigation would be conducted rapidly into the worst disaster to strike the annual hajj pilgrimage for 25 years.

> "The investigations into the incident of the stampede that took place today in Mina, which was perhaps because some pilgrims moved without following instructions by the relevant authorities, will be fast and will be announced as has happened in other incidents," the statement said.

> Falih said the injured were being transferred to hospitals in Mecca and if necessary on other parts of the country.

FILIPINO DIES IN HAJJ?

The Department of Foreign Affairs (DFA) on Friday said it is verifying reports that a Filipino pilgrim was among those who died in the stampede in the hajj pilgrimage in Saudi Arabia.

"Our Consulate General in Jeddah is verifying reports that one local Filipino pilgrim died in the stampede in Mecca," DFA spokesperson Charles Jose said.

Reports said there were 8,000 Filipinos who joined the hajj pilgrimage in Saudi Arabia.



a statement issued Sunday, said Carpio's opinion using customary international law (CIL) as basis was not a strong ground for his inhibi-

'Merely an opinion'

"[The] comment was merely an opinion. It was not yet the decision of the SET. Looking at the positive side of Justice Carpio's comment, it was to the advantage of Poe that three Supreme Court jushe disclosed what was in his mind, if ever that would be his final position on this issue. It is now a challenge to church in Jaro, Iloilo Poe's lawyers to prove other-

wise," Macalintal said.
"Who knows, given an argument better than his, Carpio might, after all, be convinced that Poe is a natural-born Filipino citizen under CIL that recognizes the parents of a foundling as citizens of the country where the foundling was found. In other words, Carpio has to be convinced that since the parents of Poe are recognized by CIL as Filipino citizens, then Poe is a natural-born Filipino citizen," he added.

Prejudgment

For former Sen. Rene Saguisag, however, Carpio must inhibit himself from the disqualification suit because the magistrate had already "prejudged" the case with his pronouncement.

"I don't think Justice Carpio should continue on the [SET], having sadly and openly prejudged the case. I think he should have waited until all arguments are in before concluding that Grace is naturalized, not natural-born, which Chief Justice Roberto Concepcion defined as 'one born a citizen," Saguisag said in a statement.

"It seems to me his startling imprudent and egregious prejudgment allows him no wiggle room," Saguisag said.

The SET heard oral argu-

ments on Sept. 21 on the petition brought by defeated senatorial candidate Rizalito David, who questioned Poe's qualification to hold public office, as she is allegedly not a natural-born Filipino.

The parties in the case have until Oct. 6 to submit their final arguments and positions, after which the SET, composed of tices and six senators, will hand down its decision.

Poe was found in a province, after her birth in 1968. She was adopted by movie actor Fernando Poe Jr. and his wife, actress Susan Roces, in 1974.

Under questioning by Sen. Loren Legarda, a member of the SET, during the oral arguments, David's lawyer, Manuelito Luna, admitted that David had no evidence to prove that Poe's real parents were foreigners.

Human rights

Poe, being a foundling, is considered a natural-born citizen under the United Nations' Universal Declaration of Human Rights (UDHR), which states that the right to a nationality is one of the most fundamental human rights, according to Saguisag, a human rights lawyer and advocate.

Under the UDHR, Saguisag said, a foundling "may be the weakest of minorities deserving of special case and assistance, not special discrimination."

Being a pulot (foundling) or ampon (adopted) used to be a traditional vilification modern thought now looks askance at. The UDHR's Article 15 says: Everyone has the right to a nationality," Saguisag

From birth

He added: "Grace should not be denied that right. And nationality should attach at birth, not a day, week, month, a year later, an unmanageable standard. When was she naturalized, assuming she needed to be? Naturalized from what other nationality? Naturalization implies a change in nationality. Or assumed two citizenships," he said.

Saguisag also supported the opinion that the burden of proof could not be shifted to Poe, who enjoys the presumption of being a natural-born citizen.

"When will we stop vilifying foundlings? They have parents, [although] unknown. It seems to me to put the burden on David in this seeming case of first impression is legally tenable, intellectually respectable and psychologically satisfying," he said.

Retired Chief Justice Artemio Panganiban also disagreed with Carpio and agreed with Macalintal that Poe is considered a naturalborn citizen under the generally accepted principles of international law, which form part of the law of the Philippines.

In his column in the Inquirer, Panganiban cited Article 2 of the 1961 Convention on the Reduction of Statelessness, which says: "A foundling found in the territory of a Contracting State shall, in the absence of proof to the contrary, be considered to have been born in the territory of parents possessing the nationality of that State.'

He recalled that the 1935 Constitution, which was the country's basic law in 1968 when Poe was born, provides that the Philippines

Here's a great look at China's major new runway in the South China Sea

Satellite imagery shows that China has finished construction of a major runway on a dredged reef in the South China Sea, IHS Jane's Defense Weekly reports.

The images show that China has recently finished constructing a military length runway on the Fiery Cross Reef in the Spratly Islands, an island chain primarily claimed by both the Philippines and China. Jane's estimates that the runway will soon become operational, granting Beijing a wealth of benefits and further operational advantages in the disputed region.

"The completion of the runway, which previous imagery suggests only occurred in recent weeks, will allow China to accelerate construction of infrastructure and potentially start air patrols over the Spratly Islands, which are claimed and occupied by a number of countries," Jane's notes.

The 3,125 meterlong runway is sufficiently lengthy for military operations. In addition, the runway is complete with helipads.

The runway on Fiery Cross is merely the first of many completed runways that China is building throughout the South China Sea.



Duterte: Give me time to do 'final soul-searching'

MANILA, Philippines - Davao City Mayor Rodrigo Duterte's ardent supporters once again have reason to hope.

In a text message addressed to his supporters gathered at the Rizal Park on Saturday, September 26, he told them he would do "some final soul-searching with myself and my

family," in relation to the clamor for his presidential bid.

He ended his text message by saying that he would make his decision soon and won't let them down.

"Magdedesisyon ako ng buong kalooban at mula sa puso. Pangako ko sa inyo hinding-hindi ko kayo pababayaan (I will make my decision from the heart. I promise you, I won't abandon you)," he said.

Former Armed Forces chief General Heartened crowd Hermogenes Esperon Jr, a friend of the popular mayor, read the text message to Duterte's supporters in front of the Quirino Grandstand.

Duterte's spokesperson, Peter La Viña, confirmed to Rappler that the message was sent by the mayor at 5:50 pm.

Here is his message in full:

"Salamat sa lahat ng mga taong nagbigay ng suporta. Tiniis daw ninyo ang init at ulan. At ako ay humihingi ng paumanhin. Nandito ako sa Zamboanga City dahil tumutulong ako sa paghanap ng solusyon sa kidnapping na nangyari sa Samal Island noong Lunes. Maraming maraming sala-

(Thank you to all the people who have given me your support. I was told you endured the heat and rain. I'd like to apologize. I am in Zamboanga City to help find a solution to the kidnapping incident that happened in Samal Island last Monday. Thank you very much.)

I hear your clamor loud and clear. I know you want an alternative to those who now present themselves with their ambition to lead the country. I have repeatedly said that I do not have ambitions to be your president. Leaders answer not their selfinterest or their personal glory. Leaders respond to duty and moral obligation.

Sa lahat sa kababayan natin, humihingi ako ng konting panahon (To all our coun. trymen, I am asking for some time), so I can do some final soul-searching with myself and my family.

(And after, in just a short time, I will face the country and all of you. And I will make my decision from the heart. I promise you – I will not abandon you.)"

His supporters greeted the message with invigorated cheers, despite the steady drizzle.

Duterte's message comes days after the release of a Social Weather Stations survey that showed he was 4th among voters' preferred presidential candidates.

Duterte made the statement nearly 3 weeks after the Davao City mayor made a "categorical" announcement that he would not seek the presidency.

He previously listed as reasons his age and health, his family's opposition, and his unwillingness to accept money from big busi-

Supporters from various sectors spoke during the gathering, each one pleading with Duterte to run for president. (READ: 22 things know about 'Duterte Harry')

Former North Cotabato governor Manny iñol, one of the speakers, said Duterte is not playing coy.

Maraming nagsasabi nagpapanggap lang si Rody Duterte na aayaw-ayaw, pahele-hele. Hindi po totoo yan. Ang totoong damdamin ni Duterte, ayaw niya talagang maging pangulo ng Pilipinas (Many say Rody Duterte is only pretending, saying no. That's not true. Duterte really doesn't want to be president of the Philippines). But, I believe that Rody Duterte is a leader that listens to the people.

He pointed out that the latest surveys still show a clamor for Duterte:

"Si Duterte sabi niya 'ayaw ko,' but he's still there 16,15%. Ano pa kaya kung sabihin ni Duterte, 'sige na nga'? (Duterte said, don't want to run,' but he's still there, 16, 15%. What more if he says, 'Okay, I'll run'?)" Piñol said.



Malacañang: "Laglag bala" incident an isolated case

Palace guarantees that the "laglag bala" modus operandi incident is an isolated case.

Presidential Communications Operations Office Secretary Herminio Coloma on Sunday assured the public that the "laglag bala" modus operandi should not be a cause of concern as the incident is an isolated case.

Coloma said the Office of Transport Security of the Department of Transport and Communications and the board of Manila International Airport Authority (MIAA) already conducted probe on the said modus operandi of planting bullets in passengers' personal baggage, otherwise known as "tanim bala", showing that the reported foreign guest' case is

"Natunghayan ko rin iyong kanilang ulat, at sa kanilang pananaw, ito ay isang isolated case lamang at hindi naman dapat ikabahala," Coloma said in an interview with DZRB.

Coloma assured that the government prioritizes the safety of passengers citing the duly response of the MIAA and



Civil Aviation Authority of the Philippines to prevent the cases by tightening security in all airports across the

country.

According to Coloma the government will see to it that people responsible and involved behind the modus operandi will be punished by the law.

"Ang pangunahing isinasaalang-alang ng pamahalaan ay ang kaligtasan at katiwasayan ng mga pasahero sa lahat ng paliparan," Coloma said.

Meanwhile Coloma said the government also gives the Congress freedom to decide on conducting another investigation regarding the case.

The "laglag bala" modus operandi became public after some foreign guests recently posted in social media that their baggage were "planted" with one or two live bullets and the security personnel asked money so they would get away with the "offense" and would be set free.

A 20-year old tourist identified as Michael White was detained for five days by the police for hiding bullet in his baggage which he claimed was not of his knowledge. The foreigner alleged that an airport security personnel offered settlement of P30.000.

adopts the generally accepted principles of international law as part of the law of the nation.

"[S]he—a foundling who was found in Iloilo, Philippines—is deemed to have Filipino parents. Perforce, she is naturalborn since her presumed parents, specifically her father, are accorded Philippine citizenship," Panganiban said.

Panganiban also said it was actually Poe's parents who acquired Philippine citizenship pursuant to international law. "She derived her citizenship from her presumed Filipino father; thus, she is a citizen from birth without having to do anything to acquire or perfect her Philippine citizenship," he added.

The 1935 Constitution provides, among other things, that those whose fathers are citizens of the Philippines are considered

Filipino citizens. Burden of proof

Panganiban said Poe's biological father may be proven to be actually a foreigner, "but the burden of proof belongs to those who challenge her natural-born status."

Unless such proof is presented, her parents continue to be presumed Filipinos. Thus, she retains her natural-born citizenship," Panganiban said.

Although the Philippines is not a signatory to the 1961 convention, Panganiban said it was still bound by its provisions because they had become "generally accepted principles of international law, which ... are as binding as statutes passed by Congress.

Apart from the 1961 convention, he said, foundlings are also protected by the 1930 Hague Convention on the Conflict of Nationality Laws and the 1948 UDHR, which states that the right to a nationality is one of the most fundamental human rights.

7ith all the hoopla following the signing of Enhanced Defense Cooperation Agreement (EDCA) between the Philippines and the United States on April 28, 2014 in Manila, one would expect American military forces to be deployed to at least eight strategic locations to protect the Philippines from external forces intruding into her territory.

But 16 months have passed and not a single American troop has landed on Philippine soil. Meanwhile, China began reclaiming seven reefs in the Spratly archipelago - all within the Philippines' 200-mile exclusive economic zone (EEZ) - and building artificial islands on them. And, on these "islands," the Chinese are constructing military structures including a runway and harbor on Fierv Cross Reef that can accommodate China's biggest bombers and large warships.

And from these "unsinkable aircraft carriers," China can then send her warplanes or ballistic missiles to any region in the Philippines. With no missile defense shield, the Philippines is indefensible. This would be a situation that would compel the Philippines to invoke the U.S.-Philippines Mutual Defense Treaty (MDT). But the question is: How long would it take for the U.S. to mobilize an expeditionary force to liberate the Philippines in the event that it was invaded? With her military forces thinly spread out all over the world, can the U.S. spare enough manpower and military assets to liberate the Philippines?

During the presidency of Ronald Reagan, his Defense Secretary Caspar Weinberger devised a MDT to repel foreign invasion, the

The following year, Gen. Colin Powell, the Chairman of the Joint Chiefs of Staff, updated the Weinberger Doctrine, based on the lessons learned from the Gulf War. The modified Powell Doctrine contains eight steps, to wit:

- 1. Is a vital national security interest threatened?
- 2. Do we have a clear attainable objective?
- 3. Have the risks and costs been fully and frankly analyzed?
- 4. Have all other non-violent policy means been fully exhausted?
- 5. Is there a plausible exit strategy to avoid endless entanglement?
- 6. Have the consequences of our action been fully considered?
- 7. Is the action supported by the American people?
- 8. Do we have genuine broad international support?

> to go through each step of the Powell Doctrine before deciding to send troops and weaponry to the Philippines.

An oft-repeated question from leftist and nationalist groups in the Philippines is: "Why is it that the U.S. would defend Japan and South Korea but wouldn't defend the Philippines in the event of a foreign invasion?" The answer to this question is in step one of the Powell Doctrine: "Is a vital national security interest threatened?" The answer is "No."

Tripping the wire

However, it would have been a different situation if there were American bases in the Philippines, which was the case before the Philippine Senate evicted the bases in 1992. The presence of American forces on Philippine soil would serve as a "tripwire," which could trigger immediate reaction from American troops stationed in the Philippines.

A case in point is Japan and South Korea where 50,000 and 28,000 U.S. troops are stationed, respectively. There are American airbases in both countries. The



Bongbong: In his father's footsteps

"Bongbong" R. Marcos ate in 2010, a lot of people have been wondering if he'd pursue a higher office when his term ends in 2016. Being the only male offspring of the late President Ferdinand E. Marcos, a dictator who ruled the Philippines for two decades, Bongbong is presumed to have an eye on the presidency for a variety of reasons. Foremost would be to follow in his father's footsteps and regain the "glorious" years of the Marcos era.

On February 25, 1986, Marcos talked to U.S. Sen. Paul Laxalt to seek advice form the White House. Laxalt, after consultation with the White House, advised him to "cut and cut cleanly." Felt abandoned by the White House, the Marcoses fled Malacanang. They were picked up by a U.S. helicopter and transported to Clark Air Force Base where they boarded a C-130 plane bound for Hawaii. They lived in exile in Honolulu, Hawaii until Marcos' death on September 28, 1989. A few years later, the surviving members of the Marcos family went back to the Philippines.

Political comeback

In 1992, Imelda ran for president but lost. In 1995, she ran for Congress and won as representative of Leyte, her province. It signaled the Marcoses' political comeback.

Today, Imelda Marcos is a member of Congress representing her husband's old congressiodaughter Imee Marcos is now the Governor of Ilocos Norte and Bongbong is a Senator.

It's always been Imelda's dream to see her only son become president of the Philippines. She made

ver since Sen. Ferdinand it known when Bongbong was that brought us to elected to the Senate in 2010. Due for re-election in 2016, Bongbong has to decide whether to run for re-election to the Senate or for a higher office, which would either be President or Vice President.

He was inspired by a strong pro-Marcos sentiment, particularly among the young people who are now saying, "Marcos kami." Although he has a strong following in the social media, he is lagging behind in the Social Weather Stations (SWS) and Pulse Asia polls.

Buoyed by his social media supporters urging him to run for president, he tackled the number one issue against him if he ran for president; that is, questions about his father's brutal dictatorship.

No apology

Bongbong-Marcos-and-father-During an interview with ANC's Headstart last August 26, Bongbong responded to questions on whether he would apologize for the "corruption and human rights abuses" during his father's presidency if he decides to run for president or vice president? His response was terse: "What am I to

say sorry about?" Then he added, Will I say sorry for the thousands and thousands of kilometers [of roads] that were built? Will I say sorry for the agricultural policy

self-sufficiency in rice? Will I say sorry for the power generation? Will I say sorry for the highest literacy rate in Asia?

What am I to say sorry about?"

Bongbong had been defending his father's record since he was elected to the Senate. He said "recent political history" looked favorably on his father's legacy. "Being a Marcos is not a political liability but is even an advantage." He added that there was a "constant refrain" that goes: "It was better during Marcos' time, life was more comfortable: the government helped us. There were many programs and projects. Since he was replaced, we no longer experienced that. We hope that comes back." [Translated from Tagalog]

However, with all the hoopla about Bongbong's defense of his father, he emphasized that he's still thinking whether to run for president or vice president. He's still exploring possible tandem with either Binay or Duterte. But

he pointed out that whatever he decides, he's not leaving the Nacionalista Party (NP), which raises the question: If the NP endorsed Poe as its standard bearer, is Bongbong willing to be Grace's vice presidential running mate?

Ilocano Vote

Marcos-pa-rinRegardless whether Bongbong runs for either office, he is counting on the "Ilocano Vote," which he differentiated from the "Solid North" that supported his father's political ambitions. While the "Solid

North" is a geographical designation of Northern Luzon, which has a large number of Ilocanos, the "Ilocano Vote" is everywhere, from the Ilocano stronghold of Northern Luzon to Southern Mindanao including Palawan where one of the major languages spoken is Ilocano. And don't discount the Filipino diaspora that is dominated by Ilocanos, particularly in Hawaii and the agricultural farmlands of California.

With the clannishness of Ilocanos, it is not unusual to hear Ilocanos proclaim their loyalty to Marcos Sr. with the words, "Marcos pa rin kami" (We're always be for Marcos). The question is: Would Bongbong be able to get the support his father got from Ilocanos?

One of the strengths of Marcos Sr. was his oratorical prowess in the use of the Ilocano language. Would Bongbong be able to communicate with Ilocanos in their native language? If there was one element that unifies the Ilocanos, it is because they spoke only one Ilocano language regardless of where they are. Marcos Sr. mastered his eloquence of the Ilocano language. Can Marcos Jr. do the same?

Popularity ratings

Bongbong-Marcos-pa-rinIf Bongbong is going to run for president or vice president, he should make an aggressive effort to improve his popularity ratings. In the June 2015 Social Weather Stations (SWS)

Bongbong surveys, got 3% (ranked ninth) in the presidential survey and 1% (ranked 13th) in the vice presidential survey. In the June 2015 Pulse Asia survey, Bongbong got 9% (ranked fifth) in the "preferred vice president" category

and none in the "preferred president" category.

The polls were taken 11 months prior to the May 2016 elections, which gives Bongbong enough time to catch up; however, he has to work aggressively to improve his rank in the polls.

Given the controversy that he created when he defended his father's martial law regime, Bongbong is probably betting that a large number of post-martial law babies are now of voting age. With no experience of the harsh years of martial law, Bongbong could easily sway these young voters by crystallizing the positive achievements of his father, and burying the negatives in an avalanche of positive things. But there are still a large number of those who saw the brutalities of the martial law era and would most likely vote against Bongbong.

Bongbong likened his father to the late Prime Minister Lee Kuan Yew of Singapore, saying that his father could have done a lot more if he remained longer in power. Does it seem like Bongbong is going to follow in his father's footsteps and continue his "unfinished" work?

Surmise it to say, if Bongbong wins, it would be a vindication of his father. If he loses, then it will give the people a glimpse of how history will treat Ferdinand E. Marcos. It has been said, "Time heals all wounds." But the wounds are deep and it might be too soon for healing... if it ever will.

Two Lunas, two Mabinis

OCIAL MEDIA comments on "Heneral Luna" make me smile. Someone posted that the film is a "fair" retelling of a bloody episode in Philippine history. It is actually unfair to Emilio Aguinaldo. As to the casting of Epy Quizon as Apolinario Mabini, right on, I thought, because he resembles the Mabini in monuments. But then someone asked, why is Mabini seated throughout the film? I thought all schoolchildren knew about Mabini being the "Sublime Paralytic" (or "Dakilang Lumpo").

Everyone who comes out of "Heneral Luna" blames Aguinaldo—an oversimplification because history is more complex than our textbooks make it out to be. History is not about memorizing "facts" or reacting emotionally, but being critical of facts and narratives. Aguinaldo is a soft target in a complex story where there are other villains. Some of the villains are not people but flaws in human nature and Philippine society.

In 1984 the eminent historian Teodoro A. Agoncillo gave me his take on Antonio Luna, recalling his word war with Vivencio Jose (author of "The Rise and Fall of Antonio Luna") that appeared on the pages of Solidarity. Agoncillo made two points worth remembering: first, that there were two sides to Mabini—one pro-Luna and the other anti-Luna; and second, that there were two Lunas—one who was against the Philippine Revolution against Spain in 1896, and the other who fought in the Filipino-American War.

In my interviews with Agoncillo, he said: While Aguinaldo is not personally involved in the death of either Luna or Andres Bonifacio, he should be held to account for the behavior which he did not order investi-

gated.

Ambeth R. Ocampo: Do you think he tried to cover up?

TAA: That was Aguinaldo's mistake. Granted, Luna was assassinated. Why did he not order the investigation of those people who assassinated Luna? That was his responsibility. I'm not pro-Aguinaldo or pro-Bonifacio. I judge a person on the basis of the documents available. If the time comes that I am proved wrong and other documents are shown, then I'll accept it. Conclusions are not final, because nobody can say that I have exhausted all my sources. No! Ang anti-Aguinaldo si Vivencio Jose, masyadong pro-Luna. This is the kind of thinking I do not like.

ARO: [But that is your interpretation.]

TAA: Hindi! [Jose] suppressed the documents. It's all right if it is a question of interpretation, but the trouble is he suppressed. Kahit na kasalanan ni Luna, he is trying to suppress [the documentation]. Example: the letter of Mabini to Aguinaldo denouncing Luna. Hindi niya binanggit. The letter of Baldomero [Aguinaldo] to [Emilio] Aguinaldo denouncing Luna? Hindi niya

inilagay. Ang sabi lang niya, naiinggit lang iyong mga taong attacked.

ARO: Mabini wrote later, Noong bandang huli, kung hindi pinatay si...

TAA: That is the superficiality of these people. Mabini is inconsistent. Firstly anti-[Luna] later pro-[Luna]. You should study [the sources and the motives]. If you are really critically minded, why is this fellow now anti-Aguinaldo? You should try to discover why.

"In historical methodology, it says that the more private a communication is, the more authoritative it is. In a letter, in 1899, to Galicano Apacible whom he called Canoy and Calvo, Mabini denounced Luna and praised Aguinaldo. Then in that Guam opus 'La Revolucion Filipina,' binaligtad. The historical methodology says the document which is not meant for the public but for private eyes is more authoritative than the one for the public eye. Why? Because when you are writing to a friend, more or less you are sincere, because what you write to him is your secret feeling. But when you write for publicity, [it's the other way around]. This is historical methodology, and in Guam Mabini was writing for

publicity to justify [himself]. At that time he was already bitter against Aguinaldo. Why was he bitter against Aguinaldo toward the end? Because Aguinaldo did not follow his advice. He was too intransigent. So, in using the two Mabinis, you have to exercise your critical thinking."

What I did not know at the time was that Luna denounced the Revolution of 1896. This Agoncillo did not take lightly, and he roared:

"Minamana mong sabihin na si Luna was the leader of the revolution against Spain? P-ñeta! Since when did Luna fight against the Spaniards? He never fought the Spaniards, tapos sasabihin niyang leader? As a matter of fact, Luna was a traitor to the Revolution of 1896! Alam mo, I will write an essay on Luna and Aguinaldo. I will write an essay kung bakit maraming nagalit kay Luna, and I'll justify, sapagkat Luna not only did not join the Revolution of 1896, he was [also] a traitor! Nagturo yan a! Nagturo! Pero inilagay ba ni Vivencio Jose iyan? Wala! Maraming hindi inilagay si Vivencio roon, either because of ignorance or ibig niyang palakihin si Luna. As a matter of fact, I do not consider Luna a hero. How did he become a hero? He never won any battle, papaano mo sasabihing hero iyan?

ARO: Unrealized kasi ang role niya in Philippine history eh.

TAA: He never won a battle! Um! Pagkatapos sasabihin ni Vivencio, kung sinunod daw si Luna, yung guerilla warfare. Noong panahong sinasabi niyang maggegerilya, hindi maaari ang guerilla eh because the Americans were still weak at the time, papaano gegerilyahin iyan? Pangalawa, there was no preparation for guerilla warfare. Hindi niya ina-analyze. All that he wants is to justify all the things that Luna did."

History has left us with two sides of Mabini, two sides of Luna.


COED's First Graduate is a Magna Cum Laude

Frustrated in losing weight?

tried to lose weight several times but I failed. I tried outdoor activities such as jogging, lawn tennis, biking and indoor treadmill and other physical exercises but I can't sustain the momentum. There were times I would say I'll do it tomorrow but when tomorrow comes I was lazy to do it. In short, I was doing procrastination all those times. I tried to control my diet to lose extra pounds but my appetite has been good most of the time. My satiety value for food has been always positive, not to mention my wife cooks good. Tried to google techniques in weight loss and the search engine gave me several. Tried some of them but again I was unsuccessful. I failed. Failure in life is not the end and it doesn't define who we are. After all, it's up to us to find ways to succeed. As the old adage goes, "As long as the sun rises in the east there is hope."

One day I was browsing in my favorite social media site called "facebook", I come across an ad at the news feed which says, "20 pounds in 6 weeks at Results Transformation Center." It got my attention. I clicked the site and read what was stored in there. I was interested. I then registered for the orientation at their Elk Grove branch, the 5th branch in Sacramento which is about two miles away from home. After listening to their talks, I signified my intention to join. I paid a conditional registration and processing fees of \$510. The agreement says I can have my money back, per signed contract, when I lose 20 pounds in 6 weeks. How is that? Would you bet your money in exchange of good health? Where in the world can you find a gym that provides you a coach daily and teach you to lose weight scientifically? Results Transformation Center is the answer.

On Saturday, July 18th, I joined the 300+ participants at Double Tree Hotel in Sacramento for a formal briefing and orientation on weight loss. The activity includes lecture on the importance of nutrition for the success of the program. The following Monday, July 20th, I started my 6 weeks 20 pounds challenge.

The techniques are simple two words: diet and exer-

As a general rule, weight loss is 75 percent diet and 25 percent exercise. First technique is to Stick To The Food Plan (STTFP). Planning is vital in everything. Failure to plan means planning to fail. As advised, it is much easier to cut on calories than to burn them. Based on recommended STTFP, a challenger is recommended to eat or drink fluids every three hours. I created my meal schedule: breakfast at 0600, snack with protein drink at 0900, lunch at 1200, snack at 1500, dinner at 1800, and last snack at 2100. A meal must have protein, carbohydrate, vegetables/fruits, and water.

The size of protein must be as big as the size of your open hand or smaller. The size of carbohydrate must be as big as your closed fist or smaller. The size of vegetables/fruit must be as big as the size of your two open hands. A challenger must drink at least one gallon of water per day. When you feel thirsty drink some water. Don't let yourself be hungry. Fresh vegetables and fruits are available at your favorite stores. I prefer to buy at Farmer's Market where organic produce are sold cheaper. Then you cook your own food. If you don't know how to cook, learn to. The food you cook is clean and healthy. Fresh farm produce taste better and sweeter.

Second technique is one hour of moderate physical exercises per day. Exercise improves your muscle mass and bone density and for a

challenger to sweat those body waste and toxins out. Endorphin, by the way, is good; it makes you feel fulfilled and happy. Expect muscles to be sore on the 2nd, 3rd, and 4th day of training. Glutamine powder drink is advice to help sore muscles heal fast. Powder drink with amino acid or its equivalent is excellent in replenishing electrolytes. Remember micronutrients are not produced by the body. We get it from food sources. It is also prudent to have your labs check during or after the challenge. It is important to see blood chemistry like sodium and potassium. Just for the information of others and as a caveat to those who don't know, serum sodium is diluted when you drink plenty of water, and potassium, on the other hand, goes with the urine when you pee. When sodium is low, tendency is, a person gets confuse. And if the potassium is low, a person might get arrhythmia or irregular heart rhythm that will lead to heart problem. If any of these happens, talk to your doctor. Banana, avocado, broccoli, and orange juice are good sources of potassium. Table salt is a good source of sodium.

Once you strictly follow the above mentioned two important techniques with discipline, will, and determination, I bet you'll achieve your goal and you won't be the same again. In my case I lost 23.4 pounds in 6 weeks which exceeded my target 20 pounds weight loss. I feel way much better today with lighter weight than before the challenge. (gabbyortig@yahoo.com)

'Bagong Buwan' (2001)
