Economy grows 5.8% in 2015

at a pace of 6.3 percent in tal value of all goods and the fourth quarter of 2015, 5.8 percent, the government outpaced most of its peers. announced Tuesday.

Last year's economic expansion was slower than the 6.1-percent growth in 2014. It also fell short of the Aquino administration's target of 7 to 8 percent.

The National Economic and Development Authority (NEDA) said the 2015 growth gave a six-year average of 6.2 percent, the highest since the late 1970s.

The fourth quarter growth, meanwhile, was expectedly the highest quarterly growth for the year. Yet it is still slower than the 6.6 percent posted in the same period in



The Mamasapano saga continues

he recent hearing of the Mamasapano incident, in a way, was more of the same and a lot different at the same time.

The brilliant questioning of Senator Juan Ponce Enrile did not

disappoint although many of the respondents stuck to most of their original answers even though it was already obvious that they were lying through their teeth. But I digress.

I talked about the importance of the chain of command in the military and the consequences that may come about should this chain be broken.

Incidentally, Senator Gregorio Honasan apparently had the same concept of the importance of the chain of command even as he underscored that even the family has a chain of command. He expounds that the father is the titular head with the mother as next in command followed by the "panganay."

In fact, a visibly bothered Honasan said "kaya tayo minsan naiisahan kasi 'yung mga terorista sumusunod sa chain of command, tavo hindi.

A miffed Senator Enrile questioned former AFP Chief of Staff Gregorio Catapang why the "beleaguered SAF troops" were not given immediate assistance or air assets to aid them in the operation that was taking a

Catapang said the tactical commanders were the ones running the show and stated, "We follow the chain of command, your honor. The decision to use the helicopter was relegated to the tactical commanders. We don't macromanage (micromanage) operations

because if we do that, every time there are encounters, they will ask me what to do. Pangilinan was making the decision, the battalion commander, lieutenants; that's their job. I can't macromanage (sic) them.'

Under these circumstances, it was also the ineptness of the tactical/ground commanders that did in the SAF troopers. That is what I would call the weakest link in the chain of command.

Yes, in this issue I agree with Catapang.

In fact, the Chief of Staff is not even supposed to delve into the operations aspect of AFP operations. You have the service commanders - the commanding generals of the Philippine Navy, Philippine Air Force and the Philippine Army – to do that.

This does not dilute, however, my admiration for this grand old man of the Senate whose sharp intelligence and wit continue to cut into the arguments of the resource persons.

As I write this, it is a continuing saga for the people involved in the Mamasapano incident. I continue to root for Senator Enrile that he can ferret the truth from all the gobbledygook that is spewed in the hearing.

And while I know that this is supposed to be in aid of legislation, I truly hope this travesty can be corrected. It would be best if the executive can help correct the loopholes in the

Enrile blames President for SAF 44 massacre

he line of command in the Armed Forces of the Philippines was paralyzed the day 44 elite troopers were massacred in Mamasapano a year ago.

Sen. Juan Ponce Enrile, seeking to prove an alleged failure of leadership, Wednesday said President Aquino had "compartmentalized" the Mamasapano operation on Jan. 25, 2015, that left out the existing police and military hierarchy, immobilizing ground commanders at the critical moments and leading to the massacre of the Special Action Force (SAF) commandos.

Enrile said Wednesday at the reopening of the Senate inquiry into the slaughter of the SAF troopers after they had killed Malaysian terrorist Zulkifli bin Hir, alias Marwan, that the planning and execution of "Oplan Exodus" were left only to Alan Purisima, the then suspended chief of the Philippine National Police, and Getulio Napeñas, the director of the Special Action Force (SAF) who had been sacked.

In a meeting in Malacañang's Bahay Pangarap on Jan. 9, with Napeñas, Purisima and Supt. Fernando Marquez, the President gave the go ahead that Interior Secretary Mar Roxas and then the PNP officer in charge, Deputy Director General Leonardo Espina, be informed of the operation "time on target" when the SAF troopers were on the ground.

Purisima also later said he would take care of informing Gen. Gregorio Pio Catapang Jr., the then Armed Forces chief of staff on the day of the operation to get Mar-

Enrile berated Catapang for not responding fast enough to help the trapped SAF men. He was irked at Catapang at first when he asked the number of military troops sent to aid the SAF men and the former AFP chief replied by saying this AFP chief of staff said this was the

could be answered by Maj. Gen. Edmundo Pangilinan, commander of the 6th Infantry Division.

"For heaven's sake, you are the chief of staff. If we are at war with China, and that is what you do, this country is doomed," Enrile said.

Critical situation

He also asked why Catapang called his staff to make an assessment on the "criticality of the situation" of the SAF men. To which Catapang said they were not informed about the operation against Marwan.

'The Army should operate at the tip of your fingers in case of emergency. You are not supposed to remove your boots, that's the manner of preparedness of the Armed Forces. You must be prepared all the time, at any time anywhere,'

Noting that the military was not informed about the operation, Catapang admitted that it took sometime for the military ground commanders to "react at the tacti-

Catapang also said there were two helicopters prepositioned in Cotabato province that day but the PNP did not request air support.

"My God, do you really need a request to support a beleaguered troop? My goodness," Enrile said. Catapang replied: "We follow the chain of command. The decision to utilize the helicopters was delegated to our tactical commanders.

Enrile asked Catapang if he informed President Aquino about the ground situation and the former

"So the line of command was paralyzed that day. The command system of the AFP and the PNP was paralyzed on that day and that was the reason for the loss of 44 people," Enrile concluded.

Eight blunders

He said this compartmentalization was among eight blunders that the Chief Executive committed in the planning and execution of Oplan Exodus, the code for project Marwan, and these were "at the center" of the Mamasapano debacle.

Saying he was out to seek justice for the dead and survivors in the bloody clash with Moro rebels after Marwan was killed, Enrile blamed Mr. Aguino for the Mamasapano debacle as he pointed out the role the President played in the police operation.

After the seven-hour hearing of the Senate committee on public order, Enrile said he focused on the President's role, responsibility and accountability in the Mamasapano episode because this was not discussed in the earlier hearings of the committee chaired by Sen. Grace

He said he had "established" the President's role in the operation, and that Wednesday's hearing was enough.

Asked on the possible liability of Mr. Aquino, he said that this will be up to the courts if this reaches them. "Let the law enforcement people do the job in the future," Enrile said.

Fulfilling promise

In his opening statement, Enrile said that he was just fulfilling his promise to the wounded SAF survivors who were confined at the PNP General Hospital in Camp Crame, Quezon City. Enrile was detained there on a plunder case against him in connection with his alleged misuse of pork barrel funds but was released on bail in August last year.

Philippines, Japan forge stronger ties

MANILA, Philippines - Under the cloud of China's aggressively staking maritime territorial claims, Japan's Emperor Akihito and Empress Michiko arrived in Manila yesterday to forge stronger ties between their country and the Philippines.

President Aquino was on hand for planeside honors for the Japanese royals at a special hangar at the Ninoy Aquino International Air-

It was the first time for Akihito to visit the Philippines as emperor. He was two weeks short of his eighth birthday when Japan bombed Pearl Harbor in Hawaii with the blessings of his father, the late Emperor Hirohito, setting off the war in the Pacific that would lead to the Japanese invasion of the Philippines.

Since then ties have improved between the two former foes, linked by their common ally the United States. Japan is now the Philippines' single largest source of official development assistance and Japanese businessmen are among the biggest investors.

With China staking claims on islands occupied by Japan and claimed by the Philippines, Manila and Tokyo have also strengthened defense cooperation.

The imperial couple met the Japan Overseas Cooperation Volunteers yesterday afternoon shortly after their arrival.

Today, the imperial couple is scheduled to attend a welcoming ceremony at Malacañang and meet Aquino in the morning, and visit a cemetery for Filipino victims to lay flowers in the afternoon.

After that, they will return to the palace for a state din-

On Thursday, the imperial couple is expected to meet some people of Japanese descent living in the Philip-

On Friday, they will travel to Caliraya by helicopter and lay flowers at a monument installed by the Japanese government to commemorate the war dead, before returning to Japan the following day.

Former Japanese Foreign Minister Masahiko Komura will serve as principal atten-

Around 1.1 million Filipinos and 518,000 Japanese soldiers and civilians perished during the war.

The Imperial Japanese Army launched air strikes on the Philippines, then a US colony, on Dec. 8, 1941 (Dec. 7 Hawaiian time), the same day Japan attacked Pearl Harbor in Hawaii, marking the start of the Pacific phase of World War II.

Japan occupied Manila in January 1942, while local residents continued to resist the move through guerrilla fighting. A month of Japan-US fighting in Manila in February 1945 claimed the lives of around 100,000 Fili-

Japanese people were lost during the previous war. Especially, an enormous number of innocent Filipino civilians fell victim in the urban combat in Manila," the emperor said prior to departure from Tokyo's Haneda airport.

"We'd like to carry out this visit while always bearing this in mind," he said, adding that he is pleased to travel to the country again following a previous visit by the couple in 1962 when they were crown prince and princess.

Their return after more than half a century comes at the invitation of President Aquino, extended during his state visit to Japan last June.

The trip was arranged on the occasion of the two countries marking the 60th anniversary of the normalization of bilateral ties in

With a strong desire to mourn all the war dead, the emperor has been traveling with the empress to places hit hard by the war at home and abroad, including Saipan, one of the Northern Mariana Islands, in 2005 and Palau last year, in commemoration of the 60th and 70th anniversaries "In the Philippines, many of the war's end in 1945.

Cardinal Tagle: Corrupt politicians part of 'throwaway culture'

CEBU CITY—Manila Archbishop Luis Antonio Cardinal Tagle criticized corrupt politicians and said they were part of the "throwaway culture" condemned by Pope Francis.

Speaking on the fifth day of the 51st International Eucharistic Congress (IEC) being held here, Tagle noted that materialism and individualism had skewed traditional values and there was a need to foster the "culture of giving and sharing.'

"Politicians, will you throw away people's taxes for your parties and shopping or guard them as gifts for social services?" the prelate said.

While urging dialogue with "traditional and emerging cultures," Tagle warned against dealing with people whose values are contrary to Christianity's, apparently referring to materialism and individualism.

"We should avoid cultures with widespread acceptance but incompatible to Christian values," he said.

Meanwhile, Cardinal Peter Erdo of Hungary contrasted the vitality of Catholicism in the Philippines with the dormant faith in former Communist coun-

tries of Eastern Europe.

Delivering the homily for the High Mass on the fifth day of the IEC, Erdo noted that while there were many young people actively participating in the churches of Cebu, there was nil participation by young people in Hungary.

Erdo said that the situation in Eastern and the rest of Europe was correctly likened by Pope Francis in the latter's address to the European Parliament last November 2014 in which he noted the continent's "weariness and aging.

Pope Francis likened Europe to a "grandmother, no longer fertile and vibrant," pointing out that "the great

ideas which once inspired the continent seem to have lost their attraction, only to be replaced by the bureaucratic technicalities of its institutions.'

Like the Pope, Erdo blamed materialism and individualism for the decline of Christianity in Europe.

Erdo said that during the rule of the Communists, Hungarian fathers were made to choose by the Communist Party between keeping their jobs and renouncing their faith.

He said many chose to keep to the faith at the risk of losing their livelihood because of their belief and "hope in eternal life."

(We need) trust in eternal life," Erdo declared

Teausant, 22, of Acampo, pleased guilty to attempting to provide material support or resources to a foreign terrorist organization, announced Assistant Attorney General for National Security John P. Carlin and United States Attorney Benjamin B. Wagner.

According to court documents, on March 17, 2014, Teausant was arrested near the Canadian border en route to Canada with the intent of continuing to travel to Syria to join the Islamic State of Iraq and the Levant (ISIL), a foreign terrorist organization. On March 26, 2024, Teausant was indicted on one count of attempting to provide material support or resources to a terrorist organization. He pleased to the single count indictment with a plea agreement. Teausant is scheduled to be sentenced by United State District Judge John A. Mendez on March

"Nicolas Michael Teausant attempted to travel overseas to join ISIL and to provide material support to the the terrorist organization," said Assistant Attorney General Carlin. "The National Security Division's priority is counterterrorism, and we are committed to stemming the flow of foreign fighters abroad and holding accountable those who attempt to provide material support to designated foreign organizations.

"This case, like others in communities across the United States and around the

Sacramento, Calif. --- Nicolas Michael world, is an example of how a young person from any place and any background might make the terrible decision to try and become part of a terrorist organization, "U.S. Attorney Wagner stated. "Fortunately, the FBI intervened in this case before any harm could be inflicted upon innocent persons. We hope that this case will be a reminder to us all to stay vigilant and involved in the lives of our youth and in particular with respect to the dangerous influences they may be subject to on the Internet where these organizations are very active."

This case was the product of an investigation by the Federal Bureau Of Investigation, the Modesto Police Department, and the San Joaquin Sheriff's Office, who are members of the Modesto/Stockton Joint Terrorism Task Force, with significant assistance from the U.S. Customs and Border Protection. Assistant United States Attorneys Jean M. Hobler and Jason Hitt and Trial Attorney Andrew Sigler of the National Security Division's Counterterrorism Section are prosecuting the case.

Teausant faces a maximum statutory penalty of 15 years in prison and a \$250,000 fine. 

wenty-four years after the Philippine Senate rejected the extension of the American bases, the Philippine Supreme Court upheld the constitutionality of the Enhanced Defense Cooperation Agreement (EDCA). EDCA is an "executive agreement" between the U.S. and the Philippines that would allow the American military to once again set foot on Philippine soil. It didn't take long for the Philippines to act; she immediately offered eight strategic locations throughout the country where the U.S. could position equipment and personnel on a rotational basis.

It's interesting to note that prior to the Supreme Court's ruling, every time American warships docked at the Subic port (formerly Subic Naval Base), they were met by

protesting leftist groups displaying anti-American signs. This time around, when the USS Topeka, a nuclear attack submarine, docked at Subic a few hours before the high court decision was announced, it was welcomed by a marching band composed of local students.

Changing times

Indeed, times changed since the Philippine Senate, by a narrow 12-11 vote, decided not to renew the U.S. bases agreement in 1991. A year later, after then President Cory Aquino's administration tried vainly to work out an extension, the U.S. flag was lowered in nationalist groups have constitutional.

vigilantly opposed any presence of American forces on Philippine soil. It was a period when the nationalists proudly declared the Philippines as "truly independent." However, it was also a dark period when China started grabbing Philippine territories including the Panganiban (Mischief) Reef, Scarborough Shoal, and six other islands where she built artificial islands that could be used for military purposes. China has been trying to expel a contingent of Philippine Marines guarding the Ayungin Shoal in a grounded and rusty naval vessel, the BRP Sierra Madre.

But it was when China started building the artificial islands that the nationalist legislators began to worry. They turned to the U.S. for help but Uncle Sam stayed out of the disputed islands, claiming neutrality. Some of them even tried to invoke the der: Did they expect the

Americans to come to the aid of the Philippines after they were booted out of the country? And these "patriotic" legislators know that with a navy without warships and an air force without warplanes, the country is helplessly and hopelessly — at the mercy of China.



Since then, leftist and 12, 2016, the day the Philippine Supreme Court ruled the EDCA lands.

It did not then come as a surprise when President Benigno Aquino III opened the doors for the U.S. to station troops and equipment on a rotational basis. And that's when EDCA came to fruition. But it wasn't easy. As soon as the EDCA was signed in April 2014, several

leftist and nationalist personalities petitioned the Supreme Court to declare EDCA unconstitutional. Among them were former Senators Rene Saguisag and Wigberto Tañada who were among the "Magnificent 12" — as their supporters called them - who voted to kick the U.S. bases out of the Philippines 24 years ago. Today, these 12 senators are now referred to as the "Dirty Dozen." Indeed, times are changing.

Supreme Court ruling

When the Supreme Court circulated the draft of the ponencia penned by Chief Justice Lourdes Sereno last November, the Senate immediately passed Resolution 1414 introduced by Sen. Miriam Defensor-Santiago, which says that any treaty should be concurred in by the Senate otherwise

it becomes "invalid and ineffective." However, the U.S. and Philippine governments have always insisted that EDCA is an executive agreement, not a treaty.

Fourteen senators voted to adopt the resolution. Only Sen. Antonio Trillanes IV voted against it while Senate President Franklin Drilon and Senate Minority Leader Juan Ponce Enrile abstained. It's ironic that Enrile, who was one of the

'Magnificent had abstained this time around, which makes one wonder: Did he finally realize the folly of his action in 1991? Indeed, had he voted for retention of the U.S. bases then - a notion that might have swirled in his mind today — China would have stayed out of the Spratly Is-

Nevertheless, in spite of the "invalid and ineffective" language of Resolution 1414, the Supreme Court went ahead and voted 10-4 on Sereno's ponencia. Justices Estela Perlas-Bernabe, Arturo Brion, Teresita Leonardo-De Castro and Marvic Leonen dissented while Justice Francis Jardeleza inhibited.

In his concurring opinion to the court's ruling, Senior Associate Justice Antonio Carpio said that EDCA's provisions that allow the prepositioning of U.S. war materiel and equipment in Philippine military bases would "give teeth" to the U.S.-Philippines Mutual Defense Treaty (MDT). "With the EDCA. China will think twice before attacking Philippine military resupply ships to Philippine-occupied islands in the Spratlys. With the EDCA, the Philippines will have a fighting chance to hold on to Philippine-occupied islands in the Spratlys," he said.

Containing China

With EDCA in place, the Philippines can now play an important role in preventing Chinese expansionism in the Indo-Asia-Pacific region that spans more than 12,000 miles across the globe - from the coast of East Africa to the shores of California. The

Philippines, which was the weakest link in the First Island Chain that forms the first line of defense against Chinese intrusion into the Pacific Ocean, is now going to be a fortified 1,100-mile "retaining wall" against China's "nine-dash — which U.S. Admiral Harry Harris calls the "Berlin Wall of the Sea" — that runs parallel to the Philippines' 12-mile territo-

rial boundary and the First Island Chain. And at both ends of that retaining wall are the Bashi Channel in the Batanes Islands in the north and the Tawi-Tawi Strait in the Sulu archipelago in the south. It's no surprise then that the U.S. has requested access to Batanes Island and the Lagag Airport in Ilocos Norte where movements in the Bashi Channel could be monitored, and blocked if a conflict with China occurs.

Whoever controls the Bashi Channel, Tawi-Tawi Strait, and the Miyako Channel - a major choke point that connects the East China Sea to the Pacific Ocean would control the First Island Chain; thus, containing China to the confines of the South and East China Seas.

It's also been reported in the news that the existing Philippine naval facility at Oyster Bay, Pala-

wan is being developed into a "mini Subic." Oyster Bay, which is only 100 miles from the Spratly Islands, is the Philippine Navy's sole base facing the South China Sea and the staging point to the Kalayaan Islands that includes the populated Pag-Asa Island.

In the previous week, three important events happened that gave the U.S. a geopolitical victory over China in Asia-Pacific, to wit: (1) The resolution of the "comfort women" issue between Japan and South Korea; (2) The election of pro-independence Tsai Ing-wen as Taiwan's next president; and (3) The Philippine Supreme Court's ruling on the constitutionality of

With America's military alliances with South Korea, Japan, Taiwan, Philippines, Australia, and Singapore secured, President Obama's "Pivot to Asia" strategy is finally paying off, which solidified the position of the U.S. as a Pacific power. And with EDSA in place, a new strategic partnership between the U.S. and the Philippines is created; thus, providing a safety net for the Philippines to protect her sovereignty and territorial in-

Bonifacio, together with Deodato Arellano, Valentin Diaz, Teodoro Plata, Ladislao Diwa, and Jose Dizon, upon learning of Dr. Jose P. Rizal's deportation, convened secretly and agreed to form a secret society. The founders called the secret society the Kataastaasang Kagalang-Kagalang na Katipunan ng mga Anak ng Bayan or Katipunan for short.

Bonifacio, born on November 30, 1863, is considered the Father of the Philippine Revolution against ary government. In Spanish colonization. He became the Katipunan's military leader or "Supremo." The Katipunan grew into a large organization and became a potent revolutionary force against the Spaniards.

It was also referred to as KKK.

The country honors Bonifacio by declaring November 30 as "Bonifacio Day," a national public holiday. But there is one question that remains unanswered today and that is: Was Bonifacio the First President and why was he murdered?

Was Bonifacio the First President?

On July 7, 1892, Andres Bonifacio - upon hearing the news that Dr. Jose Rizal was arrested and deported to Dapitan the day before called for a meeting with five of his friends, to wit: Jose Dizon, Valentin Diaz, Deodato Arellano, Ladislao Diwa, and Teodoro Plata. That night, they organized a secret society called Kataastaasang Kagalanggalangan na Katipunan ng mga Anak ng Bayan (Highest and Most Respected Society of the Sons and Daughters of the Nation) — in short, Katipunan. Bonifacio was named their "Supremo."

They recruited people to join and by 1896, on the eve of the revolu-400,000 members. During the numbering forty-five — met again revolution, two dominant leaders at the same venue of the convention. emerged — Bonifacio and Gen. Emilio Aguinaldo. By 1897, to the detriment of the revolution, their rivalry had divided the revolutionary forces into Bonifacio's Magdiwang faction and Aguinaldo's Magdalo faction.

Attempts were made to reconcile the two leaders. On March 22,

Jacinto Lumbreras, a Magdiwang, presided over the assembly. The agenda of the convention was to adopt a plan for the defense of Cavite. However, the subject was not even discussed as the meeting

became tumultuous. Instead, those in attendance decided to elect the officers of the revolutionessence, the participants threw out the Supreme Council of the Katipunan under which all the revolutionary forces had been fighting for. Bonifacio reluctant-



ly agreed to preside over the election. Aguinaldo was as chairman of this assembly and elected President; Mariano Trias as President of the Supreme Counas Vice President; Artemio Ricarte Captain-General; Emiliano Riego de Dios as Director of War; and Bonifacio as Director of the Interior. The following day, March 23, Aguinaldo and the other elected officials, with the exception of Bonifacio, took their oath of office in the new revolutionary government.

Bonifacio and his supporters believed that Aguinaldo's men were responsible for the chaos at the Tejeros convention. He believed that Aguinaldo's men had maneuvered him out of power. Indeed, it was a rude awakening for him because even the Magdiwangs, his followers, did not vote for him ei-

ther for President or Vice-President.

Adding insult to an injury, Daniel Tirona, a Magdalo, protested Bonifacio's election as Director of the Interior saying that a person with a lawyer's diploma should hold the post. Bonifacio, outraged by Tirona's insult,



At Naik, where Bonifacio subsequently moved his Magdiwang forces after the failed Tejeros convention, Bonifacio and his supporters drew up another document known as the Naik Military Meanwhile, on the same day that Agreement — in which they resolved to establish a government independent and separate from the

Bonifacio and his supporters proceeded in forming a government. The government was called Har-Bayang ing Katagalu-

They printed its Cartilla, a small handbook containing the rules, the 14-point code of ethics, and the recruitment process. In it, the Katipunan declared that the word 'Tagalog' stood for "all who were born in this archipelago... hence Visayans, Ilocanos and Pampangos were all Tagalogs" ("Filipino" during the Spanish regime was

were brought to Naik to face a military tribunal. Albeit the absence of evidence, the Bonifacio brothers were found guilty of treason and sedition. They were recommended for execution. Aguinaldo commuted the sentence to deportation. However, Generals Mariano Noriel and Pio del Pilar, both former allies of Bonifacio, convinced Aguinaldo to withdraw his order and proceed with the execution. They believed that as long as Bonifacio were alive, there would be no unity. On May 10, 1897, Aguinaldo's soldiers executed the Bonifacio brothers at the foot of Mt. Tala. They were buried in shallow graves without markers.

On June 12, 1898, Aguinaldo proclaimed the independence of the Philippines and installed a "Dictatorial Government" that would be temporary in nature until peace is achieved at which time it may be "modified by the nation, in which rests the principle of authority.'

Andres Bonifacio On March 23, 1901, exactly fours years after he took his first oath of office, American forces captured Aguinaldo in Palanan, Isabela. Thus ended the Philippine revolution started by Bonifacio.

It's been more than a century since Bonifacio was betrayed and murdered by his enemies. Many believed that had he lived and ruled the First Philippine Republic, the country today would be different from the colonial past in so many ways. It would have been different from the Las Islas Filipinas that Rizal had dreamed about. It would have been different from what Quezon wished the Philippine Islands were 50 years later. It would have been different from what our present-day political leaders have crafted the government of the Republic of the Philippines into. But one thing would have happened for sure: It would have been a free country governed by the people, of the people, and for the people.

"I am doing this so the people will know the national leaders who failed them because of ineptness and lack of leadership. I am doing this for truth and for no one else," he said.

In his opening remarks, Enrile said Mr. Aquino:

Actively and directly participated in the planning and preparation of Oplan Exodus.

Deliberately compartmentalized the operation to himself and Purisima.

Was the approving authority of Oplan Exodus.

Was fully aware of what was going on during its execution. Want only disregarded the command system of the PNP and the

Intentionally and actually and directly dealt with a person who before and at the time of the Mamasapano gruesome massacre was not an active part of the command system of either the AFP or the PNP.

Did not make any effective decision or issue any effective order or an effective action as President of the Republic of the Philippines to prevent barbaric slaughter and slaying of PNP troopers whom he knowingly sent in a dangerous mission to capture Marwan and two other targets.

Enrile was able to confirm from Napeñas that Mr. Aquino, along with Purisima, Napeñas and Marquez, had discussed the details of Oplan Exodus, including the capture of Marwan dead or alive, on Jan. 9 at Bahay Pang-

Napeñas also said the President did not object or comment to his proposal on the usage of time on

target or the manner of cooperation of the SAF with the military. He confirmed to Enrile that he asked Mr. Aquino that they would coordinate with the military only after the assault force was on the target location and that the Chief Executive did not object or comment.

Based on the text messages that Purisima sent the President on the police operations, including the groups that the SAF groups were engaged with at that time, the Chief Executive was "fully informed about the ongoing operations," Enrile said.


Napeñas, for his part, told reporters that Enrile was able to show President Aquino's role in the police operation as he insisted that the Chief Executive had the final say in the approval of Oplan Exodus.

Enrile told Napeñas that President Aquino "compartmentalized" or agreed to compartmentalize Oplan Exodus to himself and Purisima and Napeñas agreed.

"When I say compartment of Oplan Exodus, I mean the President intentionally, deliberately and actually confined and arrogated unto himself full knowledge, command and control and strategic decisions. The President excluded all others, including members of the Cabinet... he left it to himself and his trusted men,' he said.

Enrile asked Purisima if he understood what he meant by compartmentalization that the President did on the police operations. He replied by saying that Oplan Exodus was "crafted by the PNP SAF and our part is informatory.'

"That's your defense," Enrile said of Purisima, adding that President Aquino "excluded everyone else.







tress is one of the major causes of stroke. For a matter of six months I witnessed three of my coworkers got stroke.

Aside from personally seeing it happened, I am the first one to recognized it among

others and called for help, not to mention I even detected my mother having stroke when I called her long distance in the Philippines. She was slurred. I told her, "Ma, you are having stroke. You need to see a doctor insigida. Tell Papa to bring you to the hospital now." I thank God for giving me sense to detect it while happening real time and was able to initiate first aid measure.

A stroke occurs when the blood supply to part of your brain is interrupted

or severely reduced, depriving brain tissue of oxygen and nutrients. Within minutes, brain cells begin to die. A stroke is a medical emergency (Mayo Clinic, 2015).

Mortality is high with stroke. The first one of my three coworkers was not able to make it. May she rest in peace. The second one said, "Gabe, I have severe headache and half of my face is numb." I said you are having stroke. I will send you to the emergency department. She got stroke and have physical deficit and is not back to work yet. The third one told me, "Gabe, I am dizzy." I told her, "I will help you." And reassured her we will bring her to ED. Stroke alert was called. Appropriate treatment was done and the prognosis is

promising. Praying for fast recovery.

Early recognition is the name of the game and treatment should not be delayed. Four important letters to remember to determine stroke: FAST. F for face. Look for facial assymetry. Let the victim make a smile and see if the face is balance. If not, the victim must have stroke. A for arms. Let the victim raise both arms straight at shoulder level and look if one arm drops before 10 seconds. S for speech. Let the victim speak and listen if there is slurring. T for time. As the saying

goes, "Time is gold." Call 911 or bring the victim to the emergency department

Sharing information is one way of educating ourselves. I hope and pray that someday, if I am the victim of an impending stroke, somebody out there can proficiently detect STROKE and prevent major physical damage brought by this dreaded condition (gabbyortig@yahoo.com)

mao" will be able to knockout Timo-


thy Bradley when they face each other on April 9 at MGM Grand Garden Arena in Las Vegas, Nevada.




