Alan to Bongbong: Return stolen riches

Cayetano says rival must apologize for hiding loot

en. Ferdinand "Bongbong" Marcos Jr. should not apologize for martial law, but he should return the wealth that his family allegedly stole from the nation during their 20 years in power and apologize for his role in concealing it, Sen. Alan Peter Cayetano said on Friday.

Cayetano, who is contesting the vice presidential race with Marcos and four other candidates in the May 9 national elections, acknowledged that Marcos, son of the late dictator Ferdinand Marcos, should not apologize for his father's iron-fist rule, during which thousands of Filipinos were killed, disappeared or died in prison.

I stated that the sin of the father is not the sin of the son. If the father did something wrong, the son should not be blamed for it," Cay-

etano told local journalists during a campaign visit to Cebu City.

"But if the son is involved in spiriting away billions of dollars in ill-gotten wealth that the government is trying to recover, that's another story," Cayetano said.

"Operation Big Bird showed that he made arrangements to make sure that the government could not lay its hands on those billions," he added.

"Operation Big Bird" was a failed attempt in 1986 to recover \$213 million (P10.16 billion) in ill-gotten wealth allegedly stashed by the Marcos family in Swiss

It was initiated by retired military general Jose Almonte and banker Michael de Guzman but was called off because it did not have the approval of the administration of then President Corazon Aquino.

that occasion [2013 interview on Rio-Rome flight] I said this — 'If a person is gay and seeks out the Lord and is willing, who am I to judge that person?' — I was paraphrasing by heart the Catechism of the Catholic Church, where it says that these people should be treated with delicacy and not be marginalized. ... And people should not be defined only by their sexual tendencies: let us not forget that


God loves all his creatures and we are destined to receive his infinite love. . . I prefer that homosexuals come to confession, that they stay close to the Lord, and that we pray all together.— Pope Francis, The Name of God Is Mercy

WHAT would Pope Francis say about boxing champ Manny Pacquiao's quoted remarks about homosexuals?

"As Christian, same-sex marriage is forbidden. Woman was made for man; man was made for woman. This is just my view: It's only common sense. Do you see male animals with male animals, or female with female? Animals are better, knowing how to recognize [gender]. Now, if men are with men, or women with women, human beings are worse than animals, isn't it? A man really cannot marry another man.

"But I'm not condemning them [homosexuals]. Just [same-sex] marriage. Committing sin against God. But if two of the same sex love each other, there's no problem there. What's important is being good people and just living a simple life. But just don't get married. They just show they love each other. It's enough to live together, but for people of the same sex to marry, that shouldn't be, because that's against the law of God.'

Amid the ensuing outcry, Pacquiao posted on his Facebook account: "I'm sorry for hurting people by comparing homosexuals to animals. Please forgive me for those I've hurt. I still stand on my belief that I'm

So what would Pope Francis say to that? For starters, as one who preaches mercy for the repentant, Pope Francis cannot but look positively on Pacquiao's avowed apology, love and prayers for people he

offended.

Secondly, given the Holy Father's compassionate words for people in relationships forbidden by the Catholic Church, he may counsel the eight-division champion that moral admonition — one of seven spiritual works of mercy taught by the Church — is best done without unnecessarily offending those being admonished and provoking them to stop listening.

As for Pacquiao's moral thinking, Francis could very well agree with the boxer that Christian morality forbids homosexual acts, based on verses in the Old and the New Testaments, as well as edicts by past pontiffs and Church councils.

Thus, while preaching mercy, the Pope does say in the quote from his new book, The Face of God Is Mercy: "I prefer that homosexuals come to confession." That means acknowledging and atoning for offenses, asking God's forgiveness, and resolving to avoid such acts in future

What about the bit about animals? Is that in accord with Catholic doctrine? Francis probably won't go there, to avoid further upseting LGBTs. More to the point, what determines morality is God's will as revealed in inspired Scripture and teachings, not animal behav-

Sexuality must serve God

Sex with different partners, for instance, is done by many creatures, but the Church forbids it. Indeed, Christian teaching eschews merely giving in to physical drives, and re-



China's moves alarm nations

MORE nations expressed concern at China's rising maritime assertiveness with Japan, Australia, India and the Association of Southeast Asian Nations expressing "concerns" about tensions in the region.

Senior officials of Japan, Australia and India met in Tokyo on Friday to stress the importance of maintaining the rule of law in the South China Sea and expressing "strong concerns" about tensions in the region amid China's rising maritime assertiveness.

"We shared strong concerns about moves to unilaterally change the status quo that would lead to destabilization in the region," Vice Foreign Minister Akitaka Saiki told reporters after talks with his Australian and Indian counterparts.

The three-way meeting comes as China's deployment of an advanced surface-to-air missile system has stoked concerns the country is pursuing militarization in the South China Sea, adding to tensions already heightened by Beijing's massive and fast-paced reclamation works in the sea.

China is also boosting its presence in the Indian Ocean, which provides essential maritime traffic access for the transportation of oil, gas and other resources from the Arabian Sea.

"We also shared the need to establish a new rule in the region to secure the rule of law and the freedom of navigation," Saiki said. Saiki was referring to the on-

going discussions between China and the Association of Southeast Asian Nations to conclude the Code of Conduct in the South China Sea, a legally binding document that could be used to resolve deadlocks, disputes and tensions in the sea.

Peter Varghese, secretary of Australia's Department of For-



eign Affairs and Trade, and Indian Foreign Secretary Subrahmanyam Jaishankar took part in the threeway meeting, the second of its kind following a meeting in India

The diplomats also discussed their responses to North Korea, following its nuclear test last month and long-range rocket launch earlier

Given the likelihood that the UN Security Council may soon adopt a fresh resolution that would expand sanctions on North Korea, the three officials also agreed to steadily implement the sanctions to prevent North Korea from further promoting its nuclear development, Saiki said.

The trilateral framework is part of Prime Minister Shinzo Abe's efforts to promote a "security diamond" strategy connecting Japan, Australia, India and the US state of Hawaii to safeguard maritime interests stretching from the Indian Ocean region to the western Pacific.

Abe introduced the concept in December 2012 to counter Beijing's military buildup and perceived attempts to change the status quo in the South China and East China seas.

Ahead of the three-way talks, Japanese Foreign Minister Fumio Kishida told a press conference, "The trilateral cooperation covering the Indian Ocean and the Pacific Ocean contributes to the peace and stability of the region.' 'Japan seeks to further strengthen trilateral ties," he added.

In Vientiane, officials said Chi-

na's recent artificial island-building and fortification of its garrison in the South China Sea is among the pressing political and security challenges that Asean foreign ministers will discuss when they meet in the Laotian capital.

One diplomat said Asean ministers are "seriously concerned" by recent and ongoing developments in the South China Sea.

Specifically, Asean sources said the ministers will have frank discussions about the land reclamation and escalation of activities in the disputed sea, saying "these assertive moves erode trust and confidence, increase tension and may undermine peace, security and stability in the region.'

Charles Jose, a spokesman for the Department of Foreign Affairs, said the Philippines will focus on maritime security, saying that China's construction of islands in the disputed waters has heightened tensions in the South China Sea.

Jose said that reports claiming Beijing has positioned surface-toair missiles in the disputed territory in the Paracel Islands chain are a cause of concern.

"We are expressing concern over these developments, including the reported missiles on Woody Island," Jose said.

"Of course all these things raise our concern and its effect on freedom of navigation, over-flight and unimpeded flow of commerce. In this meeting we will continue to express our concern with the developments in the South China Sea."

Laos, this year's Asean chairman, is expected to issue a press statement at the end of the day-long retreat Saturday.

"There are ongoing discussions and consultations on whether to include in the press statement a line that says that ministers reaffirmed their commitment to non-militarization and self-restraint in the conduct of activities in the South China Sea," an official source said.

US to step up military operations in West PH Sea

The US Navy Pacific fleet is planning to step up its military operations in the West Philippine Sea

Admiral Harry Harris says China is clearly militarizing the region despite the latter's repeated denial

He also reaffirms the US commitment to "fly, sail and operate wherever international law allows them"

MANILA, Philippines The United States Navy will step up maritime patrols in the West Philippine Sea as concerns over Ĉĥina's recent deployment of surface-toair missiles and jet fighters in the Paracels chain grow over the past weeks among regional powers like Japan, US and Australia.

Speaking before the House of Representatives Armed Services Committee hearing early this week, Admiral Harry Harris, commander of the US Pacific fleet, said Washington needs to boost its military operations in the region by sending more warplanes, battleships and submarines to deter China's continued militarization of the disputed island-features currently under its control.

Harris said China is without a doubt militarizing the West Philippine Sea/South China Sea and no amount of excuses from the Chinese government could deny the

"In my opinion, China is

China Sea. You'd have to Defense Ministry spokesbelieve in a flat earth to believe otherwise," Harris told US lawmakers.

Changing the operational landscape

Harris accused China of trying to change the "operational landscape" in an attempt to enforce dominance in the region.

It is along this premise, the Navy official said, that his fleet is planning to send more assets in the contested waterways and counter China's continued aggression that worries other regional powers in Asia and Ocea-

"We will be doing them more, and we'll be doing them with greater complexity in the future and we'll fly, sail and operate wherever international law allows," Harris reiterated.

He added further: "We must continue to operate in the South China Sea to demonstrate that water space and the air above it is

Don't use SCS issue

Harris' proposition was met clearly militarizing the South with rebuke from Chinese

man Wu Qian who admonished the US admiral for trying to use the South China Sea issue to seek more funds from Congress.

"We don't interfere in your seeking defense budget funds, but you can't carelessly smear China while asking for more money," Wu said in a statement.

In the same hearing, Harris also raised the possibility of providing the Philippines with 'new guarantee' under the existing 1951 U.S.-Philippines Miitual Defense Treaty that would see the Philippine Marine troops deployed at Ayungin Shoal (Second Thomas Shoal) adequately protected in the event China decides to become more aggressive and try to expel them from the island.

This guarantee would include designing a declaration which states that any attack on Philippine facilities on West Philippine Sea would prompt a US military response.

The late Sen. Joker Arroyo had said the operation was not code-named "Big Bird" when it was presented to President Aquino. He said the code name was coined by the media.

Inheritors

And Senator Marcos, he said, should apologize for his role in concealing his family's billions of dollars in alleged ill-gotten wealth.

If the Marcoses would insist that they legitimately owned those billions, they should explain where all that wealth came from, he said.

The Inquirer's efforts to reach Marcos or his spokesperson for comment on Saturday were unsuccessful.

The Marcoses have repeatedly denied amassing ill-gotten wealth, insisting that the family wealth has been legitimately acquired.

They fell from power in 1986, ran out of the country by the Edsa People Power Revolution. They lived for years in Hawaii, where the ousted dictator Marcos died in 1989.

\$10-B ill-gotten wealth

Unofficial estimates put the alleged Marcos gotten wealth at \$10 billion. According to the Presidential Commission Good Government (PCGG), created in 1986 to recover the alleged loot, \$4 billion had been recovered and given to the national treasury.

been used mostly for land reform. As ordered by a Hawaii court, \$210 million (P10 billion) was used to compensate about 10,000 victims of human rights abuses during martial law.

The government hopes to raise \$17.7 million from an auction of some confiscated Marcos jewelry, property and stocks, sources said this month.

PCGG head Richard Amurao said the government was still seeking to recover \$1 billion through 100 court cases in the Philippines and other countries.

"We don't really know if the \$10-billion estimate is accurate but what we can tell you [about the \$1 billion now sought] is based from estimates of the court cases and from what we already recovered," Amurao said.

More than half of the court cases are civil lawsuits to recover shares of stock, real estate, cash and jewelry, he

A quarter of the cases involve "behest loans" that state-owned banks gave individuals with political connections to the late strongman, he said.

Former PCGG Chair Andres Bautista, now head of the Commission on Elections, said most of the cases under litigation were complicated and difficult because government prosecutors could no longer locate witnesses and find documentary evidence.

"Some of the key players are also back in power,' Bautista said.

Members of the Marcos family remain active in politics. The matriarch, former first lady Imelda Marcos, is a congresswoman from Ílocos Norte province, the family's political base where her eldest daughter, Imee Marcos, is the governor.

Recovered funds have Now Senator Marcos is try-

ing to win the vice presidency, which, if he wins, will put him next door to the presidency-and the ultimate political comeback for his family.

No apology

Marcos, tied with Sen. Francis Escudero for the first place in voter preference polls for the vice presidential race, has never apologized for his father's abusive rule.

"What am I to say sorry [for]?" he said during a television interview last August.

He said that during his father's administration thousands of kilometers of roads were built, the Philippines had one of the highest literacy rates in Asia, and the country was an exporter of rice, not an importer, as it is

Marcos, 58, is pressing a revisionist view of the Philippines' harrowing experience during martial law, aimed at rehabilitating his family and putting it back in power.

He has built a coalition from his father's remaining supporters and young people who were not yet born when martial law was declared in

President Aquino, son of Sen. Benigno Aquino Jr., the leader of the opposition to Marcos who was assassinated in 1983, is trying to prevent the election of the late dictator's son to an office that would put him within reach of Malacañang.

On Thursday, at the celebration of the 30th anniversary of the Edsa People Power Revolution that toppled Marcos from power, Mr. Aquino pushed hard against Senator Marcos' revisionist campaign, belying the candidate's claim that the Philippines saw its best years during his father's administration.

Without naming Marcos,

Mr. Aquino blasted the senator for refusing to apologize for the sufferings Filipinos went through during his father's rule instead of asking the nation to be given a chance to right the wrong his father had done.

Both Nacionalistas

Both Cayetano and Marcos belong to the Nacionalista Party (NP). Cayetano said he had no plans of dropping his campaign even if he ranked fourth in the polls, behind Escudero, Marcos and Rep. Leni Robredo.

"We run because we believe we are the better choice," he said.

Cavetano was in Cebu for a dialogue with patients at government-run Vicente Sotto Memorial Medical Center.

His visit was part of the dialogue with the people strategy of his campaign with his presidential running mate, Davao City Mayor Rodrigo Duterte.

erdinand "Bongbong" Marcos Jr. and Francis "Chiz" Escudero are not related by blood or political affiliation, but their provenance – Bongbong's biological roots and Chiz's political roots -- comes from the same person: Ferdinand E. Marcos Sr. Bongbong is the biological son of the late dictator and the Escudero political clan was deeply associated with the Marcoses during the martial law years. dential election in 1992. Miriam is a good – nay, fantastic! choice to run under as her vice presidential running mate. However, she is fighting the greatest battle of her life - stage 4 lung cancer, which she claims is now However, at their controlled. kickoff campaign last February 9 in Batac, Ilocos Norte, Miriam told the crowd that Bongbong is the "best person" to succeed her potential position as president "if something happens to her." Indeed, the odds are great that Bongbong would ascend to the presidency byway of presidential succession.

In the case of Chiz, his presidential running mate, Sen. Grace Poe, is facing disqualification charges against her before the Supreme Court in regard to her citizenship status and residency. If Grace were disqualified from running,

then Chiz would end up without a standard bearer. He would be like the Japanese "ronin" of old, a samurai whose master had died. And he'd be campaigning solo for the rest of the campaign season. Is it good or bad? I'd say neither. Actually, Chiz could turn the situation around into a winning strategy. Being a "ronin," he can find

a "master" in any of the top three presidential candidates: Jejomar Binay, Mar Roxas or Rodrigo Duterte. They all have the potential of winning but their respective vice presidential running mates -Gregorio Honasan, Leni Robredo, and Alan Peter Cayetano – are no match against Chiz... or Bongbong, who, like Chiz, could also end up a masterless "ronin."

But regardless of whether Chiz and Bongbong become a "ronin," it shouldn't make a lot of differ-

Yes, ence; that is, either one could win the vice presidency on their own strengths and resources. And whoever wins would become a strong candidate for president in 2022.

Taste for power

In my article, "The 2022 presidential derby is on" (October 16, 2015), I wrote: "As I have postulated earlier, whoever wins the vice presidency in 2016 would be the next president in 2022, which begs the question: Of the six [only five left now] vice presidential candidates in 2016 – Robredo, Escudero, Trillanes [he's out], Cayetano, Marcos, and Honasan - who wouldn't want to run for president in 2022 if he or she were elected vice president in 2016? What I am seeing in my crystal ball is that all of them, with the exception of Honasan, will run for president in 2022. But Honasan,

sources they have at their disposal to win - by all means -- the vice presidency in 2016. It would be shooting two birds with one stone; whoever we elect vice president in 2016, we're also electing president in 2022."

Three-way battle royale

The latest Social Weather Stations (SWS) survey conducted last February 5-7 showed Chiz and Bongbong tied in first place with 26% ratings. What is interesting is that Bongbong overcame Chiz's threepoint lead in the SWS survey conducted on January 8-10, 2016. But this is a small gap compared to the SWS survey on December 12-14, 2015 that showed Chiz at 30% and Bongbong at 19%, a whopping 11-point difference. That was the biggest gap between Chiz and Bongbong since March 20-23, 2015 when Chiz's popularity rating was at 6% and Bongbong at 3%.

Interestingly, Leni Robredo at 19% is not too far behind Bongbong in the latest SWS survey. Can Leni catch up with either Chiz or Bongbong? With President Aquino's support and the Liberal Party's huge war chest, she can prevail over Chiz and Bongbong. What's going for her is she's untainted and the wife of the popular late DILG Secretary Jesse Robredo. Indeed, what we're seeing here is a three-way battle royale.

But barring a bloody and dirty battle between the two ronin -

Chiz and Bongbong - that could end up with both of them losing out to Leni, these two heirs to two powerful dynasties - the Marcoses of Ilocandia and the Escuderos of Bicolandia – would put all their resources to use to win – by all means - the vice presidency. And this is where Bongbong might have an edge because of the Marcoses' reputedly

amassed wealth, which, if true, could make a lot of difference.

Both Chiz and Bongbong have one shot at the vice presidency. And as I said before, it would be like shooting two birds with one stone; whoever is elected vice president in 2016, would be elected president in 2022.

Search for Marcos' wealth: Compromising with cronies

What the entire world knows after 30 years is a mere fraction, and not the entirety, of the Marcos loot

MANILA, Philippines – Months after its creation in 1986, the Presidential Commission Good Government (PCGG) saw tangible results of its quest for the return of the illegal assets of the Marcoses and cronies.

It negotiated the first compromise deal with crony Jose Yao Campos, a Chinese Filipino entrepreneur who owned the controlling interest of United Laboratories Inc., a major drug firm, for the return of the Marcos assets listed under his

Campos, low key and unassuming, was probably the most cooperative among the known Marcos cronies. Unlike other cronies who chose to slug it out with the post-Marcos government, Campos cooperated fully in surrendering the Marcos assets under his name. Marcos used him mainly as caretaker of those illegal assets.

A friend of the dictator, Campos surrendered to the PCGG the 197 titles representing pieces of real estate property in Metro Manila, Rizal, Laguna, Cavite, Bataan and Baguio City, and P250 million (\$5.3 million) in cash. The pieces of real estate property have a combined value of over P2.5 billion (\$52.5 million). (READ: Recovering Marcos' ill-gotten Hawaii. wealth: After 30 years, what?)

In 1987, the PCGG recovered P375 million (\$7.9 million) from the accounts of Campos and Rolando Gapud, reputedly the dictator's financial adviser, in Security Bank and Trust Company, a local commercial bank. Decades later, the Honolulu court decided to compensate the human rights victims of the Marcos regime and ruled the sale of two pieces of property in the US to pay them. They were listed under Campos'

Among the Marcos assets under Campos' name, which the PCGG sold to the private sector, were: the Dasmariñas property in 1994 for P200 million (\$4.2 million); IRC Antipolo property in San Isidro in

1995 for P27.6 million (\$580,000); the IRC Antipolo property in Victoria Valley Subdivision 1996 for P35.2 million (\$740,000); Philippine Long Distance Telephone Company shares in 1999 for P74.2 million (\$1.6 million); and Anscor and PLDT shareholdings in 2005 for P41 million (\$860,000).

Also sold were: Manila Bulletin shareholdings in 2008 for P163 million (\$3.4 million); the Wack-Wack property in Mandaluyong City in 2011 for P127 million (\$2.7) million); Hans Menzi Compound agricultural lands, and cash diviin Baguio City in 2012 for P93 million (\$2 million); Banaue Inn compound in 2012 for P10 million The PCGG sold the Marcos assets (\$200,000); Mapalad property in under Benedicto's name, which Paranaque City in 2013 for P247 million (\$5 million); and the J. Y. Campos property in Baguio City in in Cebu in 2001 for a total P228.5 2014 for P160 million (\$3.4 million).

Banana magnate, too

In 1987, banana magnate Antonio Floirendo entered into a compromise deal with the PCGG and turned over P70 million (\$1.5 million) in cash and assets. The Marcos assets he gave to the PCGG included the Lindenmere Estate and Olympic Towers in New York and the real property listed as 2443 Makiki Heights Drive, Honolulu,

The PCGG sold the Marcos assets under Floirendo's name such as: rule, Marcos recruited unknown Beverly Hills property in California in 1994 for \$2.52 million and its residual items for \$42,300; the mise settlements with low profile Makiki property in 1995 for \$1.35 million; and the Lindenmere Estate in 1996 for \$40 million. Since the Lindenmere property was heavily mortgaged, the PCGG's share was \$1.62 million.

Roberto Benedicto, the dictator's close friend since their law school days at the University of the Philippines, followed suit in 1990. In a compromise agreement with the the ill-fated but overpriced Bataan PCGG, he surrendered \$16 million in Swiss bank deposits, share- with state authorities. The PCGG recovered illicit assets from persons, who were not necessarily cronies but lesser known caretakers to whom Marcos entrusted his ill-gotten wealth. When the volume of his illegal operations grew at the height of martial persons to do the job for him.

The PCGG entered into compro-Anthony Lee, who surrendered shareholdings in Mountainview Real Estate Corporation in 1991; Alejo Ganut Jr., who surrendered P50 million (\$1 million) in 1996; and Antonio Martel, who ceded a Philippine Ambassador to Japan 4.6 hectare property in Bacolod City in 1996.

Eyeing big companies

What the entire world knows after 30 years is a mere fraction, and not the entirety, of the Marcos loot, A number of their illegally acquired assets in the country have been identified.

What has been stashed abroad remains a big question, although it has been estimated that the loot could be between \$5 billion to \$10 billion.

Marcos was not content to receive huge under-the-table commissions from foreign contractors of big ticket state projects. Marcos and his cronies had set their eyes, too, on major firms long regarded as blue chips by the stock market. These included Manila Electric Company (Meralco), Philippine Long Distance Telephone Company (PLDT), and San Miguel Corporation.

Marcos, using brother-in-law Benjamin Romualdez, took control of Meralco and sent its owners, the Lopezes, to exile in the US shortly after he declared martial law in 1972. Marcos secretly used Ramon Cojuangco as his nominee in PLDT. Marcos used crony Eduardo "Danding" Cojuangco Jr to use coconut levy funds and take

The PCGG did not lose time in filing claims on blocks of shareholdings believed to be owned by the Marcoses and their ilk in those three firms. The judicial grind was taxing to the spirit, but after years of court litigation they bore fruit as the government had recovered billions of pesos from the sale of the contested shareholdings

The PCGG recovered and sold to the private sector the first batch of Meralco shares held by Benjamin Romualdez in 1994 for P13.5 billion (\$280 million); the second batch in 1997 for P2.6 billion (\$55 million); the third batch in 1998 for P53 million (\$1.1 million); and the fourth and last batch in 2008 for P2.1 billion (\$44 million), or a total of P18.7 billion (\$393 mil-

The recovery of the Marcos assets in PLDT took a more circuitous route. The court litigation was characterized by earlier decisions only to be overturned by motions for reconsideration. In the end, the PCGG has secured in 2006 the final decision from the Supreme Court saying that the contested shares belonged to Marcos and not to the family of Ramon Cojuangco.

In 2006, the PCGG sold to the Metro Pacific Holdings., a local firm owned by the Hong-Kong based First Pacific Group, the PLDT shares worth P25.2 billion (\$530 million), ending 20 years of court battle.

"Balut" is a popular delicacy in many Southeast Asian countries, such as Vietnam, Laos, Cambodia, Thailand, and the Philippines. In particular, the Philippines is arguably one country where her people not only love balut, they live it! Call it balut mentality or balut syndrome, eating balut is healthy for the body and mind... and, as many Filipino men would attest, it's aphrodisiac! The male balut lovers call them "macho food" because they're believed to boost virility and libido. Yes, balut are indeed the Philippines' "much loved delicacy."

With all the good things that balut lovers get from eating those fertilized duck eggs – thank God, they're cooked! -- it is no wonder that many Pinoys would eat balut every night. And for those who have extra money to spend, eating half a dozen balut -- or more – would make them stronger and ready for action! Indeed, many believe that balut is radioactive, which may be the source of the eater's strength and stamina.

But before you try eating balut, you need to know a little about it. Pronounced bah-loot, it's produced by fertilizing duck eggs under the sun and then storing in baskets to keep them warm. After nine days, the eggs are held to a light to see the outline of the

embryo inside. About eight days later, the fertilized eggs – the balut -- are ready to be cooked just like cooking hard-boiled chicken eggs.

The vendors then put the cooked balut in buckets of sand to retain the warmth. They go around neighborhoods at sundown and shout "bah looot..." They're sold with small packets of salt and they're eaten best while still warm.

Kinds of balut

There are three kinds of balut, two of which are okay -- the fertilized balut and the unfertilized penoy. The ideal fertilized balut is 17 days old. It is called "balot sa puti" ("wrapped in white"). After 18 days, it becomes recognizable, complete with a beak, head, claws, body, and bones. However, after a few more days it becomes too old and you'd see feathers on the chick, which many people don't like eating.

On the other hand, if after nine to 12 days old the chick has remained unfertilized, it is called penoy and it looks, smells, and tastes just like a regular hard-boiled chicken egg, albeit a little more expensive.

But the third kind is very bad. It's the undeveloped duck egg called "abnoy" or "bugok," which means, rotten. When you crack a balut and it smells awful, don't eat it!

Believe it or not

But in Pateros, Rizal where the production of balut is the town's main industry, the people have a way of putting an abnoy to good use. Are you ready for this? They use abnoy to make "bibingkang abnoy." And just like the smelly

abnoy where it's made from, bibingkang abnoy smells and tastes awful. It's cooked like a fried egg torta and dipped in spicy vinegar. But take it with a grain of salt when you hear abnoy lovers say, "It smells like hell but tastes like heaven!"

However, if you're adventurous enough (this is a challenge to CNN's Anthony Bourdain of the "Parts Unknown" series) and wouldn't want to miss the experience of eating bibingkang abnoy, here's some suggestions to follow: "Don't breath, cover your nose, grab a small slice of the bibingka, dip it in vinegar to enhance its taste, bite it, don't puke, feel the exotic taste." How to eat balut

1. Crack a small hole on the rounded part of the shell.

2. Chip away pieces of the shell until the hole is the size of a bottle cap. Pierce the membrane and suck the broth-like liquid (albumen of the duck fetus).

3. Make the opening bigger. Sprinkle the inside with "rough sea salt," which is provided by the balut vendor.

4. Enlarge the opening so you can bite off the yolk (yellow part).

5. Eat the chick. The hardened white lump is edible but most people don't eat it.

Balut syndrome

Some people are like balut. While they might love balut for any perceived benefits, some people live their lives like balut, especially the politicians. And just like the three kinds of balut (balut, pe-



noy, and abnoy), politicians are categorized in the same manner. The penoy politician is someone who is new in politics: a novice or a rookie. Like a penoy, they're cooked but unfertilized. They're new in the political game so they haven't been exposed to corruption yet. But after being exposed to corruption or "fertilized," the penoy politician transforms into a balut politician - corrupt and greedy. However, just like a duck egg that didn't develop properly, that politician might turn out to be an abnov – rotten to the core!

But regardless of whether these politicians are penoy, balut or abnoy, the people keep on electing them from the president down to the barangay captains. It's a phenomenon particularly in Philippine politics where people look up to their politicians as their benefactors. A lot of times politicians are asked to be the godfather (ninong) of people getting married or baptized. And when someone dies, the politicians are there to give financial aid to the bereaved. Indeed, it is not uncommon for

politicians to dole out or give small amounts of money to their constituents in time of need. And for these acts of charity from their benefactors (padrinos), the constituents would be forever grateful and will vote for them come election time, which begs the question: Where does the politicians' "charity fund" come from?

The beneficiaries (constituents) know where the "charity fund" originated. They come from the padrinos' ill-gotten wealth that was generated through corruption. In order to keep the flow of "dirty money" coming in, the politicians use bribes and kickbacks to grease corrupt government officials and functionaries. It's a vicious cycle that keeps the politicians in power and, sadly, the people in perpetual bondage. Yep, the politicians are just like bibingkang abnoy: Their corrupt practices smell like hell, but their dirty money tastes like heaven. That in essence is the politics of balut.



His vast experience, knowledge and expertise in his profession brought him not only in California but also in Oregon, Kansas and Washington D.C.

Dr. Aquino is one of the pillars of the Filipino Community of Sacramento and Vicinity having been an active participant since 1988. This iconic community leader, although, there were times that he had been mired in community controversies, yet his devotion, love and dedication to the community where he found comfort and solace to live could never be questioned.





The neighbor used his dog to lure the young victim. He was able to earn her trust by pretending to be a kind man next door, while her mother was doing something

Another case was when a mother got busy socializing with her friends in a Christmas party and just let her eight year old daughter get a drink from the water fountain by herself. The maintenance man in that building snatched her and took her in his car and pretended that they will just go and buy fast food, but, instead, molested her and tortured her to death.

Another case was when a seven year old girl was bicycling by herself in a supposed to be a safe neighborhood. A man driving his car saw this young vulnerable child to be an easy target. The driver intentionally bumped the girl's bike to cause her to fall and then he picked her up and promised to take her to the hospital. Instead, he took her to his house, and again, like the other victims, molested and killed her.

These unprecedented cases also happen to adults who became nonchalant about their surroundings. One example was the case where a woman in her thirties just went across her home to buy groceries during daylight. When she came out of the store, she did not bother to see if there were dangers around her because she was in a hurry to go back home to her kids. She did not realize that someone was following her with a vicious intention of hurting her. The man choked her with a rope, raped and stabbed her until she died.

Sometimes, bad things happen because of being embarrassed to be labeled as prejudiced or weak. Even though a person, especially a woman, senses that it would be wrong to take a certain step, she would ignore this feeling so as not to appear racist or afraid. A lot of

times, her original suspicion could be right for her own or her family's security. And instead of avoiding to be in the path of danger, she would choose to continue straight into the criminal's hands where she would be completely helpless. Ever since I remember, I and my family had been exposed to these kinds of danger, and thankfully,

we were able to elude to be victims. I always have an exit or an alternative plan, if faced with danger. Some people think that I am so pessimistic, but, I can look back at those incidents and I can say that I do not regret choosing those decisions I made that made me and my family safe.

I remember, in a party, when our oldest daughter was a toddler, my husband. I and some friends planned to have our daughter be watched by a relative so we can go for a short errand. In the car, I asked my husband if he actually saw our daughter with the person who was supposed to watch her. My husband was not so sure. I insisted of going back to check on her. Everyone in the car laughed at me and said that I was paranoid. I ignored them and I insisted. My hunch was right. When we went back to the party, no one was watching our daughter, and our child was away from everybody.

Also, one summer time, when our two daughters were about seven and ten years old, they were playing with other kids in our open backyard, while I was folding the laundry nearby, where I could see them play. All of a sudden, there was an old brown station wagon with four shirtless older men drove by and stopped by them. I screamed for my children to come back home, but, I saw my oldest daughter with arm stretched and pointing at one direction. I ran towards them and the car drove away towards the opposite of where my daughter was pointing at. I looked where the men were going, and they drove towards the freeway. I asked my daughter what were they asking her. With sobs and tears, maybe realizing that what she did was wrong, she explained that they were asking where the community pool was. I calmly told her that they were lying because instead of going towards the pool, they drove towards the freeway. I also added that if I did not intercede, they

could have kidnapped her and we will never see each other again. Unfortunately, during that week, there was a boy biking with a friend who got kidnapped and never was seen again.

Every time I would go shopping with my young daughters, I would physically hold the hoods of their jackets while I looked at the merchandise. I never trusted that they would always stay close to me nor myself of not getting distracted. I get harsh looks from other mothers, but, I did not care, because the safety of my children are the most important to me.

When I used to work at night, I was walking from my job to our apartment It was a dark evening and I looked around and I saw a man following close to me. I was pregnant then and I cannot run. I was scared that he would do something bad to me, so, I quickly planned something in my mind just in case my suspicion was correct. When he got near me, he bumped my shoulders, so, I hurriedly turned around to face him, with my hand in my coat pocket, I firmly said, "Leave me alone! I have a gun!" At the same time, I pointed my finger inside my empty pocket. He said, "Ops, sorry. I just wanted to know if you have a light." He then hurriedly left away from me, trembling, but,

Another incident was when one afternoon, while I was walking alone towards my work on a rural road along the railroad tracks, an unmarked older green van was slowly driving behind me and stopped by me. The male driver opened the passenger door and asked me if I needed a ride. I hurriedly crossed the street and pretended to knock at a house. The van drove away. Again, I was so scared, but, maybe, my quick response saved my life.

When we used to live in a condominium, I used to leave our unit early in the morning. As I opened the front door, the door would not push open. I looked through

the side window to find out what was hindering the door to open. I saw a man sitting in front of it. Since I was running late, I did not even bother to go back home to ask my husband to accompany me to my car. I just pushed the door open and walked past the stranger. I was lucky that the man was probably

so drunk that he couldn't even move. Thinking now about it, I kind of regret making such decision, because I could have been in a different situation just because I forgot about my safety.

Sometimes, being in a very friendly and controlled safe environment makes one nonchalant about the dangers that surround him or her. While I was working in a very nice hospital, everyone was friendly to everyone and everybody was harmless. One day, a new young employee asked me for a ride home. I figured out that it was still daylight and that he seemed nice, nothing could go bad. Also, as his supervisor, I thought I had an obligation to be civil and understanding to him, so I agreed to give him a lift. He directed me to the worst place in that area. I was praying while following his directions and at the same time, thinking an exit plan, if something bad happen. Thank God, I dropped him off to his destination without adversity. I might be wrong in thinking negative about him, but, I promised myself that I will never do that again, because trusting blindly could bring a bad experience, just like what happened to my coworker.

One day, she was invited by a good friend to her apartment. Since she trusted this friend, she went to her home without any hesitation. As soon as she got into the elevator,

there was young man inside it. Although my friend was scared, she did want not to look like she was prejudiced. She smiled at him and he smiled

back. As soon as the elevator door closed, the young man grabbed her and forced her to go up to the opened top floor. He beat her up badly and raped her. When we saw her the following day, her face was all black and blue, her lips swollen and she was sobbing to tell her vicious experience.

In my own experience, when it was almost midnight, I was supposed to pick up my husband from work, because his car broke down. My car was on our driveway, and as I opened the garage door to get into my car, I noticed a beige sedan car with four young men passed by and stopped in front of our house. Since they were young, I thought that they could just be people I knew. I stopped to check them out. The driver backed up and upon that, I knew that I would be in trouble. I hurriedly got into my car, but, I cannot turn on the engine because I had a bar on my wheel. The other car drove into my driveway over our grass area next to my car. I refused to look at them for fear of identifying them. I honked my horn and pretended that I was trying to call the attention of somebody inside my house, even though it was empty. I continued honking my horn and fortunately, my next door neighbors looked out their window and I waved my hand signifying that I needed help. The other car drove away when my neighbors came to my aid. The next day, there was a case in my neighborhood of a home robbery. I guess I was saved by my survival instinct.

I cannot emphasize enough about our safety. I have been mentioning all these facts not to scare people, but, to let them realize that having an alert mind and not letting the guards down are probably good defenses of not becoming a victim. I just hope that we can all stop the would be perpetrators by not giving them a chance to confront a vulnerable target. God bless.

Double golds for Philippines as Cray, Richardson top 100-m runs

Eric Cray and Kayla Richardson added two gold medals to the Philippines' SEA Games tallies to push the Pinoys past Myanmar for sixth place overall

MANILA, Philippines - Eric Cray's personal best finish in the men's 100-meter competition and Kayla Richardson's impressive showing in the women's 100-meter run resulted to two more gold medals for the Philippines in the 28th Southeast Asian games at the National Stadium in Singapore on Tuesday, June 9.

Cray, a 26-year-old 3-time All-American born in Olangapo, finished with a result of 10.25 seconds - a comfortable margin over Indonesia's Yaspi Boby and Iswandi Iswandi who both had 10.45 second-finishes and placed second and third, respectively.

It was another addition to Cray's a chievements, which already include being the first Filipino to reach the 400-meter hurdles finals at the

Asian Games since 1982 and ending a 28-year gold drought in the 400-meter hurdles at the SEA Games in Myanmar.

"I just tried to get out as good as possible...I don't think I had the best start. But I am just happy with the win," Cray said after the race.

The Filipino-American became the first Philippine athlete to qualify for the 2016 Rio Olympics in May, meeting the qualifying mark of 49.40 sec for the men's 400 meters hurdles at the Cayman Invitational Athletics.

The 17-year-old Richardson, a resident of Walnut, California whose mother hails from Zamboanga, tied with Thailand's Tassaporn Wannakit with 11.76 second finishes but came away with first place due to a superior reaction time of 0.216 to 0.174.

Their victories increased the number of medals for the Philippines to 12 golds, 17 silvers, and 26 bronzes, which stands at 6th overall in the medal count.

Pole vaulter Ernest John Obiena Obiena finished second in a new Philippine mark

of 5.25 meters to Purahong Pooranot, who won in 5.30. Obiena fell away after the bar was raised by five centimeters to 5.30 meters.

Harry Diones, the NCAA MVP from Jose Rizal University, finished a bronze medal by five centimeters in the triple jump. He jumped 15.87 meters.

The Philippines is set to win at least 14 gold medals and at least eight golds will becoming from the Fil-Am athletes. Cray is the favorite to take the 400 meter hurdles and lead the 4x400 meter relay team, Richardson or Princess Joy Griffey the 200 meters, Stuart the discus throw and Donovont Arriola, the men's long jump.

Marestella Torres is aiming to reclaim the long jump, while defending champion Archand Christian Bagsit or Eduardo Alejan are eyeing the 400 meters, Christopher Ulboc is seeking title no.2 in the 3,000 meter steeplechase just like Jesson Cid in the decathlon.







Philippines may ban pop singer Madonna for disrespect to flag

MANILA - American singer Madonna may face a ban in the Philippines for disrespecting its flag in her concerts this week in the capital Manila, a domestic broadcaster said on Friday, citing a historical commission official.

The 57-year-old entertainer is on a world tour to promote her "Rebel Heart" album, and did sold-out shows on Wednesday and Thurs-

"She ridiculed our flag," the official, Teodoro Atienza, told radio station dzBB, adding that Madonna violated a law that prohibits the wearing of the Philippine flag "in whole, or in part, as a costume or uniform"

The singer and concert producers could be held liable for the violation even if they were unaware of the law, said

Atienza, who is chief of the heraldry section of the National Historical Commission of the Philippines.

"They may face deportation and might not be able to return to the country. She also allowed the flag to touch the stage floor, which is another violation.'

There was no immediate response from the organizers of the concerts, held in the same hall where Pope Francis met Philip-

pine families last year.

Madonna's next stop will be in Singapore on Sunday.

A Roman Catholic bishop in the Philippines this week urged the faithful to boycott Madonna's shows over her "suggestive" performance and "vulgar" clothes.

Roman Catholics make up about 80 percent of a population of more than 100 million in the Philippines, where the church has strong influence, blocking legislation on the death penalty, divorce and same-sex marriage.
