# America first

here's trouble in the BPO industry, one of the nation's top employers, and it's not just due to President Duterte's apparent dislike for most things American.

You've heard the news, and it isn't encouraging: after President Donald Trump's 'America first' promise, US companies the biggest operators of BPOs in the Philippines – have put on hold expansion plans. The news has fueled fears of eventual shutdowns or significant downsizing.

Trump wants to roll back the tide of globalization. Normally this looks like a quixotic quest. But because this is the leader of the United States talking, people are waiting to see how he intends to compel American businessmen to go along with him.

American manufacturers took advantage of globalization and moved production out of the homeland to countries with lower labor and other costs. It also made sense in terms of logistics; outsourcing moved them closer to many of their markets.

Naturally, the move took away American jobs. But it helped ease unemployment and poverty in many developing countries. Why should America care? Steady jobs and rising incomes mean improved purchasing power for people in developing countries, which means larger markets for advanced economies such as the US. Developing nations may not be hiring American, but they're buying American, and European, and Australian-New Zealand...

China, for example, has become one of the largest markets for everything from automobiles to coffee and the world's luxury goods. If the Association of Southeast Asian Nations can get its act together, its combined market of about 650 million people can be a strong bargaining chip in trade negotiations.

Some Filipinos visiting the US are disappointed when they can't find items under their favorite American brands that are made in USA. But the Philippines has been among the top beneficiaries of US outsourcing and liberalized trade.

Fidel Ramos, in a visit to the US during his presidency, once needed gloves for the cold. His wife Ming bought a pair from one of the upmarket US shopping chains, and was surprised to find out later that the gloves were made in the Philippines.

In early October 2001 when I went to Hawaii as a Jefferson Fellow at the East-West Center, the most striking aspect of life in those first weeks after 9/11 was the widespread flag-waving as Americans expressed their patriotism.

And the striking thing about the Stars and Stripes being sold in all sizes all over Honolulu, from convenience stores to supermarket chains and the main shopping center, Ala Moana, across Waikiki Beach was that most of the flags were made in China and the rest in other developing countries.

I remember our futile hunt for a US flag made in USA because our fellowship included an amiable participant who is now a big shot in Chinese internet giant Tencent. She was amused by our hunt for a US-made flag and the trite jokes about God making the world while everything else was made

As we know, flags aren't the only items sold by the Chinese to the world. It seems they have a lock on tourist souvenirs - tshirts, baseball caps, key chains, cups,

Cheap production costs lured a horde of foreign investors to relocate to China, including iconic US jeans brand Levi's.

What may worry American manufacturers is the competition posed by their Chinese counterparts, who can produce almost everything cheaper. While consumers tend to get what they pay for and cheaper can mean inferior quality, there are millions worldwide who settle for cheaper ver-

This kind of competition posed by China's factories put several Philippine industries in the ICU, among them textiles and apparel as well as furniture.

This is the state of the global economy that Donald Trump wants to upend under his 'America first" policy.

Trump has said he wants his country to buy American and hire American - his formula for making America great again. Can he bring Levi's back to America?

US Ambassador Sung Kim urged us last Tuesday to let the Trump administration get settled first, to let the new president run his ideas by his economic team.

Kim expressed confidence that US commitment to free trade and fair trading rules would be sustained under Trump. Although the envoy was careful about making predictions about policy thrusts of the new administration, he said he did not expect a "dramatic shift" in the way Washington approached the issue of trade, except in 'specifics" such as a new focus on bilateral negotiations.

Even with Trump pulling the US out of the Trans-Pacific Partnership, which the Philippines has also not joined, Kim said his government would continue to focus on the importance of free trade, encouraging everyone to play by fair rules.

'I don't think that's going to have a negative impact on countries like the Philippines and on US-Philippines trade ties, Kim told us.

Still, the world is in jitters. After all, Trump vowed to set up a physical wall between the US and Mexico, and now he's moving to do it.

We should be ready for any adverse impact of "America first" on our BPO indus-

At the start of the BPO boom, a top official of a major development organization happily told me that the industry was slowing down the exodus of Filipinos for jobs overseas. Steady jobs with decent pay, the official also noted, was also weakening patronage politics especially in the countryside, because people no longer felt beholden to local politicians for many of their

Trump, of course, is not the only leader who is turning inward in an effort to stop the tide of globalization. There's our very own President Duterte, although his antiforeign rants are tempered by subsequent clarifications from his economic team. And unlike Trump, Du30 is befriending China.

Instead of engaging in a trade war with China, Trump the business mogul can learn from the Asian dragon, which became the second largest economy by embracing the world and the free market.

One day Trump and others who equate isolationism with nationalism may consider that what's good for the world generally tends to be good for individual states

# **Building the great wall of Donald Trump**

ust days after his inauguration, Donald Trump has set into motion his plan to build a wall along the common border between the United States and Mexico purportedly to keep off illegal immigrants.

When completed over the course of Trump's presidential term, the wall will stretch

over 2,000 kilometers. It will cost around 10.5 billion US dollars. But here is the catch. Trump intends to bill Mexico for the cost of construction! If that is not international bullying, I do not know what is.

Mexican President Enrique Peña Nieto (who was one of two heartthrobs during the APEC meeting in Manila) is, naturally, indignant. He cancelled a prior scheduled meeting this week with Trump to express his displeasure. Mexico demands respect, Nieto said. Furthermore, no way will Mexico pay for the construction.

The average Mexican is both angry and resigned. "Trump is a false prophet, leading the US into the desert. But if Trump wants to build a wall on his side of the border, there is nothing we can do about it."

While Trump has no love lost for the Chinese, his proposed wall along the Mexican border was obviously inspired by the humongous Chinese version.

The Great Wall of China actually consists of several separate walls built over centuries, spanning the reigns of several Chinese dynasties. Its purpose was to prevent foreign incursions into Chinese terri-

When placed end to end, the Great Wall, according to some estimates, would stretch more than 20,000 kilometers. Several portions of the original structures are no longer existent but the remnants are still large enough to be visible from outer space.

What would the Great Wall of Donald Trump look like?

In all probability, the wall would be at least 20 feet high (to prevent scaling) and at least 5 feet deep (to prevent tunnelling). To meet a tight construction schedule, precast cement wall panels would probably be used. This would require an estimated 339 million cubic meters of cement as well as several million pounds of steel. One can be sure, that in accordance with Trump's

America First Policy, the steel would be 'made in US.

If all goes well, the whole project will be completed just about the time Trump completes his 4 year presidential term.

The wall may or may not serve its purpose, according to observers. But one thing is definite. The construction will create jobs for the "forgotten Americans" who voted Trump into office. Farther down the road, the Great Wall of Donald Trump may also attract tourists, just like the original Great Wall of China.

While Mexican President Nieto has cancelled his meeting with Trump, Britain's Prime Minister Theresa May is pushing through with hers. Theresa May was the principal political beneficiary of the controersial Brexit vote.

The prime minister has some economic plans in common with Trump. One of them is a proposed massive cut in corporate income taxes. Like Trump, she is hoping that the corporate tax cuts would provide sufficient incentives to lure in business.

While many find Trump's ideas outlandish, it is not necessarily so with the financial market. Cheering the "Trump effect," Dow Jones last week closed above 20,000 - for the very first time in its history!

Apparently, Trump's promises of massive infrastructure spending, corporate tax cuts, 10 percent tax to encourage repatriation of offshore profits are enough to get the market quite excited.

Of course, these are, at this time, just promises....promises.

# Miss France is new Miss U

ris Mittenaere, a 24year-old dentistry student from Lille, France, edged out 85 other delegates to win as Miss Universe 2016 at SM Mall of Asia-Arena in Pasay City, yesterday morning. Like previous editions of the pageant, the three-hour event, the culmination of a threeweek activity all over the Philippines featuring some of the world's most beautiful and most intelligent women, had its share of surprises and controversies.

Mittenaere, wearing a clingy and beaded nude-colored gown, ended France's almost 64-year Miss Universe title drought. Prior to Mittenaere, the last French beauty queen who won Miss Universe was Christiane Martel.

"I was very surprised I won, I feel blessed," said the 24-yearold, whose competition profile had described her goal as advocating for dental and oral hygiene if she won.

Having clinched the crown, Mittenaere said she wanted to go beyond that and promote education for children and young women.

Malacañang extended its congratulations to Miss France for clinching the Miss Universe crown. "Congratulations to the new Miss Universe, Iris Mittenaere of France. People of France are rejoicing. Truly, this is a proud moment for their country," Presidential spokesman Ernesto Abella said.

"Iris brought tremendous joy to developed countries.

her people by representing France well on the international stage with her winning grace, regal bearing and inspiring answer," he added.

Abella said the new Miss Universe "won not only the nod of the judges but the affection of the entire world as well."

The Palace also lauded Miss Philippines Maxine Medina for her performance at the pageant. "We likewise congratulate Maria Mika Maxine Medina for making it to the Top 6. She represented the Philippines well in the international scene," Abella said.

THE French embassy in Manila expressed pride that Miss France Iris Mittenaere has been crowned Miss Universe 2016.

French Ambassador Thierry Mathou said the crowning of Miss France a year after Wurtzbach won is the "brightest symbol" of the spirit of our Phil-France: Feel French! Festival which was recently launched to celebrate the 70th anniversary of French-Philippine friendship.

"It is even more symbolic this vear as we mark the 70th year anniversary of diplomatic ties between France and the Philippines," said Ambassador Mathou. To witness Pia Wurtzbach pass the crown to Iris Mittenaere was truly a beautiful moment that represents the friendship between our two nations and our common quest for excellence."

In the same statement, the French diplomat congratulated all the contestants of the 2016 Miss Universe competition, "which celebrates the beauty, intelligence, and character of women from all over the world.'

In her first press conference some 30 minutes after she was crowned. the new Miss Universe revealed that beauty pageants are still popular in France despite people's waning interest in them, especially in

But Miss Universe is not as popular as it was before because it has been a long time since a French woman won it, she said. Because of her victory, she assured journalists and Paula Shugart, president of Miss Universe Organization (MUO), that Miss Universe would regain its popularity in France.

She has always advocated education for children, but now that she's Miss Universe, her involvement is bound to get bigger. She has also adopted one of MUO's pet causes, which HIV-AIDS awareness. She encouraged people to get tested.

"I have a charity, which is to teach children, but now I represent the universe, I want to do more than that," she said in English. "I want all the children to be in school, which is my charity, and it is the most important, education for children."

Her advocacy also includes young people, especially women because I have had the chance to live in France and to go to school every morning, and I think every children (sic) should have this chance."

#### **Toughest part**

Asked what was the toughest part of her journey to the crown, especially during the last round of competition, Mittenaere said: "Being in the top three was amazing for me, because this is exactly what I want to do. I wanted to do top six. When I was in the top six, Î was just like wow, and I answered the question."

fans to go far in the competition, few openly predicted that Mittenaere could pull off an upset by edging out perennial frontrunners Andrea Tovar of Colombia, Mariam Habach of Venezuela, Chalita Suansane of Thailand, and hometown girl Maxine Medina of the Philippines.

Tovar ended up as second runner-up, while Medina made it only up to the contest's top six. But the evening's biggest surprise was Habach's exclusion from the evening's first cut.

Easily coasting to the top 12, aside from Misses France, Philippines, and Colombia, were Misses Kenya, Indonesia, USA, Mexico, Peru, Panama, Canada, Brazil, Haiti, and Thailand. After the swimsuit competition, the number of delegates was cut to nine with the exclusion of Misses Panama, Peru, and Indonesia.

Haiti's Raquel Pelissier, who speaks five languages and is training to become an eye doctor, came out of nowhere and almost stole the thunder from Mittenaere. In the end, she had to settle for first runner-up, duplicating compatriot Gerthie David's feat in 1975.

The Philippines has now hosted Miss Universe three times, first in 1974, and then in 1994. Spain Although a favorite by pageant and India won respectively for the

first time in both pageants. Not a few pageant fans were already bracing themselves for a first-time win for Haiti.

#### **Final question**

During the make-or-break final question round, the last three girls standing composed of Mittenaere, Tovar, and Pelissier were all asked the same question by Miss Universe host Steve Harvey: "Name something over the course of your life that you failed at and tell us what you have learned about that experience.'

Mittenaere, answering through a French-speaking interpreter, said that she failed several times in her life. Once, in school, she thought she failed in her dentistry course because she couldn't find her name on the list of passers. She had to wait the next day to learn that her fears were unfounded because she did pass after she found her name in a "new book."

"So I think when you fail, you have to be elevated. You have to try to keep on going," she said in French. "If tonight I'm not the winner, I will still have the great honor of being one of the three fi-

Pelissier, this year's dark horse, had a more dramatic answer, as she Continued on page 5

#### **Dead or alive: Duterte offers reward for NBI agents** involved in kidnap-slay of Korean businessman

President Duterte said he will offer a P1-M reward in cash to anyone who can pinpoint the whereabouts of the three National Bureau of Investigation (NBI) agents allegedly involved in the killing of a Korean businessman Jee Ick-joo, if they fail to surrender within 24

Duterte, in a late night press conference in Malacañang, ordered NBI director Dante Gierran to do anything to make the involved agents surface within 24 hours.

He was also about to offer a P5-M reward in cash to anyone who can bring PSSupt. Rafael Dumlao to Camp Crame or even in front of the Malacañang Palace dead or alive, and without him asking any questions.

However, he only found out during the press conference that Dumlao had already returned to Camp Crame Sunday afternoon and is ready to 'tell all' about the abduction and killing of businessman Jee Ick-joo.

Jee was kidnapped from his house in Angeles City. Pampanga last October 2016 by around eight men including three police officers and three NBI agents and was reportedly killed inside Camp

same day. His remains was then brought to the Gream Funeral Services City and was reportedly cremated afterwards.

According to Duterte, he is enraged by the issue because Dumlao tarnished the reputation of the Philippine National Police, an institution he claimed to be 'corrupt to the core.'

"I am offering P5-M reward, cash, para kay Dumlao. Dead or alive. It will take effect pag hindi ka sumuko in 24 hours 'pag 'di ka sumuko (I am offering P5-M reward, cash, to anyone who can bring Dumlao, dead or alive. It will take effect if you don't surrender within 24 hours)," Duterte said before he learned that Dumlao had already surren-

"Bakit malaki? Kasi [expletive] sinira mo ang pulis. Galit ako kasi pati ako napahiya (Why is the reward big? Because you tarnished the PNP. I am enraged because even I got embarrassed)."

Duterte also revealed that PNP director general Ron-

ald Dela Rosa offered to resign in relation to the killing of Jee. However, he declined Dela Rosa's resignation because it will contribute noth-

ing to the progress of the case

"The scalawags will continue with or without Bato," he said, adding that around 40 percent of the police are used to corrupt practices.

Dela Rosa, during the same press conference, said he offered to resign because he wanted to give the President a free hand to choose someone else for the position who can do the job better.

"I wanted to give the President the free hand to choose somebody to replace me and do the job as expected. I don't want to add more embarrassment to the country," he said.

Dela Rosa also admitted that the case has affected the credibility of Oplan Tokhang.

Meanwhile, Dela Rosa said he will do his job to the best of his ability and hopes not to fail Duterte and the Filipino people.

# Murdered Korean cremated as 'Jose Ruamar Salvador, Filipino'

The crematorium staff say they learned that 'Ruamar Salvador' was actually Korean Jee Ick Joo only last January 18, when agents from the NBI paid a visit to St Nathaniel

He had been living in the Philippines for the last 8 years, but South Korean national Jee Ick Joo did not seem to have any intentions of changing his citizenship at least not vet.

But when the 53-year-old businessman's body was brought to a Caloocan City crematorium last October 19, his death certificate not only identified him as Filipino, it also said his name was Jose Ruamar Salvador, of Champaca Street, Sta Quiteria, Caloocan City.

Jee, who had a wife and teenage daughter, was abducted from his home in Angeles City, Pampanga on October 18, along with the family helper. He was apparently killed just hours

According to a staff member of the St Nathaniel Crematory in La Loma, Caloocan City, however, the remains of the man who would turn out to be Jee was brought there the next day and cremated at 11:00 in the morning.

An employee of Gream Funeral Services in Bagbaguin, Caloocan City had identified herself as the representative of the dead man's family and made the reservation for the cremation two hours earlier, said the St Nathaniel staff. It was also the same Gream employee who signed all the papers required for the cremation, the staff said.

#### **Death certificate forged?**

"We had no idea they were not related," said the crematorium personnel, referring to the Gream employee and Jee. "The assistant even looked distraught when they arrived at our office

to submit the documents for the cremation of the body.

The crematorium staff said they learned that "Ruamar Salvador" was actually Jee only last January 18, when agents from the National Bureau of Investigation (NBI) paid a visit to St Nathaniel

According to the St Nathaniel personnel, two people from Gream had gone to their office to submit the man's death certificate, a health permit from city hall, and authorization to cremate the remains. For the required identification card of a family member, the Gream employee whom the crematorium staff kept referring to as "the assistant" submitted her own ID. False information had been enrolled about the identity of the remains in the evidently fake death certificate.

#### Cause of death?

The St Nathaniel personnel said that the death certificate contained the time and cause of death, but declined to disclose the details. The staff also said it was only the second time that St Nathaniel had dealt with Gream, which is some 30 minutes away by car from the crematorium.

The urn containing the ashes of the deceased was released to the assistant, the crematorium personnel said. PNP chief Ronald "Bato" dela Rosa would later tell the media that a Gream employee had supposedly panicked and flushed the ashes down the toilet.

The crematorium staff said they have provided the NBI all the documents submitted to them for Jee's cremation. They also told PCIJ that a close-circuit television camera captures all the activities in the crematorium chamber and in St Nathaniel's offices.

#### Who is 'Penny'?

The St Nathaniel's staff said she saw the Gream assistant again at the NBI, where they had gone on January 18 (after the NBI's visit to the crematorium) to give their judicial affidavit on the events surrounding the cremation of Jee.

By then, the Gream assistant was answering to the name "Penny." According to the crematorium employee, she asked Penny, "Bakit ninyo naman kami dinamay dito (Why did you get us into this)?

Penny is apparently an assistant to Gream's owner, Gerardo Santiago, a former policeman who was assigned to the Northern Police District Senior Police Officer 3 Ricky Sta Isabel, one of the prime suspects in the Jee kidnap-slay, was once deployed to the same police district.

Penny and 4 other employees of the funeral parlor are now under the custody of the NBI. An NBI insider said that the 5 Gream personnel "could identify the people who brought the victim's body to them and ordered a cremation." The NBI insider added that apparently, policemen brought Jee's body to Gream at around 10:00 to 11:00 in the evening of October 18.

The insider also said that the Anti-Illegal Drugs Group members who were on duty when Jee was supposedly brought to the compound of the anti-narcotics group have been summoned by the NBI as part of its ongoing investigation. Penny and the 4 other Gream personnel may be put under the Witness Protection Program, said the NBI source.

In his message, Duterte noted how the Chinese have contributed to the economy through trade and investments, as well as in cuisine.

"Their cuisine has been dearly familiar in many Filipino homes. Their philosophy and attitude in life are a wellspring of practical lessons that all of us, regardless of nationality, can learn from," Duterte said. "May all of us develop more appreciation of our heritage as two distinct yet intertwined peoples and further fortify the goodwill that we have shared over the years."

# Mexicans begin to unite in fight against Trump's plans

MEXICO CITY — Mexicans are beginning to debate how to fight back against US President Donald Trump's aggressive stance on trade and immigration.

Prominent political figures have suggested the country expel US law enforcement agents, stop detaining Central American migrants or no longer inspect northbound trucks for drug shipments. Some activist groups on Friday were calling for a boycott of American brands.

Former President Felipe Calderon said Thursday that "we have to design a policy of retaliation" for Trump's proposed plans, which include making Mexico pay for the border wall he wants to build.

We have to put US security issues under review ... including the presence of (US) agents" on Mexican soil, Calderon told local news media.

The comments came after current President Enrique Pena Nieto scrapped a planned Tuesday meeting with Trump after the American president tweeted that it would be better to cancel if Mexico wasn't willing to pay for his proposed

Ruben Aguilar, a political consultant who was spokesman for former President Vicente Fox, noted Friday that Mexico has been stopping Central American migrants before they reach the US border "as part of the logic between two friendly countries."

He suggested that Mexico could

say, "Okay, I'm not going to stop Central Americans anymore," and added, "Now if our two countries aren't friends anymore, that is a card we could play to increase the pres-

"Drugs are another" possible card, Aguilar said. "If you want to stop them with your wall, well we won't stop them anymore, let them go through."

Trump appeared to try to defuse the spat between the two countries Friday, say-"Great respect for Mexico, I love the Mexican people.'

Pena Nieto met with Mexican lawmakers to discuss US relations. "There will be constant communication between the federal executive and the Senate to define what actions to take," said Fernando Herrera of the conservative National Action Party.

On Friday afternoon, Mexican business magnate Carlos Slim called for "national unity" in the face of Trump's hostility, and said the country should have a measured response "without getting

angry but without sur-rendering."

Slim called for a "modern, not protectionist" national program of substituting imported products, the vast majority of which come from the United

But he stopped short of calling for a boycott of American goods.

"I think it is an error to think about boycotting companies," Slim said. "What we should do instead is buy what is produced in Mexico.'

A coalition of Mexican farm and consumer groups, however, did call for such a boycott

Jan. 18, two days before Trump took office. The campaign's slogan

"Consumers cry war!" — echoes the first line of Mexico's national anthem as it calls on Mexicans to buy national products.

"The statements and threats from the US president-elect are irrational and unacceptable, but they should awaken a rational response, and lead us to radically change in our model of national development, and recover sovereignty over our food system," the coalition said in a statement.

In a country where US chain restaurants, coffee shops and stores are now ubiquitous, social media users created long strings of hashtags such as #AdiosStarbucks #AdiosCostco, #AdiosWalmart, #AdiosMcDonalds, #AdiosProductosGringos , #ConsumoProductosMexicanos.

Peter Schechter, senior vice president for strategic initiatives at the Atlantic Council, said the dispute may awaken underlying currents of resentment in Mexico. The US took away almost half of Mexico's territory in the 1848 Mexican-American War, though that historic resentment had faded in the last three decades.

"All this does is to solidify the view that an attempt to negotiate with the United States under this administration is impossible, and that we should break from the United States," Schechter said. "This argument has moved from incredulous, to possible in people's minds. The next step is it moves from possible, to the right thing, and that step is not that far.'

Former Mexican President Ernesto Zedillo wrote in an op-ed in the Washington Post that "the prudent thing" is to assume that Trump will kill NAFTA, which he said would be costly to Mexico.

"But such an outcome should not be cause for despair in my country," he wrote, calling for Mexico to reinforce its commitment to openness and tell companies from around the world that it remains open for business.

'The end of NAFTA, as disruptive and costly as it would be in the short term, could be compensated for with the right set of policies,' Zedillo wrote.

## Women's March

In a day of protest on Saturday, January 21, hundreds of thousands of women gathered in Washington, DC, to object to the agenda of President Donald Trump. The crowds in Washington were mirrored in demonstrations in cities across the country and around the world: in Boston, 175,000 people attended, according to the New York Times; in Atlanta, 60,000 people marched; and in New York, crowds of over 400,000 took to the streets, many of whom

donned pink hats and turned out along Fifth Avenue.

In the weeks leading up to the inauguration, the art world organized its resistance. Art spaces around the country responded to the #J20 call to stop operations on January 20 to "combat the normalization of Trumpism." Shepard Fairey designed a new series of hopeful posters for inauguration weekend that did not feature the image of the president this time around. And then there were the Dear Ivanka activist rallies and the "Nasty Women" art shows, which began with one exhibition that originated in a Facebook post and grew into a four-day fundraiser for Planned Parenthood and spawned similar shows around the world.

# Muslims barred from flights to U.S., as others detained

US President Donald Trump's order to ban entry into the US travelers from Iran, Iraq, Libya, Somalia, Sudan, Syria and Yemen sparks widespread international criticism and personal heartache

TEHRAN, Iran - Muslims from 7 countries were barred Saturday, January 28, from flying to the US and others detained there after US President Donald Trump froze arrivals, with one man saying his life has been "destroyed".

Iran, which saw many of its citizens stranded in European and Middle Eastern airports, denounced the "insulting" ban and said it would reciprocate.

Trump on Friday, January 27, signed a sweeping executive order to suspend the arrival of refugees and impose tough new controls on travelers from Iran, Iraq, Libya, Somalia, Sudan, Syria, and Yemen.

His move sparked widespread international criticism and personal heart-

"Donald Trump destroyed my life," Iraqi Fuad Sharef, 51, told Agence France-Presse.

He had been in transit in Cairo with his wife and two children when officials told them they could not board an EgyptAir flight to New York's John F Kennedy air-

"I had sold my house, my car, my furniture. I resigned from work and so did my wife. I took my children out of school" to resettle in Nashville, Tennessee under a special immigrant visa, he said.

A pharmaceutical industry manager who had previously worked for an NGO subcontracted by the US aid agency, Sharif and his family were put on a flight back to Iraq.

In Tehran, an Iranian studying in California said the new restrictions would affect her studies.

'I had a ticket for Turkish Airlines on February 4, but it has been cancelled,' the girl, who did not wish to be identified, told Agence France-Presse.

Several other Iranians hoping to fly from Europe were also told they could not board US-bound flights, stranded for the night in Vi-

Two travel agencies in Iran said they had been instructed by Etihad Airways, Emirates and Turkish Airlines not to sell US tickets or allow Iranians holding American visas to board US-bound flights.

There are no flights from Iran to the United States, where more than a million Iranians live.

Iranian President Hassan Rouhani did not comment directly on the ban Saturday, but said that now was "not the time to build walls between nations".

The Islamic republic's foreign ministry said it would "respond in kind after the insulting decision of the United States concerning Iranian nationals" until the measure is lifted.

Tehran called the decision "illegal, illogical and contrary to international rules". In Khartoum, the Sudanese foreign ministry expressed its "regret" at the US ban.

The New York Times reported that two Iraqi refugees with valid visas were detained late Friday at JFK airport just hours after Trump signed the order.

On Saturday, the American Civil Liberties Union and other advocacy groups filed a legal challenge to Trump's order, and asked for their suit to be considered a class

The United Nations urged Trump to continue his country's "long tradition" of welcoming refugees and to ensure their equal treatment, regardless of race, nationality or religion.

UN spokesman Stephane Dujarric said the world body hopes that Trump's decision to ban refugees is a temporary measure and that they will again be given protection.

French President François Hollande said Europe must have a "firm response" to Trump, and "when he refuses the arrival of refugees, while Europe has done its duty, we have to respond".

Trump's decree – which he says aims to make America safe from "radical Islamic terrorists" specifically says no visas will be issued for 90 days to migrants or visitors from the 7 Muslim states.

It also bars Syrian refugees indefinitely, or until Trump himself decides that they no longer pose a threat.

His decree suspends the entire US refugee resettlement program for at least 120 days while tough new vetting rules are established.

In Lebanon, Syrian refugees struggling to get by in makeshift camps bemoaned their fate.

"What on earth have the Syrian people done to deserve this?" asked Abu Mahmoud al-Ghol.

"And to think it's a democratic country doing it," the 44-year-old said.

Nearly 6 years of conflict in Syria have driven more than half the population from their homes, with many fleeing abroad and dreaming of new lives in

### Trump order will block 500,000 Legal U.S. Residents from Returning to America from Trips Abroad

In banning newcomers from seven countries from entering the United States for the next 90 days, the president has used language that will affect those who are in the U.S. already on visas and green cards

A spokeswoman for the Department of Homeland Security told Reuters on Saturday morning that the President's executive order will, in fact, stop green card holders from seven countries from returning to the United States if they travel abroad. "It will bar green card holders," the spokeswoman said.

When details leaked earlier this week about a spate of immigration-related executive orders from President Donald Trump, much public discussion focused on a 30-day ban on new visas for citizens from seven "terrorprone" countries.

But the order signed this afternoon by Trump is actually more severe, increasing the ban to 90 days. And its effects could extend well beyond preventing newcomers from Iran, Iraq, Libva, Somalia, Sudan and Yemen, from entering the U.S., lawyers consulted by ProPublica said.

It's also expected to have substantial effects on hundreds of thousands of people from these countries who already live in the U.S. under green cards or on temporary student or employee visas.

Since the order's travel ban applies to all "aliens" — a term that encompasses anyone who isn't an American citizen — it could bar those with current visas or even green cards from returning to the U.S. from trips abroad, said Stephen Legomsky, a former chief counsel to the U.S. Citizenship and Immigration Services under President Security reports. Obama.

Not included in the exemption, however, are those who hold long-term temporary visas — such as students or employees — who have the right to live in the United States for years at a time, as well as to travel abroad and back as they please.

"If applied literally, this provision would bar even those visitors who had made temporary trips abroad, for example a student who went home on winter break and is Are you from Iraq, Iran, now returning," Legomsky said on Friday evening executive order.

Trump made "extreme vetting" of foreigners a cornerstone of his campaign, particularly those countries that are predominantly Muslim and that he considers hostile to the U.S.

"I'm establishing new vetting measures to keep radical Islamic terrorists out of the United States of America. We don't want them here,' Trump said this afternoon, describing the intention of the executive order. "We want to ensure that we are not admitting to our country the very threats our soldiers are fighting overseas."

Trump signed the directive just before 5 p.m. but it took the White House almost three hours to release the actual text.

About 25,000 citizens from the seven countries specified in Trump's ban have been issued student or employment visas in the past three years, according to Department of Homeland

On top of that, almost 500,000 people from the seven countries have received green cards in the past decade, allowing them to live and work in the United States indefinitely. exempts from the ban those Legally speaking,

card holders are considered aliens. While lawyers are unsure if they would actually be barred from reentering the U.S. if they have traveled abroad, they conceded it's a possibility.

The White House did not immediately respond to a request for comment asking for clarification on the meaning of the executive

Citizens of Iran and Iraq far outnumber those from the other five countries among green card and visa holders. In the past 10 years, Iranian and Iraqi citizens have received over 250,000 green cards.

Iran also has the 11th most students in the U.S. among foreign nations, according to the Institute of International Education's Open Doors report, which tracks the demographics of international students.

"We are inundated with calls and questions of how this is going to affect people," said Jamal Abdi, policy director for the National Iranian American Council, an organization that advocates for better relations between Iranian and American people.

Abdi is concerned the temporary ban will become permanent. The order says the 90-day ban is meant to allow the U.S. and the seven targeted countries to discuss what information would need to be shared in order to start granting visas once again. But if no agreement is reached, citizens would remain blocked from entry.

"My interpretation is that the Iranian government is not going to comply regarding sharing information," Abdi said, "which would render this a permanent ban.'







ment, saying that "law enforcers must first secure warrants of arrest from judges before judges allow themselves to be 'physically accountable to any police officer' as she warned of a constitutional crisis." This did not bode well with Digong who responded angrily, "I'm giving you a warning. Don't create a crisis because I will order everybody in the executive department not to honor you," he said referring to Sereno. He added, "Please, don't order me. I'm not a fool. If this continues, (that) you're tying to stop me, I might lose my cool. Or would you rather I declare martial law?'

But there is one obstacle: the Constitution. Section 18, Article VII says that the President, as commander-in-chief, may "in case of invasion or rebellion, when the public safety requires it" suspend the privilege of the writ of habeas corpus or place the country under martial law." However, the martial law period or suspension of the writ of habeas corpus should not exceed 60 days. The writ safeguards individual freedom against arbitrary state action. It also specifies "that a state of martial law cannot override the function of both the judiciary and legislative

branches of the government." It also doesn't "authorize the conferment of jurisdiction on military courts and agencies over civilians where civil courts are able to function, nor automatically suspend the privilege of the writ.'

But his allies quickly defended him. Presidential Chief Legal Counsel Salvador Panelo said, "The imminent danger brought about by the proliferation of illegal drugs is enough basis for Duterte to place the Philippines under martial law." The question is: Can Digong declare martial law like a decision.

This is reminiscent of the dark martial law days of the Marcos era.

And this brings to mind Digong's ardent desire to have Ferdinand "Bongbong" Marcos Jr., the late dictator's only son and namesake, succeed him as president. Duterte is presumably indebted to the Marcoses who contributed large amounts to Duterte's presidential campaign. But the problem is that Bongbong lost the vice presidential election to Leni Robredo who took over the vice presidency at

the same time as Digong. Bongbong protested Leni's election, election, which was by a small margin, submitting 20,000-page document before Supreme Court (SC), which sits

as the Presidential Electoral Tribunal (PET). According to former SC Chief Justice Artemio Panganiban, it would take more than three years before the PET reaches

Well, for some reason, Digong couldn't wait that long to turn over the presidency by way of a 'resignation due to poor health." He said that he could be stepping down sooner, in which case he'd like Bongbong to persistently pursue his electoral protest. Which makes one wonder: How can Bongbong's electoral protest be expedited?

My crystal ball shows that there is one Associate Justice who is actively "lobbying" the other justices to rule in favor of Bongbong. Not three years, not one year, but very soon! The word is that majority of the PET has already been convinced to rule favorably for

Bongbong by abbreviating the process and calling for a vote immediately. How did the "lobbying" work? Is it by friendly persuasion or gentle pressure... or bribery? But if it works one way or the other, then we're looking at a decision very soon. However, it also rumored that a group

has been formed to resist martial law and stop Bongbong from taking over the presidency.

Ultimately, a Bongbong presidency could attract a hostile consortium of foreign governments who would impose economic sanctions against Bong bong and his government, just like the way the U.S. and her allies sanctioned Russia after she invaded Crimea, But Russia is barely surviving the sanctions only because she has a sovereign reserve currency of \$500 billion dollars; the Philippines doesn't have that kind of wealth.

But if for some reason, the Supreme Court justices come to their senses and for once demonstrate their loyalty to the Constitution that they were sworn to defend and uphold, then Digong might just do what he had threatened to do.

> Sad to say, all the gains that have brought the Philippines out of the economic doldrums during the Marcos era may be wasted by Digong's irresponsible and disgraceful act

of destroying the collective efforts of the Filipino people in the past three decades. And this brings to fore the question: Is martial law just a matter of time?

# China military official says war with US under Donald Trump 'becoming practical reality'

Sino-US relations are becoming more tense under America's new administration

**By Will Worley** 

ar with the US under **Donald Trump** is "not just a slogan" and becoming a "practical reality", a senior Chinese military official has said.

The remarks were published on the People's Liberation Army website, apparently in response to the aggressive rhetoric towards China from

America's new administration.

They communicated a view from inside the Central Military Commission, which has overall authority of China's armed forc-

Quoted in the South China Morning Post, the official from the Commission's Defence Mobilisation Department wrote: "A war 'within the president's term' or 'war breaking out tonight' are not just slogans, they are becoming a practical reality.

The official also called for military deployments in the tense South and East China Seas and for a missile defence system to guard the Korean peninsula, another regional hotspot, the Post reported.

The US should also reconsider its strategy in the Asia-Pacific region, the official wrote.

Mr Trump and members of his

administration have consistently voiced a hard line against China. Mr Trump has branded the country a "currency manipulator" and accusing the country of underhand trading and economic tac-

But more significantly in security terms, Mr Trump has also ignored the US's longstanding 'One China' policy, publicly engaging with the President of Taiwan, Tsai Ing-wen, in a move that was hugely antagonising for

China strongly regards Taiwan as part of its territory and the US has tacitly respected this for decades, but Mr Trump signalled a departure from this policy.

Secretary of State Rex Tillerson has also advocated a US naval blockade of artificial Chinese islands in the South China Sea which Beijing could interpret as an act of war.

Further suggestions China is preparing for conflict emerged this week, with unconfirmed reports the military has moved long range missiles closer to the north east border in Heilongjiang province -- within firing range of the US.

Chinese social media has carried pictures claiming to show the Dongfeng-41 advanced intercontinental ballistic missile system near the Russian border.

Provocative state-run tabloid The Global Times suggested the People's Liberation Army could have leaked the photos on social media as a warning to Mr

## China 'deploys long-range nuclear-capable missiles to coast' in response to Donald **Trump's 'aggression'**

English-language newspaper carries editorial urging Beijing to 'ready itself to pressures imposed by the new US Government'

hinese missiles with long-range nuclear capability have reportedly been deployed within striking range of the US.

China has moved long-range missiles to the Russian border from where they could reach

the USA, apparently in response PresidentDonald Trump's "aggression", unconfirmed reports say.

The missiles, warheads up

to 8,700 miles, have reportedly been moved to Heilongjiang province in north-east China.

A leading English language newspaper in the communist country carried an editorial urging the country to strengthen its nuclear arsenal to "force" the US to respect China in the wake of the new President's tough

The Global Times - which is state controlled like all Chinese media and is sometimes used to road-test public opinion - this week called on the Government to boost its nuclear arsenal.

The editorial said: "Before Trump took power, his team showed a tough stance toward China, and in turn, Beijing will ready itself for pressures imposed by the new US Govern-

And it added: "China bears the heavy task of safeguarding national security. Nuclear deterrence is the foundation of China's national security, which must be consolidated with the rising strategic risks."

It said a military clash with the US is "the very last thing that China wants" but nuclear weapons must be at the cornerstone of its deterrent.

The call is in stark contrast to a speech given by Chinese President Xi Jinping to the United Nations just days earlier, where he called for nuclear weapons to be "prohibited and destroyed over time".

Chinese social media has carried pictures claiming to show an advanced intercontinental ballistic missile system, Dongfeng-41 in the north-east.

The Global Times suggested the People's Liberation Army

could have leaked the photos on social media as a warning to Mr

The President, who has been in office for less than a week, has ruffled Chinese feathers with strident talk on trade and national security.

In one of the campaign debates with Hillary Clinton, he blamed China for stealing US jobs from Americans, for devaluing the dol-

lar and for engaging in state-sponsored cyberhacking.

Mr Trump said: "Look at what China is doing to our country. They are using our country as a piggy bank to rebuild China.'

He also said on Twitter back in 2012 that global warming was "a hoax perpetuated by the Chinese" – but has since said that was meant in jest.

Before he took office, Mr Trump stoked a diplomatic row by accusing China of flexing its muscles in the disputed territory of the South China Sea.

Mr Trump's nominee for Secretary of State, Rex Tillerson, said last week China's access to the islands it has built there might be blocked - raising the prospect of a military confrontation.



The US does not recognise Taiwan as a sovereign nation, but in December Mr Trump became the first US President or Presidentelect since Jimmy Carter in 1979 to speak on the telephone to Taiwan's leader, President Tsai Ingwen.

The bilateral relations between the US and China are regarded as among the most important in the world because of the potential for conflict and the size of their economies.

Relations between the two countries have generally been stable but with some periods of conflict - most notably in the Vietnam and Korean Wars.

Mr Trump has urged China to use its influence to rein in North Korea, which is believed to have conducted at least two tests of nuclear weapons in the last year.





# **Bataan Death March survivor recalls**

ALBUQUERQUE – December is one of the toughest months for 96-year-old Atilano David.

It was December 7, 1941, when the Imperial Japanese Navy made a surprise military strike on a United States naval base in Pearl Harbor, Hawaii. The deadly attack led to the United States' sudden entry in World

"I was 19; I thought I would never see 20," David told Bali-

tang America. "The hardships waiting for the enemy was is terrible.

David was among the 75 thousand Filipino and American troops to walk the 65 mile march to prison camps in the Philippines during the war.

"If I remember right, it was 7 to 10 days," he said, vividly remembering the experience. "It was about 65 miles from where we surrendered."

David was a young sergeant of the 31st regiment of the Philippine Division.

"In 'No Man's Land;' the place was already bomb[ed]... not even stone remained," he recalled. "For 3 days and 4 nights, we were subsisting on a tin of jelly, and four crackers, and there were four of us.'

David says that his experiences in the war, and part of the Bataan Death March, are all accounted for. He has already written a book and will be published in spring

"It is imperative that the young genera-

tions know what happened in Bataan, because the Americans and the Filipinos always had a good relationship," David said, remembering General Douglas Mac-Arthur's prominent role in the victory. "When Japan [invaded] the Philippines, the Americans were on the watch out for their welfare.'

The infamous death march is memorialized in several parks and museums in New Mexico.

From December 1941 to April 1942, 1,816 soldiers from New Mexico fought alongside Filipinos to combat Japanese invaders on the Bataan Peninsula. Of those soldiers from New Mexico, 829 died in battle.

Bataan Memorial Park in Albuquerque, New Mexico pays tribute to its soldiers both living and dead, that their bravery and sacrifices shall forever be etched not only in history books, but in the memories of generations to come.

# Free Range Chicken

Starting a poultry project needs a good plan to succeed.

In management, planning is the first in Housing the processes before leading, organizing, and controlling. Planning is the process of

identifying objectives and how these objectives can be attained. A good plan must be specific, measurable, attainable, realistic, and timebound.

Doing some research on free range chicken in the Philippines is a plus factor. I did mine and here are the results I found on the net.

Dimension of the poultry house:

It must be 1 chicken: 1 square meter for indoor or 1 chicken: 1 square meter outdoor

**Brooding:** 

Incandescent light or charcoal heat can be some practical ways to treat our chickens. used for 1-21 days old chicks.

Feed the chicken with organic feeds once in the morning and once in the afternoon. For noontime, feed them with vegetables. A regular size feeder can accommodate 25 chicks. One gallon of water can provide hydration to 25 chicks. Booster is recommended for 1-21 days old chicks. Starter is recommended for 21-45 days old chickens.

Broiler finish or corn for 45-84 days old

Use native materials like nipa for the roof and bamboo for posts and beams of the

chicken house. It does not need to be expensive.

For the flooring, rice hull or CRH (carbonized rice hull), and sand can be used to prevent odor. EMAS (effective microorganism activated solution) can be sprayed over the flooring once a week to best control the odor.

Vermi cast (earth worm manure) from ANC (African Night Crawler) can also be utilized to remove odor.

**Treatment** 

Chickens, like human beings, get sick too. Here are

Sili (pepper) and bawang can be used as antibiotics to prevent infection. Oregano for respiratory problems, ipil-ipil as dewormer (purga). Lemon grass (tanglad) as detoxification, mosquito and snake repellant, and water with xonrox as feet and shoes bath

hough busy with the upcoming coronation night, Miss China Li ZhenYing shared to Philstar.com her Chinese New Year traditions.



# Fight becoming inevitable as Conor McGregor, Floyd Mayweather make their pitch

However unlikely, however illogical, despite the many barriers and the skepticism from those on both sides of the aisle, a boxing match between UFC star Conor McGregor and retired boxing star Floyd Mayweather Jr. is becoming more and more inevitable with each passing day.

The lure of those three million, perhaps more, pay-per-view buys is becoming increasingly difficult to ignore, even for the well-heeled Mayweather.

A few hours after McGregor conducted a pay-per-view interview — yes, a pay-per-view interview that pushed the possibility of the fight happening a little further down the tracks — Mayweather showed up Saturday at the MGM Grand to do his part.

Carl Frampton and Leo Santa Cruz were fighting for the WBA featherweight title in front of a raucous, passionate crowd of 10,085 at the MGM Grand Garden on Saturday. Frampton is Irish, like McGregor, and so the fight was broadcast to Ireland and the United Kingdom on Sky Sports 1. Showtime broadcast the card in the U.S.

Mayweather showed up precisely as the co-feature between Mikey Garcia and Dejan Zlaticanin ended, which gave him the opportunity to play ringmaster yet again. The estimable Jim Gray of Showtime got Mayweather first, and asked him if he wanted the fight.

Mayweather smiled that mega-watt smile of his and flung his head back as if he hadn't been expecting the question.

Does he want the fight? Duh.

Of course he wants the fight. The entire reason he showed up at a fight card he wasn't promoting was precisely to go on television, particularly in the U.K., where McGregor fans and possibly McGregor himself were watching, and make his points.

And he didn't exactly pour ice water on the idea, either.

"I believe the fight can happen," Mayweather told Gray. "Like I said before, he is a tough competitor. He has proved throughout the years in the UFC that he can fight standing up. We'll have to see what the future holds."

He wants the fight because he can make a boatload of money and because he believes

it will be an easy bout. M c G r e g o r has no boxing experience — neither amateur nor pro — and Mayweather is already a massive favorite in sports books.

Earlier in the day, McGregor did his part to move the

with an Instagram post in which he exclaimed, "[Expletive] the UFC."

That was no random post, however. It was a very strategic move by McGregor and it was meant for Mayweather's ears. He was letting Mayweather know that he, too, is his own boss.

Mayweather has used this, "I'm my own boss," concept to great effect in the nearly 10 years since he defeated Oscar De La Hoya at the MGM Grand Garden to leapfrog the Golden Boy and become the sport's biggest draw.

He's used it repeatedly to give himself an edge in negotiations with every fighter he's fought subsequently, including Manny Pacquiao. In the long, slow slog toward a Mayweather-Pacquiao fight on May 2, 2015, Mayewather repeatedly pointed out he was free to choose what to do on his own, but that Pacquiao had to answer to promoter Bob Arum. He said it often enough and loudly enough that eventually it became accepted as true, whether or not Arum held that sway over Pacquiao.

The Mayweather-Pacquiao fight, which came long after it should have happened, sold 4.6 million pay-perviews, and shows the kind of market that may exist for a Mayweather-McGregor fight.


McGregor did his part, though, to show he's his own boss, too, and thus tried to level the playing field somewhat in the negotiations. Mayweather has three massive pay-per-view successes that McGregor can't approach: 4.6 million sales vs. Pacquiao; 2.5 million vs. De La Hoya and 2.2 million vs. Canelo Alvarez.

McGregor has been over a million in each of his last three fights, and Mayweather's last fight, against Andre Berto in 2015, was a relative flop, selling just 400,000.

# Australia looks set to host Manny Pacquiao - Jeff Horn fight

Queensland state in Australia may play host to Manny Pacquiao's next fight, with the 52,500-capacity Suncorp Stadium in Brisbane being considered

SYDNEY, Australia – WBO welterweight world champion Manny Pacquiao could fight Australian Jeff Horn in Queensland state after officials confirmed Sunday, January 28 (Sunday in Manila) they were in negotiations to host the bout.

There has been weeks of speculation that the 38-year-old Filipino dubbed "Pac-Man" will get into the ring with Horn in April, possibly in Australia.

"We now are getting the pieces together to deliver this major fight," Queensland's tourism minister Kate Jones told reporters in Brisbane.

"We are working very closely with Duco Events, (venue manager) AEG Ogden and as well as the (Brisbane City) Council to secure this fight here in Brisbane.

"We're hoping to lock this down as soon as possible."

Describing it as the "largest boxing event in Australia", Jones said her government was keen to secure the fight at the 52,500-capacity

Suncorp Stadium.

Suncorp Stadium general manager Alan Graham said 28-year-old Horn was keen to fight at the Brisbane venue.

"He's personally said that he couldn't think of anything more exhilarating than walking out in the middle of Suncorp Stadium with a full house and people backing him... for a fight," Graham told reporters.

Horn's promoter Duco Events was not immediately available for comment.

Brisbane's Courier Mail newspaper said Sunday the fight had been pencilled in for April 23.

Pacquiao, who has parlayed his sporting fame into a career in politics, is a veteran of 67 fights with 59 victories.

His record easily dwarfs that of Horn, who hails from Queensland, who has notched up only 17 fights with 16 wins.

Pacquiao said last week that negotiations for the fight, including the date and opponent, were still ongoing.

# Hollywood producers name 'La La Land' the year's best film

ollywood pronamed ducers the musical "La La Land" the best film of 2016 on Saturday at a ceremony marked by criticism of President Donald Trump's immigration policies.

Musician John Legend, a star of "La La Land", criticized the new president's executive order placing curbs on people arriving in the United States from certain Muslimmajority countries, which spawned protests and confusion at several U.S. airports on Saturday. "We encourage everybody out there to speak out against it," Legend said.

Later, introducing the splashy, colorful musical film, Legend said "Our vision of Amertalk television award.
