Thanks to Mona Pasquil, Appointments Secretary in the Office of Governor Edmund G. Brown Jr. the event


was held again at the Governor's Council Room. a beautiful meeting venue that continues to remind the guests of this annual event that they are indeed being celebrated by the State of Califor-

# The drug war beyond Duterte

▼ iven this administration's propensity for theatrics — including (but not limited to) crying police chiefs — I am not convinced that the Philippine National Police's withdrawal from the so-called "drug war" is the end of this horrific and bloody campaign. We have seen this before in the aftermath of the killing of Korean businessman Jee Ick-joo, when an angry President Duterte described the police as "rotten to the core" and announced that the Philippine Drug Enforcement Agency would lead the campaign against illegal drugs. As we now know, that volte face proved to be a 360-degree turn. Even if the police would in fact turn its attention to other matters, the Pandora's box of violence remains open and will continue to be that way unless the perpetrators and enablers of impunity are held to account.

Because he has made it the core of his presidency, the drug war is inexorably linked to Mr. Duterte's political fortunes. But beyond the ramifications of the drug war to the current regime (and vice versa), we must also be reminded of something that might vex both political sides (or be ignored altogether): the fact that ugly elements of the drug war have actually been waged for decades.

Random drug testing among high school students? It's actually in Republic Act No. 9165, Article III, Section 36, signed into law by GMA, and is reaffirmed in the National Anti-Drug Plan of Action 2015-2020, set forth during P-Noy's term.

Shaming of drug suspects? We've seen it in 2000 with Interior Secretary Alfredo Lim spray-painting the homes of suspected drug pushers, fully endorsed by then President Erap.

An opposition senator being linked to the drug trade? Before Leila de Lima, there was Ping Lacson, implicated by "Rosebud" Ong in 2001 — both of them leading the dramatis personae of those tempestuous times.

Death penalty for drug pushers?

Mr. Duterte wants it, GMA mulled it, but Ferdinand Marcos actually did it, overseeing the execution of Chinese drug lord Lim Seng by firing squad just a few months after he declared martial law.

Extrajudicial killings? It's been happening for a long





among many others. In light of this history, I worry that even after Mr. Duterte is gone, the "war on drugs" will once again be invoked by politicians for the same sinister ends. How can we prevent this from happening?

There are no easy, comprehensive answers to this question, but one key step is to change the way drug users and drugs are viewed by society. For decades, drug users, especially the poor have been demonized, and drugs blamed for the most gruesome crimes. Indeed, from the 1970s, when Erap starred in a film called "Kill the Pushers," to our time when Mr. Duterte is actually calling for the killing of drug pushers, the idea that drug "addicts" are the worst of criminals has been widely shared in our

The ethnographic picture, however, is very different. Various studies (including my own research) show that among poor communities, people use shabu (crystal meth) for a variety of reasons: to stay awake in order to work longer, to boost en-

ergy in order to perform manual tasks, to stave off hunger, or to forget their problems. While there are problematic (and criminal) drug users, the same can be said of alcoholics and power-drunk politicians: The human mind never required a dose of any chemical to be capable of harm or evil. Most drug users need help and rehabilitation — not death or punishment.

But society — including the media — has largely subscribed to the dominant narrative. "What a horrible act!" I recently heard one AM radio commentator say of a man who killed his mother. 'The suspect must have been an adik because only adiks are capable of doing such

This very low regard for drug users has made it possible for the President to call for their elimination and still maintain his popularity; in fact, such calls can boost his ratings. And so we must deal with an inconvenient truth: Many people know there is extrajudicial killing but approve of it, because like Mr. Duterte, they genuinely think that adiks don't deserve to

# Are doctors allowed to make mistakes?

and I was picking up the projector and the rest of my stuff in the conference room. To say that I had messed up was to make an understatement. A last-minute biopsy slide, which turned out to be that of a different organ, was probably the worst that could happen to a pathologist in training. Oh, my God, I thought, there is no recovering from this one. I had failed to adequately establish the cause of the patient's death.

Many people view doctors as infallible. That was my perception, too — until I began the journey of becoming a doctor myself. It's more of a burden for pathologists because clinicians depend on us for diagnosing malignancies, classifying or staging tumors, or confirming infections that would have serious implications on the treatment approach. Meaning: A misdiagnosis might result in the surgeon removing a benign breast or kidney, or the oncologist administering the wrong chemotherapy protocol, or clinicians undergoing the nightmare of over- or undertreating their patients.

I have tremendous respect for my fellow residents and consultants. More often than not, after a less than desirable score on the monthly exam where we are ranked, or

The crowd had left, missed lesions on microscopy, I doubt whether I should continue. Being in this specialty requires one to be objective, methodical and precise — three adjectives seldom used to describe me. While my colleagues were completing secondary education in science high schools, I was a college student during the day and a call center agent at



night. Almost every move on their part was geared toward the goal of becoming the specialist they intended to be. In my case, I started late in medical school in the province, with the intention of becoming a general practitioner.

Almost a year into training, I am still adjusting in a major way. Distinguishing benign lymphocytic proliferation from lymphoma and further subclassifying require years of study, and up to now, doling out a diagnosis of cancer makes my heart beat faster. Of course, the fact that I'm alone in this journey — my brothers, my only family left, live abroad

— does little to help. Homesickness presents a constant struggle, but I have been in frequent touch with pathologists in my native Leyte for encouragement and direction. Training in Manila comes at a high price, and I hope that when I go home to practice in the province one day, it would all be worth it.


I had felt this overwhelming longing to be with family and something familiar and comforting, but I needed to again head to the morgue to get additional tissue sections, to correct my mistakes in the diagnosis. I needed to prove in this case that mucosal and submucosal erosions and profuse bleeding from enteropathy had killed the patient.

I laid out the organs on the steel table, and began unraveling the colon. An image flashed in my mind: the patient's face, not when his body was undergoing my autopsy, but the way he looked in his ID card as a fresh graduate. He was young, and his siblings were at a loss as to what had really happened to their brother.

I thought I owed it to the patient to find the truth about his demise.

For a moment, I forgot about my own problems and focused on the task. But there was a lump in my throat and tears began to blur my eyes. Maybe it was the formalin, or maybe it was just me.

# Bongbong confident he will soon be VP

The son and namesake of late Philippine dictator Ferdinand Marcos declared Thursday he was confident of ousting the current vice president in a legal challenge, which would place him a heartbeat away from leading his country.

Ferdinand "Bongbong" Marcos Jr. also confirmed his family was in talks with President Rodrigo Duterte, a political ally, to end the government's three-decade hunt for billions of dollars worth of national assets allegedly stolen by his father and mother during their reign.

Marcos, 60, narrowly lost the vice presidential election last year but he filed a case with the Supreme Court alleging the victor, Leni Robredo, cheated by manipulating computerized vote counting machines.

that when the recount starts the true result will emerge and prove that the votes in the vice-presidential election had been incorrectly counted," Marcos told reporters.

Victory for Marcos would cement his family's remarkable political comeback, 31 years after a famous "People Power" revolution saw millions of people take to the streets to end his father's 20-year rule and force the family into US exile.

Ferdinand Marcos Sr. died in Hawaii in 1989, his reputation mostly in tatters with the government accusing him and his cronies of embezzling up to \$10 billion from state coffers during his time in power while over-

"In the past five months, we started with some 3,000 structures or buildings to be cleared," Pamonag said.

The MBLT10 was the first to reach the "finish line.

"This unit was the first that reached the final objective," he added.

The task, according to Pamonag, was very daunting and very challenging. But after almost 150 days of pushing, the military came to a point that less than five structures were left to be cleared inside the main battle area.

The full-blown battle in Marawi that started with what was a raid on a house where Abu Sayaff top leader, Isnilon Hapilon, the anointed leader of Islamic State in Southeast Asia, was staying.

Hapilon, together with the Maute group top leader Omarhayyam Maute, were killed in an early dawn assault operation, on Mon-

A day after their fall, President Rodrigo Duterte visited Marawi and declared its liberation from the influence of terrorists.

Pamonag said their mission in Marawi is one of the most successful urban battles "that we have participated" in the recent Philippine history since World War II.

"It is a test of determination," he added.

Brawner said the remaining militants, which he considered insignificant, were hiding in at least five buildings.

"Firing of guns can still be heard right now," he said. "There are still resistance from our enemies so or troops are very careful."

said 11 of 21 hostages rescued on Friday were still being verified if they were really hostages or dependents of Maute and Abu Sayyaf.

Since May 23, the number of military and police casualties had reached 165. The civilian casualties was placed at 47, while the militants suffered 897 deaths.

Officials said 1,777 civilians, who were either held as hostages or trapped in the crossfire, had been rescued since hostilities broke out

'We are trying to find out how many hostages are still inside the war zone. But we are confident fighting will be over," Brawner said.

# Battle of Marawi ends

Building where Maute militants made final stand captured; 42 bodies found By AFP, AP, & FRANCIS WAKEFIELD

five-month battle against Islamic State (IS) supporters in Marawi City that claimed more than 1.000 lives has ended, Defense Secretary Delfin Lorenzana said on Monday.

"We now announce the termination of all combat operations in Marawi," he told reporters on the sidelines of the 11th ASEAN Defense Ministers Meetings at the Clark Freeport Zone in Pampanga.

With the situation slowly returning to normal, the Philippine flag was raised at the Marawi City Hall for the first time since the siege started last May 23.

Mayor Majul Gamdamra led a short program fol-lowing the flag-raising ceremony, saying "normal operations will start today (Monday) in preparation for the return of the internally displaced persons.

Lorenzana said there were no more militants, known locally as coming from the Maute Group, providing resistance following an intense final battle that led to the capture of a two-story building where pro-Islamic State group militants made their final stand after which 42 bodies were discovered.

Those are the last group of stragglers of Mautes and they were caught in one building and so there was a firefight so they were finished," he said

"All terrorists, fighting troops. All hostages have been recovered."

"In crushing thus far the most serious attempt to export violent extremism and

radicalism in the Philippines and in the region, we have contributed to preventing its spread in Asia and gave our share to maintaining global peace, stabilty and securty.

"We declare that this achievement is clear manifestation of how our regional cooperation will lead to a decisive advance against the proliferation of terrorism in this part of the world," Lorenzana added.

Presidential spokesman Ernesto Abella commended the troops for neutralizing Maute-led rebellion, saying the government could now shift to the massive rehabilitation of the war-torn city.

He said the defeat of the Daesh-inspired Maute Group also highlighted the government's "singleness of purpose" in the global war against terrorism.

It's possible that a few militants may still be hiding. It was not immediately clear how the dozens of suspected militants found in the twostory building near Lake Lanao died but it's possible some committed suicide after they were cornered by troops, said an official, who declined to be identified as he is not authorized to talk about the situation.

Hundreds of gunmen who had pledged allegiance to IS

rampaged through Marawi, the Islamic capital of the mainly Catholic Philip-pines, on May 23, then took over parts of the city using civilians as human shields.

President Duterte and security analysts said the militants were trying to establish a Southeast Asian caliphate in Marawi.

The ensuing US-backed military campaign to evict the militants claimed more than 1,000 lives, displaced 400,000 residents and left large parts of Marawi in

Duterte travelled to Marawi on Tuesday last week and declared the city had been "liberated," shortly after Abu Sayyaf leader Isnilon Hapilon, the designated "emir" in Southeast Asia of the Islamic State, was shot dead there.

But the continued fighting raised questions over whether the city was indeed free of the militants.

Hapilon, who was on the US government's list of most-wanted terrorists, was killed along with one of group's other leaders, Omarkhayam Maute, according to the military.

Hapilon and Maute, along with hundreds of other militants, had been able

# Gadon says impeach bids aim to 'flush out' 'yellows' in gov't

The main goal of the impeachment plaints lodged against the heads of different constitutional bodies is to cleanse the government of former President Benigno Aquino III's appointees and get rid of the so-called "yellow virus," lawyer Larry Gadon admitted Saturday.

"Kailangan tanggalin mo yang mga viruses ng mga yellow diyan kasi sila puro sila mga tuta ni Noynoy—to be blunt with this, wala na tayong paliguy-ligoy diyan. Mga tuta ni Noynoy Aquino yang mga yan e," Gadon said in a news forum held at Annabel's Restaurant in Quezon

Gadon had filed an impeachment complaint against Chief Justice Maria Lourdes Sereno, which is currently being heard by the House committee on justice. He alleged Sereno has been ruling against the Duterte administration

tration," he said.

(Chief Justice Sereno is also a minion of Aquino because it's obvious that all her decision is against the administration.)

Sereno had voted against the burial of the late dictator Ferdinand Marcos at the Libingan ng mga Bayani; favoring the dismissal of illegal drug raps against Sen. Leila de Lima who is a critic of President Rodrigo Duterte's critic; and voted to declare martial law only in Marawi City.

Gadon also charged Ombudsman Conchita Carpio-Morales of displaying "selective justice" as she only filed cases against those opposing Aquino. He accused impeached

Comelec chief Andres Bautista of compromising the country's democracy over allegations of widespread cheating in the 2016 elec-

complaints, Gadon said, are part of pursuing checks and balances in the government.

"Again, we (don't) have true democracy if we will not do these things. Ang focus talaga namin dito is (Our focus is really) to attain the principle of checks and balances," he added.

Last week, law expert and Lyceum of the Philippines College of Law Dean Ma. Soledad Deriquito-Mawis said that an impeachment is not a "light weapon to be used on the whim of those entrusted with the process," or else it will "make a mockery of the entire democratic process" and the other instruments that ensure checks and balances in the government.

Impeachment, the expert said, should only be used as the "last resort when other options for correction have been applied without effect."/jpv

ecently, political debate was sparked on whether the 1987 Constitution would allow President Rodrigo Duterte to form a revolutionary government in lieu of declaring martial law. Supporters of Duterte say that by forming a revolutionary government, he doesn't have to make a report to Congress, which is a proviso of the 1987 Constitution when martial law is declared.

The framers of the Constitution believed that by requiring the President to report to Congress when the President declares martial law, it would prevent a repeat of the Marcos-era martial rule where Congress was transformed into rubber-stamp legislative body. It supplanted the rule of law with the rule of man.

But President Duterte figures that by forming a revolutionary government, he can still avail of the military's support, which is stacked up with loyalist Dutertistas, who would keep him – and themselves -- in power. And they'll be part of a power structure that will protect their personal and business interests. It's a philosophy that keeps the few elite in power.

### **Dutertism**

Duterte's campaign against criminality and illegal drugs has so far claimed the lives of at least 10,000 alleged drug users. However the "war on drugs" has failed to put the powerful drug lords out of action. Duterte himself has admitted to the existence of Chinese triads in the country. Tons of the illegal drug "shabu" continue to proliferate the country due to conniving customs officials, powerful smug-glers, and corrupt influence

peso is falling and the cost stitutional. It is also preof food is going up.

With each passing day, the country's gloomy situation has evoked fears of martial law. And as criticism against Duterte's "war on drugs" and extrajudicial killings intensifies, Duterte warned that he'd declare a revolutionary government if his critics' attempt to "destabilize" the government escalates and causes trouble. He accused the (communists) and the "Yellows" (Liberal Party and supporters of former President Benigno Aquino III) of conspiring against him. He said that he'd arrest all of the destabilizers once he declares a revolutionary government, just like what Marcos did when he declared martial law. He jailed almost all of the Liberal Party leaders including Sen. Benigno Aquino Jr. (Cory's husband).

He likens his move to what former President Cory Aquino did. He said that Cory was about to declare martial law and then changed her mind and instead declared a revolutionary government.

However, lawyer Romulo Macalintal disagreed. In a media interview, Macalintal said that as a lawyer, Duterte should know that "revolutionary government is the result of a revolution where the existing legitimate government is completely overthrown by a new group of leaders that establishes its own government.'

He cited the EDSA People Power Revolution in 1986 that ousted the late dictator Ferdinand Marcos and installed Cory Aquino as its "titular head," and later as the chief executive, under the Freedom Constitution (also known as the Cory Constitution).

If Duterte insists on pursuing a revolutionary government, then it goes without saying that he is doing it to circumvent the Constitution; thus, it is illegal and uncon-

sumed that Congress would cease to exist, as we know it. How can it continue to function as a legislative body under a revolutionary government where Duterte would rule by decree? He might allow Congress to exist only to rubber-stamp his own legislative agenda. Wasn't that what had happened during Marcos' martial law era?

The Supreme Court under a revolutionary government could likewise be under the indirect control of Duterte. In my column, "Dutertesized Supreme Court" (September 22, 2017), I wrote: "If Duterte succeeds in removing [Chief Justice Maria Lourdes] Sereno and appoints someone whom he knows would be loyal to him, it would create a 13-justice super bloc that could easily provide him with a minimum eight-vote majority.

### Fascism

If Duterte succeeds in appointing majority of the Supreme Court Justices led by a Chief Justice of his own picking, then Duterte's revolutionary government would become a one-man dictatorship in the mold of the late Benito Mussolini, the founder of Fascism, a form of radical authoritarian nationalism characterized by dictatorial power, forcible suppression of opposition, and control of industry and commerce. Fascism flourished in Europe from the 1920s to the end of World War II. The three major fascist states were Germany under Hitler, Italy under Mussolini, and Spain under Franco.

Mussolini believed that the government is "supreme and the country is all-encompassing, and all within it must conform to the ruling body, often a dictator." Mussolini also believed that "any type of questioning the govern-

Volunteers donated more than 2,100 hours in the search efforts, the San Bernardino County Sheriff's Department said.

The bodies of Nguyen and Orbeso were found in a remote area of the park at 11:30 a.m. Oct. 15, according to a National Park Service press release.

Gilbert Orbeso, Joseph's father, was part of the search party that found the bodies, reported KABC. Gilbert Orbeso had continued searching for the hikers on weekends, aided by friends and volunteers, after the official search was called off.

On Oct. 15, he found pieces of clothing, water bottles and food wrappers in a wash two miles from the Maze Loop. Searchers followed the trail to the two bodies, found embracing each other.

"I feel that we have closure and we know we found them. That was our main goal, to find them," Gilbert Orbeso told KESQ Oct. 15.

Joshua Tree National Park, in San Bernardino and Riverside counties, covers 792,000 acres, an area slightly larger than the state of Rhode Island, according to the National Park Service.

A large part of the park is a designated wilderness area. About 1.4 million people visit the park each year.

The volunteer Joshua Tree Search & Rescue team said in a reply to a comment on Facebook that it's "surprisingly easy" to become lost in the park.

"You can take a short hike and lose sight of the road, and, if you didn't pay attention to what the landmarks look like, in the opposite direction, you could start wandering," a volunteer wrote. "People even get lost a short distance from a trail."

Disaster Supplemental Nutrition Assistance Program (D-SNAP) gives food assistance to low-income households with food loss or damage caused by a natural disaster and is available regardless of immigration

FEMA Longer Term Assistance (e.g. Individuals and Household Program) provides financial and direct services to eligible individuals and households affected by a disaster who have uninsured or underinsured necessary expenses and serious needs. It is available if at least one household member is a U.S. citizen or a "qualified" immigrant. # How big is the burn area of California's wildfires? It would engulf several major cities

As wildfires continue to burn in California, here's a look at the size of the burned areas compared to cities – and even a state.

California's major wildfires have burned more than 330 square miles, the state Governor's Office of Emergency Service said Tuesday.

That is about equal to the size of Sacramento, about 100.1 square miles; Fresno, about 114.7 square miles; San Francisco, about 46,87 square miles; and Oakland, about 77.86 square miles, combined.

The area burned has surpassed the size of New York City's five boroughs cago, which is 234 square miles. It's also 65 percent

Bronx, Manhattan and Staten Island - which measure about 305 square miles, SF-

The burn area is also more than a quarter – 27 percent – the size of Rhode Island, which is about 1,214 square miles, and larger than Chithe size of the city of Los Angeles, which is about 503 square miles.

Firefighters have said they are finally beating the blazes in Northern California, but a new fire erupted in the Santa Cruz Mountains and a large fire – now contained – hit Orange County in Southern California.



### Lost hikers decided to die to end their suffering, friends and family believe

Family and friends reacted with shock and grief to the discovery that missing hikers found in Joshua Tree National Park died of gunshots, but expressed confidence that it was a mutual decision to end their suffer-

Searchers found Joseph Orbeso, 22, and Rachel Nguyen, 20, both of Orange County, Calif., dead in each other's arms Oct. 15 in a remote part of the national park east of Los Angeles. On Friday, the San Bernardino County Sheriff's Department revealed that Orbeso appeared to have

shot Nguyen, then himself. Sheriff's department spokeswoman Cindy Bachman told KABC that the hikers appeared to be in a "very dire" situation. They had arranged clothing to shade themselves and seemed to be rationing food, but had no water, she

"They were lost, they were in a bad area there, and their resources were either almost gone or gone, again, they were in a very desperate situation," Bachman told the station.

In another interview, Bachman told USA Today that the evidence did not suggest Orbeso had planned the killings in advance. "There is no indication that he wanted to harm her; that there was any plan for something like this," Bachman told the newspa-

the bodies was registered to Orbeso, Bachman said. Authorities did not initially release the information about the gun or gunshot wounds because the bodies still awaited autopsies and final identification, the department's statement said.

A statement from Nguyen's family called the situation "very difficult for the family," according to The Orange County Register.

'It was explained to us by the investigators on scene, with the circumstances and positioning of the bodies, that they believe this was a sympathetic murder-suicide. We hold no grudges against Joseph or the Orbeso Family. We extend our heartfelt condolences to the Orbeso Family, and that they will remain in our prayers. We thank God that we'll be able to give Rachel a proper burial and lay her to rest,' the statement said.

"They had a choice of a slow and painful death or a quick death," Austin Young, a friend of Orbeso, told The Long Beach Press-Tele-A handgun found with gram. "And they made the

choice of a quick death."

Young said Nguyen and Orbeso had dated in the past but had recently been just friends. He told the paper they had gone to Joshua Tree National Park to celebrate Nguyen's birthday.

Nguyen and Orbeso had set out for a hike at Joshua Tree National Park east of Los Angeles on July 27, when temperatures in the park hit 100 degrees. A ping from Joseph Orbeso's cellphone was recorded in the park that day. The owner of the AirBnB where they had been staying notified authorities when they didn't check out the next day.

Searchers found their car at the head of the Maze Loop trail in the park but few other clues. Volunteer searchers scoured the park for days, using search dogs, helicopters and airplanes. Some searchers and dogs required rescue themselves after becoming injured or dehydrated in the harsh terrain, reported Joshua Tree Search and Rescue volun-

# PMA Grading System and the Honor Code

The Philippine Military Academy (PMA) grading system is divided into three major components: academics, conduct, and athletics. A cadet is required to pass all three parts to proceed to the next level and/or to graduate. Otherwise, a cadet will be turned back or be discharged from the academy.

Academics is based on the quantifiable performance of a cadet in class room activities, i.e., quizes/ lesson exams, and major examinations. A cadet must have at least 70% correct answers to pass each exam. Getting a grade below the allowed passing percentage is recorded as failed.

Atletics is another component in the grading system and a cadet must achieved the requirements to pass, i.e., 3.2 Km run, number of pull ups, sit ups, push ups, and other athletic related activities.

The conduct of cadets at PMA is regulated by Cadet Corps Armed Forces of the Philippines Regulation (CCAFPR) or the Gray Book. Every cadet is dutybound to read, understand, and internalized the meaning and content of this book which is considered to be the bible of PMA cadets.

Military and civilian employees of the academy who are directly involved with cadets' training such as instructors from the Academics and Tactics Groups are highly urged and encouraged to read and understand the CCA-FPR; other employees of the command who are not directly involved with cadet's training are adviced to read the book.

The cadet corps is bound by the Honor Code which states, "We, the cadets, do not lie, cheat, steal, or tolerate among us those who do so." Violation of the code has a serious consequence.

The Honor Committee is composed of selected cadets with high moral ascendancy among the corps who are in charge of implementing the code.

Once a cadet is reported, a cadet is also mandated to report himself, of violating the code the chair of the committee can schedule an investigation. The committee usually scheduled the investi-

gation at the wee hour to keep it

It needs a unanimous decision amongst the members of the Honor Committee to render a guilty verdict agaisnt the accused.

A cadet found guilty by the committee must accept the verdict, silently resign, and leave the academy with dignity. On the other hand, a guilty cadet who chose to stay in the acdemy until he/she resigns because of the pressure or stands on his/her decision to stay untill graduation has to face a psychological and emotional treatment of ostracism.

The Honor Committee may order the CCAFP to ostracize a cadet found guilty of violating the code. Once ostracize, a cadet is considered not part of the corps and treated persona non grata or an outcast, or a lepper where the cadet corps won't talk to that cadet and the underclass, including the plebes, will not salute or address him/her sir or ma'am. A guilty cadet is on his own.

PMA cadets are easy to control than civilian college students. Cadets' lives are structured and they follow order. During class examination, cadets are allowed to move their heads to look up and down only. No moving of  $\bar{h}eads$ looking from side to side. An instructor can leave the room for bathroom privileges while the cadets are taking examination. The incidence of cheating is as good as nil.

If you've ever been to our Little Manila Center in Down-Stockton, you'd know that we have beautiful recreations of our banners historic surrounding the Little Manila Historic Site on our windows.

It is with a heavy heart to tell you that on Monday, someone defaced our windows and ripped our historic photographs that bore the words: Community, Culture, Empowerment, Arts, History, and Heritage. The first people to find our center in the condition it was in were our youth

dance students who stood heartbroken in front of our center.

As we celebrate Filipino American History Month this October, we know that discrimination against Filipino Americans is nothing new. The street our Little Manila Center is on is Main St. in downtown Stockton which was the dividing line for people of color in this city in the 1920s and 1930s. People of color were not welcomed north of Main St. and signs saying "Positively no Filipinos allowed" were displayed openly. It was illegal for Filipino men to marry White women in California. Later on, state and local officials would decide to destroy the Little Manila and Chinatown neighborhood by the building of the Crosstown Free-

This event has reminded us about the importance of the work we do. Through the Little Manila After School Program and Us History program we teach ethnic studies to high schoolers. Our advocacy helped Stockton Unified School District to adopt Ethnic Studies at our high schools just this year. Our Little Manila Dance Collective and Kulintang Academy teaches the art and culture of the Philippines to new generations of





ing identity and a sense of belonging to our roots.

Little Manila was destroyed in the 1960s and 1970s by misguided policies. Our advocacy for the preservation of the Little Manila Historic Site is a result of the worst case scenarios of racist

federal, state, and local public policies that prioritized freeway construction, urban redevelop-ment, and suburbanization over our communities

Little Manila Foundation and our Little Manila Center will continue to be a space for understanding and love, bringing together diverse communities. This incident only strengthens our resolve and reaffirms the work that we are already doing.

He noted that it begin with the founding of the FANHS in Seattle, WA. In 1982. Six years later, FANHS declared the Year 1988 to be the 225th Anniversary of the first permanent settlement of Filipinos in the continental United States, the settlement at St. Malo Parish, LA, established in 1763. In 1988, FANHS set into motion a year-long national observance in order to focus on the story of nation's past from a new perspective by concentrating on the critical economic, cultural, social, and other notable contributions Filipino Americans had made in countless ways toward the development of the United States history. Eleven years later, in November 2009, Congress passed the resolution officially recognizing October as Filipino American His-

Atty. Bill continued that October's significance is due to the fact that 430 years ago, October 18, 1587, the first documented presence of Filipinos in the continental United States occurred when the Spanish galleon, Nuestra Senora de la Esparanza, completed what was at the time only the second trans Pacific crossing in history from Asia mainland to America, and Filipinos sailing on that ship set foot on the sandy beaches at what is now known as Moro Bay, CA.

Atty. Bill continued by sharing three pertinent parts from the Congressional Resolution that stress the study of Filipino American his-

Then disaster strikes, Lions Clubs International Foundation (LCIF) responds! When service projects are too large for a Club or a District to financially support, LCIF is there to assist. A great example of Lions and LCIF working together happens during disasters. This summer, the world watched as natural disasters struck around the world. In South Asia, parts of India, Nepal, and Bangladesh are experiencing devastating monsoon rains. In Mumbai alone, over 1,000 people have been reported killed in the floods. In the past three months, LCIF has approved 20 emergency grants to South Asia, totaling US \$125,000. In July, flooding in Japan took lives and destroyed homes. LCIF awarded a US \$100,000 Major Catastrophe Grant to help the community recover.

In August, Hurricane Harvey devastated the Texas coast stretching from the Houston area into Louisiana. During one of the worst natural disasters in American history, thousands of people lost their homes and everything they own. Some people lost family members. LCIF immediately awarded a US \$100,000 Major Catastrophe Grant to assist in reconstruction efforts. 
