# **Duterte says he's now friendlier with US**

President Rodrigo Duterte on Thursday said he was now on friendlier terms with the United States, which he has frequently slammed for interfering in the domestic affairs of the Philippines.

Duterte said the US has "redeemed themselves a lot." He declared in October 2016 that he was breaking the Philippines' long-standing military and economic alliance with the US.

"There are so many factors involved but I'd rather be friendly to them now because aside from these episodes of, I said, sad incidents, overall I think the Americans also redeemed themselves a lot," he said in a speech during the 116th commemoration of the Balangiga Encounter Day in Eastern Samar.

Duterte acknowledged the assistance of the US throughout the years, even citing Washington's help to quell terrorists in strife-torn Marawi City.

The President, known for his expletive-laced speeches, said he was advised by the Department of Foreign Affairs (DFA) to "temper" his language not to issue any incendiary statement against the Us government while it was trying to recover the bells.

"I was under advice by the Department of Foreign Affairs that I would just temper my language and avoid [cussing]—which I'm prone to do if I get emotional," he said.

During his second State of the Nation (Sona) in July, the President demanded the return of the Balangiga bells.

He said efforts were ongoing between the Philippine government and the US on the return of the historical bells.

"I was under advice that the negotiations are going on, that the government of America is looking for ways how to get out of this problem of the Balangiga bells because it remains to be not only the source of irritation but the source of a painful reaction, what really happened to our countrymen," he said.

# Philippines drug war alarms 39 countries in UN

n a joint statement deliv- ate is curered by Iceland through representative Högni Kristjánsson on Thursday, the countries noted that the human rights situation in the Philippines continues to be of serious concern, particularly in the light of killings associated with the Duterte administration's war on

The states called on the Philippines "to cooperate with the international community to pursue appropriate investigations into these incidents, in keeping with the universal principles of democratic accountability and the rule of law.'

They also expressed concern over threats against human rights defenders and urged the government to ensure they are accorded full protection.

The joint statement came as the Universal Periodic Review (UPR) of the Philippines was adopted at the 36th session of the United Nations Human Rights Council (UNHRC) last week.

# 'Who... are you to tell me': Duterte hits IBP over 'onion-skinned' remark

anila, Philippines President Rodrigo Duterte slammed the Integrated Bar of the Philippines on Saturday for telling him not to be onion-skinned as the Office of the Ombudsman probes into his alleged ill-gotten wealth.

"I want a discussion with you tonight, I do not intend to deliver a speech. Let me start with 'onionskinned' and a cliche which says that a thousand lies being run every day becomes the truth, Duterte said to an audience of IBP members as he spoke during the installation of new officers and induction of new members of the organization's Davao City chapter.

The IBP made the remark Friday, reminding the president that he made his life open to public scrutiny upon assuming government office. The organization said this after Duterte threatened he would form a commission to look into corruption allegations against the ombudsman.

# Duterte on 'millions:' 'They can take it'

PRESIDENT Rodrigo Duterte has insisted that he did not have millions in his bank accounts and that if the money existed his critics "can take it."

At the same time, Duterte reiterated that he would step down from the Presidency if it could be proven that he had deposits outside the Philippines.

"If there is P211 million, they can take it. And I'd be happy if they give me P1,000 and they can...if

there is one, they can confiscate it," Duterte said in a speech during the 116th anniversary of the Balangiga, Eastern Samar encounter between Filipino and American soldiers.

'And if I have a deposit outside of the Philippines, even just for a dollar, I will step down from the Presidency and you can kill me in a moment in the name of those who suffered for the greater good of what is now the Republic of the Philippines," Duterte added.

The P211 million Duterte was referring to was the money that Sen. Antonio Trillanes 4th claimed the the Bank of the Philippine Islands (BPI) branch in Pasig.

The bank issued a certificate saying that Duterte did not have an account with them.

Trillanes, however, filed a complaint before the Office of the Ombudsman in May 2016, election month, claiming that Duterte and his family amassed P2.4 billion through corrupt activities from 2006 to 2015.

### 'Politicking'

The President dismissed on Friday the controversy on his bank accounts as politicking and that the public should believe him.

You know politics. But just take my word for it, there is really none.

I don't have P200...P211 million. [If I had that] I would not have run for President. I would have just rested," Duterte said.

"It's like this. If you believe these...go ahead. Believe them. If you believe me, then so be it," Duterte added.

#### **Ombudsman unfazed**

Meanwhile, the Office of the Ombudsman said it would pursue the case of Duterte's alleged ill-gotten wealth even after the President announced that he would be creating a commission to investigate the Ombudsman.

'The President's announcement then Davao mayor allegedly had at that he intends to create a commission to investigate the Ombudsman appears to have to do with this Office's on-going investigation into issues that involve him. This Office, nonetheless, shall proceed with the probe, as mandated by the Constitution," according to a statement released on Friday.

"This Office, all the same, welcomes, as it has always welcomed, efforts to help it cleanse its ranks. Its Internal Affairs Board has, in fact, entrapped and removed Ombudsman officials and employees for various offenses," the statement said.

Duterte accused the Office of the Ombudsman of corruption and accused it of choosing who it would investigate.

The Ombudsman said it would

be investigating the complaint Trillanes filed in May

"If the President has nothing to hide, he has nothing to fear," it said.

#### AMLC report

Meanwhile, Trillanes asked the Anti-Money Laundering Council (AMLC) to focus on expediting its report on the President's bank transactions as requested by the Office of the Ombudsman instead of issuing unnecessary statements that seemed to absolve the President.

At the same time, Trillanes also questioned the authenticity of the statement issued by the AMLC.

"AMLC should just expedite its final report regarding Duterte's questionable bank transactions as requested by the Ombudsman, so that the public would know the truth about the Duterte bank accounts," said Trillanes, a staunch critic of the Chief Executive.

The AMLC, in a statement Thursday, denied giving Duterte's bank records to either Trillanes or the Ombudsman.

According to the AMLC, it received on September 6 the request of Overall Deputy Ombudsman Melchor Arthur Carandang to initiate an investigation into the President's accounts, but added it would have to first evaluate the request.

Carandang said the copy of the bank records from AMLC was "more or less" the same as the ones exposed by Trillanes.

Trillanes expressed doubts on the AMLC statement because it was unsigned and undated.

"The signature is important so that the statement could be attributed to a particular person, who has been authorized by the Council to issue such a message," he

### **Trump to visit PHL in November -White House**

WASHINGTON Donald Trump will travel to Asia next month for the first time since becoming president, stopping in Japan, South Korea, China, Vietnam and the Philippines on a trip expected to be dominated by the North Korea nuclear threat.

Joined by his wife Melania, Trump will travel Nov. 3-14. His visit will include attending two major summits, the Asia-Pacific Economic Cooperation forum in Vietnam and the Association of Southeast Asian Nations conclave in the Philippines.

Trump's attendance at the Manila summit had been in doubt until recent days, with officials saying he was reluctant to reward Philippine President Rodrigo Duterte, who has been responsible for a number of anti-American outbursts.

A US official said Asian leaders who met Trump at the United Nations General Assembly in New York last week helped persuade him to attend in unity with key Asian allies.

The president, who has been engaged in an increasingly bitter war of words with North Korean leader Kim Jong Un, will have the opportunity to bolster allied resolve for what he calls the 'complete denuclearization" of Pyongyang.

He has denounced Kim as a 'rocket man" on a suicide mission for test launches of ballistic missiles and for nuclear weapon tests. He has warned North Ko-

rea would face total devastation if it threatens the United States. Kim has blasted Trump as "mentally deranged.'

"The president's engagements will strengthen the international resolve to confront the North Korean threat and ensure the complete, verifiable, and irreversible denuclearization of the Korean Peninsula," the White House said in announcing the trip.

Trump's visit to China will re-

ciprocate a trip to the United States made in April by Chinese President Xi Jinping. Trump has applied heavy pressure on China to rein in North Korea. While his efforts have had limited success thus far, he went out of his way to thank Xi on Tuesday for his ef-

"I applaud China for breaking off all banking relationships with North Korea — something that people would have thought un- something that thinkable even two months ago. I want to thank President Xi," Trump said at a news conference with Spanish Prime Minister Mariano Rajoy.

# Napoles wants bail ala Jinggoy

WHAT is good for Jinggoy can also be good for Janet.

The camp of businesswoman Janet Lim Napoles yesterday said the same grounds cited by the Sandiganbayan in approving the bail request of former Sen. Jose "Jinggoy" Estrada are applicable in her case and could be a key to securing her release from detention.

Defense lawyer Dennis Buenaventura said he and other members of Napoles' legal team are now reviewing the court ruling to prepare her own request for setting of bail in all her plunder cases.

"As far as we are concerned, this is favorable to us. We shall go over the actual terms of the resolution, then we will file our own (motion). We will start here at the Fifth (Division), then we'll see about the others," Buenaventura said.

Napoles is facing five plunder cases before different divisions of the Sandiganbayan in relation to allegations that she conspired with senators, congressmen, and executives of government-owned of controlled corporations (GOCCs) to siphon off hundreds of millions of pesos of Priority Development Assistance Fund (PDAF).

Prosecutors said the money was funneled into bogus foundations allegedly created by Napoles and her employees supposedly to undertake livelihood and agricultural assistance programs that turned out to be non-existent or "ghost projects."

The Office of the Solicitor General early this year said Napoles was wrongly convicted of illegal mind. detention, giving rise to speculations that a deal for her freedom is being worked out with the Duterte government.

APEC party-list Rep. Edgar Valdez involving P95 million PDAF, and former Masbate Rep. Rizalina Seachon-Lanete involving P112 million pork barrel funds.

"Bail has been granted (to Napoles) in two cases against congressmen. This is the first time for a senator...other than the Enrile case which was on a different ground. But this (court ruling granting bail to Estrada) definitely touches on the main information. It changes the complexion (of the case)," Buenaventura said.

In a resolution dated September 15, 2017, a special division of five justices voted 3-2 to grant Estrada's bail request citing weaknesses in the prosecution's evidence in light of recent pronouncements by the Supreme Court in the dismissal of plunder charges against former President Gloria Macapagal Ar-

The majority resolution signed by Associate Justices Maria Theresa Mendoza-Arcega, Reynaldo Cruz, and Lorifel Pahimna held that there was insufficient evidence that Estrada was the principal plunderer saying the evidence so far presented created an impression that Napoles was the master-

In addition, the court declared that Estrada's stature as a former senator and the fact that he voluntarily surrendered and served de-Buenaventura noted that Napoles tention for more than three years has already been granted bail in the plunder and graft cases of former ered a flight risk.

Associate Justices Rafael Lagos and Zaldy Trespeses dis-sented, noting that the strength of the prosecution's evidence has already been upheld after a lengthy bail hearing where the accused was allowed to challenge testimonies of witnesses and documentary evidence offered.

Napoles' camp, however, said the theory of conspiracy among the plunder defendants essentially means that what benefit one of them will likewise benefit the others.

'As we have argued earlier .the nature of the information does not really amount to plunder. The legal definition of plunder says it cannot be a private person, it should be a public officer. So, if at all appears like that, this is not plunder, this is something else...a very different matter," Buenaventura said.

Prosecutor Ma. Christina Marallag-Batacan, however, said the Ombudsman's panel of prosecutors have also reviewed the Sandiganbayan resolution and found several bases to mount a

She said the prosecution will also file an appeal to ask that Estrada's bail be revoked.

"We will file an MR (motion for reconsideration) of course, we have good grounds so we hope the ruling granting bail will be reversed," Batacan said.

# Abu Sayyaf has 'franchise' of 'Bamboo triad', Duterte claims

Duterte has tagged the 14K and "Bamboo Triad", which are based in Hong Kong and Taiwan, as among groups allegedly behind the proliferation of illegal drugs in the Philippines.

In a recorded interview on staterun television which was aired Friday evening, Duterte claimed that the Bamboo triad, allegedly based in Taiwan, has penetrated the southern portion of the country through the terrorist group. Advertisement

On Monday, the Taipei Economic and Cultural Office in Manila denied being a source of illegal drugs in the Philippines, saying it would continue working closely with Philippine authorities to fight the narcotics trade.

In May, P6.4 billion worth of shabu from mainland China was discovered in a warehouse in Valenzuela after it slipped past through the port of Manila allegedly through the help of corrupt Customs offi-

Philippine Drug Enforcement Agency (PDEA) spokesman Derrick Carreon also said in December that mainland China is the origin of most meth in the Philip-

pines.

"It's safe to say that the majority of the meth we have comes from China," he told Reuters in an interview.

Of 77 foreign nationals arrested for meth-related drug offenses between January 2015 and mid-August 2016, nearly two-thirds were Chinese and almost a quarter were Taiwanese or Hong Kong tempt to arrest Abu Sayyaf leader residents, according to the PDEA.

# History, adventure amid urban bustle

t's probably because of Cavite province's history and strong link with the past that we have come to know its people as fierce and clannish. But Caviteños are warm and accommodating hosts.

"Here, people are very welcoming," said Lei Aldea of the Cavite El Viejo Heritage Tourism Association.

Cavite El Viejo, the old name of Kawit, is the hometown of the first Philippine President, Gen. Emilio Aguinaldo.

Only 21 kilometers south of Manila, Cavite is the country's most populous province with 3.68 million residents as of 2015.

From what used to be vast tracts of farmland, it has evolved into an industrial and residential hub, absorbing the spillover of investments and development in Metro Manila.

The daily traffic along Aguinaldo Highway, Cavite's 41-km main thoroughfare, proves its rapid urbanization. "It's becoming the new Edsa," Aldea said.

### Fly high, swim deep

Cavite has a lot of less prominent but interesting sites for a 48-hour travel.

Among its "hidden gems" are the Cabag Cave in Maragondon town; the Matala and Piitan caves in Indang town: and a number of falls, such as Palsajingin Falls in Indang, Balite Falls in Amadeo town, and Saluysoy Falls in Alfonso town.

From Manila, the easiest entry points are via the Cavitex (a 14-km expressway from Roxas Boulevard) or the South Luzon Express-

An early Saturday adventure may start in Carmona town, with a daring flight on a canopy wing of a para-

Paragliding is the most popular air adventure sport in the Philippines, said Randell Reginald "Buko" Raymundo of the Federation of Paragliding and Hang Gliding of the Philippines.

Since 2009, Raymundo's group has been organizing tandem rides (riding with a

certified pilot) in Barangay Lantik. "It started as a hobby but is now being offered as a sport to boost Carmona's tourism," he said.

Tourists may want to bring their own food since there are no facilities on site A 15-minute ride at an altitude of 500 to 1,000 feet costs P2,500 to P3,500.

But the sport is seasonal as it depends on the wind direction. In Carmona, paragliding is offered between November and April, with early morning as the best time to fly.

Those afraid of heights may try trekking and swimming in the Malibiclibic Falls in Gen. Emilio Aguinaldo town.

Travel from Manila takes about two hours through Cavite's quaint, historic towns of Kawit, Tanza, Naic and Maragondon before taking the turn toward

and coconut milk.

The next best stop is Tagaytay City. Known for its perfect vantage point of Taal Volcano, it is a top tourist destination not only in Cavite but also in the Southern Tagalog region.

A ridge that stretches 28km from the Tagaytay rotunda to the boundary of Nasugbu town has been dubbed its "tourism strip," as it is lined with restaurants, coffee shops, retreat houses, hotels, and bed and breakfast (B&B) facilities.

Restaurants commonly serve "bulalo" (beef marrow stew), crispy "tawilis" (herring), and "kare-kare," but if one is up for a more authentic feel (at a cheaper price), head straight to the Mahogany market for lunch. It is a beef market and a "pasalubong" center with several "carinderia." Bananas and

"kapeng (brewed barako' native coffee) come free.

Tour the Museo Orlina and be awed by the works of renowned glass Ramon sculptor Orlina.

Visit the Puzzle Mansion, where over 1,000 jigzaw puzzles earned collector Gina Lacuna her Guinness record in 2012.

Gen. Emilio Aguinaldo, a fifth-class town and a favorite destination among bikers and trekkers.

"If you ask locals for directions, ask for Bailen. They might not know where Aguinaldo is," municipal tourism officer Glori Ann Sain said, referring to the town's old name.

From the town center, a tricycle (fare: P50) takes the visitor to Barangay Lumipa where a 20-minute trek to the falls begins.

The town also promotes a strawberry farm in Barangay Kabulusan and the "tilbok," a local delicacy made from glutinous rice

Also in Tagaytay, Nurture Wellness Village has been runing a 6,000-square-meter organic farm of medicinal plants and vegetables since

Try its signature "nilaib," a traditional massage that uses hot pouches of herbs and sand wrapped in banana leaves. The village also hold Tai Qu Gong and basic yoga, and juice and coffee roasting demonstrations ev-

ery morning.
But, of course, what is Tagaytay without a view of Taal Volcano. Try the perfect vantage point atop the Sky Eye, a 63-meterhigh ferris wheel inside the 5-hectare Sky Ranch. From

Tagaytay has kept its steady influx of tourists, which reached over 2 million this year alone, said city tourism officer Lani Diesta.

Big Ben's also serves "batchoy" Tagalog, "adobong" Tagalog and the adobong "tinali" among the heirloom dishes bequeathed by Gutierrez's grandfather Ben.

Get a quick stop for Dig-man's "halo-halo" in Bacoor City. Digman is a small village with narrow streets and a couple of diners serving halo-halo, "siopao" and "tahong" (green mussels) chips.

"When you say Cavite, two things (come to mind): Tagaytay and the Aguinaldo Shrine," Aldea said. "(But Cavite) has a very rich historical and cultural heritage, it's like taking you back to the time of the Katipunan."

A walking tour around Kawit normally takes about three hours, starting or ending at the iconic white mansion of Aguinaldo.

The lesser known but historic Gen. Baldomero Aguinaldo Shrine in Barangay Binakayan also stands as perfect example of the "bahay na bato" (colonial stone house) with a "kamalig" (granary). It used to be the home of Baldomero, a cousin of President Aguinaldo and a cofounder of the Philippine Veterans.

Proceed to the St. Mary Magdalene Church, built in 1737 and one of the oldest in Cavite.

Heritage tours, according to Aldea, are not only meant to pique tourists' interests but also to encourage locals to know and preserve their own heritage.



## For victims' families, a fatal shooting means a lifetime of grief

For the loved ones of gunviolence victims, a moment of tragedy can mean a lifetime of pain and a search for justice.

One of the bedrooms in Lourdes Reves' home in Federal Way belongs to her son George Gabriel Jr.

Its walls are covered with framed photos of Gabriel when he was an adorable kid, posing at high-school dances with girls who found him adorable (in a distinctly more grown-up way) and gazing into the camera while dressed in his blue Marines uniform and white cap.

But Lance Corporal Gabriel has never set foot in this house. This room full of lovely memories is, in fact, a loving memorial.

Gabriel was killed by a stray bullet fired during a shooting on May 13, 2014, while he was on leave, visiting his mother at the Federal Way apartment complex where she lived at the time. Gabriel and his new wife had just driven home from a night out and were waiting for a parking space when they got caught in the crossfire of a dispute, police said.

It was his birthday. When shots ring out, the pierced air causes ripples that spread well beyond the trauma of the wounded.

They send shock waves through a community's consciousness that don't diminish after the headlines fade away and the cameras gravitate toward the next day's

The perverse thing about much of the Seattle-area gun violence that has captured the public's attention in recent years — including a series of incidents, some fatal, this spring and summer — is that shootings too often go unsolved for months and even years, with witnesses refusing to cooperate and investigations stalling.

Families and friends of the victims are then left with the dual traumas of grief and mystery, making it that much harder to heal the wounds of

Gun violence, no matter where it happens, damages our sense of the natural order of things.

It is not natural, in any community, to say goodbye to a son or daughter or neighbor when they head out into the world, and wonder whether you'll ever see them again.

Reyes heard the commotion outside that night, but she never imagined that her son was caught up in it.

That revelation came a short time later, when police knocked on her door to deliver the news that her son was gone.

Gabriel was a born engineer. He installed auto alarms and sound systems for people and could take the shell of a

Reyes, 50, admits with a smile that she spoiled her son. She let him eat dinner in front of the TV in his bedroom when he was younger. Gabriel never washed his own

One day, when he was 18, Gabriel told his mother he'd just signed papers to join the Marines.

Reyes remembers saying, stunned, "You're kidding, right?"

Gabriel said no; he was serious.

'You don't even know how to wash a plate," she retort-

ed.
"He was my baby, and you worst," always expect the worst," Reyes says. "But he was happy ... When he left, I was crying, crying, crying, but he called me every single day."

"What I hope is, I just want justice," says Lourdes Reyes, whose son, George Gabriel Jr., was shot and killed in his car as he was waiting for a parking space three years ago.

Reyes was 19 when she came to the United States from Tamaulipas state in Mexico. She worked seven days a week in janitorial services and ran her own cleaning business. She raised Gabriel on the income from the business. When he died, Reyes stopped working, and her husband, Gabriel's stepdad, stepped in to support them.

She and her son were always close. Gabriel, known as "Junior" to most people in the apartment complex, never missed an opportunity to tell his mother he loved her, sometimes five or 10 times a day, even in front of his highschool buddies.

apartment building on May
He might have been a devoted mama's boy, but Gabriel stunned Reyes once more when he called three weeks before his death to say he'd gotten married to a fellow member of the military in San Diego, where he was based.

But Reyes couldn't stay upset at her son for long.

When Gabriel was in high school, a young man visited the apartment, she says. He put a gun to Reyes' head and demanded to know where "George" was. Because of the way he referred to her son, she assumed the stranger knew him from school. Terrified, Reyes pulled Gabriel out of school and sent him to live with relatives in Miami. But only a month later, she had Gabriel sent back to be with her after he complained.

She decided to move the family to a different apartment complex, thinking the new location would be safer. A few years later, that's where the shooting happened.

Gabriel's room is lined with chairs. A U.S. flag folded into a triangle, which Reyes received at her son's military funeral, hangs above the portrait of him in his Marines uniform.

"I still have his clothes," she says. "People always tell me to get rid of them, but I'm not ready."

The gold pendant hanging from a chain around her neck spells out "George Jr.," with angel wings around the "Jr."

"He lives in me," Reyes

She visits Gabriel's gravesite every weekend.

Every 13th of the month, she hosts a gathering to celebrate his life. On his birthday this year, Reyes arranged for a mariachi band to play in his

memory.
Some relatives have urged her to let her son rest, to let go of her grief. But it is grief that has a hold on her.

To lose any child, but especially in such a random and horrific way, brings a distinct kind of pain, she says. "I think I'm never going to get up from this."

Even worse, three years later, no arrests have been made in her son's death.

Federal Way Police said at the time that a man who was suspected of involvement in two other shootings around the same time, one a fatal shooting, was a person of interest in Gabriel's, as well. The man spent a year in prison on murder charges connected to that other fatal shooting, but was released in 2015 for lack of sufficient evidence to carry out a successful prosecution.

"All I want is justice," Reyes says. "If there was justice, my son could rest in peace."

# The Marcoses' obsession with power

f forty-five years after the late dictator Ferdinand Marcos proclaimed martial law and 31 years after he was deposed by the People Power Revolution of 1986, you'd think that his heirs would stay out of politics and lead a quiet life? You're wrong. The Marcoses are nowhere living their lives in the quietude of obscurity; they're basking in the limelight of power.

Indeed, during a forum commemorating her father's 100th birthday in Batac, Ilocos Norte, Governor Imee Marcos reminded the attendees of a statement made by her father after they were ousted Defiant to the end: Ferdinand and from power, that "history was not done yet" with her family. She was referring to her late father's comment when they landed at the Hickam Air Force Base in Hawaii. "We were all in tears and everyone said, 'The end is nigh, it is finished, we are dead and doomed," Imee said. "My father said, 'No,



including Robredo. However, Duterte dispelled rumors that the offer was part of an "operation" to aid Bongbong in his alleged plan to run for president.

But first, Bongbong has to clear the way of any impediment - legal or otherwise -- that could torpedo his presidential ambitions. It did not then come as a surprise that several lawmakers and martial law

close any condition for its return, and hold them accountable.

Vice President Robredo also believed that the Marcos family could only be offering to return part of the loot to dodge the "legal repercussions" of stealing from the country. She rejected the notion to grant the late dictator's heirs immunity without them admitting to their crimes. However, Bongbong's supporters insist that immunity must be granted as a condition for returning the stolen wealth.

And this brings to mind the question: Is the presidency worth more than the billions that Marcos had stolen and stashed in secret bank accounts? While one can say that the ill-gotten wealth has a finite value, the value of the presidency is infinite. Immense power comes with the presidency and it opens

a lot of doors to opportunities of immeasurable wealth. In other words, the Marcos family could regain the ill-gotten wealth and a lot more than what they would have returned to "secure" the presidency.

At the end of the day, one wonders if what the late dictator had in mind when he told his family who were then languishing in exile in Hawaii, "To my family and to everyone, history is not done with me yet.'

This reminds me of the Shakespearean novel "Macbeth," which says, "The protagonist Macbeth is caught in a down spiral induced by his ambition, which in the end,

was the cause of his tragic end. Macbeth, once a great hero falls victim of his ambition for power. Although the protagonist initially tries to resist his human urge, he in the end committed crime his country, his friends, and sadly himself."

By the end of Duterte's term on June 30, 2022, there will only be three justices left who weren't appointed by Duterte and that is Chief Justice Maria Lourdes Sereno and Associate Justices Marvic Leonen and Alfredo Benjamin Caguioa. With Sereno still at the helm of the Judiciary Branch, Duterte would be vulnerable to attempts to bring him to justice

to settle a number of issues against him once he's out of office. And considering Duterte's alleged complicity to the filing of impeachment against Sereno by lawyer Larry Gadon, it would be unlikely for Sereno to bat for Duterte.

The attempt to remove Sereno reminds move Sereno reminds his impeachment trial. me of the impeach-

ment of former Chief Justice Renato Corona. Corona shielded then president Gloria Macapagal Arroyo who ducked several attempts to impeach her during her presidency. Corona, who is now deceased, owed his appointment to Arroyo whom he worked for as presidential legal secretary before his Supreme Court appointment.

But Corona earned the ire of then president Benigno Aquino III for blocking Aquino's executive orders. But when Corona successfully maneuvered to break up and distribute Hacienda Luisita - a huge plantation owned by the Cojuangcos, Aquino's other side of his family - Aquino allegedly bribed congressmen and senators to impeach and remove Corona

from the High Court.

To accomplish the alleged "bribery," Aquino used the Pri-Development Assistance Fund (PDAF), otherwise known as "pork barrel," and also create another funding source called the Disbursement Acceleration Program (DAP), which was a "special" budget allocated to ate or hasten a government project without Congressional approval. The Supreme Court ruled both programs as unconstitutional.

#### Impeachment complaint

Recently, the impeachment complaint against Sereno moved another step when the House of Representatives justice commit-

tee ruled that the complaint is sufficient in form and substance. Among the Supreme Court documents used were official lists of Sereno's travel expenses and appointment letters.

ment of assets liabilities and net worth (SALN), arising from her attorney's fees in the Piatco Case, are at the top of the list. But one can argue that she earned her attorney's fees legally. Her only "sin" is that she did not report it on her SALN, which begs the question: How many government officials missed filling out their SALNs? Is it serious enough to warrant re-

> moval from office? In the past, when there was a discrepancy in someone's SALN, he or she was given the opportunity to correct and resubmit it. It would have been a different situation if Sereno

couldn't explain how she earned her attorney's fees.

Another accusation leveled against Sereno was the purchase of a P5.1 million Land Cruiser 2017 model, which Gadon deems as "extravagant." But what is "extravagant"? We are not talking about a Cadillac or Mercedes Benz here.

Ever since president Joseph 'Estrada was ousted in the People Power revolution in 2001

oftentimes called EDSA Dos or EDSA 2 -it had become a national pastime to jail or detain the president upon finishing his or her term. It was no surprise then when Aquino jailed Arroyo after she stepped down from office. Now, Duterte wants Aquino jailed. But Aquino has four Supreme Court ap-

Sereno, who could give tial law? him a boost should Aquino be brought to justice and, if convicted, would have to reckon with a High Court that is slowly being packed with Duterte's appointees. However, Chief Justice Sereno could exert influence on some of the justices whom she had developed good rapport and collegial relationship.

If Duterte succeeds in removing Sereno and appoints someone whom he knows would be loval to him, it would create a 13-justice super bloc that could easily provide him with a minimum eightvote majority, his last line of defense against any attempt to jail him for corruption or plunder.

#### **Martial Law**

And if all else fails, then Duterte could declare martial law. Indeed, martial law is the ultimate method of asserting one's predominance over the people. But while it is effective for as long as you have the military behind you, abuses against the people are bound to happen, which would then result in the collapse of the power structure that you have put in place to control the people. What you'd end up with is a corrupt governlike what happened to the Marcos

But declaring martial law wouldn't be easy. Article VII Section 18 of the 1987 Constitution stipulates the following:

1) Within forty-eight hours from the proclamation of martial law or the suspension of the privilege of the writ of habeas corpus, the President shall submit a report in person or in writing to the Congress. The Congress, voting jointly, by a vote of at least a majority of all its Members in regular or special session, may revoke such proclamation or suspension, which revocation shall not be set aside by the President.

2) The Supreme Court may review, in an appropriate proceeding filed by any citizen, the sufficiency of the factual basis of the proclamation of martial law or the suspension of the privilege of the writ of habeas corpus or the extension thereof, and must promulgate its decision thereon within thirty days from its filing.

3) A state of martial law does not suspend the operation of the Constitution, nor supplant the functioning of the civil courts or legislative assemblies, nor authorize the conferment of jurisdiction on military courts and agencies over civilians where civil courts are able to function, nor automatically suspend the privilege of the writ of habeas corpus.

Of these three stipulations, Duterte shouldn't have any problem in getting the support of Congress, which is packed with

die-hard Duteristas. The problem would be in the Supreme Court where the justices led by CJ Sereno would balk at giving him absolute and unmitigated authority that would allow him to stop the operation of the civil government. Removing Sereno would therefore result in a Dutertesized Supreme Court that swings like a pendulum whichever way the puppet master wants it





### FILIPINO MYTH

Here are five of the most scary and unusual monsters in Filipino mythology.

#### 5. Aswang

The aswang is probably the most common of Filipino monsters since there are so many different kinds. In general, they are shape shifters who are human by day and then at night turn into a dog, a pig, a bat, cat, snake... the type of animal depends on the regional lore. They break into funeral homes and steal recent corpses. They are also known to enter homes to drink human blood and can turn people into aswang by tricking the human to bite


them in return. The aswang are especially hungry for human fetus so some of the more superstitious stories include neighborhoods patrols set up in front of the home of a pregnant woman to protect her from wandering stray animals in case they are the aswang in disguise.

### 4. Tiyanak

The tiyanak is similar to the Greek mythological siren in that it lures its prey with its voice. A person hears a baby cry from deep in the woods and then follows the sound to rescue the baby. Some stories say the person wanders aimlessly in search for the baby and becomes hopelessly lost. Other stories claim that the person eventually finds a baby in the middle of the woods. When it is picked up, the baby then shape-shifts into a monster with large, sharp teeth. It then eats the person and transforms back to a baby to await its next victim. With either version, the story ends with "... and he was never found again."

### 3. Tikbalang

The tikbalang is described as having the head of a horse, the body of a man and the hooves of a horse where human feet would be. In northern regions, the tikbalang is considered a nuisance but generally harmless. They enjoy disorienting weary travelers and making them imagine things that don't exist. Travelers can easily stop the pranks by turning Top 5 Scariest Filipino Monsters



their own shirt inside out and asking the tikbalang to stop bothering them. The stories of tikbalang from southern regions paint the creature as a much more sinister monster. He has glowing red eyes, a large cigar and smells of the stench of burning hair. When angered (and he angers easily), the tikbalang will stamp you to death. To tame the beast, the person must pluck the one of three unusually long hairs found in its mane. After that, the tikbalang is your slave. Folklore states that when the sun shines through the clouds while it is raining, a pair of Tikbalang are getting married.

### 2. The White Lady / Kaperosa

The White Lady is a specific kind of Multo, or ghost. Most multo tend to be family members who come back to certain relatives to take care of unfinished business but the White Lady is unique in that she doesn't appear to only her relatives or even to specific people she knew when alive. Many sightings have reported her in empty buildings, near forests and on cliffs. However, she is most commonly reported seen along Balete Drive in Quezon City. She was a young lady who was raped and killed by two Japanese soldiers during WWII. While there haven't been stories of the White Lady being a purposefully malicious being, she has been the reported as the cause of more than a few car

accidents by drivers who look in their rearview mirror and see a young lady in the backseat wearing a white dress. Sure, some strange, unknown lady sitting in your backseat is bad enough but the White Lady is also said to have no face or a face covered in blood.

times considered to be a special breed of the aswangs. They are sometimes referred to as "Tik-tik" because of the sound it makes while in flight. To confuse its victims, the tik-tik sound becomes fainter as she nears. These creatures generally take on the form of a beautiful woman with large, leathery bat wings. The lower half of her body takes root to the ground while the upper part detaches as she flies in search of food. The mananaggal has a taste for human blood and a particular craving for the hearts of human fetuses which it retrieves with its long, proboscis-like tongue. Like the Western culture's vampire, the manananggals hate garlic and salt so hanging garlic or placing a bowl of salt near the window is the best way to keep them away. To kill a manananggal, one must find the lower body and spread salt or ashes on the open wound. That prevents the two halves from joining and transforming back to human form when daylight breaks.

# **Distress Call** Inflight

t was around 11:30 pm and I just closed my eyes to begin my sleep on a 12-hour straight flight from Manila to San Francisco via Philippine Airlines' Boeing 777-300 ER when I heard an overhead paged for medical assistance: "Any medical doctors or registered nurses on board please contact any of our flight attendant." I waved my hand to the lady FA and told her I am an RN. I asked my wife to go with me to respond to the call.

There was no medical doctor on board. My wife and I, who are both RNs at Kaiser Permanente in South Sacramento, were the ones who managed the condition of the 71 years old male passenger who complained of chest pain and looks pale.

The patient has coldclammy skin, radial pulses on both arms were weak, and he complained of dizziness., with no nausea or vomiting.


When I asked the patient to point the location of pain using his index finger he pointed at his epigastric area. When asked to de-

scribed the intensity of pain from a scale of zero to 10, 0 as no pain and 10 as the worst pain, he said the pain was at six. When asked the character of pain whether it was pressure-like, dull, or sharp, etc., he responded it was sharp pain.
The FA handed me a manu-

al bulb-operated blood pressure apparatus and a stetholeg straight while I held his left leg straight. Then I re-checked his BP which revealed the same but his HR went up to 81/minute and it was strong. His skin became warm to touch. Patient felt better. Dizziness was lesser but still had epigastric pain.

When asked about his medical history, the patient said he has hypertension and

takes maintenance medication once a day which he took at 8 am. Our flight SFO was at 10 pm. Other than hypertension, he has allergy to shrimp which



The passenger denied gastric ulcer but his wife told us he is taking acid reducer tablet which we gave during the flight.

We kept the passenger warm and comfortable on his reclined seat. The condition improved until we arrived in San Francisco.

The patient's wife and the lead flight attendant came to us to say thank you. Thank God we save an-

# The nightmare called 'bangungot'

angungot is known by many complicated medical names: acute hemorrhagic pancreatitis, sudden arrhythmic death syndrome or sudden adult death syndrome (SADS), bed death, sudden unexplained death syndrome (SUDS), Brugada Syndrome, and sudden unexpected nocturnal death syndrome (SUNDS). Bangungot is the Tagalog word for "nightmare," but it can also refer to a malevolent spirit or elemental in Filipino folklore: Also known in Ilocano as batibat, it appears in the shape of an overweight man (bangungot) or overweight Botero-like woman (batibat) who sits on the chest or head of the victim (always male) and suffocates him to death. According to witnesses, the victims groan (ungol in Tagalog) while struggling against the bangungot, and if they do not rise from sleep (bangon in Tagalog), they die. Ît is useless to try to push away the bangungot or batibat, but one can survive if one is able to wiggle a big toe and wake up.

A Foundation for Bangungot Research was set up in the 1950s by the owner of Benipayo Press after his son died of bangungot. More than six decades later one can find a lot of literature on the subject online, but no real cure or explanation has been found to explain the malady. It was previously believed that only Filipino males were afflicted with bangungot, but there are words in other Asian cultures that refer to bangungot: Dab tsong in Hmong is a ghost; lai tai in Thai refers to death in sleep; dolyeonsa in Korean; digeuton in Indonesian; pokkuri in Japanese; and bei gul ya in Chinese, that means "crushed by a ghost."



While much of the current medical literature is focused on Hmong deaths in the United States in the 1980s, the earliest medical references to bangungot are Maria Paz Mendoza Guazon's 1917 journal article "Algunas notas sobre bangungot" (Some notes about Bangungot) that appeared in the Revista Filipina de Medicina y Farmacia (Philippine Journal of Medicine and Pharmacy) and A.V. Majoska's "Sudden Death in Filipino Men, an unexplained syndrome" that appeared in the 1948 Hawaii Medical Journal.

Dr. Alvin Majoska was a forensic pathologist who rose to become the chief medical examiner in Hawaii. His inquiry into bangungot caused a panic in Hawaii in the early 1950s—another footnote in the history of Filipinos in Hawaii. Erle Stanley Gardner, author of the famous Perry Mason detective novels, dedicated his 1955 "The Case of the Sun Bather's Diary" to Majoska with a foreword that made reference to bangungot:

"I have spent many hours with Dr. Alvin V. Majoska in Honolulu, discussing the strange 'Nightmare Deaths' of Honolulu. I first heard of these deaths when I was attending one of Captain Frances G. Lee's seminars on homicide investigation at the Harvard Medical School in Boston. Dr. Milton Helpem, the famous forensic pathologist of New York, was lecturing there and remarked that it was not always possible to determine the cause of death. He cited as an example that he had recently been called upon to examine vital organs from bodies sent him from the Hawaiian Islands, and that in each case it had been impossible to discover a cause of death. There was no sign of poison; the heart, lungs, brain, kidneys, and all of the vital organs were in perfect working order. These men simply had ceased to live, and medical science was powerless to find out why they had ceased to live.

Driven by intense interest, I finally went to Honolulu and tried to find out about these strange deaths. What I found amazed me. The deaths occurred only in young Filipino men who were in the prime of life and the best of health. These men invariably died at night, under circumstances indicating a nightmare. They would go to bed apparently in the best of spirits. During the night they might be heard to moan. Before help could reach them, they would be dead."

Bangungot medical literature was built slowly over the years from the work of Mendoza Guazon and Majoska. A 1998 article in the International Journal of Epidemiology by Ronald G. Munger and Elizabeth A. Booton is based on a review of bangungot deaths recorded in Manila from 1948 to 1982; 96 percent of the victims were male, the mean age was 33 years old and the modal time of death 3 a.m., with cases peaking in December-January.

In time we will come to a full scientific explanation of what all Filipinos know from folklore as bangungot.

Kathryn Bernardo was named the Pond's Brightest Star of the Night award while Julia Barretto was recognized as the Pond's




