

## Police tell one story of drug killing, videos tell another

arangay 19, Manila – The police report was clear. Anti-drug officers shot and wounded three men in this poor Manila district and "rushed" them to a hospital where they were pronounced dead on arrival.

But security camera footage obtained by Reuters tells a different story of what happened just after midday on October 11 here. It shows that police took at least 25 minutes to haul away the men they had shot. The victims show no signs of life; police are seen carrying them by their arms and legs and loading their limp



# SC allows justices to testify vs Sereno

MANILA, Philippines — Supreme Court (SC) magistrates and officials will attend the hearings by a congressional panel on the impeachment complaint against Chief Justice Maria Lourdes Sereno if invited.

Voting unanimously in session yesterday, Sereno's fellow magistrates decided to allow members of the judiciary invited by the House justice committee to testify in hearings on issues raised in an impeachment complaint filed by lawyer Lorenzo Gadon.

The voting was done in Sereno's absence as she was on leave.

House justice committee chairman Oriental Mindoro Rep. Reynaldo Umali thanked the justices for their decision.

"This is very important to us so that we can resolve these issues the soonest," he

The committee is trying to establish probable cause to

impeach Sereno.

Three magistrates cumbent Associate Justices Teresita Leonardo-de Castro and Noel Tijam and retired Associate Justice Arturo Brion - have manifested to the House panel their intention to testify in the impeachment case.

In a press conference, SC spokesman Theodore Te said any official of the high court would be allowed to appear before the House panel and testify on administrative matters of the Court raised in Gadon's complaint.

Those who are invited to testify on administrative matters may do so if they

True-to-Life Encounter with Stroke

know it's about time that I write something about my health situation. My intention, first and foremost, is to make awareness. To all my family in California, Virginia, and in the Philippines, I know I have not said anything about what happened. I waited, as I wanted to make sure first, that I'm clear and alright to tell about my shortfall. Anyway, I have to practice what I preach, right?

More than a month ago on Oct. 12, I was uncertain of my physical wellbeing. I suffered an acute ischemic stroke, which affected my speech and the right side of my face. Hence, my Facebook post: CPU stalled-rebooting! The CPU, or central processing unit is what holds together computer equipment. Any malfunction could produce a glitch or the entire computer system will not work at all. That's my analogy of the human brain.

I was unsure after a few days, regardless of how mild of a stroke it was and all the symptoms have immediately resolved, if I will fully recover, or if the symptoms will recur. This was also around the time when a young Filipino-American community friend in Sacramento had just passed away from a hemorrhagic stroke. Also about the same time of the Filipino celebrity Isabel Granada's falling into coma from aneurysm while attending a function in Qatar. The most tragic of all, was the mass shooting by a lone gunman in Las Vegas that killed several people. I didn't want to feel selfish and couldn't afford to make others worry more about my own condition. I have been back to feeling normal after being off work for two weeks since the incident. I was also able to go on a previously scheduled trip to Europe without any setback at all. I have to say; I came back around with a different perspective in liv-

I was fortunate, this happened when I arrived early in the morning at the hospital where I work. As a nurse, I should be knowledgeable on how to recognize the signs and symptoms of stroke, and to know how immediate treatment can increase the chance of surviv-

prognosis. We are drilled and trained to respond to this kind of patients' sce-

narios. In my case though, I almost failed to respond

#### Recognizing the signs of having a stroke

to my own emergencies.

I remember feeling a little bit off, barely thirty minutes after I arrived at my workstation. Before I left the house, I already felt the inside of my mouth feeling thick, as if, it was inflamed. I also felt having some difficulty in speaking, which I thought was due to my previous dental works. I ignored what I was feeling and went on with my morning routine. I was thankful to my coworker who recognized the droop on the right side of my face, and suggested that I go to the emergency room to get examined.

#### Types of stroke

With my coworker, I decided to walk to the emergency room. Immediately upon my arrival, I was placed in a room and underwent several blood test, carotid ultrasound, echocardiogram, CT scan and MRI, in no amount of

time. I was first diagnosed with having a TIA (trans ischemic attack), then to an acute ischemic stroke after the MRI findings confirmed a small blood clot was found in the left side of my brain. The symptoms that I experienced, which included slurred speech and facial droop were from decreased blood supply due to the blood clot, interrupting the blood flow to the vital areas in the left side of my brain. Arms and legs weaknesses or paralysis can also be seen, but symptoms vary depending on the areas in the brain that are affected. I felt relieved at the time, as I didn't experience any of those other symptoms. If the blood vessel (artery) was weak, that blood clot could have caused it to rupture leading to aneurysm. It is a hemorrhagic type of stroke resulting in bleeding inside the brain. It is often a debilitating, incapacitating, or a fatal type of stroke, as I hear what had happened in Isabel Granada's case.

#### **Lessons Learned**

Since then, I was placed on several different medications to treat high blood pressure, high cholesterol, diabetes, including low-dose Aspirin to help thin my blood. For the first two weeks, I was placed on continuous heart monitoring to detect abnormal heartbeat (atrial al and in order to produce a better fibrillation) that could have pos- more years ahead of me

prescribed by my doctor, who I just met for the first time. My former primary doctor died in January last year. He was only in his late 30's. Even before then, I hardly saw him. In suffering a stroke, I realized I'm not invincible!

#### **Self-First Before Others**

Before all these, I have had experiences when I postponed, delayed, and cancelled my medical appointments. In short, I didn't give

them priorities. I thought I was invincible like Wonder Woman, who does everything with all her power and might. Work, family and other obligations came first. We love helping in our community through our newspaper publication. I realized now, how can I continue to take care of my family and to pursue my community's mission with my fail-ing health? It's just like how the flight stewardess would remind us to put on our oxygen mask first in emergencies, to be able to help others, especially the children. And so, the way I live these days and many

are changing. I have to rearrange

#### Signs and Symptoms of Stroke


Remember the acronym FAST, to recognize the signs and symptoms of stroke. In my case, the FA-CIAL droop without the ARMS' weakness was apparent. I had the slurred SPEECH. After recognizing the signs and symptoms, think of the emergent and needed treatment. TIME is important. Call 911 or be seen at the nearest emergency. This reminds me of this past, so-called black Friday

experience. I had to call 911 and be transported by an ambulance to Kaiser emergency. I suffered a very painful neck and upper back spasm, which I associated with having a massive brain bleed. I didn't take chances but I got sent home after it was ruled out. I was just having some muscle spasms and was given Valium to relieve the pain.

#### Increase knowledge about ones health

Information nowadays are vast and easier to find with computer technologies. Google and search engines can provide us the information that we need to take better care of ourselves. Research, seek medical treatment, and get advice from health professionals. Since my most frightening experience, I have been watching everything that I put in my mouth. I eliminated eating anything that has complex sugars, increase fats, and other food with artificial additives. With that alone, I see better results in controlling my weight and lowering my glucose and cho-lesterol level. We have it all in lesterol level. We have it all in our hands. We do not need any magic ball, heavy weight lifting, and expensive fitness gadgets. At the convenience of our homes and determination, we can increase our physical activities and achieve a healthier lifestyle to survive the years ahead.

During my brief hospital stay, I have come to realize how unprepared I was when it comes to financial planning, advance directives, living trust, and if things could have turned for the worse, my funeral arrangement. Suffering from a stroke has become an eye opener for me to make plans for the years ahead. I have yet to see my children have their own families, take care of my grandchildren, and enjoy retirement life. I'm making plans to LIVE a lot longer to make them all happen!



# 'Constitutional crisis looms'

Senate Minority Leader Franklin Drilon and Sen. Francis Escudero on Monday said lawmakers neither had the power to issue a subpoena nor order the arrest of Chief Justice Maria Lourdes Sereno in an impeachment hearing.

Drilon, a lawyer, former secretary of justice and former Senate President, warned that imprudent exercise of these powers may trigger a serious constitutional crisis.

Escudero, also a lawyer, issued a similar warning.

Oriental Mindoro Rep. Reynaldo Umali, head of the House justice committee, said in a radio interview on Sunday that the panel was studying if it could subpoena Sereno to answer the allegations in the impeachment complaint against her, as the Chief Justice had repeatedly refused to face her accuser, insisting instead on representation by counsel.

Umali said the committee would exercise its power to order Sereno's arrest if the Chief Justice refused to honor the subpoena.

Drilon told reporters on Monday that the power of Congress to issue a subpoena and order the detention of a witness who refused to obey the summons were available only in investigations in aid of legislation, not in impeachment proceedings.

A subpoena, in effect, will compel Sereno in an impeachment complaint to testify against herself, Dri-

Forcing Sereno to attend and testify against herself in an impeachment hearing cannot be done without triggering a constitutional

crisis, he said.

"When the House of Representatives conducts a hearing on an impeachment complaint, the hearing is not in aid of legislation. The Chief Justice is not being asked to testify as a resource person who can be subpoenaed to assist the [House] discharge its legislative function," Drilon said.

He urged Umali to "exercise extreme caution" in using the coercive powers of Congress to issue a subpoena to Sereno, as there is no basis for it and it will only provoke a needless constitutional crisis.

"Requiring her to testify against herself would place her under the strongest temptation to commit perjury, and subject her to an extortion of confession by duress," Drilon said, adding that issuing summons would violate Sereno's constitutional rights and the principle of separation of powers.

#### **Constitutional crisis**

Senator Escudero said respondents in impeachment cases could not be compelled to give evidence against themselves.

He said the refusal of Sereno to attend the impeachment proceedings if summoned "may result in a constitutional crisis if the Chief Justice refuses to attend.

"[I]f I remember correctly, the attendance or participation of the respondent in an impeachment case, or in any case for that matter, cannot be compelled. [He cannot be forced] to give evidence against himself or herself even if he or she attends,' Escudero said.

The House justice committee went into executive session briefly on Monday

to discuss whether the panel had the right to compel Sereno to come to the impeachment proceedings.

When the committee members returned for the public hearing, Umali did not raise the matter of Sereno's possible arrest but stressed the 'extraordinary constitutional powers" wielded by the impeachment panel.

Umali noted that only the justice committee, as an impeachment panel, was mandated by the 1987 Constitution "to give attention to the very important process of checks and balances."

He added that impeachment proceedings "take precedence over other all legislative processes.

Umali said Sereno was only one of the Supreme Court's 15 members, and thus did not hold the powers of the entire judiciary.
"This is precisely why

some of the members are complaining. One of the allegations is there is usurpation or arrogation of power of one supreme body in one person," he said.

Speaking to reporters before the executive session, Umali clarified that his bringing up the possibility of Sereno's arrest was only "hypothetical" and under the assumption that she would ignore an official summons from the panel.

"I was just speaking my mind because I firmly believe the extraordinary power given to the committee on justice as an impeachment committee is a constitutional mandate that ought to be followed by everyone," he

Sereno, he said, is not an ordinary accused in a criminal case, and thus does not enjoy the rights of such an accused.

# 3 justices to testify vs Chief Justice

MANILA, Philippines Three magistrates of the Supreme Court (SC), including a retired colleague, have expressed their intention to testify in the impeachment proceedings against Chief Justice Maria Lourdes Sereno at the House of Representa-

Associate Justices Teresita Leonardo-de Castro and Noel Tijam as well as retired justice Arturo Brion yesterday said they want to accept the invitation of the House justice committee. But they would first seek consent of the SC sitting as a collegial body.

De Castro and Tijam have raised the issue with their colleagues and the matter is set to be tackled at their regular session today.

Brion said he would also wait for the SC's approval, since the issues they are called upon to testify involve internal matters of the tribunal.

All three magistrates sent separate letters to the House panel asking to be given more time to answer the invitation, pending permission from the SC.

"May I request that I be given time to seek clearance from the Court, during the session on Tuesday (Nov. 28, 2017), to produce at the hearing all internal communications, memo-

randa and other documents relevant to the allegations in the Verified Impeachment Complaint. As soon as the clearance is granted, I shall honor your invitation to attend the aforementioned hearing," read De Castro's letter to the House panel.

'Considering that this issue involves the actions of the members of the Court. the undersigned deems it appropriate to first secure their approval before participating in the aforesaid proceedings. Likewise, there is a need to collate records for an informed and accurate recollection of relevant information," explained Tijam in a separate letter.

Brion, for his part, said he would also await the decision of the SC on the matter even if he has retired from the judiciary.

De Castro, who earlier reportedly agreed to testify in the impeachment hearing, was invited by the House over the internal memoran-

dum she filed in the SC last July questioning several administrative orders of Sereno, including appointment of a Philippine Judicial Academy (Philja) official and provision for travel allowances of her staff.

In the memorandum, De Castro specifically assailed the appointment of lawyer Brenda Jay Mendoza as Philja chief of office for the Philippine Mediation Center, which she said violated their Administrative Order No. 33-2008 that required the appointment to be approved by the SC collegially.

The magistrate also assailed Sereno's grant of foreign travel allowance to members of her staff without required approval from the SC.

She revealed that the Chief Justice's staff members were being given travel allowances even when their trips abroad were on "official time," which should not involve expenditure of public funds.

De Castro has also questioned the "long delay" in the appointment in vacant key positions in the SC pending before Sereno's office, "which is prejudicial to the best interest of the ser-

These issues are among the allegations raised by lawyer Larry Gadon in his impeachment complaint against Sereno.

"She is a respondent ... This is more akin to an administrative case," he said. Contempt threats

The justice committee also threatened to cite for contempt two spokespersons for Sereno for describing the impeachment proceedings a "dog and pony show."

an order directing lawyers Joshua Santiago and Aldwin Salumbides to explain within 72 hours why they should not be cited for contempt for making the statement last

The panel issued a simi-The committee issued lar order for Human Rights Commissioner Roberto Cadiz, who was quoted in a news report as saying last week that the "law of the jungle" seemed to be prevailing in the impeachment case against Sereno.

#### Police tell one story of drug killing

In June. Reuters revealed that police have shot hundreds of people during anti-drug operations, then taken them to hospitals where they are declared dead on arrival. Police say they're trying to save lives. Bereaved relatives and other witnesses allege police are sending corpses to hospitals to disrupt crime scenes and cover up extrajudicial killings.

Police have shot dead at least 3,900 people in anti-narcotic operations since Duterte took power in June 2016 – always in self-defense, police say. Human rights activists blame police for thousands more killings attributed to vigilantes, but authorities deny any involvement.

A witness to the Barangay 19 killings told Reuters that the three men were executed and not, as the police claim, shot in self-defense. Police say they only use deadly force in self-defense, but a series of investigations by Reuters suggest they are summarily executing people.

The report said Rolando Campo, 60, sold drugs to an undercover officer, who signaled for back-up. Campo "sensed the presence" of the police officers and ordered his two associates – Sherwin Bitas, 34, and Ronnie Cerbito, 18 – to draw their guns and open fire on them, the report said.

The police retaliated, leaving the three men "fatally wounded," it said.

But the footage shows Campo chatting with people in the neighborhood in the minutes before the police arrive, and not, as the report said, selling drugs to an undercover officer.

#### **Legitimate operation**

The security camera footage not only contradicts the police account of the Barangay 19 killings. It also provides further evidence of another drug-war tactic: the disabling of surveillance cameras at crime scenes by the police. In the footage, filmed simultaneously by four security Manila Police District director Chief Superintendent Joel

turning the camera that captured the action away from the scene.

The police understand the dangers posed by such footage, which can expose their actions. An active-duty commander involved in the drug war told Reuters earlier this year that police collude with local officials to unplug security cameras in areas where they plan to carry out a drug-

war killing.
Reuters has obtained footage from all four security cameras, each capturing the episode from a different angle. Together, the cameras provide a unique record of a police operation from start to

"The operation was legitimate," said Superintendent Santiago Pascual, the commander of the station that conducted the raid, in a statement to Reuters. A station investigation showed that his officers had followed correct operational procedure, said Pascual, and eyewitness testimony that they had opened fire on unarmed men was "untrue and unfounded."

Police carried out the Oct. 11 raid a day after Duterte ordered them to leave anti-drug operations to the state-run Philippine Drug Enforcement Agency. The October memo marked the second time that Duterte has publicly told police officers to stop waging his drug war.

In the video footage, at least 15 armed policemen were seen clearing an area in Tondo, Manila before the three drug suspects were reportedly

Philippine National Police (PNP) chief Director General Ronald dela Rosa said, "I have not seen the video footage. There will be no cover up on this." But two days after the incident, dela Rosa absolved the policemen involved in the Tondo buy-bust of any wrong doing. Dela Rosa said the cops were not at fault because "the executive order of the President has not yet reached them when the operation was conducted.'

Napoleon Coronel also insists it was a legitimate operation.
"It was a high-risk police

operations conducted in Tondo against three suspected drug traffickers reported to be armed and dangerous. Precisely why our police operatives took the necessary precautions to secure the area while conducting police operations," said Coronel.

#### 'Following orders'

The police operation doesn't seem to be undercover. The footage shows mainly plainclothes officers, most of them visibly armed and some wearing body armor, entering the area through the alley on which Campo and Bitas lived. The officers pass in full view of the victims' house seven minutes before the shooting

Arlene Gibaga, Bitas' wife, told Reuters that she witnessed the shooting and the three men were unarmed. We don't have the money for guns," said Gibaga, who has three young children with Bitas. She said her husband didn't deal drugs.

Police detained the men in an alley next to her house, she said, and asked her to get Bitas' ID. When she produced it, said Gibaga, one officer shouted "Positive! Positive!" and then the officers fired on

"Don't do that to my husband!" she screamed, as the police shot Bitas. "I will report you! There are CCTV cameras here!"

One of the officers then aimed his gun at Gibaga and ordered her inside, she said.

The footage doesn't show the police shooting the three men, but does show an officer appearing to open fire on an unseen target. Campo then falls backwards into the frame, his body hitting the ground. His arms move for a while before resting motion-

Less than a minute later. the camera that captured the scene of the shooting is effectively put out of action: someone turns it to face the wall. A second camera shows a police officer reaching up and turn-

wish. The Court is not requiring them but the Court is granting them clearance if they so wish to appear and testify on administrative matters," he explained.

But on matters involving decisions of the Court, Te said only Justice De Castro has been authorized by the SC with specific conditions.

"On adjudicative matters, meaning matters that go into the decision of cases, which would include deliberation of cases, only Justice Teresita de Castro has been authorized to appear and testify before the House committee on justice and only in relation to three matters," he added.

De Castro is allowed by the Court to discuss the exchange of communications with Sereno on the issuance of the temporary restraining order in a case involving senior citizens.

She may also testify on the merits of the decision she penned that declared unconstitutional the clustering of shortlisted nominees made by the Judicial and Bar Council (JBC) last year in connection with the vacancies in the Sandiganbayan.

De Castro has also been authorized by the Court to discuss the merits of her separate concurring opinion in the August 2014 ruling that voided the JBC's decision not to include the name of then solicitor general Francis Jardeleza in the shortlist of nominees for SC justice integrity issue against him.

The magistrate, however, barred from discussing matters involving the deliberations of the Court on those three cases, which are covered by the confidentiality rule under SC rules.

Apart from De Castro, Tijam and Brion have also been invited by the House panel.

Tijam has been invited by the House committee to shed light on the complaint that Sereno had caused delay in the transfer of the rebellion cases against arrested members and supporters of Maute terrorist group in Marawi City to a court in Metro Manila.

Brion, for his part, has been asked to talk about his concurring opinion in the SC ruling on Jardeleza's appointment.

Also invited by the House panel were Te, Court Administrator Jose Midas Marquez, Clerk of Court Felipa Anama and chief judicial staff officer Charlotte Labavani.

The SC had allowed in August the release of court records and documents sought by impeachment complainants to bolster their case against Sereno.

Among the records ordered released were the SC's revocation of Sereno's order in 2012 to reopen a regional constitutional administrative office (RCAO) in Cebu without the collegial approval of the Court.

The SC also allowed the release of Sereno's memorandum on the appointment of lawyer Solomon Lumba as post after Sereno raised an her staff head and the subse-

quent letter of Senior Associate Justice Antonio Carpio withdrawing his signature from the appointment paper over an internal issue.

But the high court rejected the request for the release of a memorandum from De Castro questioning Sereno's orders regarding the appointment of a Philippine Judicial Academy (Philia) official and the allocation of travel allowances for her staff.

The SC explained that such memorandum could not be released pending resolution from the Court.

With the SC decision, Umali said he told committee members – many of whom are lawyers – to work among themselves some ground rules or guidelines for propounding questions to the SC justices, to make sure they would not feel disrespected.

Before the committee adjourned yesterday, Umali discussed the guidelines with his colleagues Vicente Veloso of Leyte, a former Court of Appeals justice; Henry Oaminal of Misamis Occidental and Deputy Speaker Gwen Garcia, among others.

Umali said the justices would be notified of the dates or time of their appearance before the committee. The next hearings will be on Dec. 4 until Dec. 6.

"We will invite them one at a time and on a particular date para naman hindi masayang ang oras nila (so we'll not be wasting their time). There will be an allocation of one hour each per (impeachment) charge," he said on Monday.

Station commander Pascual said the camera was averted for a "valid security reason" and to ensure the operation wasn't compromised. His statement reiterated the police re-port's version of events – "that the suspects first drew firearms and shot the operatives," who returned fire in self-defense.

Later that day, at Police Station 2, Gibaga said officers told her it was useless to complain. "It's the government you will be fighting against," she recalled one officer saying. "Don't get angry at us. We are just following orders.'

# **Oplan Tokhang under fire!**

ne of the most controversial police operations is Oplan Tokhang where police officers have killed suspected drug pushers and users in the past 16 months. "Tokhang" is derived from two Bisayan words: "toktok" (to knock) and "hangyo" (to plead). It is a police operation wherein the police knock on the doors of sus-

pected drug users or pushers and ask them to surrender. In most cases, when the police go to the house and the household people refuse to allow them to enter, the police force their way in, which could lead to a shootout... and death.

Since President Rodrigo Duterte took office through the end of 2016, around 6,000 people have been killed in the campaign, 2,000 of which were killed during legitimate police operations while the remaining 4,000 were extrajudicial killings (EJKs) or vigilante-style Based on these killings. numbers, Duterte claimed the anti-illegal drugs campaign to be a "success."

Records also show that the number of deaths during legitimate police operations dropped to an average of five persons daily in 2017, compared to an average of 30 deaths per day in 2016.

Presidential Communications Secretary Martin Andanar said "the government's crackdown on narcotics also pulled down the country's crime rate by 32 percent.

"People feel safer in the streets and at night because the number of theft, carjacking, robbery, rape, physical injury has decreased. At the end of the day, this is what counts," Andanar noted. However, local and interna-Andanar noted. tional human rights groups have condemned the Philippine government for the human rights violations and extrajudicial killings.

#### Police abuse

Last January, Duterte sus-Tokhang pended Oplan Tokhang following the kidnapping and killing of Jee Ick-Joo, a South Korean businessman whose body was found within the grounds of Camp Crame, the headquarters of the PNP. Consequently, Duterte stripped the PNP and the NBI of the authority to conduct Oplan Tokhang operations and designated

the Philippine Drug Enforcement Agency (PDEA), backed by the Army, as the lead agency in Oplan Tokhang operations. also abolished the anti-drug units of PNP and vowed to cleanse the PNP of "scala-

But it was the death of two teenagers, which stirred public furor. One was Kian delos Santos, 17, who was murdered according to the NBI and the Public Attorney's Office (PAO). "The boy was killed kneeling down," the NBI report said.

The other, Carl Arnaiz, 19, was killed with excessive violence, according to the PAO report. Bruises were found around his eyes and his wrists were swollen from the metal handcuffs. The autopsy revealed four gunshot wounds to his chest and one to his arm. The PAO report said that it was a case of "overkill."

#### "Sole agency"

As a result of the two teenagers' killing, Duterte's satisfactory rating plummeted by 18 points. Alarmed by the sudden drop in popularity, Duterte issued a memorandum, which ordered the PNP, the National Bureau of Investigation (NBI), the Armed Forces of the Philippines (AFP), the Bureau of Customs (BOC), the Philippines Postal Office and other "ad hoc anti-drug task force" to leave the implementation of the drug war to the PDEA. But despite removing the PNP from the drug war, Duterte directed the PNP to maintain its visibility "at all times" as a 'deterrent to illegal drug activities." Does that translate to a "shoot to kill" order?

But citing lack of manpower in the anti-drug war, Duterte later decided to tap the PNP again in the war on drugs. However, he stressed that only the "qualified" ones would be allowed to join Oplan Tokhang. Hmmm... Does it seem like it's "business as usual" where the police could "neutralize" suspected drug pushers or

users if the need arises? As the Amnesty International has said, the designation of PDEA as the lead agency to conduct the war on drugs could just be a "PR" move by the government. Like they say, "Pa PR PR lang yan" ("That's just all PR"). But 'PR" or not, Oplan Tokhang is finally being challenged,

not in the streets of Metro Manila but in the halls of justice.

Last October 11, a group of human rights lawyers urged the Supreme Court (SC) to stop the implementation of Oplan Tokhang by revoking two orders that serve as the campaign's blueprint. The three petitioners are represented by the Free Legal Assistance Group (FLAG), which filed a petition before the SC to declare the PNP Command Memorandum Circular 16-2016 and the DILG Memorandum Circular 2017-112 unconstitutional.

#### "Double trouble"

FLAG Chairman Jose Manuel Diokno said the CMC 16-2016 known as Project Double Barrel is unconstitutional because: "It expressly authorizes the police to kill suspected drug personalities; it replaces the police function of evidence-gathering and case build-up with that of compiling lists of suspected drug criminals; and the house-to-house visits under Project Tokhang are based on the 'furtive fingers' of unknown informants.

The other order MC2017-112 known as Masa Masid orders all barangays to establish a drop box system to anonymously report suspected criminals, which Diokno said "violates the right to due process of law and to be presumed innocent.'

He explained that reporting crimes is done by witnesses who have knowledge of criminal activity while submitting names of alleged criminals "can be done by anyone who suspects, rightly or wrongly, that another person is a criminal." He likens this to the Kempeitai during the Japanese occupation in the Philippines and the secret police Gestapo in Nazi Germany. He said allowing the submission of complaints through a drop box gives any person the opportunity to "report any

## Rape-slay suspect admits holding victim's cell phone

MANILA, Philippines The prime suspect in the rape-slay of bank employee Mabel Cama last Nov. 12 has admitted to holding the victim's cell phone, Pasig City police chief investigator Roberto Garcia said yesterday.

This admission, according to Eastern Police District director Chief Superintendent Romulo Sapitula, made the case against suspect Randy Oavenada stronger, especially after the EPD crime laboratory found matching fingerprint marks on the phone and linoleum used to wrap Cama's body.

He also directed Pasig City police chief Senior Superintendent Orlando Yebra Jr. to secure the suspect's admission in writing.

Rape and homicide charg-

es were filed against Oavenada, a truck driver, before the Pasig City prosecutor's office. But Sapitula said the suspect continued to deny any hand in the rape and killing of the 22-year-old Cama.

He added that Oavenada insisted that two other persons could have attacked Cama, killed her and later set her body on fire.

The Pasig City police already held the two for questioning and subjected them to paraffin tests to determine whether their fingerprints matched those found at the crime scene.

Sapitula refused to name the two pending the result of the investigation.

The EPD crime laboratory recovered five aluminum foils at the crime scene but Oavenada refused to confirm he was among those who sniffed shabu inside the abandoned office where Cama's body was found last Nov. 12. Investigators also found her underwear and shorts near her body.

Crime lab chief Isidro Cariño said Cama died of traumatic injuries in the head.

# Hawaii reinstates 'attack warning' siren to prepare for possible North Korean missile

"It was quite traumatic and totally unexpected," said the 96-year-old World War II veteran, who was a student at the University of Hawaii at the time. "That morning the radio called for all University ROTC [Reserved Officers' Training Corps] to report to the university armory. We were issued rifles to help guard the city and our regiment was converted into the Hawaii Territorial Guard."

Ted Tsukiyama served in World War II with the U.S. Army's 442nd Regimental Combat Team before being reassigned to the Military Intelligence Service in India and Burma.

Sirens were installed around the city after the war started, Tsukiyama added, and there would be periodic tests. "I remember hearing the sirens going off. The radio would give us a warning: 'This is only a test, don't get alarmed,'" said Tsukiyama, who was born and raised in Hawaii.

Along with other Nisei [second-generation Japanese Americans], he joined the Varsity Victory Volunteers and the U.S. Army's 442nd Regimental Combat Team, then was reassigned to the Military Intelligence Service in India and Burma. (One of the characters in the new movie, "Go For Broke," is based on Tsukiyama's life and he also made a cameo appearance in the film.)

These days, Tsukiyama says he isn't surprised the air raid warning sirens will be wailing again come December — only this time, it's due to the rising tensions between the U.S. and North Korea and

because Hawaii has long been a military defense outpost.

"I suppose that's necessary as a precaution, but I don't think North Korea is gonna attack," Tsukiyama said. "They'd be foolish to threaten South Korea or Japan or the United States."

But concerns are growing. North Korean leader Kim Jong-un has repeatedly threatened to drop a bomb over the Pacific Ocean, and President Donald Trump has threatened North Korea with "fire and fury" and designated North Korea as a state sponsor of terrorism.

So what is the probability of a North Korean missile striking Hawaii? According to Vern Miyagi, administrator of the Hawaii Emergency Management Agency (HI-EMA), which is part of the state's Department of Defense, the chances North Korea will act are unlikely, but making sure Hawaii is prepared is still vital.

"If North Korea launches against us or our allies, the retaliation would be complete and they would defeat North Korea's ambition to continue its regime. The regime would probably end," explained Miyagi. He notes Hawaii is protected under the U.S. Pacific Command's defensive umbrella, the anti-ballistic missile system, and it is home to the Pacific Command, the military's headquarters for the Asia-Pacific region.

But, Miyagi points out, "Hawaii is a likely target because we're closer to North Korea than most of the continental United States... As we track the news and see tests, both missile launches and nuclear tests, it's the elephant in the room. We can't ignore it. People of Hawaii need to know what Hawaii is doing in preparation for this."

Because of the North Korean threat, the Aloha State is currently ramping up efforts to educate its 1.4 million residents, as well as its visitors, on how to prepare for a nuclear attack.

Hawaii has become one of the first states in the nation to initiate a nuclear preparedness campaign, and starting Dec. 1, it will reinstate the "attack warning" siren, which it hasn't tested since the Cold War. The siren will follow the monthly "attention alert" signal, which warns people of an incoming tsunami or hurricane.

The state has also been holding community meetings and broad-

casting public service announcements on TV and the radio to prepare people for a possible attack.

Most importantly, officials are encouraging people to have a plan. Gone are the days of "duck and cover" during the Cold War; today, the mantra is "shelter in place," preferably in a concrete structure. Officials also recommend having enough food and water to survive for 48 hours, and being prepared with supplies to last up to 14 days.

If North Korea launches a missile, officials estimate it could take about 20 minutes to reach Hawaii. It would take about five minutes for the U.S. to determine where it's going, which would leave about 12 to 15 minutes to warn the public.

"Each individual, each family should have a plan to be resilient, so they can take care of themselves, while we focus on getting the critical infrastructure, the harbors, the water, the roads, all back to some sort of normalcy," said Miyagi, who's also a retired U.S. Army Major General and has extensive experience in domestic and international humanitarian assistance and disaster response.

Officials are also advising everyone to stay updated on what's going on in North Korea, get more knowledgeable about nuclear affects, and learn what they can do to prepare for a nuclear strike.

Based on a nuclear threat now, officials predict 80 to 90 percent of the population could survive.

"I would be remiss in not doing my responsibility, or our responsibility at Emergency Management to not consider this, and list this as one of the hazards and prepare for it. That's our job here, to prepare for hazards. If we save one life, it's worth it," Miyagi said. "If we save lives, that's the whole purpose of our existence, and we're very passionate about what we do."

The pope said the attack on Friday "brought great pain," adding that he continued to pray for the dead and the wounded "and for the whole of that community, that has been so hard hit."

# **Trudeau incurs the wrath of the Punisher**

t the urging of his Filipino-Canadian constituents, Prime Minister Justin Trudeau dared to bring up "human rights" when he met with Philippine president Rodrigo "The Punisher" Duterte at the end of the 31st Summit of Association of Southeast Asian Nations (ASE-AN) and Western nations in Manila. Had Trudeau taken the cue from former U.S. president Barack Obama, he would have skipped the subject matter. But like they say: the devil made him do it.

Obama, who tried to "lecture"

Duterte on human rights last year at the ASEAN summit in Laos last year, earned the epithet of Duterte who warned that if Obama asked his government's extrajudicial killings, "Putang ina ("son of a bitch" in Filipino), I will swear at you." Well, Obama cancelled their meet-

ing and said that Duterte was a "colorful guy."

Indeed, Trudeau was only among a few world leaders who daringly raised the issue of human rights at the ASEAN summit. Known for championing human rights, Trudeau told a Canadian reporter that he discussed the issue with Duterte when they met for the ASEAN-Canada Commemorative Summit. He told Duterte that Canada was "concerned" over the human rights violations and extrajudicial killings happening in the Philippines as a result of Duterte's "war on drugs" which has claimed the lives of thousands of drug suspects. He said in a press conference: "I also mentioned human rights, the rule of law and specifically extrajudicial killings as being an issue that Canada is concerned with. "I impressed on him the need for respect for the rule of law, and as always offered Canada's support and help as a friend to move forward on what is a real challenge.'

Tons of garbage

But notwithstanding the appeals from Filipino-Canadians.

Trudeau's trip to Manila was confronted with another issue: Canadian trash dumped in Manila – 2,500 tons declared as "recyclable plastic scrap materials." Chronic Plastics Incorporated (CPI), an export company base in Ontario, Canada, shipped it in 2013. It was consigned to Live Green Enterprise. In January 2014, the Bu-

reau of Customs (BOC) discovered the garbage when they opened the container vans as part of procedures on shipments not claimed for a long period of time. What they found was plastic bottles, plastic

bags, newspapers, household garbage, and used adult diapers. The garbage was then classified as "hazardous" as per Toxic Substances and Hazardous and Nuclear Waste and Control Act of 1990, or Republic Act 6969.

In February 2014, the BOC filed a smuggling complaint against

opment had said that there was nothing hazardous in the material shipped and that no laws exist to force Ontario Chronic Inc. to recall the shipping containers. This is in contradiction to what the had found out when it inspected the cargo.

Theoretically possible

Trudeau is now saying that it is "now theoretically possible" for Canada to remove the trash. However, he explained that several issues need to be worked out, including who should bear financial responsibility? He said that "legal barriers and restrictions" are preventing Canada from taking the trash back. "Those impediments have now been addressed,"

Trudeau said during a press briefing. Malacañang responded by saying that Duterte has faith that Trudeau will keep his promise to resolve the garbage issue.

One has to feel sorry for Trudeau because, (1) he wasn't the Prime Minister when the garbage was shipped to the Philippines; and (2) he can't find a way to go around

Ultimately, Trudeau, who is now under pressure from world leaders to remove the trash, would have to



In my column, "Trump's geopolitical miscalculations" (May 12, 2017), I wrote: "After he assumed the presidency, that foreign policy -

which he had no prior experience is a complicated and complex game of statesmanship and adroit diplomatic leadership and maneuvering. It must have been a rude awakening for him to recognize that the practice of brinkmanship is quite different from the 'art of the deal,' which he proudly claims to be his forte.

'His tough stance against China gave Japan and South Korea, America's closest treaty allies, a sigh of relief. At last, they have an American president who would stand by them if attacked, unlike Trump's predecessor, for-mer president Barack Obama, whom he criticized for appeasing China and didn't do anything to stop China's construction of artificial islands in the Spratly archi-

'And to make things worse, he appointed Rex Tillerson to the post of Secretary of State. With no prior experience in foreign policy - or government for that matter – poor Tillerson was thrown into the murky waters of geopolitics. And between him and Frump, how do you think they'd handle bullies like Vladimir Putin, Xi Jinping, and Kim Jong-un

# Trump makes a fool of himself again

in the world stage? They are no ordinary world leaders; they are authoritarian dictators who love to threaten the U.S. with nuclear destruction. In particular, North Korea's 'Supreme Leader' Kim Jong-un seems to have rankled Trump who doesn't appear to know how to handle the unpredictable Kim."

#### **Good chemistry**

After the first Trump-Xi summit at Mar-a-Lago in Florida last April 2016, Trump's hard-line

stance against China melted like marshmallow over a fire. After two days of negotiations, Trump declared that China was not a 'currency manipulator" and decided to maintain the status quo on trade issues. That's a 180-degree turnaround from his position during the presidential campaign.
When Xi went back home, he

ordered shipments of coal from North Korea to be turned back. Trump was ebullient when he got the news. He said that China took a "big step" in easing tensions between the two countries. He described his relationship with Xi as one with "good chemistry" and praised Xi for banning North Korean coal.

But that was just about it. Banning coal imports from North Korea was just a ruse to make Trump think that China was doing its end of the bargain. Trump felt so good at what he had achieved at Mar-a-Lago that he virtually ceded control of the South China Sea (SCS) to China. With China calling the shots at SCS, it wouldn't be long before China begins to populate the islands and deploy missiles, warships, warplanes, and troops. There would be Chinese cities


on these islands just like Sansha City on the Paracel Islands, which is contested by Vietnam. Sansha has been designated as a prefecture-level city of Hainan. It administers the Paracel Islands, Scarborough Shoal, Spratly Islands, and Macclesfield Bank.

Meanwhile, North Korea was unperturbed by the Chinese ban on North Korea coal and had launched more than a dozen missile tests including detonating a hydrogen bomb. And Xi didn't lift a finger to stop Kim, who is out of control.

#### **Showcasing Chinese power**

When Trump visited China last week, as part of his five-nation Asian tour, Xi laid out the red carpet for his friend and gave him the royal treatment including a rare official dinner in the Forbidden City and a grand welcoming ceremony featur-ing hundreds of cheering children in front of the Great Hall of the People. The whole event made the Mar-a-Lago welcoming ceremony for Xi looked like a meeting of two business leaders, which was pretty much what it was.

The welcoming ceremony in Beijing turned out to be more of a showcase of Chinese power and prestige, choreographed for the American viewers, specifically, and the international community, in general. It was demonstration of Chinese



hospitality at its best, and it was orchestrated to project China's emerging role as a world superpower. A visitor who shows disrespect for the Chinese host would be violating Chinese hospitality customs.

But while the desired effect might have been to show China and America as co-equals, the end result was that Trump handed world leadership to Xi simply by giving what China wants, which is "respect on the global stage" and as a co-equal. During their bilateral meeting, Xi told Trump, "The Pacific Ocean is big enough to accommodate both China and the U.S." He said the same thing to Obama during their summit in California in June 2013. Global Times, a Chinese state-run, said Trump "seems to be pragmatic on his Beijing policy, and has no interest in ideological diplomacy.' But Trump could have graciously responded to Xi's suggestion without disrespecting Xi, and asserted America's preeminence in the Indo-Pacific Region.

#### Capitulation

Unlike his predecessor Barack Obama, Trump did not raise the issue of human rights, knowing that China's ideology is not compatible with human rights. "He hasn't used the issue of human rights to make

trouble for China so far, and this means the Sino-US relationship can focus on substantive matters,' Global Times said.

But what wiped out any credibility Trump had was when he told his Chinese audience, "I don't blame China, who can blame a country

for being able to take advantage of another country for the benefit of its citizens. I give China great credit," Trump said. He said that what criticism he had for China on trade imbalances was caused by U.S. policy, not Chinese.

In a joint speech, Trump heaped praises on Xi, saying the American people were "very proud" of him and hailing the "very good chemistry" between the two of them. Then he blamed past American administrations for China's huge trade surplus with the U.S. He then saluted Xi for leading China that he said had left the U.S. "so far behind." He also said that he could not blame the Chinese for taking advantage of weak American trade policy. Then he said that he was confident that Xi could defuse the threat from North Korea. Didn't he try that at Mar-a-Lago before... and failed? Xi, on the other hand refused to take questions from American journalists. Why?

However, behind closed doors, American officials said, "Mr. Trump forcefully confronted Mr. Xi about the chronic trade imbalances between the two countries. He also pressed China to take tougher measures toward North Korea, including a suspension of oil shipments." However, Xi did not make significant concessions, just like what happened at their Mar-a-Lago summit.

Which makes one wonder: "What exactly did Trump accomplish in China? On trade, there were no substantial agreements that would address the trade imbalances. On the North Korea dilemma, Trump consigned to China the responsibility of stopping North Korea, which we know that's not going to happen simply because China needs North Korea as a buffer against South Korea and the U.S.

On global leadership, Trump relinquished ceded it to Xi. Trump has put an end to Pax Americana and what we're seeing is the emergence of Chinese hegemony -- Pax Sinica.

And the only thing that Trump accomplished was that he makes a fool of himself again, which has become so frequent that some people call him, chief." "moron-in-





# A Thanksgiving Tribute

I am my big sister's baby brother. Estela was my Ate. In Filipino, a big sister is respectfully addressed as Ate (At-TEh). She would call me on the phone when I needed a big sister, when I needed some uplifting.

At least once a week, Ate Estela and my wife would spend minand my wife would spend min-utes, if not hours, on the phone. My wife Melita probably knows more about Ate Estela than I do because of their hours spent on the phone. Melita would tell me about Ate Estela's younger years in the Philipping up to bor corly. in the Philippines up to her early years here in the United States.

I am here today because of a decision Ate Estela made years ago. My siblings and their families are here today because of Ate Estela's love and dedication. When she made up her mind about something, there was no wavering. She would forge on until she got her way, or at least try to get her way.

My sister was very independent. She needed to do things her own way. Independence is a trait I also have and perhaps everyone in the family had already discovered about themselves. I'm not sure if the strength of our independence could match Ate Estela's.

She was born before the war, she lived through WWII, and in the early 1950's moved to the United States. I'm sure she had to adjust rapidly to the culture of a new country. She dedicated her early life here as a good wife, a great mother, and for a long time, the only Esperante sibling in the United States. Our mom visited

from the Philippines to help Ate Estela at about the time she gave birth to my first niece. My mom took me along and we stayed here for two years. I'm not sure if we stayed here for two years because my second niece soon followed my first niece. In the pictures, I think I've seen old photos of my first two nieces and me. I'll have to check the old photos again.

In recent years, during the long chats between my wife and Ate Estela, the phone would be passed on to me at times for me to say hi to Ate. I would tease her and say, "hey beautiful." She would answer, "my baby brother." With all due respect to my other sisters, Ate Estela stood on a pedestal in my eye. 

Completing nine-day simbang gabi or dawn masses leading to Christmas Day is not like a genie in a bottle that will grant wishes, a Catholic bishop said yesterday.

Manila Auxiliary Bishop Broderick Pabillo reminded the faithful that the purpose of the novena is to commemorate the birth of Jesus Christ and spiritually prepare Catholics for celebration of Christmas Day.

He called on priests to also remind their parishioners that going to dawn masses is not meant or designed for their wishes to be granted by the Lord, which he described as a misconception

"Completing the nine days of simbang gabi is not for their wishes to be granted. That is a wrong belief. That is not what going to the simbang gabi is for," Pabillo said in an interview. "These should be explained in the masses in order to correct the people's thinking."

"The nine days of praying is

part of the preparation for the big feast of Christmas. For the formation of the faith and thanking God for His generosity," he explained.

The prelate added that the novena was designed to represent the faithful's devotion to God.

"The nine days is a manifestation of the people's persistence. Imagine you will wake up early for nine straight mornings... It is a sign of your love of God," he explained.

The dawn masses started last Friday, Dec.16, and will end with the Misa de Gallo on Dec. 24, eve of Christmas Day.

Meanwhile, another bishop reminded the faithful that the Christmas season is a perfect time to make sacrifices for others.

Cubao Bishop Honesto Ongtioco has urged the faithful to reach out to the poor and victims of violence as a sign of love to fellow people.

He also appealed that acts of compassion, generosity and love should not be limited to Dec. 25 but should be done every day.



# Behind the Charmer May Hide an Abuser

CHARMING. Life of the party. Generous to a fault. Who does not know someone who matches that description?

Few would think twice before bonding with a person who seems to possess the qualities idealized for a lifetime companion.

But to paraphrase the adage about an old medium, fonts don't make the book. Open it and browse before purchasing to avoid buyer's remorse.

Same rule should apply to potential intimate partners: Appreciate the appealing first impression, but don't rush into a commitment. Because behind the affability may be malevolence exposed only to the most unsuspecting beholders -- the ones who get captivated, literally.

Survivors of dating and domestic violence say their partners who abused them have two faces: the one they show the public and the one they take home, behind closed doors.

Marlene Caballero knows too well.

In her testimony to raise awareness of domestic violence October 1 in Kaiser Permanente Medical Center in South San Francisco, California, Caballero related how her ex-husband hardly was around when she gave birth to their four children, minimized a serious ailment and riffled through her closet rummaging for evidence of an imagined affair when he was the one who was fooling around. He tried to strangle her with the telephone cord and stopped only when he realized she was a breath away from death.

"I never saw this abusive behavior before we married," Caballero

told some 150 medical professionals, resource providers, public officials and individuals seeking help for their troubled relationships at the program organized by ALLICE Kumares & Kumpares, the all-volunteer domestic violence prevention education nonprofit based in Daly City. "He was always honest and humble about his upbringing, hardworking and always poured all-out efforts into his professional projects.'

Had their partner been obnoxious when they first met, survivors say they would not have paid a second look at the person they thought was heaven-sent in the beginning but who revealed a devious side later.

Neither wiser was accountant Nenette Flores of South San Francisco, among the attendees supporting fellow survivors at the ALLICE gathering.

"I thought he was the answer to my nightly prayer for a partner who would love and protect me," Flores spoke of the dashing Californian she met after fleeing Manila and her first husband, who beat her up when they quarreled over his gambling and woman-

Her then-suitor only had eyes for her and swept her off her feet with his chivalry. He made every date special, complete with flowers, which thrilled the object of

Her guard down, she found every reason to accept his marriage proposal after a brief courtship.

"I never suspected that his affection would deteriorate into unreasonable demands for sex," Flores said, knowing now how pleasure can turn to pain on several levels. "He insisted on intimacy so often to the point where he ordered me to skip work."

"He was relentless, forcing sex even after I had just survived a car accident trying to get away from him," Flores told Positively Filipino.

That incident drove her to the ER, where a question from a caring nurse about her home situation unlocked a secret that one out of every four women suffers in the United States.

Abuse, say experts, is a learned behavior. People who abuse employ tactics they've observed to be effective.

Likely to grow up an abusive adult is a child who witnesses his or her abusive father constantly berating if not beating up the mother into an unhappy, fearful wreck. The child may see the domineering parent as the better model than the submissive one.

Who wants to be the sorry victim when the dominant party gets all the attention?

"Abuse is about power and control," stressed Dr. Jei Africa, a licensed psychologist in the San Francisco Bay Area. "Many abusers can be charming and 'nice' not to control others but to mask their abusive behavior."

"Abusive behavior" is a phrase frequently used and misunder-

Merriam-Webster defines abuse as a corrupt practice or custom,

improper or excessive use or treatment, deception, vilification and physical treatment.

What one culture may find appalling, however, another might consider typical. Bribery may be a way of life in a particular society and an act of treason in another. Similarly, one culture frowns on extra-marital or multiple partnerships, which might be a tradition in another.

To therapists and counselors in this country, cheating or having a relationship outside an intimate relationship is unhealthy and potentially abusive behavior. It is a form of dating and domestic abuse they say betrays and humiliates the offended partner whether or not the former is aware of the infidelity.

The home is not the only place where abusive behavior begins and explodes.

"Abuse may be learned through many different things: media, personal experience and seeing others go through the experience, misinformation," Africa said, with a caveat. "When abusive behavior is normalized or reinforced, it can be seen as an acceptable response.

Some communities approve of spousal battery as a means to resolve a domestic conflict, for example. When a celebrity athlete is charged with perpetrating domestic violence, he or she gets a pass from most fans who say the matter is between the intimate partners because only they know what actually triggered the inci-

By the time the abuse turns physical, therefore visible and obvious, perpetrators will have already inflicted silent or unseen attacks causing tension, making the victim feel she or he is walking on eggshells around the perpetrator.

San Francisco Bay Area licensed marriage and family therapist Jennifer Jimenez Wong reminds clients to be mindful of how their partners behave and how the behavior affects them to assess if the relationship is unhealthy and potentially abusive (see side bar).

Wong, a clinical supervisor at Fred Finch Youth Center, says that if an individual constantly worries about angering the partner, the relationship may be in

Knowing the signs for a tendency to crave power and control indeed may save someone from a lifetime of sorrow.






