# **2 Editorial** Tokhang, Take 3 the most lucrative traditional

After covering the crime beat for many years, I can declare with certainty that there really are criminals who resist arrest or nanlalaban.

And when they do, there truly are instances when they are so hardened, or feeling so desperately trapped, that they resist violently, using whatever weapon is available. And it's likely that the weapon would be used to kill, which is the best way to avoid being further pursued and captured.

In such instances, of course the arresting officer would defend himself, by neutralizing the threat.

It's also not farfetched that the police

would be outgunned. Organized crime rings can be wellfunded, and they invest in firepower, getaway vehicles and communication devices.

The most well-funded are the drug traffickers and gambling lords, whose illegal activities can be sustained for long periods. Not as sustainable, but also profitable, are kidnapping for ransom and carjacking.

As we have seen in many cases in the past, the goons who engage in these activities are typically heavily armed - and they have no compunctions about using the weapons to kill those who get in their way: victims, arresting cops, prosecutors, witnesses, even judges who send gang members to prison.

Obviously, engaging in activities to raise colossal amounts of dirty money is not for the faint-hearted. And neither is fighting them. Cops who run after such criminals must be ready to kill or be killed, and even risk the safety of their loved ones.

The greater the gains from illicit activities, the tougher the resistance to arrest. And the illegal drug trade has to be

criminal activity (hacking into bank accounts, a 21st century crime, can be more profitable, and easier for experts). Plunder can't be far behind, but this is another story.

So the chief of the Philippine National Police was just being honest and realistic when he said a bloodless war on drugs is impossible. Director General Ronald dela Rosa made the comment as the PNP relaunched Oplan Tokhang at the start of the week.

As real as the cases of nanlaban, however, are the "salvagings" or summary executions along with the planting of evidence by police, especially in drug cases. Philippine cops have been engaging in salvaging since the Commonwealth period.

One reason last year's killing of teenagers by police so spooked people and pulled down President Duterte's ratings was the thought that anyone could be targeted for brutal execution, including children. It doesn't matter if the kids are experimenting with drugs or not; parents believe in their children's capacity for reform and want the kids to be safe, especially from homicidal cops.

Tokhang Take 3 is supposed to do away with such abuses. At the relaunch last Monday, all the "tokhangers" were in proper police uniform. As promised, the kinder, gentler tokhang was carried out only during daytime, and will be suspended during weekends.

With so many journalists accompanying the tokhangers and all the kibitzers raising their smartphones to record everything, it was a wonder

the cops managed to get anything done as they conducted house-to-house visits.

The real action is going to be when tokhang's relaunch recedes from the headlines, and when the tokhangers begin focusing their attention on the folks on President Duterte's updated narco list.

Public support for Duterte's ruthless war on drugs, unusually high for about a year since he assumed office, began crumbling after video footage, witnesses

and recovered bodies provided incontrovertible evidence of brazen abuse of police power, mostly targeting the impoverished

Duterte has been trying to explain the focus on penny-ante hampaslupa drug suspects,

arguing that they are the users of shabu, poor man's cocaine, which fries the brain.

But other drugs have the same effect, and worse. Perhaps with Tokhang 3, the cops can focus their energies on those who distribute and use cocaine, Ecstasy and other party drugs. They can go after dealers of the opioid analgesic fentanyl and its cousin carfentanyl, said to be 100 times more potent than fentanyl, 5,000 times stronger than heroin and 10,000 times stronger than morphine.

Carfentanyl is being likened to nerve gas and eyed as a potential chemical weapon. The biggest distributor of fentanyl and its analogues is China, which legally manufactured and sold the drugs mostly online until they were classified as controlled substances last vear

If the tokhangers run into the traffickers of these drugs and a genuine firefight erupts, Pinoys will probably again look the other way if the take-no-prisoners approach is applied.

In this day of social media. it is difficult for battered women to be kept hidden.


Nosy neighbors will talk and spread the news or better, inform the authorities, who would know what to do. I know it is better said than done.


But action must be taken. Ask for advice from the women's desk in every police station.

MANILA, Philippines There is no guarantee that the relaunched "tokhang" will not result in bloodshed, Philippine National Police (PNP) chief Director Ronald dela Rosa said yesterday.

At Malacañang, presidential spokesman Harry Roque expressed hope the police "have learned from their experience" and would try their best to make sure community anti-drug operations or Oplan "would be less Tokhang bloody.3

The program made a comeback with an assurance from Dela Rosa that it would be free of violence if offenders agree to go peacefully with police.

But he could not promise "foolproof anti-drug camа paign that would be bloodless," Dela Rosa stressed, explaining that police were "not dealing with people who are in their proper state of mind."

'On the way of addressing this problem, we also have to protect ourselves, preserve our own life and the life of the stranger," he said. "Now. tell me who among the police commanders can do it, and I will be willing to give up my post.

'That's impossible," he said.

"We are just giving you the assurance we will try our best to make it less bloody," he added. Tokhang operations, he said, would only be conducted between 8 a.m. and 5 p.m

But Sen. Panfilo Lacson questioned the PNP's move to limit "tokhang" to office hours and weekdays.

"I don't understand why drug pushers will have a weekend holiday," he said. Lacson said as long as the provisions of the Revised Penal

Code and the rules of engagement on arrests. especially warrantless arrests, are followed, "the law enforcement function of the PNP should be continuous.'

In many of these operations, say rights activists, suspects did not get the chance to surrender, but were executed in cold blood. Police insist suspects died because they violently resisted arrest.

Nearly 4,000 drug suspects have died in gun battles with police since June 2016, when President Duterte came to power. The government lost 85 police and soldiers in the drug war, police data show.

More than 1.2 million people had also turned themselves in after the home visits.

Duterte stopped police antidrug operations twice due to questions over the conduct of the operations.

The President, who has promised to continue his war on illegal drugs "until the last drug pusher is out of the has also vowed to streets," protect policemen who shoot drug suspects in self defense. But he has clarified that the

protection does not cover law enforcers who commit crimes and abusive practices. Roque welcomed the PNP's

> Interior and local government department officer-incharge Eduardo Año has said that the new Tokhang guidelines emphasize accountability of police personnel providing support to the Philippine Drug Enforcement Agency, which has been tasked to lead the campaign.

> While the PNP promised a less bloody Tokhang, at least four suspected drug personalities in Quezon City, Pasig and Cavite were killed days before the relaunch of the anti-drug crackdown.

> Last year, Duterte removed the PNP from the anti-drug war following the deaths of teenage drug suspects in Caloocan.

He restored the PNP's role in the campaign after a few months because of the supposed "notable resurgence in illegal drug activities and crimes.

More than 19,000 "homicide" cases have been recorded since the start of the drug war in 2016, of which only about 2.200 are drug-related, according to PNP.

The PNP has conducted more than 64,000 anti-drug operations, with more than 102.000 arrests.

To ensure transparency,

Dela Rosa invited human rights advocates, priests and the media to join the relaunched tokhang.

The police officers involved would also undergo a vetting process to weed out rogue officers, said Dela Rosa, adding that past abuses had involved the police seeking bribes to drop the names of people from the lists they compiled.

"We are certainly hoping that it will be less controversial, because controversy will only blur the real intention, which is really the fight against dangerous drugs." Roque told reporters. National Capital Region

Police Office chief Director Oscar Albavalde also extended the same invitation to the Commission on hUman Rights (CHR).

We are inviting the CRH to join all our Oplan Tokhang operations to erase once and for all accusations of EJK (extrajudicial killings) and other illegal activities by our Tokhangers," said Albayalde in an interview.

Albayalde led the simultaneous re-launching of Oplan Tokhang in Metro Manila as he stressed that Tokhangers strictly passed a vetting process and background investigation.

The NCRPO chief said every tokhang operation would involve at least four policemen and village officials.

The PNP's Directorate for Intelligence (DI) would pinpoint houses to be subjected to tokhang.

The Tokhangers would be in full uniform and unarmed. but would be accompanied by armed units depending on the security situation in the area users. of operation.

According to Albayalde, the Tokhangers would be different from the Station's Drug Enforcement Unit (SDEU) which would separately conduct anti-drug operations in Metro Manila.

Tokhangers, based on rules, should not force subjects to come out of their houses.

"Those who turn themselves in or surrender would be brought to the barangay hall or police station where they would undergo documentation. They would be evaluated and first timers would be recommended for rehabilitation." he said.

"When their subjects refuse to open their houses, the visiting Tokhangers would conduct a case buildup against them for the purposes of police operation later," he added.

#### **Dismissed policemen**

A total of 352 policemen have been dismissed from the service for various offenses since Dela Rosa's assumption as PNP chief 18 months ago.

PNP, I have already dismissed 352 policemen for various offenses, 167 for drugs or drugrelated, 155 others for kidnapping, murder, extortion, various offenses," he told reporters in a press briefing yesterday.

The ranks of the dismissed policemen ranged from police officer 1 (PO1) to superintendent.

He said 329 more are facing administrative and criminal charges and might also be dismissed.

Quoting a report from the Directorate for Personnel and Records Management (DPRM), Dela Rosa said 146 of the 167 policemen dismissed for drug related reasons were found to be drug

As part of the internal

cleansing in the police force, Dela Rosa reassigned 200 errant Metro Manila-based policemen to Mindanao.

The DPRM records also showed 21 other policemen arrested for alleged involvement in illegal drugs, 72 dismissed for being absent without leave (AWOL), 57 for offenses like immorality, estafa and dishonesty; 22 for murder and 15 for robbery extortion.

Records also showed that nine police officers were dismissed for homicide, illegal arrest, detention or "incriminatory machination." and parricide - offenses the PNP consider human rights violations

Eight other policemen were dismissed for charges of kidnapping; one for graft and malversation and one for rape, DPRM records showed.

Dela Rosa revealed the dismissal proceedings against a police senior superintendent remain pending before the Office of the President. He refused to name the officer.

The Office of the President handles dismissal proceedings against officers with ranks of senior superintendent and higher.

"The city director of Iloilo City allowed drugs to proliferate, and Odicta to lord it over the drug trade. There's a case against the city director," he said, apparently referring to alleged Iloilo drug lord Melvin Odicta Sr. and his wife Meriam, who were shot dead at the Caticlan Jetty Port in Aklan on Aug. 29, 2016.

Dela Rosa did not disclose details about the police officer.

He also revealed a policewoman is facing charges after she was caught in a casino in Cebu. "Despite our warning, some remain hardheaded." he said.

# 'Probe Benham Rise research deal'

MANILA, Philippines Seven leftist party-list lawmakers belonging to the Makabayan bloc want the House of Representatives to look into the governmentapproved Chinese maritime research in Benham Rise.

In Resolution No 1623, Zarate and his colleagues said the United Nations Commission on the Limits of the Continental Shelf awarded Benham Rise, renamed Philippine Rise, to the Philippines in 2012.

"Despite the Chinese government's adverse view on Philippine Rise, the Department of Foreign Affairs (DFA) granted China a permit to conduct maritime research in the eastern seaboard of the Philippines starting Jan. 24," they said.

According to Rep. Gary Alejano of Magdalo, who blew the whistle on the DFA's approval of China's application, the "research" will last for a month up to Feb. 25.

Makabayan noted that various groups and individuals have aired opposition to the Chinese expedition "as it appears to be a repeat of China's 'modus operandi' used in 2005 under the Arroyo-era joint marine seismic undertaking (JMSU) that jeopardize our claims in the Recto (Reed) Bank.'

'Under the JMSU that the then Arroyo administration entered into with China, the latter was able to discover and confirm the enormous reserves of natural gas in Recto Reed Bank, where one field already holds about 2.7-3.4 trillion cubic feet of the valuable resource," the lawmakers said.

They said China did not share with the Philippine government the information it gathered in the joint marine seismic study.

They claimed that China pine Rise.

is now very zealous in taking over these rich natural gas deposits as evidenced by its aggressive stance, even constructing islands and placing missile systems to control the area."

They noted that the National Mapping and Resource Information Authority of the Department of Environment and Natural Resources already conducted a survey of Philippine Rise between 2004-2008 and produced a highly detailed 3D digital bathymetric model done by Filipino scientists.

Another state agency, the Bureau of Fisheries and Aquatic Resources (BFAR) of the Department of Agriculture, has also been conducting annual fisheries research and experimental fishing expeditions in Philippine Rise to determine the tuna fishery potential of its waters, Zarate and his colleagues said.

The UP National Institute for Geological Sciences (NIGS) and UP Marine Science Institute (UPMSI) have also been collaborating with counterpart institutions from Korea and Japan since 2016 to begin initial exploration of the seabed in the Philippine Rise, they said.

Local scientists capable They said other Filipino marine geologists and biologists have produced academic papers and analyses for policy considerations and have been analyzing samples and observations gathered from research cruises and have made interesting findings and potential discoveries.

"The Philippines, in fact, already has a deep-sea research vessel, known as BRP Gregorio Velasquez, that can conduct its own study," they added.

They pointed out that contrary to the claims of the Duterte administration, the Philippines does not have to rely on China to study the Philip-

Alejano earlier revealed the arrival of Chinese vessel Ke Hue Hao in Philippine waters on Jan. 22, or two days ahead of its supposed month-long research.

appeal to the DFA and other concerned agencies, including the University of the Philippines, to closely monitor activities in the Philippine Rise.

What we should make sure now is compliance of China with all the requirements demanded by the Philippine government as conditions to the permit issued. In particular, we should be wary on the sharing of information that will be culled from the expedition. Filipino scientists on board should be given equal access to all results of the research," he said.

Alejano also chided administration officials for saying Filipinos alone could not do research in Philippine Rise because of the huge cost involved.

"It is not because our scientists do not have the ability to conduct research, it is because our government does not allot sufficient funding for it. In fact, there have already been expeditions there by Filipinos to support our claim over Benham Rise before it was awarded to us in 2012." he said.

He said the BFAR had proposed funding for a research facility in Benham Rise during last year's budget deliberations, but Congress rejected the proposal.

'This administration has shown no interest and support on strengthening our presence in Benham. Thus, it has no ascendancy to say that Filipinos cannot conduct research in the area given its lack of sup-

Zarate criticized the DFA for its "precipitous claim" that the Chinese "research" in the Philippine Rise would benefit the Philippines.

The UPMSI said the collaboration supports its initiative to develop a national oceanographic program that can help in understanding better the changing climate and ocean processes.

The collaborative research involves a study on temperature, salinity and current distributions in several locations in the Philippine Rise region. UPMSI said instruments of the Chinese institute will be used in the research.

The research activity, UPMSI said, will focus on the North Equatorial Current, which splits off the Philippine coast to form northward and southward moving bodies of water known as the Kuroshio Current and the Mindanao Current, respectively.

The UPMSI said studies on the currents are necessary as these affect climate in the region.

"The Kuroshio is responsible for the transport of heat to the rest of the North Pacific and therefore is an important driver of the regional climate and even the El Niño/La Niña cycles," it said.

# **Bongbong Marcos bares 'evidence'** of fraud in vice presidential race

MANILA, Philip-Former pines senator Ferdinand "Bongbong" Marcos Jr. yesterday bared what he claimed was evidence of fraud in the May 2016 elections to boost his poll protest against Vice President Leni Robredo before Presidential the Electoral Tribunal (PET).

In a press conference in Manila,

namesake made public cop-ies of election documents he received from the PET recently that supposedly showed "shocking and highly questionable" poll results in at least two provinces.

Marcos alleged that the images of ballots from polling precincts in several towns in Camarines Sur and Negros Oriental proved how the camp of Robredo "had manipulated the voting and trampled upon the true will of the people on their choice for vice president.'

He said the documents showed that votes for him in the provinces were either not counted or considered undervotes - not counted because of unclear marking by voters.

Marcos questioned why the votes in some precincts all went to Robredo even though two or more candidates were shaded in the ballots. He said these should have been considered "overvotes.'

"We discovered that my votes were not counted and they made (these) 'under-votes.' This is probably why there were more than three million undervotes in the vice presidential race," he stressed.

"But when it comes to our opponent, they counted for her the votes that belonged to the other candidates," Marcos alleged, referring to the Commission on Elections (Comelec) and Robredo.

Marcos also assailed the presence of square shapes in the ballot images.

"When we voted, we had the oval shapes. How come in the ballot images, the ovals are gone and instead we have the squares. What does this mean?" he asked.

Marcos said he would unveil more evidence of poll fraud against Robredo.

"We will show more proof as we go through the rest of the printed ballot images. They bastardized our democracy and the sense of honesty and integrity of the Filipino people. Their de-pravity is unprecedented," he claimed.

Marcos' lawyer Vic Rodriguez said their technical and legal team reviewed the decrypted ballot images in the provinces for a week after receiving them from the PET.

"We discovered a lot of discrepancies. We could not help but really wonder if the current automated election system is really clean as Comelec and Smartmatic claim it to be," he said in the same forum.

Rodriguez added they have opted to secure the soft copies of the ballot images since it was the less expensive option than paying once again for the photocopies of the images.

Earlier this month, the PET denied the bid of Marcos to "We could see based on secure original copies of dethe election results sum- crypted ballot images and

electoral protest against Robredo.

The PET rejected the plea of Marcos to keep the original copies of the poll records in the three pilot provinces of Camarines Sur, Iloilo and Negros Oriental for the duration of the recount.

The tribunal only allowed the former senator to secure soft copies and photocopies of the decrypted ballot images, election returns and audit logs from contested clustered precincts of the pilot provinces "subject to the payment of incidental costs

The camp of Marcos lamented the development as it accused the magistrate in charge of the case, Associate Justice Benjamin Caguioa, of bias in handling the election protest.

An appointee and close friend of former president Benigno Aquino III, Caguioa recommends to the tribunal the actions to be taken regarding Marcos' protest and Robredo's counter-protest, being the PET member in charge of the case.

But Robredo is unafraid of the impending recount of votes in connection with the electoral protest filed against her by Marcos as it would only affirm her victory in the May 2016 vice presidential race.

In an interview with dzRH, Robredo also denied Marcos' allegation that they are delaying the process.

"They (Marcos camp) have a new propaganda on Facebook, where they make us appear that we're the ones avoiding the recount,' the Vice President said.

'But if you look at what's happening now, that's not true. First, we're not the ones causing the delay. Second, we have been very cooperative with the Supreme Court," she said.

Poe asks: Is it time to 'shut down' Mocha Uson blog?

Because of possible conflict of interests, should Assistant Secretary Mocha Uson's controversial blog be "shut down" or should she just stay in private sector so she could freely speak her mind?

Senator Grace Poe raised these questions at the resumption of the Senate committee on public information and mass media's hearing on fake news on Tuesday.

Poe noted that Mocha's role as assistant secretary of the Presidential Communications Operations Office (PCOO) and as a blogger at the same time might have "overlapped," citing Section 7 of Republic Act 6713.

The law, she said, provides that public officials may engage in the private practice of their profession "unless authorized by the Constitution or law provided that such practice will not conflict o tend to conflict with their official functions.'

"It's very hard to separate her own personal opinion from that of the PCOO. Have you ever considered, and I will ask this and I hope you will answer in all candidness that since her own private blog is also a way of expressing and communicating, that this

indeed (is) overlapping with her official functions? Perhaps even using government time to be able to fulfill her work in her blog," Poe said. 'Have you ever considered that perhaps this a conflict of interest and it should be shut down, Sir?" she asked, directing her question to PCOO Secretary Martin Andanar.

Responding to the question, Andanar said: "I've spoken to Mocha about it, Madam Chair, and we've also spoken about her freedom of expression and also her way of speaking on her own Facebook page and I've called her out a few times and she has also taken down a few remarks...

While recognizing Andanar's efforts to talk to Uson, Poe asked the PCOO chief what steps he had taken to assert his authority.

"Is there a suspension or is just merely a slap on the wrist...? So what do you do? What particular penalties or action do you take for employees?" she further asked. The senator later added: "I think that Asec Mocha would be permitted to speak out should she be in the private sector."

But Andanar argued that Uson had specific market to serve and "she has (been) serving the market well as far as the PCCO platforms are concerned."

"Anong particular mar-ket at sabihin mo sa akin kung hindi nya ito magagawa bilang isang pribadong mamayan at hindi kawani ng gobyerno?" Poe asked Andanar

Andanar then pointed out that based on social media analytics, Uson's markets are overseas Filipino workers, and Classes C, D, and E

Poe later on clarified that she was not suggesting that Uson's blog should be taken down but that she was just saying that her opinions as a blogger and her role as a public servant has created 'confusion.'



# Pilot who hunted for orphan children to rape overseas faces life in prison

There's not much doubt that Michael Carey Clemans had a thing for young girls.

By the time federal agents finished combing through digital devices seized from his family home in Sacramento, they found 27,469 images of child pornography, court documents say.

An airline pilot who lived in Bangkok, Thailand, Clemans preved on girls as young as 7, paying associates overseas to take sexually explicit photos of his victims and conspiring to travel to the Philippines to rape the ones he found particularly desirable, federal prosecutors say.

"He tried to protect his identity," prosecutors say in court documents. "He avoided hotels with security cameras. He devoted incalculable hours on his criminal work.'

On Tuesday morning, Clemans is scheduled to be sentenced in U.S. District Court in Sacramento following his September conviction in an international child pornography and sex case.

His lawyer is asking U.S. District Judge John A. Mendez to give Clemans a break, arguing that his client has accepted responsibility for his actions and after his arrest helped agents ensnare two associates in the Philippines.

The government has a different request: life in prison.

"Clemans committed unspeakable acts in pursuit of his sexual obsession with children," said McGregor Scott, U.S. attorney for the said McGregor Sacramento-based Eastern District of California. "He is a sophisticated offender who leveraged technology and the economic disadvantages of the Filipino children he targeted to commit his crimes."

Prosecutors say in court documents filed last week that Clemans is among the worst such offenders.

"By any standard, Clemans' criminal conduct in this case is severe," Assistant U.S. Attorneys Andre Espinosa and Colleen Kennedy argue in a sentencing memorandum. "Indeed, only a small number of child exploitation cases in any federal district include conduct and facts as lurid, willful and disturbing as those in this case."

Clemans was working with a Filipino associate, Lyan Tandeg, who was to procure young girls for Clemans to have sex with, court documents say.

"Clemans was particularly interested in young virgins...," court documents say, mony from three victims who

and he paid Tandeg more than \$5,000 to buy a digital camera and computer equipment to use in photographing the victims. Clemans in-

structed Tandeg to focus on finding girls whose parents wouldn't be around to pose

a problem, prosecutors say, "to locate girls ed travel for illicit sexual who were orphans, victims of typhoons or were otherwise vulnerable.'

According to prosecutors, Clemans' downfall began in 2014, when investigators detected his activities while he was using a Yahoo.com account and the company reported him for suspicious activities. That got him placed on an FBI/Homeland Security watch list, and when he flew into San Francisco International Airport in April 2015 federal agents selected him for a secondary screening.

During that process, he allowed U.S. Customs and Border Protection agents to search his iPad and other devices and they discovered child pornography, court papers say.

He was arrested on state charges and released on bond, but even then could not stop, according to prosecutors.


'Multiple times in May 2015, Clemans logged onto his Yahoo! account from an IP address that traced back to his mother's home, where he was residing during the pendency of his state criminal proceedings," court documents say. "During those chat sessions, Clemans told Tandeg about his arrest and told her that if convicted, he would not live in the United States anymore.

"He said he wanted to have sex with Tandeg and the minor girls featured in the child pornography she was creating at his instruction."

That led federal agents to search the Clemans Sacramento home in July 2015 and his eventual indictment.

While he awaited trial, Clemans provided agents with the password for his Yahoo! account, and they began an undercover probe that led to child exploitation charges against Tandeg and another associate in the Philippines, court documents say.

He went to trial last August, and on the first day pleaded guilty to conspiracy to produce child pornography, attempted production of child pornography and receipt of child pornography. His trial on three remaining counts continued, and included testi-



September on three additional **Michael Clemans** counts of attempt-

conduct, conspiracy to travel for illicit sexual conduct and buying of children.

The buying of children charge carries the steepest penalty: from 30 years to life.

Clemans' Palo Alto attorney, Daniel Olmos, argued in court papers that his client's assistance in the case after his arrest saved some children overseas and that the judge should order a sentence below the 30-year minimum.

Prosecutors disagree.

"Clemans is precisely the type of person for whom a life sentence exists, a remorseless child-sex predator who poses an urgent, persistent and grievous risk to all children for the rest of his life," the argued in court papers.

The Clemans case is one of several significant prosecutions that have come from a 12-year-old crackdown by the Justice Department through a program called Project Safe Childhood that began in the Eastern District of California while Scott was serving as U.S. attorney previously in the George W. Bush administration.

The program's success led to the Justice Department adopting the effort and targeting offenders nationwide and overseas, and Scott is planning a news conference Tuesday afternoon to highlight such cases.

Just last Thursday, prosecutors in Sacramento announced the indictment of a New Jersey man, Michael Anaya-Otero, 21, on charges of producing child pornography and traveling to Rocklin to have sex with a 13-yearold seventh-grade girl. The same day, U.S. District

Judge Troy Nunley sentenced a Sacramento man. Jeffrev Miles Hayes, 55, to 33 years in prison for receiving child pornography.

And on Friday a jury found James Jay Hitt, 49, of Anderson, guilty of receiving child pornography, distributing child pornography and three counts of possessing child pornography.

# Bruno Mars has a magical night at Grammys, winning 6 for 6 BY MESFIN FEKADU

Bruno Mars owned the Grammys with his R&B-inspired album "24K Magic," winning all six awards he was nominated for at a show where hip-hop was expected to have a historical night.

Jay-Z, the leading nominee with eight, walked away empty handed Sunday - a year after his wife lost album of the year to Adele, causing fans and peers to criticize the Recording Academy for not properly rewarding Beyonce's bold "Lemonade" project.

And though Kendrick Lamar won five awards, he lost in the top categories, marking another year where rappers were restricted to wins in the rap categories, instead of earning coveted prizes like album of the year.

Mars picked up album of the year for "24K Magic," record of the year for the title track, and song of the year — shared with seven co-writers — for the No. 1 hit, "That's What I Like."

Jay-Z and Lamar could have become the first rapper to win song or record of the year, and the third rapbased act to win album of the year.

But Mars' win still marked some growth for the Academy: His is one of the few R&B albums to win the top prize. He dedicated his win to songwriters who have made history in R&B music, including Babyface, Teddy Riley, Jimmy Jam and Terry Lewis.

Lamar's wins at Madison Square Garden in New York City included best rap album, best rap song, best rap performance, best rap/sung performance and best music video. He has a career total of 12 Grammys.

Lamar also won with his performance: He kicked off the Grammys with a powerful and poignant performance featuring video screens displaying a waving American flag behind him, as background dancers dressed as army soldiers marched and moved behind him. At one point, Lamar's background dancers, dressed in red, were shot down as he rapped lyrics, later coming back to life as fire burst to end the six-minute performance.

But the night's top performer was Kesha, who was passionate and striking onstage with the help of powerful women behind her, including the Resistance Revival Chorus, Cyndi Lauper, Camila Cabello, Julia Michaels, Andra Day and Bebe Rexha. Dressed in white.

they won over the audience while sing-Kesha's ing "Praying" and hugged at the song's end as some audience members cried, including Hailee Steinfeld.

The performance, with best new artist winner Alessia Cara and Khalid, included a group of suicide attempt and loss survivors selected by the National Suicide Prevention Lifeline

Sting's performance was somewhat political as he sang his 1987 song, "Englishman in New York," which includes the lyrics, "Oh, I'm an alien, I'm a legal alien, I'm an Englishman in New York.

Chris Stapleton paid tribute to Tom Petty with Emmylou Harris and also won three awards, including best country album, best country song and best country solo performance.

Little Big Town, who beautifully sang their Taylor Swiftpenned No. 1 hit "Better Man," won best country duo/ group performance with the song.

Others who shined onstage included Lady Gaga, who

# China plays Duterte for a sucker

ecently, Mgdalo party-list Rep. Gary Alejano exposed a "secret deal" worked out between President Rodrigo Duterte and the Chinese that would allow the Institute of Oceanology of Chinese Academy of Sciences to conduct a marine scientific research in the Benhan Rise (also known as Philippine Rise).



DENR – with finality -- that Benham Rise is part of the country's continental shelf and territory. As such, it is not subject to any maritime boundary disputes and claims.

After Alejano's exposé was reported in the news, critics questioned the palace's approval of the project and demanded that Malacañang withdraw the approval, which they said would be a threat to the country's maritime

"China Daily published a report about China's 'secret undersea exploration' in the Benham Rise area. The report said that China discovered massive mineral deposits. It also said that the volume of natural gas deposits in the area was at par with what was discovered in the Spratly Islands.

With China's goal of controlling the vast Western Pacific, which includes the East China Sea (ECS), South China Sea (SCS), and the Philippine Sea, the entire Western Pacific would be transformed into 'Lake Beijing.' The Philippines would be right in the middle of the lake, isolated from the rest of the world. 'Lake Beijing' would also encompass the mineral-rich Benham Rise as well."

#### **Grand Plan**

In June 2013, an intriguing article

appeared in the Want China Times titled, "China to take the Second Island Chain by 2020." It says: "Within seven years [only two years from now], China will be able to control the Second Island

disadvantageous position... is Chain - a series of island groups that runs north to south from the Japanese archipelago to the Bonin and Marshall islands.

The article also said: In 1982, Admiral Liu Huaqing, the former commander of the PLA Navy and

> the mastermind of China's modern naval strategy, said that it would be necessarv for China to control the First and Second Island Chains by 2010 and 2020. The PLA Navy must be ready to challenge US domination over the Western Pa-

cific and the Indian Ocean in 2040. If China is able to dominate the Second Island Chain seven years from now, the East China Sea will become the backyard of the PLA Navy.'

With China's attempt to explore – and eventually claim - Benham Rise, Admiral Liu's "grand plan" to dominate the Second Island Chain and establish Chinese hegemony over the entire Western Pacific, would come to fruition.

Currently, China has two aircraft carriers and a third to be completed pretty soon.

With several more in the works, China would be able to extend air power throughout the entire Western Pacific and Indian Ocean.

China also has plans to build floating nuclear power plants and position them throughout the entire region. She can also build artificial islands in the Benham Rise just like she did in the South China Sea. She can then build processing plants to extract methane gas from methane hydrate. This was once an expensive process; however, China has since developed less costly method. All that she needs now are vast deposits of methane hydrate and Benham Rise has plenty of them.

#### **Philippines' crucial role**

The Philippines plays a crucial role in China's grand plan. Who-ever controls the Philippines would also control passage to the Western Pacific through the Bashi Channel, which separates Luzon from Taiwan. The other passageway is the Miyako Strait between Okinawa and Taiwan. But Japan has the capability to stop China from passing through Miyako Strait, while the Philippines doesn't have any military force at the Bashi Channel. In the event that China took possession of Luzon, the geostrategic significance of Luzon is removed; thus, allowing China unrestricted access to the Philippine Sea.

China had coveted Luzon ever since she gave up possession of Luzon in the 15th century. In 1405, during the reign of the Ming Dynasty in China. Emperor Yung Lo claimed the island of Luzon and placed it under his empire. The Chinese called the island "Lusong" from the Chinese characters Lui Sung. The biggest settlement of Chinese was in Lingayen in Pangasinan. Lingayen also became the seat of the Chinese colonial government in Luzon. When Yung Lo died in 1424, the new Emperor Hongxi, Yung Lo's son, lost interest in the colony and the colonial government was dissolved. However, the Chinese settlers in Lingayen -- known as "sangleys" -remained and prospered.

Chinese President Xi Jinping must be ruing the day Emperor Hongxi left Luzon. Xi's "China Dream" of extending power and influence beyond her shores,

which the Ming Dynasty had six centuries ago, is now within reach. It's no longer a dream; it's more real than ever before. With the South China Sea under China's virtual de facto control now, it won't be long before she gains control over Benham Rise.

The Philippines lost the Spratly Islands and Scarborough Shoal because President Duterte abandoned the country's claim after winning the arbitration case against China in 2016. It's evident now that China had played Duterte for a sucker then; is he being played for a sucker again? (PerryDiaz@gmail.com)

# - Caligula Trumpus Americanus

If there is one Roman emperor that that makes me laugh, it was Caligula. His real name was Gaius Julius Caesar Germanicus. He succeeded Tiberius in AD 37. He ruled for only four years and was assassinated in AD 41 at the young age of 28.

He got his moniker "Caligula" (meaning "little soldier's boot," the diminutive form of "caliga"), which he hated, from the Roman soldiers who served under his father Germanicus, a popular general and Tiberius' nephew and adoptive son. His mother was Agrippina the Elder, granddaughter of Tiberius. Upon the death of Germani-

Upon the death of Germanicus, Agrippina returned to Rome with her six children where she became entangled in a bitter feud with Tiberius. It resulted in the destruction of her family. Caligula was the sole male survivor. Tiberius adopted him. Following the death of Tiberius, Caligula succeeded him in AD 37.

Caligula enjoyed a brief period of popularity and admiration. He was described as a noble and moderate emperor during the first six months of his rule. But it didn't take too long before he earned the wrath of the people. For the brief time that he ruled Rome, Caligula exhibited cruelty, lunacy, sadism, extravagance, and sexual perversion. Many believed he was crazy.

Among those that Caligula was known to have insanely done were: He terrorized Rome with his unbridled madness; talked to the moon; ordered arbitrary executions; and planned to make his horse Incitatus a consul. For one thing, his fellow lawmakers would likely have whisked him out of power for such conduct. But

assuming the much-maligned emperor was the loon his chroniclers describe, some scholars have suggested that an illness made him come unhinged—possibly temporal lobe epilepsy, hyperthyroidism or Wilson's disease, an inherited disorder that can cause mental

#### Caligula and Trump

Two millennia later, history seems to have repeated itself – in America. The 2016 presidential election in the United States has brought to fore an eerie similarity between the presidential winner, Donald J. Trump, and Caligula. For his first year in office, President Trump demonstrated a character and idiosyncrasy that mimics Caligula. One wonders if Trump has some

form of mental disorder? In an opinion piece in May 2017 in The Washington Post titled, "Trump has a dangerous disability," George F. Will wrote: "It is urgent for Americans to think and speak clearly about President Trump's inability to do either. This seems to be not a mere disinclination but a disability. It is not merely the result of intellectual sloth but of an untrained mind bereft of information and married to stratospheric self-confidence."

"He has instructed us that An-

drew Jackson was angry about the Civil War that began 16 years after Jackson's death. Having, let us fancifully imagine, considered and found unconvincing William Seward's 1858 judgment that the approaching Civil War was 'an irrepressible conflict,' Trump says: 'People don't realize, you know, the Civil War, if you think about it, why? People don't ask that question, but why was there the Civil War? Why could that one not have been worked out?' It's obvious that Trump has a

cockeyed view of American history. Or worse, could it be that he's insane?

#### "This guy is insane!"

Not too long ago, Trump attended a dinner with several Latin American leaders. They discussed the political and economic problems in Venezuela. Critical of Venezuelan President Nicolas Maduro, the leaders expressed apprehension over how Maduro was handling the crisis. And out of the blue, Trump expressed surprise that they did not want a war with Venezuela. For his part, Trump proposed a "military option" to ensure Maduro leaves office. According to a Politico news report, many of the gathered officials thought, "This guy is insane!" They were in shock.

Trump has been the subject in discussion among well-

known psychiatrists, psychologists, and mental health experts. A new book, "The Dangerous Case of Donald Trump: 27 Psychiatrists and Mental Health Experts Assess a President," has concluded, "Trump's mental state presents a clear and present danger to our nation and individual well-being." The media chatterati seems to be of one mind: "Donald Trump is mentally incompetent and may have to be removed from office before he blows us all to hell." [Source: TheAmericanConservative.com]

psychiatrists, psychologists, and other mental health experts argue that, in Mr. Trump's case, their moral and civic "duty to warn" America supersedes professional neutrality. They then explore Trump's symptoms and potentially relevant diagnoses to find a complex, if also dangerously mad, man. The solution, to their minds, lies in the 25th Amendment to the Constitution, which creates a mechanism outside of impeachment to remove an "incapacitated" president. Trump's mental state, some believe, qualifies him. Is there a case? [Ibid]

#### **Nuclear Button**

Many believe there is a case. And this scares a lot of Americans. They don't know when Trump would have another episode of threatening to push the "nuclear button" like what happened between him and North Korean leader Kim Jong-un.

Kim Jong-un had stated in

one of his commentaries that the "Nuclear Button is on his desk at all times." Trump responded on Twitter, "Will someone from his depleted and food starved regime please inform him that I too have a Nuclear Button, but it is a much bigger & more powerful one than his, and my Button works!"

His tweet sent jitters around the world's capitals. American lawmakers, diplomats, and national security experts were particularly alarmed. They called it "juvenile" and frightening for "a president handling a foreign policy challenge with world-wrecking consequences." The language was reminiscent of Mr. Trump's boast during the 2016 presidential campaign that his hands, and by extension his genitals, were in fact big enough." [Source: New York Times]

#### Rulers by accident

Caligula and Trump were born a world apart: different cultures, different upbringing, and different eras. But in so many ways, their minds worked alike. They both became rulers by accident, not by pedigree or design.

In a new book Quid Pro Quo, author Valerie Block says of Caligula: "An arrogant, narcissistic, blond serial rapist attains the highest office in the land, abuses his power, and

offends everyone personally: this is the subject of my newest novel, Quid Pro Quo, a behindthe-scenes look at the assassination of Caligula, the third Emperor of ancient Rome. It is impossible to ignore the many echoes of Caligula's story that played out in the 2016 election of Donald J. Trump, a

man whom the 2nd century historian Suetonius might have been describing when he wrote of Caligula, "there was nothing in his own character which he admired and approved more highly than...his shameless impudence." Block also said that Caligula and Trump share a lot of characteristics, to wit: (1) Narcissism ["All of the women on The Apprentice flirted with me – consciously or unconsciously. That's to be expected," he boasted]; (2) Grandiosity ["I know more about ISIS than the generals do, believe me."]; (3) Cruelty [Trump once said, "I would bring back waterboarding and I'd bring back a hell of a lot worse than waterboarding."]; (4) Comfort with negative

attention ["Bad publicity is sometimes better than no publicity at all. Controversy, in short, sells."]; (5) Sexual misconduct, promiscuity, and violence ["You know I'm automatically attracted to beautiful women, I just start kissing them, it's like a magnet. You know when you're a star they let you do it. You can do anything. Grab them by the pussy. You can do anything." -- Trump talking to the host of Access Hollywood in 2005.]; (6) Motivated by revenge ["My motto is: Always get even. When somebody screws you, screw them back in spades."]; and (7) Delusion ["I alone can fix it."].

With all these similarities, Trump might as well be called Caligula Trumpus Americanus. Could it be that Trump is Caligula reincarnated?







# To the man who told me to 'get the fuck out' of the U.S.

'You have nothing to fear from me. It is I, judging by the lessons of history, who should be fearful.'

"Get the fuck out of my country you fucking immigrant!" yelled a man at me as he slowly drove by in his pickup truck.

I paused in disbelief. There I was, dead in my tracks in the middle of a schoolyard situated right next to a road, on my way to teach a class of middle school kids. Before I could process what just hap-

pened, a handful of kids adoringly ran up to me with their hellos and hugs. Thankfully, none of them heard the xenophobic outburst.

I share this experience, not as a commentary on the current political landscape nor to cause division.

On the contrary, I share this because it is so uncharacteristic of my American experience.

In the past half decade, I have been shown nothing but acceptance, kindness, love and friendship. I truly believe my experience today was an aberration.

I attribute my unfortunate experience to ignorance and intolerance, whether it be emboldened intolerance or ignorance that hides behind lips that are mute in the midst of bigotry. I cast no blame on any one group, after all, ignorance is not the sole proprietorship of one single race or ideology. As a scholar, and as a student of history, I believe that learning and education is a means by which to overcome this.

To the man in the gray pickup truck, Sir, you have nothing to fear from me. It is I, judging by the lessons of history, who should be fearful. To me, you are an outlier and my admiration and opinion of America have not diminished.

As you choose to hurl invectives while you hide behind the ambiguity of a moving truck, I choose simply to write and treat this subject with the gravitas that it deserves

Let me share with you a few lessons in history that may not be known by many, but continues to fester in the consciousness of the Filipinos.

#### **History by numbers**



ten" was the order given by Col. "Howling" Jacob H. Smith to his men when they turned the entire town of Balanghiga on Leyte Island into a howling wilderness.

20 - Twenty million dollars was the amount paid by the U.S. to "purchase" the Philippines from Spain in the treaty of Paris on Dec 10, 1898, later ratified by President McKinley. In defiance to this, anti-imperialist Andrew Carnegie offered to pay the U.S. treasury the same amount so that he could set the Philippines free.

200,000 - Two hundred thousand is the number of civilian Filipino men women and children who died in the U.S. attempt to subjugate and pacify the Philippines. Up to 50,000 Filipinos were killed directly by U.S. soldiers.

1000 - The number of Filipino Moros killed by the U.S. army on a single day, March 7, 1906. The Moros had taken refuge at Bud Dajo, a volcanic crater in the Philippine Island of Jolo.

1898 - The year the water-cure (today known by another name) was first used by the U.S army to torture Filipinos. William Howard Taft describes water cure as "that torture which I believe involves pouring water down the throat so that the man swells and gets the impression that he is going to be suffocated and then tells what he knows.'

1911 - The 1911, or better known as the 45 caliber pistol, was de-veloped by the U.S. Army to put down Filipino warriors in the Island of Mindanao, the Filipino warriors would continue charging even after being shot with the less 10 - "Kill everyone over the age of powerful 38 caliber handgun.

As we cast these events to be forgotten in the annals of history, let us also remember the good things brought by America. Like the Thomasites, a shipload of American school teachers who arrived in the Philippines in 1901 to establish the first ever Philippine public school system, which includes my Alma mater, the University of the Philippines.

I am still hopeful and thankful for the beautiful people I have met in America. I have always and still continue to admire American valnes

America did not just wake up one day and decide to rule the Philippines. Rather, the debate raged between the Expansionists like William McKinley, Theodore Roosevelt, William Randolph Hearst, and the anti-imperialists such as Mark Twain and Andrew Carnegie. The debate featured in the leading papers of the time, occupying America's consciousness and conscience.

In the end, President McKinley chose to occupy the Philippines, vowing "to educate the Filipi-nos, and uplift and civilize and Christianize them." Unknown to McKinley, the Philippines Islands were already "Christianized," and had been so for over 300 years.

The lessons of the past liberate while dwelling on them enslaves us, but to forget condemns us to repeat them.


"Health is the real wealth. And not pieces of gold or silver" - Ghandi

New year brings brighter hope for everyone. It is the best time of the year to commence your new year's resolution. If your goal is to lose weight, this article is for you. Weight loss made simple for all.

Diet is a major factor in weight loss. Seventy five percent of weight loss is contributed to food intake. You are what you eat. It simply means the food you eat directly contributes to your built and weight. Planning is vital in everything. Failure to plan means planning to fail. Food plan is important tool in weight loss. I plan and strictly follow my meal schedule into the following: breakfast at 0600, morning snack with protein drink only at 0900, lunch at 1200, afternoon snack with protein drink only at 1500, dinner at 1800, and last snack for the night with protein drink only at 2100.

A meal must have protein, carbohydrate, vegetables, fruits, and water. The size of protein must be as big as the size of your open hand. One of the functions of protein is to build muscles. The size of carbohydrate must be as big as your closed fist. Carb is the source of energy; it keeps you going. The size of vegetables and fruits must be as big as the size of two open hands placed together. Veggies and fruits are good sources of fiber that make you move your bowel. A challenger must drink at least one gallon of water per day. When you feel thirsty drink some water. Do not let yourself be hungry. Fresh vegetables and fruits are available at your favorite stores or at your organic garden. Learn to cook your own food. The food you cook is clean and healthy. Fresh farm produce taste better and sweeter.

Vegetables and fruits are good sources of micronutrients. Remember micronutrients are not produced by the body. We get it from food sources. Food supplements are available in the market. Glutamine powder drink helps sore muscles heal fast. Powder drink with



rum sodium is diluted when you drink plenty of water. Serum potassium, on the other hand, goes with the urine when you pee. When sodium is low, a person gets confuse. And if the potassium is low, a person might get arrhythmia or irregular heart rhythm that leads to heart problem. If any of these happens, talk to your



doctor. Banana, avocado, broccoli, and orange juice are good sources of potassium

What food and drinks to avoid? Avoid drinks with artificial sweetener but you can have water and natural fruit juices. Avoid salty and fatty food. You can use a pinch of Himalayan salt, Ms. Dash, or vinegar to put some taste on your food. Avoid frying your food, steam it. If you can do away with dairy products and alcohol, go for it. These two delay digestion. It is much easier to cut on calories we put in our body than to burn them.

Joule is a unit of energy in the International System of Units but people are familiar and use calorie to measure energy. One small calorie is about 4.2 joules. One big Calorie is about 4.2 kilojoules. A gram of protein is 4 calories. A gram of fat is 9 calories. A gram of carbohydrate is 4 calories, and a gram of alcohol is 7 calories.

Exercise is another major factor in weight loss. Twenty five percent of weight loss is through exercise. One hour of exercises per day, five times a week is good enough to shed off those calories and tone your muscles. Physical activi-

and bone density. Exercise makes you to sweat out those body waste and toxins. Exercise causes your body to secrete endorphin, a hormone that makes you feel happy and fulfilled. Expect your muscles to be sore on the 2nd, 3rd, and 4th day of training. It is ok and expected. Just continue with your exercises. The aches will go away. I found interval exercises interesting. It motivates me to finish and repeat the exercise cycle.

The last but not the least important factor in weight loss challenge is mental readiness. Ask yourself: "Am I ready for weight loss challenge?" If your answer is positive, then go ahead and face the challenge without hesitation. Make sure to continue the fight to shed those extra calories and melt those ugly fats from your body and transform yourself into a beautiful creation God made you to be.

Once you follow the above mentioned three important factors with discipline and determination, I bet you will achieve your goal and will never be the same again. A goal will remain a goal if you will not act on it. Check your body mass index (BMI) and make it your target to be achieved this month, couple of month from now, or this year. A person can lose an average of 2 to 4 pounds a week. As a caveat, there will be a time you reaches the plateau phase of your challenge which you do not lose weight for the week, and worst your weight increases. Do not be discouraged because it is part of the challenge. I encountered the same but I stayed positive and kept the momentum. In my case, I did my weight loss challenge at Results Transformation Center in Elk Grove and lost 24 pounds in 6 weeks which exceeded my target of 20 pounds weight loss. I feel way much better today with lighter weight and good muscle tones. I can wear smaller sizes of clothes than I used to and has been at the pink of health since then.

# **Sustainable Crop Production**

ccording to the Nations, United as of December 2017, the world's population is 7.6 billion and it is expected to reach 9 billion by 2050 and will further balloon to 11.8 billion in 2100. While population growth is tremendously

increasing, the land use for agriculture is decreasing which directly affect the quality and quantity of sustainable crop production.

The question now is how do we increase food production? Before I delve into this question, let me explain to you the production situation which I learned from my online Wagenstudy at ingen University in The Netherlands.

There are three major categories of this situation. The first category is potential production, the second category is limited production, and the third category is actual production

#### **Potential production.**

It has defining factors and these are the climate and the crop genetics. The climate influences the growth of a plant. A seed germinates faster under controlled temperature in the greenhouse or during spring and summer while it takes time to germinate in fall and harder during winter. A tiny lettuce seed germinates in 5 days during spring and can be harvested in 30 days. It takes over a week to germinate the same during winter. Climate change is a major factor that affect crop production. Climate change is about rising level of carbon dioxide (CO2) in the air. CO2 is a major greenhouse gas. CO2 increase concentration is believed to be caused by human activities. Increase emission leads to increase CO2 concentration in the atmosphere which causes global varming or the greenhouse effect. Climate change has major impact on agricultural production. Measures we can do to counter the effect of climate change are mitigating and adopting measures. We can mitigate the effect of climate change by reducing greenhouse emissions. Climate Smart Agriculture (CSA) is an agriculture that sustainable increases productivity and





tionalizes adaptation and mitigation practices by a farmer. Crop genetics play a major role in food production. Selected seed from good variety or hybrid seed has an edge over ordinary seed. For example, a hybrid is more resistant to climate change, pests and diseases.

#### Limited production.

It has limiting factors composed of water and nutrients. Water is life. It plays an important role in crop production. In the absence of water, it is impossible to grow crops. Water determines crop's turbidity, it serves as solvent of nutrients, and a medium for biochemical processes. Crops are watered via flooding method, sprinkler, and irrigation. Precision irrigation provides water to crop in an optimum time. It saves water. Nutrients are needed for plant growth. Three major nutrients are nitrogen, phosphorus, and potassium (NPK). Aside from NPK, essential macronutrients such as calcium, magnesium, and sulfur are needed by the plant for crop production. Plant's leave becomes yellow when it is deficient in nitrogen. A good soil has nitrogen but if it runs out of nitrogen, because of over production or soil erosion, we can replenish it by adding vermicast, cow manure, and by planting legumes which fix nitrogen. Eighty percent (80%) of atmosphere is nitrogen gas. During the Great Depression, German scientist Haber-Bosch discovered how to capture nitrogen from atmosphere through a chemical process to make nitrogen fertilizer. Plant's

growth is stunted or its leaves turn purple when it is deficient in phosphorus. Banana peels, crab shells, shrimp peels, grains and nuts are good source of phosphorus. It can be added to farm composts. Plant's leaves be-

comes yellow while its veins stay green indicate deficiency in potassium. Banana peels, ashes, and coffee used grounds are good source of potassium.

#### Actual production.

It has reducing factors such as weeds, pests, diseases, and pollutants. Weeds compete with crop growth. It sucks soil nutrients needed by the plant. If the growth of weed is faster than the crop its canopy slows the growth of the crop. Yield reducing factors under pests and diseases are biopatch buster (i.e., moth, fly, virus, and fungus), leaf consumers (i.e., caterpillar), light stealers (i.e., mildew fungus), assimilate suckers (i.e., aphids), xylem blockers (i.e., worms, stem borers), root consumers (i.e., ants), and storage consumers (i.e., locusts, birds). To prevent soil-borne pests and diseases, grow crops in rotation, inter-cropping, use biological control, use chemical (I prefer organic) control, and integrated pest management (IPM) which is a combination of different measures to minimize yield reduction by weeds, pests, and diseases. For yield protecting measures, prevention and eradication can be done mechanically, chemically, and biologically.

Sustainable crop production can be attained if we can increase production on existing lands, eliminate limiting factors like water and nutrients, reduction of pre-harvest as well as post-harvest losses which amount to 30% to 40%, reduce yield losses thus increasing resources use efficiency, uses of irrigation system, and land nutrient improvement.
