Why can't PH do a Vietnam?

I hile the Philippines is mum on what moves it has taken to counter China's aggressive actions in the South China Sea, at least on the diplomatic front, Vietnam has been vocal in condemning China's militarization of the disputed area.

On May 22, Vietnam, China's ideological brother but mortal enemy, accused Beijing of violating its territory when Chinese bombers landed and took off from Woody Island in the Paracels-an activity that Beijing said was part of its training exercises.

"Vietnam demands that China stop these activities, cease militarization of the area, and strictly respect Vietnam's sovereignty over the Hoang Sa islands," Vietnam foreign ministry spokesperson Le Thi Thu Hang said in a statement, using the Vietnamese term for the Paracels. She said the presence of the bombers in the area had an adverse impact on ongoing negotiations between China and the Association of Southeast Asian Nations on a Code of Conduct in the South China Sea

Woody Island is being claimed by China, Vietnam and Taiwan. But according to an American think tank, the bombers could affect a radius of more than 1,000 nautical miles, meaning the Philippines is within range.

Earlier this month, Vietnam also called on China to withdraw military equipment from the nearby Spratly Islands in the disputed waters, following news reports that China had installed missiles there. Vietnam said China should show responsibility

"in maintaining peace and stability in the East Sea" (the Vietnamese term for the South China Sea). It also said China should not "carry out militarization activities "withdraw military and equipment illegally installed on features under Vietnam's sovereignty.²

The statement was issued after US news network CNBC reported on May 2 that China had installed antiship cruise missiles and surfaceto-air missile systems on Philippine-claimed three reefs in the Spratlys that it had seized and transformed into artificial islands, then developed into military outposts-Kagitingan (international name: Fiery Cross), Zamora (Subi), and Panganiban (Mischief).

Unlike the Philippines, Vietnam's claims over some parts of the Spratlys are not even validated by an international court ruling. And yet it continues to stand up to China.

But what have Philippine officials done except to say that the problem has been discussed in bilateral meetings with Beijing? Has Foreign Secretary Alan Peter Cayetano actually filed diplomatic protests against China's incursions into Philippine territory, as he has claimed? Or is the government so enamored of the millions of dollars in loans and grants from China that to respect yourself.

it now allows Beijing to trample upon its dignity and honor?

All that we hear is presidential spokes-person Harry Roque saying that the government is taking diplomatic initiatives but is "not making a big deal out of it."

At least President Duterte has been candid in saying that the Philippines will not wage a war with China that it cannot win.

Of course, we all know that to go to war with China would be the height of stupidity. But there must be a way, short of going to war, to stand up to, or remind, China that the reefs that it has occupied and developed into military bases belong to us, and that our sovereign rights over these areas are clearly spelled out in the arbitral ruling from The Hague in July 2016.

I was among those who applauded the President when he initiated new foreign policy moves that weaned the Philippines from dependence on the United States. But it is sad that while we have now ceased to be subservient to the United States, we are now unabashedly subservient to China.

No foreign government will respect us if we, as a nation, lose our own self-respect. As Aristotle once said, "It's impossible to win respect from others until you learn

The original cesspool

s the cleanup of Boracay continues, the government may want to take a look at the other body of water that has been a "cesspool" far longer than the resort island. In the 10 years since the Supreme Court directed 13 government agencies to clean up, rehabilitate and preserve Manila Bay, water quality has worsened. This was the assessment of the Senate committee on environment and natural resources after reviewing the progress of the cleanup.

The failure to implement the SC order could have been due in part to the position of the executive that it was an encroachment of the judiciary into the functions of an independent and co-equal branch of government.

Improving water qual-ity in the bay where the country's biggest port is located is also a tall order. Aside from the international ships that dump all sorts of waste into the wa-



ter, deliberately or inadvertently, many communities around the bay are home to some of the country's most impoverished families. One community in the Manila port neighborhood, where most residents make a living producing charcoal, is so filthy it was described by a world-renowned novelist as 'the gates of hell.'

These informal settlements dump all their human and other wastes into the bay and they don't bother installing pipes underground, as in Boracay, to channel wastewater and fecal matter from their shanties into the

Yet these pollution problems are not insurmountable. Other countries have shown that it is possible to

drastically reduce pollution and improve water quality even in rivers and seas used extensively for commercial purposes.

Obviously, effective en-forcement of water pollution laws is critical. Random inspections of ships can promote compliance with environmental laws. In the communities around the bay, local government units and barangay offices must bear the responsibility for waste management. Even in informal settlements, this need not prove impossible. Political will and committed involvement of communities can still save the original cesspool that is Manila Bay.

Sereno appeals ouster from Supreme Court

usted chief justice Maria Lourdes Sereno yesterday appealed the Supreme Court decision removing her through a mere quo warranto petition, noting that the SC violated her constitutional right to due process and overstepped its power.

In a 205-page motion filed minutes before the deadline, the ousted chief magistrate asked the SC to reconsider its ruling on May 11 that abruptly ended her unprecedented 18-year term by granting the quo warranto petition of the solicitor general to invalidate her appointment in 2012.

Sereno likewise urged the court to reverse the decision of six associate justices she accused of bias against her - Teresita Leonardo-de Castro, Diosdado Peralta, Lucas Bersamin, Francis Jardeleza, Noel Tijam and Samuel Martires - not to inhibit from the case.

'More than its numerous legal and factual errors, the decision proves that in meting out justice, an impartial tribunal is crucial and indispensable. The decision illustrates vividly the dire and far-reaching consequences of a denial of due process," she argued.

Sereno insisted that the SC has no authority to remove her from office because under the Constitution, the chief justice can be ousted only through an impeach-

ment process.

"The indisputable intent of the Constitution is that impeachable officers, save for the President and Vice President, can be removed from office only by impeachment," read the motion.

She reiterated that the issue on her statements of assets, liabilities and net worth (SALNs) cannot be the basis for adjudging her supposed lack of integrity and dishonesty.

"This Honorable Court erred in ruling that the Respondent 'chronically failed to file her SALNs...' The filing per se of a SALN neither proves nor negates a person's integrity," she argued. Sereno likewise insisted

that the quo warranto petition should not have been granted because it already went beyond the one-year prescription period from appointment.

The ousted SC chief added the decision made baseless conclusions that are unsupported by the evidence, such as her alleged tax fraud when there was no evidence to support it.

"The matters that were never raised by either party are actually mere allegations or charges raised in the impeachment complaint before the House of Representatives, all of which have yet to be proven. Since the allegations stated therein are nothing more than mere charges, they cannot be taken as evidence against the Chief Justice," she stressed. Sereno also told The Chiefs

in an interview aired Tuesday night on Cignal TV's One News that her ordeal continues after her ouster as the Bureau of Internal Rev-

enue (BIR) has launched an investigation against her, which she said is "illegal" and part of "persecution" by the Duterte administration.

She said the six justices should have been required by the Court to inhibit from the case due to actual biases.

"The justices' testimonies and actuations in the hearings before the House committee on justice (and in the oral argument, in the case of Justice Martires) are clear and convincing evidence of actual bias," Sereno explained.

The justices' statements, and the emotional implications that are attached to the same, are evidence of actual bias. Actual bias is anchored not simply on their participation in the proceedings, but rather, on the substance of their statements," she added.

The SC voted 8-6 to declare the chief justice position vacant and ordered the Judicial and Bar Council to start the search for Sereno's replacement.

Apart from Sereno's ouster, the SC also issued a show cause order requiring her to show why she should not be penalized for supposedly violating the Code of Professional Responsibility and the Code of Judicial Conduct "for transgressing the sub judice rule and for casting aspersions and ill motives to the members of the Supreme Court."

Those in the majority were Associate Justices De Castro, Peralta, Bersamin, Jardeleza, Tijam, Martires, Andres Reves Jr. and Alexander Gesmundo.

Senior Associate Antonio Carpio and Associate Justices Presbitero Velasco Jr., Mariano del Castillo, Estela Bernabe, Marvic Leonen and Alfredo Benjamin Caguioa dissented from the ruling.

Sereno revealed that she has been meeting support-ers from all walks of life in her speaking events, especially the youth, who shared their sentiments against the administration on issues involving extrajudicial killings, closure of Boracay island and the policy towards China.

"I tell them we have to fight to defend democracy and have an independent judiciary," she stressed.

The ousted SC chief believed that the justice system is "in ICU (intensive care unit) stage" and the Constitution is in danger because the President does not respect it.

anila, Philippines — As school opening draws near, manufacturers of school supplies, particularly paper-based products, have jacked up prices due to higher costs of raw materials and foreign exchange.

The Department of Trade and Industry (DTI) said several brands of notebooks and pad paper increased prices due to the high cost of raw materials imported from China and the depreciation of the peso against the dollar.

Seven brands of composition, writing and spiral notebooks hiked prices between P1 to P4, while one brand did not make any price adjustment. But trade undersecretary Ruth Castelo said paper manufacturers gave assurance that there will be no more price increase until December.

Two brands of pencil hiked pric-es by P4.50 and P1 respectively, while other brands maintained last year's prices.

The DTI said most brands of ball pens did not increase prices since last year except for three, which adjusted prices from P1 to P6.

For crayons, two brands raised prices by P2 to P10 for boxes of Regular No. 8, Regular No. 16, Regular No. 24 and Jumbo 8.

There were no recorded price movements for sharpeners, while one brand of eraser increased by P2.

For rulers, two brands hiked prices by P2 and P3, respectively.

"There have been increases in some staples but consumers can check for school items sold in bundle or promo packs which can help them save P30.75 depending on the brand," Castelo said.

Meanwhile, billions worth of support are expected to pour in to thousands of public schools nationwide as the Department of

Education Secretary Leonor Briones yesterday led the nationwide kick-off of the National Schools' Maintenance Week at the New Society National High School in General Santos City.

Across the country, education stakeholders including students, parents, teachers and community leaders took part in school repair activities in preparation for the opening of classes on June 4.

The Office of the Vice President (OVP) and its private partners will provide more than P700,000 worth of books and construction materials to select public elementary and high schools in Luzon and the Visayas to make their classrooms and facilities more conducive for learning

The OVP has allocated P100,000 for its Brigada Eskwela package this year, while its Angat Buhay partners donated P541,996 for the OVP's education funds.

Fourteen schools in poor areas in Metro Manila, Cebu, Eastern Samar, Bohol, Capiz, Camarines Sur and Albay will receive the assistance in time for the opening of the new school year on June 4.

"The (Brigada Eskwela program) reminds us that educating our

Education (DepEd) has launched children is not just the job of our teachers and the schools, it's the obligation of the parents, the com-munity and local government too," Vice President Leni Robredo said as she joined Brigada Eskwela at the Wawa Elementary School in Navotas City yesterday.

Support from the private sector also poured in, including from top corporations such as Nestlé, Smart and Globe that turned over various materials during yesterday's kick-off of Brigada Eskwela.

The National Grid Corp. of the Philippines (NGCP), on the other hand, gave school supplies to 120,000 Grades 1 to 3 pupils from 400 public schools nationwide through the company's Gamit ni Bulilit program.

Gamit ni Bulilit is NGCP's yearly project that aims to give school bags, notebooks, pencils and other school supplies to pupils in com-munities hosting NGCP's facili-

Beneficiaries are from 166 schools in North Luzon, 55 in South Luzon, 81 in the Visayas and 98 in Mindanao.

"We focused our program on children from the lower grade levels on the idea that educational motivation is most effective during a child's formative years," NGCP said.

"The program is also NGCP's way of expressing gratitude to our

host communities who, through the years, have been supportive in protecting NGCP facilities and in ensuring its safety so that every-one enjoys reliable electricity," NGCP said.

Employees of Maynilad Water Services also helped refurbish classrooms and upgraded water and sanitation facilities in 151 public schools throughout its concession area

Maynilad kicked off its yearly participation in Brigada Eskwela with the installation of 26 bidets and replacement of busted faucets and toilet flushes at Malinta Elementary School in Valenzuela City. The company also donated 500 pieces of bottled water for the volunteers, educational signages and cleaning materials to the school.

DepEd undersecretary Tonisito Umali said the department expects the value of donations and manhours rendered by companies and volunteers for this year's Brigada Eskwela to exceed last year's almost P5.4 billion.

Over the years, the value of support for Brigada Eskwela continuously increased, from just a few million pesos when it started 15 years ago to P3.6 billion in 2015 and P4.7 billion in 2016.

The number of volunteers also increased in recent years, from 11.6 million in 2016 to 12 million in 2017.

"We all know that not everything we need in our schools are provided for in the General Appropriations Act," said Umali. "But because of Brigada Eskwela, our schools, classrooms and facilities

are a lot better."

Brigada Eskwela is a yearly program implemented by DepEd to prepare thousands of classrooms for the new school year. The program aims to encourage the Filipino community to take a direct role in the education of the youth.

Umali said partnerships should not be limited during maintenance week, noting that engagement can happen all throughout the year.

The concept of partnering with our community, parents and all our stakeholders to ensure quality basic education for all our children should not be construed to be achieved in just one week. It should be the entire year," he said.

Briones earlier said that public schools nationwide are ready for the 25 million students who will return to school on June 4.

In Bicol, parents and volunteers from the Office of Civil Defense and DepEd have cleaned classrooms for 1.75 million students from kindergarten to senior high school, according to Ramon Fiel Abcede, DepEd regional director for Bicol

"DepEd has also hired some 6,000 new teachers," Abcede said during the launch of Brigada Eskwela at the Barcelona Elementary and High School in Sorsogon province.

Region 1 is also ready to welcome more than one million elementary and high school students. "Definitely no classes under the trees in Region 1," said Alma Ruby Torio, DepEd regional director for Region 1

'Garin, Abad diverted P10.6-billion fund for senior citizens'

anila, Philippines — Some P10.6 billion in funds of the Philippine Health Insurance Corp. (PhilHealth) for senior citizens was illegally diverted in December 2015 and supposedly used for the campaign of Liberal Party (LP) candidates in the 2016 elections, a joint congressional review of PhilHealth's finances showed yesterday.

version, the life of the PhilHealth reserve fund was reduced from the mandatory 24 months to just 10 months as part of it was used to fill the P10.6 billion for senior citizens' benefits.

Last March 18, PhilHealth filed a complaint before the Office of the Ombudsman against Garin and Padilla for alleged violation of the Anti-Graft and Corrupt Practices Act in connection with the fund diversion.

violated China's laws and relevant international laws," Wu said.

"Chinese military took immediate actions by dispatching naval ships and aircrafts to conduct legal identification and verification of the US warships and warn them off," Wu also said.

Beijing stressed that the Paracel Islands, which are also being contested by Vietnam, are "Chinese in-

digenous territory." Wu accused Washington of violating Beijing's sovereignty, undermining strategic mutual trust between the American and Chinese military and undermining peace, security and good order in the region.

"China firmly opposes this. The Chinese army is determined to strengthen the preparations for sea and air combat readiness.

raise the level of defense, defend national sovereignty and security, and maintain the determination of regional peace and stability," Wu said.

The US Navy ships' passing through the islands came days after the US disinvited China from the 2018 Rim of the Pacific Exercise, the world's largest international maritime warfare exercise. The Pentagon's withdrawal of its

invitation to Beijing was an "initial response" to the latter's increasing militarization of the South China Sea.

On May 18, China's People's Liberation Army Air Force announced that it had landed an H-6K strategic bomber on Woody Island, China's largest outpost in the Paracels.

Following the landing of a bomber aircraft on Woody Island, China reportedly

deployed HQ-9 surface-to-air missile systems on the island, according to independent think tank Asia Maritime Transparency Initiative.

According to the Washington-based think tank, the new weapons were probably placed on the outposts during the Chinese military's drills last May 8.

Philippines lost Sandy Cay to China, Alejano tells Cayetano

Rep. Gary Alejano (Magdalo party-list) on Tuesday reminded Foreign Affairs Secretary Alan Peter Cayetano that the Philippines effectively lost control of Sandy Cay in the West Philippine Sea under the Duterte administration.

The Magdalo lawmaker was responding to the DFA secretary's challenge to prove that the country lost an island to Beijing in the time of President Rodrigo Duterte.

Alejano told Cayetano that Chinese coast guard vessels and militia fishing boats have been stationed near Sandy Cay since August last year.


"Every time Philippine govern-ment vessels patrol Sandy Cay, they are driven away by Chinese coast guard vessels. This could be likened to the situation in Scarborough Shoal in 2012 wherein our fishermen and military forces are prevented from approaching. Since then, China controlled the shoal," Alejano said in a statment.

Sandy Cay lies over 4 nautical miles from Pag-asa Island, which is part of Palawan province. The cay serves as a traditional rest and recreation area for residents and visitors of the island.

Citing Republic Act 9522, also known as the Philippine Baselines Law, Alejano said that Pag-asa Island, including Sandy Cay, is part Philippine territory under Article 121 of the United Nations Convention on the Law of the Sea.

Alejano called out Cayetano for refusing to protest the Philippines' loss of Sandy Cay to China.

"Secretary Cayetano has an-nounced publicly that he is not filing a protest against China's seizure of Sandy Cay, which is definitely a Philippine land territory. This is an undeniable proof that Philippines lost effective control on an island during the incumbency of President Duterte

and Secretary Cayetano," Alejano said.

The Department of Foreign Affairs has been criticized for not being more vocal about China's activities in the West Philippine Sea and because of the secrecy surrounding diplomacy with China, it cannot be verified whether or not the Philippines filed a formal pro-

The Magdalo lawmaker further stressed that the Philippines is slowly losing control of its territory while China is restricting the access of Filipino fishermen and challenges the Philippine military.


"Let us not wait for physical occupation of islands to happen,' Alejano said.

Sandy Cay is just one case. In a bigger picture, if our ability to patrol and supply our islands is slowly being diminished, then time will come China will have effective control of the whole West Philippine Sea. We would lose everything," he added.

Speaking in a flag-raising cer-emony at the DFA on Monday, Cayetano said that he would quit public service if his critics could prove which features in the South China Sea were "lost" under the Duterte administration.

"I challenge anyone of them. Whatever their professions are justice, politician, newsman, journalist — if we lost a single island during Duterte's time, I will pack my bags, go home and I will not serve the public in any elected or appointed position," Cayetano said.

Woman attacks Asian-American service member in racist tirade: 'Go back to f--ing China'

A viral video released this week caught a woman on camera launching a racist tirade against an Asian-American service member in a parking lot in California.



James Ahn said he was

driving earlier this month when the woman however, said investigators determined pulled up next to him and pulled her eyes back in an offensive gesture.

"This is not your f---ing country," she says in the video. "This is my country."

Ahn is a Korean-American member of the Air Force Reserve, according to HuffPost. Ahn's passenger recorded the incident and Ahn posted the video on Facebook earlier this week after the altercation.

"As I changed the lane, she kept driving towards my car gesturing to crush me and cutting in front of me to slam on the break," Ahn wrote Monday. "I later realized that this was more like a hate crime than a road rage.

The women yells at Ahn to "go back to f---ing China, you ugly Chinese."

He reported to incident to the Fremont, Calif., police, according to the New York Post.

Police spokeswoman Geneva Bosques,

that no crime was committed.

"What we have here is hate speech," Bosques said. "And we met with her and she does not deny that she did any of this. But she claims he started it by saying to go back to her country.

The female driver reportedly told police that Ahn had started the traffic dispute.

"All that we could establish is that this was derogatory remarks between two par-ties," Bosques said. "There was no threat and there was no crime committed. We did document everything in a report and we classified it as a disturbance.

The woman's freedom of speech - although hateful — is protected by the First Amendment, police said.

'The other piece of this is that these two motorists were driving in traffic yelling at each other and the situation could've been worse for other drivers around them," Bosques said.

California debuts 'digital' license plates. Here's what they'll cost you.

California's dramatic new license plate is hitting the streets — a digital display board that allows changeable messages controlled by the driver or remotely by fleet managers.

The new plates use the same computer technology as Kindle eBook

readers, along with a wireless communication system.

They come with their own computer chips and battery.

Motorists who choose to buy the plate can register their vehicles electronically and eliminate the need to physically stick tags on their plates each year. They also may be able to display personal messages — if the DMV decides to allow that.

If the car is stolen, the plate's manufacturer says the plate can tell the owner and police exactly where the car is or at least where the license plate is if it has been detached.

California, which has been quietly prepping its roll-out this year, is the first state to try out the new plates.

The state Department of Motor Vehicles is conducting a pilot project with a Bay Area company, Reviver Auto, which makes the plate and is about to begin marketing it for sale at auto dealerships.

Last week, Sacramento became the first city to agree to test the plates, taking a shipment of 24 plates for its in-house vehicle fleet.

The technology comes with a high price, however, and has already prompted ques-



tions about privacy and safety.

Dealerships are expected to sell the plates for \$699, not including installation costs. Users also must pay a monthly fee of about \$7. The plates are not available through the DMV.

Some drivers are questioning whether the device's communications system could allow the state, the police or private companies to track a driver's movements.

In a recent blog posting, Alex Roy, an editor at The Drive website, raised those and other questions.

"What little privacy we have left is anni-hilated," he wrote. "This makes sense for fleet management. For my personal car? No thanks.

Neville Boston, founder of Reviver Auto, said he expects initial interest to come from companies for their vehicle fleets.

Some businesses will use them as minibillboards to advertise their products or services, he said, but will be able to do so only when the vehicle is stopped. The license plate number will still appear on the screen when messages pop up, but it will be smaller and tucked into the upper right corner of the screen.

7 men accused of touching girls at Roseville water park

ROSEVILLE, Calif. - Seven men were arrested and accused of inappropriately touching several young girls on Memorial Day at Golfland Sunsplash water park in Roseville, police said.

At least one victim was under 14 years old

Sunsplash officials received reports of several men touching girls on Monday, Roseville police said.

Witness statements, in conjunction with Sunsplash security personnel, led officers to have probable cause to arrest the seven men on multiple charges, according to investigators

After children and family reported the inappropriate behavior, Golfland Sunsplash security separated the victims and kept the males suspects together in a group before police arrived and arrested them.

"It appears that the individuals worked in a coordinated fashion to get a young victim near them or around them and then they proceeded to inappropriately touch the victim," said Rob Baquera, with the Roseville Police Department. "The kids involved in this situation reported it to onsite security and onsite security immediately reported

it to the police department. That's how we were able to apprehend these individuals.

Steve Rodgers, general manager with Golfland Sunsplash, said the men were doing other abnormal behavior before their arrests.

"These guys were -- I think they were acting up because they were getting saved in all the pools," Rodgers said. "I don't know if they could swim -- they acted like they couldn't swim."

Baquera credits the actions of the

water park and victims for the arrests. "It was swift thinking by these young ladies involved in this situation to report it to security," Baquera said. "And we always recommend if you see something or something seems inappropriate, make sure you report it to appropriate personnel."

Sovereignty without security

^{then} President Rodrigo Duterte was elected in 2016, he immediately embarked on a journey into uncharted territory that he referred to as "independent foreign policy." He believed that by adopting the vaguely defined "independent foreign policy," his country would prosper. But how can a country that is economically underdeveloped, unaligned, unallied, and indefensible, compete in a globalized economy?

Indeed, globalization has made countries economically dependent upon each other. This interdependence has made it virtually impossible for them to go to war against each other. But there are still a few nations – rogue regimes – who do not go along or get along with the rest of the international community. To name some, Iran and North Korea are a "pain in the neck" to the rest of the civilized world.

But of greater threat to world peace are a few world powers that are still pursuing imperialistic ambitions to economically, politically, and militarily dominate smaller and weaker countries. And just like the predators in the animal kingdom, they prey on countries that don't have the ability to defend their people and protect their sovereign territory from the world's bullies. Top among these bullies are Russia, the largest country on earth, and China, the most populous country.

But while Putin's expansionist moves in Eastern Europe were checkmated by a reinvigorated North Atlantic Treaty Organization (NATO), a military alliance of 29 countries that includes the U.S., China on the other hand, is having some successes. Since the ascent of Xi Jinping as China's undisputed leader, communist China has succeeded in wriggling out of the defensive parameters established by the U.S. along China's eastern seaboard, which was to prevent the Red Menace from advancing at the end of World War II.

Chinese Dream

Today, Chinese President Xi Jinping, who managed to change China's constitution to allow the president to run for reelection without any term limit, rules China for as long as he wants. In effect, he has made himself president-for-life and nobody would dare challenge him. Indeed, Xi has been in pursuit

of "Chinese Dream," a China that would rule the whole of Asia and the Pacific. In fact, China began promoting "Asia for the Asians" about a decade ago in the hope of drawing the Asian countries into China's orbit and dislodging the United States as the preeminent Pacific power.

In my article, "Xi Jinping's Pax Sinica" (November 3, 2013), I wrote: "Last October 31, 2013, China's state-run Global Times published an article, saying that escalating tensions between China and Japan over territorial claims to the Senkaku Islands could ignite a war. It said that Beijing was preparing for a 'worst-case' scenario of military conflict over the dis-

puted islands.

"It seems that China's worst-case' scenario is a deliberate attempt to fulfill Xi's 'Chinese Dream,' which is the revival of imperial China — or Pax Sinica (Chinese Peace) – that had maintained Chinese hegemony in Asia during the reign of the Ming dynasty. 'The great revival of the Chinese nation is the greatest Chinese Dream,' Xi said before taking office in November 2012."

It is interesting to note that China's dream of becoming the dominant power in the entire Indo-Asian Pacific region goes back three decades. In an article

in the Want China Times that appeared on June 27, 2013, Admiral Liu Huaqing, the mastermind of China's modern naval strategy, was quoted as saying in 1982 that it would be necessary for China

to control the First and Second Island Chains by 2010 and 2020, respectively. "The PLA Navy must be ready to challenge US domination over the Western Pacific and the Indian Ocean in 2040. If China is able to dominate the Second Island Chain seven years from now, the East China Sea will become the backyard of the PLA Navy,' he said.

In 2014, China began

building artificial islands in the South China Sea. These manmade islands were built around islets and reefs in the Spratly archipelago. A total of seven artificial islands have been built. Today, all of these artificial islands have

been militarized. Airfields were built to accommodate long-range Chinese bombers and harbors were built to allow Chinese warships to dock. American spy planes have reported missiles and radar sites. Barracks for troops have been installed.

"In all directions..."

Now, China has undisputed presence in the South China Sea with bombers and missiles deployed in the artificial islands, most of which are just 100 to 150 miles from Pal-

awan province of the Philippines. In a press statement released

by China's air force last May 18, it said: "A division of the People's Liberation Army Air Force (PLAAF) recently organized multiple bombers such as the H-6K to conduct take-off and landing training on islands and reefs in the South China Sea in order to improve our ability to 'reach all territory, conduct strikes at any time and strike in all directions'." The H-6K strategic bomber is a top-ofthe line nuclear-capable bomber and can reach Manila and all five military bases identified for devel-

opment under the US-Philippines Enhanced Defense Cooperation Agreement (EDCA). Nearly all of the Philippines falls within the radius of the H-6K bomber. It was also reported that China had installed anti-ship cruise missiles and surface-to-air missile systems on three Philippine-claimed reefs in the Spratly archi-

pelago. The report also warned of China's future deployment to the "Big Three" bases in the Spratlys. The "Big Three," the report noted, have been constructed with reinforced hangars that can accom-

modate bombers, transport, patrol and refueling aircraft. Surmise it to say, they would soon be fully operational ready to strike targets within 1,000 nautical miles.

With the "Big Three" within reach of the Philippines' military bases, the country is at the mercy of China. President Duterte, who thought that Xi was his friend and protector, couldn't do anything. In fact, Duterte bragged that on his recent trip to Beijing that Xi had provided him with a personal assurance that Beijing would not allow him to be removed from office. In a speech last May 15, Duterte said: "The assurances of Xi are very encouraging: we will not allow you to be taken out from your office and we will not allow the Philippines to go to the dogs." However, we need to be reminded what Xi told Duterte in Beijing not too long. Duterte told Xi that the Philippines intended to drill oil in the Recto Bank, which is within the Philippines' exclusive economic zone (EEZ), because it's ours. Xi's response was blunt: 'We're friends, we don't want to quarrel with you, we want to maintain the presence of warm relationship, but if you force the issue, we'll go to war." Duterte should then have realized that Xi was not a friend; Xi is just another expansionist leader who would crush anyone – foe or

Just another expansionist leader who would crush anyone – foe or friend -- who would stand against China's advances in the South China Sea. In essence, Duterte seemed to

In essence, Duterte seemed to have placed the Philippines under China's vassalage, short of territorial submission. Indeed, the Philippines has, by Xi's personal declaration, become a Chinese protectorate. And Duterte couldn't be happier.

It is very sad because Duterte disregarded the United Nationsbacked arbitral ruling that favored Manila, just a few days after Duterte was sworn in as president in 2013. China immediately rejected the landmark decision. Duterte put the award in deep freeze in exchange for warmer ties with China including large amounts of funds

for his ambitious infrastructure program.

Uncle Sam loses big

And what did Uncle Sam do? All the U.S. could do was send a warning to Beijing of "near-term and long-term consequences" over the growing militarization in the region. However, the U.S. did not say what the "consequences" would be.

If there is one big loser in China's territorial expansion in the South China Sea, it is the United States. With China creating a "strategic triangle" in the South China Sea, any ship navigating through the waterway would be within strike

range from China's bases in the Spratlys and Sansha Island in the Paracels, which China grabbed from Vietnam in 1974.

The second loser is the Philippines. With the Chinese Dragon breathing fire over Manila and the country's defense forces, Beijing could make any demand from Duterte. Short of ceding the country, Duterte could only hope and pray that Xi would not annex the Philippines – or Luzon at least – as Chinese possession.

What Duterte is now left with is a sovereign country without security. But as a wise man once said, "If you cannot defend and secure the independence of your country, then you are not sovereign." If not, what are we then? (*PerryDiaz@gmail.com*)

USMA: The Most Envied Military Academy on Earth

was extremely glad when my former neighbor in my hometown of Mlang invited me to the graduation of her son Eli on May 26, 2018 at the United States Military Academy in West Point, New York.

At 1125 pm of May 24th, my wife and I departed Sacramento to Newark via United Airlines. It was a good five-hour straight flight. From Newark we drove to USMA at West Point via a rented car. Thanks to the E-Z Pass provided by the rental car agency. We saved a lot of time from turnpikes in New Jersey and were able to attend Friday morning skydiving and parade shows at West Point.

The United States Military Academy was founded in 1802. It is now 216 years old. USMA is exactly located in West Point, New York, about 50 miles north of New York City. It takes about an hour ride via train from West Point to Manhattan and vice versa.

All 4,400-strong USMA cadets must live on its Motto of Duty, Honor, Country. West Point Class 2018 has 935 graduating from 1,200 original cadets. Cadet's life is not a holiday training, it is four years of devotion to discipline and study.

Thayer Gate is West Point main entrance. It was named after its former Superintendent Sylvanus Thayer. Millions of visitors each year pass through this gate.

Fortress West Point is the U.S. Army's oldest Post. The American flag was raised at West Point since January 27, 1778. The Plain at WP is the US Army's most hallowed training ground. West Point is built with beautifully designed building architectures. West

Pointers call it Military Gothic.

Superintendent's House fronting The Plain was built in 1820. Dean's House at Professor's Row is a classic Victorian Valley Victorian villa built in 1857. Pershing Barracks is a granite walled building opened in 1895 is being used as west academic building. Thayer Hall houses four academic departments. Taylor Hall is a 160-foot Academy's administration building.

Washington Hall is the Cadet Mess that seats the entire 4,400 Corps of Cadets. Cadet officers head each table. "The Gunner" is a plebe (freshmen) assigned at the foot of the table.

Eisenhower Hall has 4,400-seat theater to accommodate cadet's activities like 100th Night Show, Cadet Hops, and Ring Weekend. West Pointers call their dances "hops".

USMA are the most favored government scholars where everything needed for academic and military training is provided. New cadets are issued computers before academic instructions begins. Bugle Notes is a small book packed with West Point information. It is provided to all the cadets and must be learned quickly and repeated word-for-word.

West Point Cadets Honor Code

states, "A cadet will not lie, cheat, steal or tolerate those who do."

The Cadet Corps is composed of four regimen Cadet Brigade. It has 32 cadet companies.

Teamwork and leadership skills are directly mentored within each companies.

Each cadet company is assigned two-person U.S. Army tactical team composed of a commissioned officer and a noncommissioned officer.

Class standing is measured by academic ability (55 percent), military skills (30 percent), and physical skills (15 percent).

Cadets ranks are structured like army's military grade. Forth Class (freshmen) are privates; Third Class (sophomores) are corporals; Second Class (juniors) are sergeants; and First Class (seniors) hold officer positions.

Long Grey Line is composed of USMA

cadets. The First Captain heads each 1,100-strong regimen. The First Captain has six stripes and a star. There are four regimen in the Cadet Corps.

Religious life is strongly sup-

ported by the Academy. West Point has Protestant, Catholic, and Jewish chapels inside Post.

West Point success rate is about 80 percent and its attrition rate is about 20 percent. Accordingly, WP retention rate is better than many highly selective American colleges and universities.

On graduation day, at the First Captain's command "Class Dismissed," white

hats soar up the sky which culminates the 47 months of rigorous academic education and military training at USMA.

"The Goat" is the cadet who graduates last in each West Point class. At some point, a loud cheer will erupt from the corps as "The Goat" receives his/her diploma and a bag of cash collected from WP Class.

Gen. Dunford, the most senior military officer of the U.S. armed forces, urges the 2018 West Point graduates to embrace change as the approaches in war change and changes fast.

Simone Askew, from Fairfax, Virginia, is the first black woman to lead the 4,400-strong Corps of Cadets as the First Captain.

The Corps of Cadets has four regiment. Graduating cadets from First Regiment are 234; Second Regiment, 245; Third Regiment, 250; and 252 from Fourth Regiment.

Eli Moses Arzaga Eichenberger, son of my neighbor Fely Arzaga-Eichenberger from Mlang, North Cotabato, Philippines; Paulo Almeida, a nephew of my friend and former military nurse Glenda Almeida-Britanico, are both Filipino Americans born and raised in the U.S.







The History in the Struggle for Freedom

"The Filipinos have always cherished their freedom long before they were aware of the concept. Filipinos had always wanted to be free."

Around the end of 1400's European countries developed a taste for Oriental spices which from not only improve the taste of the food but were used instead of salt to preserve the meat longer. When Magellan appeared before King Charles V of Spain, the only naval power at that time, he claimed that the Spice Islands belong to Spain. The King agreed to outfit Magellan five ships for the journey. At that time in the 1600's, the Philippines, which is composed of more than 7000 islands, were grouped into baranghais headed by a chieftain called datu. Social classes in the islands were divided into nobility, called magindanao by the Tagalogs, or datu by the rest; maharlika for the warrior class; the timawa for common people, and alipin namamahay, or serfs. The people of the archipelago; had their method of trade, religious beliefs and idiosyncrasies when Magellan reached the shore of Samar in 1521. To impress native sovereigns, Magellan put on an exhibition with his men with swords and daggers attacking a 2. British Occupation of Manila

his body without drawing blood. The kings were rendered almost speechless by what they had seen. Magellan knew that the news of his exhibition will spread far and wide.

Significant Chapters in Philippine History

1. First Battle of Mactan:

Rajah Humabon of Cebu and Magellan pricked a drop of their blood into a cup of wine as a sign of peace and friendship. Humabon and his men swore obedience to the king of Spain and accepted Christianity by allowing them to be baptized in masse. Magellan called all the chiefs of the island and told them "that unless they obeyed and accepted the King of Spain as their king, he would have them killed and give their possessions to the King. Magellan was angered by Lapu-Lapu's refusal to join the other chiefs that he decided to lead the punitive expedition against Lapu-Lapu. He was not aware that the people of Mactan, a small island, were different from those of Cebu. They were skilled seamen and excellent fighters who loved their freedom too much to submit to a foreign yoke. In a hand to hand combat, Magellan was killed.

3. First Revolt of Timawas

People of Pangasinan and Ilocos. Diego Silang wanted to free the Ilocos region of Spaniards. His alliance with the British proved his downfall, and he was assassinated. His wife, Gabriela Silang continued his work.

4. Execution of three young priests in 1872-

Father Gomez, Burgos and Zamora were executed on trumped up charges. They wanted more participation in the religious administration. A small uprising inspired the rise of nationalism in the archipelago.

5. Cry of Balintawak, August 1896:

(Revolution of 1896) On August 30, 1896 Andres Bonifacio led 100 Katipuneros to capture the powder Depot in San Juan del Monte, Manila. Andres Bonifacio, a laborer, was inspired by the book on French revolution and founded the Katipunan, eventually known as KKK which stands for Kataastaasan, Kagalanggalang, Katipunan ng mga Anak ng Bayan. The opening of the Suez Canal brought progressive ideas to the island. The sons of the wealthy Filipinos were sent to Europe to study. Filipino students in Madrid were

tion in their Spanish Courts.

6. Execution of Jose Rizal in December 1896.

Jose Rizal the most talented Filipino of that century was one of the students in Madrid. Through his brother, Paciano, he learned about the execution of the three priests. This inspired him to write about the abuses of the friars in the two novels- Noli Mi Tangere and El Filibusterism. The two novels further fostered unity in the country. He was a peaceful man, a doctor, a poet, a scientist and spoke twelve languages. He was executed for treason and rebellion. His trial and his execution united the country to rise in revolt.

Numerous public executions were designed to scare and discourage rebellion.

7. March 11, 1897 First Philippine President.

Unbeknownst to Emilio Aguinaldo, he was elected President of the Philippine Republic at a convention in Tejeros, Cavite. This was reported to him the day before his 28th birthday because he was needed for the oath-taking. He refused to leave his post on the eve of the Spanish advance. His older brother urged him to take his oath now that the rebels were united.

Apolinario Mabini, a paraplequietly working for reforms for gic wrote the constitution for the

8. Tragic end for Andres Bonifacio.

On May 10, 1897, Andres Bonifacio, the man who started the

revolution and his brother Procopio were killed at Mount Tala. Having fathered the most successful revolt in the Philippine history, he became a victim to it. The internal struggle for control of the revolutionary forces moved to a tragic end. After the Tejeros assembly in Cavite, Bonifacio drew up in Naic, Cavite a document establishing a new government with an army of its own. He was arrested and brought before a Council of War which found him guilty and sentenced him to death.

Nursing Service amidst the Challenge of Diversities

A Filipina tops London speaking contest

Another young Filipina did our country proud on May 19 by besting 52 other student competitors in the annual English Speaking Union's International Public Speaking Competition in London.

Twenty-year-old Jazmin Tan Jabines, a UP Diliman junior in business administration, thus became the third representative of the English Speaking Union Philippines chapter to win the global competition. Patricia Evangelista emerged as grand finals champion in 2004, while Gian Carlo Dapul did the same in 2008.

Having three champions in only 17 years since its inception in 2002 marks a distinguished record for ESUPhil, whose earliest supporters included then Philippine Ambassador Cesar Bautista, then consular media officer Ed Maranan, and Loline Reed of London, who personally hosted our delegates for over a decade. They must all be smiling proudly up there over their legacy.

Jazmin won the national finals conducted at FEU Makati last February, with ESU-Phil officers as the judges: chair Gigi Virata, Dr. Lourdes Montinola, Erlinda Panlilio, Butch Dalisay and this writer. Other ESU-Phil members include Ed Chua, Atty. Kat Legarda, Santi Dapul, Chito Sobrepeña, and the British Council's Mike Cabigon.

Jazmin was welcomed at Heathrow by Gene Alcantara, who with his wife Carmela hosted her at their home before she joined the other delegates.

For the preliminary heats, Jazmin's five-minute speech was "Great artists have no country" — dwelling on the EJKs and how these have inspired Filipino artists to express universal protest.

She made it to the Grand Finals with six others from China, Hong Kong, South Korea, Lebanon, Estonia and the United States, with the American lady as the only other female finalist.

The judges' panel was chaired by Alan Johnson, who had served as UK Home Secretary in 2009-2010. The other judges were Tommy Seagull and Amanda Moorghen.

The topic for the finals was

"The best way to predict the future is to invent it." Here's Jazmin's speech, titled "One Hour at a Time."

I had just one hour. One hour was all I needed to recreate my memories with a person that time and circumstance had yanked away from my life. I was waiting at the international airport in Manila, because after ten years, she was finally coming home. My aunt would be back in the Philippines for her layover! For ten years we had exchanged pictures and video calls, but I knew that these were nothing compared to an hour of meeting in the flesh.

The Filipino diaspora is often talked about in numbers — they are the 12 percent of our nation spread across the continents, the \$US 2 billion in remittances they send home every month - but this neglects a larger part of the story — the daily sacrifices conducted in far-away countries. The stories of our Overseas Filipino Workers aren't just stories of success. They are also stories of invention of finding new ways to succeed where none exist.

Our clock started ticking when a voice announced the arrival of her flight. We had our faces pressed on the glass as we waited for the balikbayans or the returnees who had come home. As soon as I saw my aunt pass through the airport gates, I knew. I am lucky to have a family that can make the journey back.

the journey back. Not every Filipino working abroad can make the journey back home. Many of us get left behind. Many remain as TNTs, literally "those who hide." They live as undocumented immigrants, playing an endless game of hide-and-seek with the authorities. They invent new identities, facing the anxiety that comes with hiding, fearful of being deported back home. In the United Kingdom alone, there are an estimated 600,000 undocumented immigrants, who long for the lives they've left behind.

I have 30 minutes left with her. The sweeping vistas of the countryside we used to visit were now the gray horizon of concrete pavement as we saw airplanes fly in and out. She will leave soon, along with the rest, to a life where she is needed — indispensable yet

invisible at the same time. After all, they are half a million seafarers of the world, travelling to places as far as Malta, Italy, and the Netherlands. They will nurse you back to health as they fill the 5,000 vacancies in this country's health care system. And they will take care of your children when you are too busy with work, when all they wish for is to be back home with their own.

Because this isn't just a story of those who leave. It's also a story of those who get left behind. These are the spouses, the children, the nephews and nieces, who also need to invent their futures apart. In my case. I had to reinvent ours at the terminal, until our ticking clock's time had finally run out. It is an ironic fact of a migrant's life that to show someone you love them, you often have to leave.

But that doesn't mean we can't invent new ways to connect, to be as much a family as ever. Because we families do what we do best. We rebuild our lives across the oceans, reinvent our ties with those we love, one hour at a time whether it's the hours we spend on Skype calls, or the hours we spend with all our relatives back home for Christmas, or the hours we spend praying for those who are absent — every immigrant family invents their own unique way of spanning that distance and strengthening their love.

We can't change circumstance, but we can predict the future of our families by inventing it. We pick up the pieces they've left behind, and invent a new kind of dream for ourselves and for them.

For the last time, I saw my aunt pass through the airport gates, but this time, without a heavy heart. After all, our futures can still be written — one hour at a time.

MNAP members are governed by ethical standards. Military nurses are registered nurses who serve humanity in times of war and peace. Nursing is a noble profession. Gallup Poll ranked nurses #1 most ethical profession in America 17 years in a row. Moral principles are in the DNA of a nurse. People feel comfortable knowing an acquaintance is a nurse. I am proud to

belong to the most ethical profession.

Security of tenure keeps military nurses going. Job security is an important aspect of life. There are thousands of civilian nurses out there desperately looking for job. Some will land a nursing job but are paid below the minimum wage. Believe it or not, some nurses get a monthly pay of P3,000. This made military nurses unique from civilian

nurses. Under a current AFP pay scale, a starting monthly salary for a newly Call to Active Duty second lieutenant nurse is P39,356. Yes, that is right: thirty nine thousand three hundred fifty six pesos per month. Aside from fat base pay, a mili-

tary nurse receives good benefits and allowances to include cold allowance, if you are assigned in Baguio or Tanay, and loneliness pay, if you are assigned in far flung remote areas.

Finally, to MNAP members, continue to be strong, dedicated, committed, and be of service to the nation. As leaders, be a good example to your members who have diverse culture and beliefs.
