On why most of those killed in his administration's war on drugs belonged to the poor, the 73-year old Chief Executive explained it is because crystal meth or shabu is basically the drug of choice of poor people, who also comprise majority of the addicts in the country.

"If you're into drugs, I'll really kill you. Human rights? I don't give a sh-, Mr. Duterte said. "If we don't have law and order in this country, we would be going nowhere.'

Human rights groups said Duterte's drug war has already claimed the lives of thousands of mostly poor individuals.

2 Editorial Military and police support for Duterte

That is the extent of military and police support for President Duterte, almost three years into his controversy-filled presidency?

From the day he assumed change in pow-office on June 30, 2016, the er. The police President has steamrolled his way from one contro-versy to another. The controversies are intentionally generated by Mr. Duterte himself. He has cursed God, blasphemed the Church, priests, mocked scorned women, badmouthed foreign powers, slurred critics, and threatened human rights advocates.

The most controversial undertaking that Mr. Duterte has mounted as the centerpiece mission of his presidency is the bloody war on drugs. This has resulted in over 4,000 deaths in the hands of policemen, and 23,000 more victims by masked vigilantes suspected of being state agents.

Another highly controversial move of the Duterte administration is its complete reclassification of ally and enemy in our international relations. He has assumed a posture of hostility toward the United States and has groveled to become a close ally of China. This, despite China's occupation of land features and water territories belonging to the Philippines in the West Philippine Sea.

What has been the effect of all these controversies, and several other scandals. on the extent of support by the police and military establishments for President Duterte?

The police force has always been completely servile to whoever occupies the presidency. This is in full display



er. The police force never creates the tide of change; it merely rides the tide to benefit from the resulting change.

It is the military establishment that has served as the fulcrum of power in our history. People power succeeds or fails when the military tilts its weight one way or the other. We have seen this in the successful ouster of both Ferdinand Marcos and Joseph Estrada, and in the failed attempts to overthrow Gloria Macapagal Arroyo.

The military has largely been enigmatic in its reaction to the many controversies surrounding the President. But there's one controversy where the military has clearly made known to Mr. Duterte that there are limits to his excesses. When the President issued Proclamation No. 572 voiding Sen. Antonio Trillanes IV's amnesty, he ordered the military to arrest the senator and to commence court martial proceedings against him. In a clear act of defiance, the military refused to implement the presidential order. The President has been forced to go to court and apply for a warrant of arrest against Senator Trillanes

The virtual rebuke stung the President. He accused the military of ingratitude, reminding them that he has doubled their salaries and that he gave them new firearms. He challenged soldiers to stage a coup against

his administration.

Whether the military "pushback" is due to selfinterest (many top military officials are amnesty beneficiaries) or because soldiers sincerely feel that their "loyalty is to the Constitution," it has been demonstrated to Mr. Duterte that his propensity to misuse power has limits.

There's rising people's discontent because of the worsening economy. Poor families have increased, and even the middle class is complaining of high prices. There are unanswered questions on the President's health. His pivot to China is not resulting in any kind of benefit for our country. His approval rating is plummeting, very soon emboldening opportunistic politicians to reinvent themselves as government critics when they see the tide turning.

All these developments will increase the people's intolerance for the President's self-inflicted controversies, and they will make the ground fertile for a people's unrest. If he refuses to heed the virtual warning made in the Trillanes fiasco, President Duterte may end up giving the military an excuse to tilt the fulcrum of power away from him.



he famous Isle of Boracay was closed on April 26, 2018 and it gave Pres. Rodrigo "Digong" Duterte great proof that he had the political will to effect change in this country when it is needed!

Boracay is set to reopen on Oct. 26 and we hope that what needed to be fixed in Boracay would be fixed by now. Now the government is using Boracay as the main standard for resort hotels that open by the beach and all this was set by no less than Pres. Digong Duterte.

With problems plaguing us for decades without any solution in sight, I sincerely hope that Pres. Duterte would lean his ears and help solve the problem of trash and garbage being thrown in Manila Bay where the only tourism sight to behold is merely the sunset that we see over the water. With the Duterte administration coming up with a Department of Human Settlements I propose that Pres. Still on the Manila Bay issue, my good friend, Rick Ramos wrote me again to say: "Bobit, Thank you for your column last October 9, 2018 on saving our Manila Bay. The pollution of Ma-



pound along Roxas Blvd after a typhoon. It just shows that the garbage of Metro Manila - far worse now ends up in what used to be a beautiful Manila Bay with a world famous sunset.

In the Year 2000, my family and I took a ship going back to Manila. It was then when I realized that Manila Bay has been long dead with the dark brown fecal color of the water. Upon docking at the Manila North Harbour, we saw the myriad of squatter dwellings that contribute to the pollution of the bay. Then in late 2016, we saw trash floating at the pier in Corregidor Island. Amazing that the government authority in charge of the tourist destination cannot even address the visible, miserable evesore

Manila Bay, with an area of almost 200,000 hectares, has sadly become the country's biggest cesspool with sewage and trash coming not only from Metro Manila, but also from the four provinces of Cavite, Bulacan, Pampanga and Bataan with a total population of almost 20 million people. It is only the rain and the Pampanga River that pours in an estimated 50% of its freshwater. In a study conducted on its cleanup, some four million

gallons or 16 million liters of raw untreated sewage were disposed to the bay together One Million units of fecal matter per cubic meter of water. It certainly does not sound too inviting. Yet if we only take care of Manila Bay, it can feed Metro Manila with enough fish. The total area of the bay is three times the size of the metropolis (an area of 62,000 hectares).

For the past four decades, our national government has been remised - an understatement - with its duty to protect a great body of water with a coastline of almost 200 kms. Out of the 54,000 hectares of mangroves a century ago, there are only some 800 hectares left in the Parañaque-Las Piñas area. This perhaps explain why Senator Cynthia Aguilar Villar is so passionately against the reclamation project for a new runway to compliment a new international airport at Sangley, Cavite. In 2008, the Supreme

Court ordered the immediate cleanup of Manila Bay in recognition of PD 1152 issued by then President Marcos in 1977 that states that it is the responsibility of government to clean up when bodies of waters are polluted. A year after in 2009, the High Tribunal also issued a landmark decision and ordered 13 government agencies led by the Department of Environment and Natural Resources to "clean up, rehabilitate, and preserve Manila Bay, restore and maintain its waters, make them fit for swimming, skin-diving, and other forms of contact recreation." But nothing has happened especially under President Aquino.

I shall pursue the cleanup off the Manila Bay together with Laguna de Bay whose total pollution could be a thousand times worse than Boracay, which has the advantage of being an island. It is not an easy task, but nobody seems to be doing it. I have consulted a friend, a former Supreme Court

'I DON'T WANT TO KILL YOU' **Duterte urges NPA anew to surrender**

resident Rodrigo Duterte has made a fresh call to communist rebels to surrender, saying he wanted peace in the country and did not want any more bloodshed.

Duterte made the statement in remarks in Davao City on Friday, reiterating his willingness to offer jobs and houses to member of the New People's Army (NPA), who will submit themselves to authorities and lay down their arms.

"Listen, NPAs. I'm not fighting with you and I don't want to kill you, but I don't know about you. But we are really friends," Duterte said in the Visayan language.

'Your underground movement will not amount to anything. But I am ready to accept you if you surrender. Bring your firearms, give it to me, and I will give you a house and a job," he added.

The President said he wanted to return the favor to communist rebels in his home city of Davao who helped him win the presidency in 2016.

"I will not be where I am today without the help of the people of Davao and the NPÅ. I'm thankful for that. And because you helped me, I am asking you to also help me find a way for all of us to live. Not necessarily rich but...," Duterte said.

"During my term you can approach me anytime. I will not harm you because I have served for so long and I know that you supported

me," he added.

The President made the fresh offer even after he expressed confidence that the communist insurgency would be over by next year. The NPA is the armed wing

of the Communist Party of the Philippines (CPP). The President, through a proc-lamation, declared them a terror group in December 2017.

Duterte, a self-described left-leaning leader, told the NPA rebels they would get nothing from killing him, adding it would be better for them to just return to the fold of the law.

"What will you get from it? You NPAs. What? You're going to kill me? O the next day what will happen? What will happen to the Philippines? You amazonas (women fighters) are better off coming here. I'll hug and kiss you," he said.

Corruption, lawlessness

The President also said the country would never improve if corruption continued to exist and if law and order was not observed. "I already told you - and

remember this because I won't last long here on earth - that if there is no law and order or peace here in the Philippines and corruption is still rampant, our country will never prosper," he said.

Hopes were high that the communist insurgency in the Philippines, one of the longest-running in Asia, would be over under Duterte.

Duterte said he had leftist leanings, having been mentored by CPP leader Jose Maria "Joma" Sison. But ties between Duterte

and the Left soured amid continuous fighting between government troops and communist rebels.

Duterte had also dismissed the possibility of forging a coalition government with the communists, which he said was the goal of the communist movement which had been bent on toppling the government.

Peace talks were supposed to resume in late June this year, but the government decided to postpone it and opted to conduct more consultations with stakeholders.

Duterte's advice to government job seekers: Be honest

DAVAO CITY, Philippines President Duterte has advised all those wanting to join the government to be honest and competent.

"To those of you intending to enter government now, my criteria is you must be honest and you must be competent. That's it. If you can handle the job and if you are a decent person ... ? Duterte said during the inauguration of the new Gaisano Grand Citygate Mall in Buhangin district here the other night.

Duterte vouched for the honesty and competence of former Army chief Rolando Bautista, whom he appointed as secretary of the Department Social Work and Development immediately after the general's retirement on Oct 15.

Bautista, who took his oath the following day, was also chief of Task Force Davao before he was assigned as brigade commander in Basilan.

In 2016, he was Duterte's first Presidential Security Group chief.



President Rodrigo Duterte's 3 eldest children are seeking the highest local positions in their hometown of Davao City.

The President's eldest son Paolo is running for Davao City 1st District congressman and was the first of the 3 to file his certificate of candidacy (COC) on Friday, October 12.

On Monday, October 15, Sara Duterte Carpio filed her COC for Davao City mayor, a post she currently holds.

On Wednesday, October 17, the last day for COC filing, Duterte's youngest son Sebastian formalized his bid

Arroyo's other son, Di-osdado "Dado" Arroyo, served two terms in Congress as Camarines Sur district representative.

But Sara and Paolo had served in local positions in Davao City even before their father's presidency. Sara had been mayor and vice mayor, while Paolo had been vice mayor, councilor, and barangay captain.

Imee Marcos seeks Senate seat, Imelda to run for governor

ANILA, Philippines – Ilocos Norte Governor Imee Marcos will run for senator in the 2019 elections.

Marcos is set to file her certificate of candidacy at 10 am Tuesday, October 16, at the Commission on Elections headquarters in Intramuros, Manila. She will run under the banner of the Nacionalista Party.

"Naniniwala tayo na malaki ang maitutulong natin sa bansa sa usapin ng ekonomiya (I believe I can contribute much to our country when it comes to the economy)," Marcos said in a statement, citing some of the country's problems, such as inflation and the rising prices of commodities.

Marcos, daughter of the late dictator Ferdinand Marcos, served as Ilocos Norte governor starting from 2010 up to the present; she is on her last term.

Prior to this, she was Ilocos Norte 2nd district representative from 1998 to 2007.

Aiming to replace her as Ilocos Norte governor is her mother, former first lady and incumbent Ilocos Norte 2nd District Representative Imelda Marcos.

As supporters of opposition senate bet Chel Diokno shout 'Never again to Martial Law,' Imee Marcos says she only hears supporters chant 'Imee, solusyon'.

3 ex-senators charged in pork barrel scam running in 2019

Plunder cases in connection with the pork barrel scam will not stop 3 former senators from seeking a return to the Senate in the May 2019 midterm elections.

Ramon "Bong" Revilla Jr's family filed his certificate of candidacy (COC) on his behalf at the Commission on Elections (Comelec) headquarters on Wednesday, October 17, the last day of the filing period.

On Tuesday, October 16, Jinggoy Estrada personally filed his COC for senator, while Juan Ponce Enrile filed through his lawyer Joseph Sagandoy after a surprise announcement of his senatorial bid.

Revilla is currently detained, while Estrada and Enrile are out on bail.

The 3 senators were charged with plunder at the anti-graft court Sandiganbayan over alleged misuse of their pork barrel or Priority Development Assistance Fund (PDAF), the lump-sum funds previously allocated to legislators. (READ: Pork Tales: A story of corruption)

The scam's supposed mastermind is Janet Lim Napoles, who is also facing plunder and graft charges at the Sandiganbayan.

Revilla's trial at the Sandiganbayan 1st Division ended in August this year, and has been submitted for decision. It was the first-ever pork barrel scam case to wrap up. The plunder defendant Enrile, Estrada, and Revilla,

the regional party's Senate slate.

On Wednesday, Revilla's wife, Bacoor City Mayor Lani Mercado Revilla, insisted on his innocence.

The truth will come out, and justice will prevail," she said.

Estrada's plunder case remains ending after the Supreme Court (SC) recently affirmed the charges against him.

The Sandiganbayan Special 5th Division granted bail to Estrada in September 2017.

Meanwhile, pre-trial proceedings against Enrile are still ongoing at the Sandiganbayan 3rd Division, which had junked the former Senate president's pleas to dismiss the plunder case against him.

The SC allowed Enrile to post bail in August 2015.

Can they run?

The 3 plunder defendants are allowed to run for office because the Local Government Code and the Omnibus Election Code disqualify people from holding public office only upon a conviction, or if they have been administratively sanctioned with the penalty of perpetual disqualification from office.

and ex-senator is the 14th name in though charged criminally with plunder and graft, were not administratively sanctioned by the Office of the Ombudsman.

In the event of a conviction for any of them, disqualification will not be automatic as well, according to Sandiganbayan Presiding Justice Amparo Cabotaje Tang.

Under the Local Government Code and the Omnibus Election Code, those convicted of crimes punishable by 12 to 18 months or more in jail are disqualified from holding public office.

Plunder is punishable by lifetime imprisonment, and conviction also carries a perpetual disqualification penalty.

"The judgment of conviction must be final and executory...so if there is a pending motion for reconsideration or appeal from the judgment of conviction, the disqualification does not yet attach," Tang said.

Simply said, if any of the 3 are convicted, they would not be disqualified unless the SC makes a final and executory ruling, a period of litigation that will take more time.


Roque's stint as presidential spokesperson was marred by controversy as he made pronouncements contrary to his former stances as a human rights lawyer and Kabayan representative.



Dr. Christine Blasey-Ford wins America's heart

hristine-Blsasey-Ford-supportersWhen President Donald Trump acceded to Sen. But having them do a thorough investigation, I actually think will be a blessing in disguise. It'll be a good thing." To which I asked, "Good thing for who?'

After five days of "thorough investigation," the FBI released one copy - I repeat, one copy - of its findings, which was sent to the Senate for the 21-member Senate Judiciary Committee and after they're done with reading the report, it's passed to the rest of the 100member Senate. Does anybody think that the senators would have a chance to read the voluminous report given the short time they're given to peruse it?

As it turned out the FBI interviewed only nine "wit-Strangely, and nesses." anomalously, they did not interview the accuser Dr. Christine Blasey Ford and the accused Judge Brett Kavanaugh. And they did not interview about 40 witnesses submitted by Dr. Ford and Deborah Ramirez, the second accuser. The third accuser, Julie Swetnick wasn't interviewed at all. The net effect is that the testimonies of Dr. Ford and the nine other witnesses are rendered useless for lack of corroboration, which is a key element in determining the credibility and acceptability of evidence against the accused, which begs the question: Did the White House instruct the FBI not to interview the 40 witnesses, who were deemed as "corroborative witnesses" and therefore favorable to Dr. Ford's testimony? There is only one explanation to that: the FBI investigation was truncated, incomplete, and a sham!

had been hampered by restrictions imposed by the White House. They were given the names of whom to talk to and what questions to ask. The scope of the investigation was limited to questions about sexual misconduct and drinking beer. They can't ask about gang rape, which was what the third accuser alluded to.

With the restrictions the White House imposed, the FBI's hands were tied behind their backs. And since their client was the White House - which the White House they pointedly re-minded the Senate – they couldn't do much but to go along, play along. They'd probably asked themselves, What the heck, why bust my butt to do the investigation right, get punished and reassigned to the Aleutian Island in Alaska?" Sen. Lisa Murkowski of Alaska would certainly welcome their assignment to her State that would add to the low employment in an island where the sun rises only one month each year.

Indeed, I have to salute Murkowski for her gallant stand by siding with Dr. Ford. She was the only one of the 51 Republicans, who voted "No" on Kavanaugh's confirmation. As to the other fence sitters, Senators Susan Collins (R, Maine), Jeff Flake (R, Arizona), and Joe Manchin (D, West Virginia), it's sad that they lost their cojones to stand by Dr. Ford.

Collins who seesawed in her decision whether to support Dr, Ford or not, eventually succumbed when Republican Majority Leader Mitch McConnell met her for lunch on October 5, the day before the final vote. After their meeting, Collins told the media that she'd announce her decision at 3:00 PM. I had a visceral feeling then that she was going to vote for Kavanaugh. But it took her 45 minutes to slalom her way around into declaring that she'd cast a "Yes" vote, which gave me

From the get-go the FBI the notion that she was just grandstanding. Why not? Well, that's 45 minutes of free time on the networks!

> Sen. Joe Manchin, the macho gun-loving Democrat from deep-red West Virginia, never had the gumption to buck the Republican political machinery in his State. In essence, he has to protect his Senate seat, which is teetering in the November midterms. If he cast a "No" vote against Kavanaugh, he might as well kiss his Senate seat goodbye.

Another courageous woman was Democratic Senator Heidi Heitkamp of Montana, another deep-red State, showed that she has more cojones than Sen. Manchin when she announced that she'd cast a vote of "No." It took a real Amazon warrior to make a last stand against her male Republican opponent who is leading in the November elections.

President Donald Trump unpopular across globe and America's standing dropped, new **poll shows**

WASHINGTON - President Donald Trump is deeply unpopular across the globe, holding the most negative rating among five world leaders, according to a new poll conducted by the nonpartisan Pew Re-search Center. vowing to partimetri to vowing to partimetri can sovereignty over multilateralism – was not well received. Key

A median of 70 percent of respondents across 25 countries said they do not have confidence in Trump to do the right thing – a significantly higher disapproval rating than the leaders of Germany, France and China. Only Russian President Vladimir Putin came close, with 62 percent of the poll's respondents saying they did not trust the former KGB agent. It's not just Trump. Atti-

tudes toward America are at historic lows around the world - from from Sweden to South Africa with a median of 50 percent holding a favorable opinion of the U.S., compared to 43 percent who see the U.S. unfavorably. More people also say their own country's diplomatic relationship with the U.S. has grown worse over the past year.

The Pew survey comes as Trump's second year in office draws to a close. In that time, the American president has made waves across the world with his attacks on multilateral institutions, such as the United Nations and NATO, and his public spats with key allies, including Canadian Prime Minister Justin Trudeau and British Prime Minister Theresa May.

he had - in media interviews – expressed his mixed feelings about Kavanaugh's nomination. Could it be that he was ready to vote "No" but kept it to himself until the last minute prior to the final Senate vote? Or, could it be that he could be useful to Trump when he is going to revamp his cabinet as is being rumored in the White House? It would certainly keep him on Federal payroll when his term expires in January. And what would be a better way to clinch a job than to cast that one vote Kavanaugh needed to

secure his nomination?

The poll also comes just one week after Trump and other world leaders gathered in New York for the U.N. General Assembly. Trump's message - vowing to put Ameri-U.S. allies also sharply rejected Trump's hard line against Iran.

Pew surveyed more than 26,000 people in 25 countries, from May 20 to Aug. 12. The center, which studies public opinion and demographic trends, re-leased the poll late Monday. There were some bright

spots for the U.S., with residents of Israel, the Philippines and South Korea registering overwhelmingly positive attitudes toward America.

But in other countries, many respondents said the U.S. is not stepping up to solve global crises like it used to, and America's reputation as a champion of freedom has also waned.

Frustrations with the U.S. in the Trump era are particularly common among some of America's closest allies and partners," the Pew report concludes.

In Germany, for example, only 10 percent of those surveyed said they had confidence in Trump, 75 per-cent said the U.S. is now doing less to address global problems, and many believe the U.S. no longer respects personal freedoms.

Trump gets his lowest marks from those living right next door in Mexico - with only 6 percent of respondents saying they trust Trump as a leader. The pres-

ident repeatedly pledge since his presidential campaign to build a wall on the southern border with Mexico. About onequarter of Canadians rate **Trump** positively.

In Russia, only 26 percent of those surveyed voiced a favorable opinion of the U.S., a drop from 41 percent in 2017, and just 19 percent Russians have a positive view of Trump.

German Chancellor Angela Merkel has the highest rating among the five leaders tested, with 52 percent saying they trust her. French President Emmanuel Macron earned a 42 percent positive rating

In a similar 2017 poll, Pew found that global opinion of the U.S. had "dropped precipitously" after Trump's election. Former President Barack Obama, who championed multilateralism and nurtured ties with foreign leaders, was seen as a more trustworthy steward of global affairs, with a median of 64 percent expressing confidence in his ability to direct American foreign policy, the 2017 survey found.

So it came to pass that an

FBI investigation was conducted with "time" and "scope' constraints that would satisfy the three fence sitters, which would then give them reason to say that they're satisfied with result of the FBI investigation. Now they can say with "clear" conscience that Kavanaugh deserves their 'Yes' vote. And so they did, heads high for Trump to see and damn the protesters.

The final Senate vote was 50-48 for confirmation. That's the lowest vote a Justice of the Supreme Court had gotten in the annals of American jurisprudence. In other words, Kavanaugh will put on a Justice's black robe, knowing that he was just one vote shy from wearing it.

Indeed, the sad denouement of the quirky confirmation process would be instilled in the psyche of women who now see themselves as victims of America's unequal treatment of half of her citizenry.

At the end of the day, Trump may have won a seat on the Supreme Court, but Dr. Christine Blasey Ford has won the heart of America.

s soon as rumors that President Rodrigo Duterte was seriously ill, political groups began consolidating their forces and allies to position themselves to succeed him.

Could China drive the US out of Indo-Asia-Pacific?

Then Chinese Admiral Liu Huaqing laid out modern China's "naval strategy" in 1982, his goal was to be "ready to challenge U.S. domination over the Western Pacific and the Indian Ocean by 2040." Nobody at that time, not even the Americans, had ever thought of the Chinese going beyond China's coastal waters into the deep blue waters. She simply didn't have the naval power to go beyond her territorial waters. That was then.

Today, China has claimed virtually the entire South China Sea. And to protect her territorial claims, she employed a strategy known as "salami slicing." It's a strategy that takes possession of a territory, small slices at a time; small enough that nobody would go to war over it. That 's what China did to take possession of a lot of Philippine territory since 1994 when she grabbed the Panganiban (Mischief) Reef in the Spratly archipelago on the pretense of building a rest outpost for fishing boats in the region. The Philippines can use it too, the Chinese said.

In 2012, China seized the strategically located Scarborough Shoal and cordoned off the large lagoon within the atoll to prevent the Philippine Coast Guard and fishing boats from getting into the marine-rich lagoon.

The following year, the Chinese reclaimed six more islands in the Spratly archipelago and started building artificial islands around them including Mischief Reef. By 2016, three of the reclaimed reefs were militarized. China then built airfields to accommodate bombers and jet fighters, and harbors for large warships to dock.

With China's fleet of warshipsincluding one aircraft carrier -and submarines deployed to the South China Sea, it makes one wonder: Is China's navy capable of confronting U.S. forces in and around the South China Sea, which is America's "buffer zone" to prevent China from breaking out into the Western Pacific.

America's military power

Right now, China doesn't have the capability to confront the U.S. in the South China Sea. Not yet. Not with the tactical merger of the U.S. Third and Seventh Fleets for a total of 200 warships includ-

ing six aircraft carriers. Not with more than 200,000 personnel based around the region, of which 80.000 are stationed in Japan and South Korea. Not with a squadron of nuclear-capable B-52 bombers and a squadron of stealth fighter jets stationed on Guam. Not with three ballistic missile submarines -- known as "boomers" – de-ployed to the Western Pacific that can launch a total of 42 ballistic missiles, each capable of aiming thermonuclear warheads to hit 12 different targets.

Indeed, America's military power in the Indo-Asia-Pacific region is awesome. But it didn't deter

China from taking possession of the Scarborough Shoal and seven islands in the Spratlys. Why? Many think tank analysts believe that, while America is at least tenfold stronger than China militarily; America's leadership doesn't have the political will to stop China from grabbing territories. They likened America's acquiescence during the Scarborough Shoal incident to the Mu-

nich Appeasement in 1938 when the Western Powers allowed Germany to grab the Sudetenland region of Czechoslovakia for the price of peace. They achieved peace momentarily. But within months, war broke out in Europe.

Pretty soon, country after country in Europe fell.

Best hands always win

Indeed, history is repeating itself again. But does it have to? Is it fair to presume that this "histori-cal resurgence" can be avoided -- or sidestepped – by applying a classic poker player's rule, "Bluff only if you have the best hand." And if you follow this rule, you're guaranteed to win. The objective is to make your opponents believe that you don't have the "best hand" in which case they'd call your bluff. So, how can you lose? Remember, "best hand" always wins

Militarily, the U.S. has the "best

hand." She had it since the end of World War II when she emerged as the world's sole superpower. Her navy ruled the seas and her air force ruled the sky. But Russia, China, Iran, and even North Korea played their weak hands to their advantage, bluffing America into

scared and forced Amer ica, who may not have the "best hand," to fold.

Vividly, the world cannot forget when Russia invaded Georgia in 2008. Sad to say NATO and the U.S. did not lift a finger to help her. Emboldened by NATO's inaction during the Russo-Georgian War, Russia grabbed and annexed Crimea in 2014. The following year, Russia sent her troops and iet fighters to Syria to help President Bashar al-Assad fight the pro-American Syrian rebels.

In 2017, when President Donald Trump took office, he started cozying up to Russian President Vladimir Putin, which led many to believe that a secret or unholy alliance between Trump and Putin exists.

Meanwhile, the U.S. is facing a strong and aggressive challenge to her world leadership. When

Xi took power in 2012, he told the Chinese people about his pursuit of "Chinese Dream," the a China that would rule the whole of Asia and the Pacific. In fact, China began promoting "Asia for the Asians" about a decade ago in the hope of drawing the Asian countries into China's orbit and dislodging the United States as a Pacific power. Xi boldly gave a

timeline: the "Chinese Dream" would be fulfilled by the middle of the century, which dovetails with Admiral Liu's "naval strategy," whose goal was for China to become the undisputed hegemon in the Indo-Asia-Pacific region.

Today, America is on a selfdestructive course, following a roadmap drawn by nationalist elements in the current administration. Take for instance the U.S. administration's withdrawal from globalist initiatives such as the Trans-Pacific Partnership (TPP), the Paris Agreement on Global

Warming, and the Iran Nuclear deal.

With protectionism in mind, the nationalists' goal was to sever America's links to the United Nations and other international institutions that she helped create the International Monetary Fund

(IMF) and the World Bank (WB) – at a gathering at Bretton Woods, New Hampshire in 1944. The conference drew 730 delegates from 44 Allied nations met for the purpose of regulating the international monetary and financial order at the end of World War II. It was at Bretton Woods where currencies were pegged to the price of gold. The U.S. dol-

lar was seen as the world reserve currency, since the U.S. was the largest holder of gold at that time -- which was a key element in making America the world's sole

superpower, which begs the question: Can the U.S. survive by co-

cooning herself into isolation? Today, the U.S. is still the single largest holder of gold reserves in the world. But China -- the fifth largest holder -- is a threat to America's coveted position. China is also the world's second largest economic power behind the U.S. However, at the rate China's economy is booming, speculation is rife that she could overtake the U.S. within five years.

Interestingly, China is silently waging a war against the U.S.; that is, to replace the U.S. dollar as the world's reserve currency with China's yuan. In the past several years, China has been on a buying spree for gold. A popular theory is that she is hoarding gold as part of a plan to convert the yuan to the gold standard and replace the U.S. dollar as the default global currency.

If China succeeds in supplanting the U.S. dollar and at the rate she is building her military armaments and nuclear arsenal, China could then be in a position to challenge America's military prowess in the Indo-Asia-Pacific


just a semblance of success, his journalistic brilliance.



1. Security Doorbell:

There is a new technology doorbell that could show whoever passes by or rings the doorbell. It is a very little investment for a very good security. One can also watch other neighbor's shared videos captured in their doorbells.

2. Light Salad Meal:

Try having a light salad for either lunch or dinner. Here is a suggestion that could be tried. It is easy to prepare and may be prepared in advance:

Lettuce pieces, carrot slices, celery Slices, 1 cut up tomato, a small handful of dried cranberries or raisins, some cheese of choice, a small handful of favorite nuts or seeds, some red onion slices, and a hard boiled egg or water-based tuna. May also add some other fresh vegetables, if desired.

For dressing, try a mixture of 3 tablespoons vinegar, black pepper, and sweetener or sugar if no substitute.

3. Sleep Faster:

A trick on how to go to sleep faster is: Relax the shoulders, open the mouth, place the tongue in the middle of the mouth without touching any part of it, and think of nothing.

4. Getting Rid of Unneeded Cloth-

It is hard to part from some clothes that are still usable. One help is to place a grocery bag in one corner of the bedroom. While dressing up and when found that one piece of clothing that is tried and decided not wanted anymore, place it in that paper bag, not to be opened at all, but, to be given away.

5.Tuna Casserole Without Baking: Tuna casserole is a delicious dish, but, baking is too much work. Here is a way of cooking it without turning on the oven at all.

Cook the noodles according to the instruction on the package. While the water is boiling, place a cup of frozen peas and carrots in it with the noodles. When noodles and the vegetables are cooked, drain and transfer them in a big bowl. Add a can of drained water chestnuts, 2 cans of drained tuna. a tall can of mushroom. a small can of drained mushrooms, one teaspoon each of garlic and onion powder, salt and pepper, one half cup of shredded cheese of choice, and one fourth cup of Parmesan cheese. needs. For example, buy only the toothpaste that has fluoride, and if whitener is not needed, do not buy that for extra cost.

8. Storage Of Fresh Produce:

First of all, buy only the needed produce for that day or two. If there is leftover, store them properly. When storing them in plastic bags, place holes on the bags, or keep them in the net bag where they were in. Keep the produce away from each other, especially onions and potatoes. Do not wash the vegetables and fruits before storing. Unpeeled garlic may be stored in an open container. Peeled ones may be stored in plastic containers. Do not keep pota-toes, onions, and tomatoes {they dehydrate fast} in the refrigerator. Spinach or kangkong may have their leaves separated from the stalks, place paper towel in the plastic bag and refrigerate. Green beans may be refrigerated with paper towel in the bag also, or may be blanched and frozen.

9. Coconut Oil:

Coconut oil may be used instead of the expensive oil or cream for the face and the body. It may also be used once in a while oiling the hair to make it shiny and healthy.

10. Retain Books Read:

As book is being read, have paper and pen handy to jot down the important words, quotations or memorable events being encountered.

11. Increase Vocabulary:

eneral Emilio Aguinaldo is the most controversial Filipino revolutionary leader in our history. But his patriotism and love of his country is, undoubtedly, cannot be questioned. Under his leadership, the Philippines became the first country in Asia to proclaim its independence from foreign domination.

Although, the Republic that he established was short lived, nevertheless, he showed to the whole world that the Filipinos cannot be forever subjugated and proved that we were capable to govern without foreign intervention. Emilio Aguinaldo was the youngest President, the Philippines ever had and the youngest leader in the world to lead a revolution against foreign colonialism. He was barely 30 years old when he held such positions.

Emilio Aguinaldo was never schooled in military tactics but

against superior Spanish army and showed his military brilliance by outmaneuvering the well-trained military opponents. He emerged victorious in several battles. Andres Bonifacio, the founder of Katipunan suffered several defeats that made Emilio Aguinaldo gained popularity and respect among the leaders of the revolution.

For such reputation Emilio Aguinaldo, his popularity and leadership became so widespread that seemed to rival Bonifacio. Eventually, the Tejeros Convention was convened to establish the Philippine Revolutionary government during the fight against Spain, he and it was even presided by An-led a ragtag revolutionary force dres Bonifacio. The convention

elected Emilio Aguinaldo as the President and several of his cabinet members. Andres Bonifacio was elected as Director of Interior but the qualification to hold such position was questioned by Daniel Tirona that caused Bonifacio to be deeply insulted. Because of this incident, Andres Bonifacio being the Supreme head of the Katipunan walked out from the convention and refused to recognize the legitimacy of the gathering.

There were many battles fought against Spanish forces, but the most decisive battle was fought on May 28, 1898 in Alapan, Imus, Cavite where the Spanish forces were annihilated. Subsequently,

after the victory, Emilio Aguinaldo unfurled for the first time the Philippine Flag in the presence of thousands of Filipinos including 300 captured Spanish soldiers and even witnessed by American Sailors of the US Asiatic Squadron. Later, the Philippine Flag was again unfurled when President Emilio Aguinaldo proclaimed the Philippine Independence from Spanish rule on June 12, 1898 at the balcony of his mansion in Kawit, Cavite.

Eventually, when the Spainish rule was practically ended, the Malolos Congress in Bulacan was convened and adopted a constitution as it proclaimed the Independence of the Philippines. Emilio Aguinaldo was elected the first President of the Republic of the Philippines. The intrusion of the United States led to the Philippine American War and the fight of independence continued again led by Emilio Aguinaldo until he was captured in Palanan, Isabela by the American forces.

It is undeniable, that Emilio Aguinaldo played an important role in our fight for our independence and freedom. He had shown to the whole world that the Filipinos were determined to live freely and capable to peacefully establish a constitutional government without any foreign intervention.

Filipino American History Month 2018

The 2018 Filipino American History Month them is TURNING POINTS.

Three events changed forever the lives of Filipinos and Filipino Americans: the dec-laration of Philippine independence and estab-

lishment of the First Philippine declared independence from Spain Republic, the Spanish American War and the establishment of Ethnic Studies. These events were turning points in Filipina/o/x American history. FANHS encourages particular attention to the following events, which have both shaped the Filipina/o/x American experience. FANHS also reminds everyone that the month is HIS-TORY month, not "Heritage" month. "History" encompasses the experiences and events that have shaped our lives, as well as culture and heritage.

In 2018, we will celebrate the 120th Anniversary of the declaration of Philippine independence from Spain in 1898 and mark (not celebrate) the 120th Anniversary of the Spanish-American War. Spain and the US engaged in a brief war in May, 1898 when it was believed that a US ship, The Maine, was bombed by the Spanish in Havana Harbor. Meanwhile, Emilio Aguinaldo, leader of the Philippine Revolutionary forces,

on June 12, 1898 and proceeded to establish the First Philippine Republic. Despite this, in the Treaty of Paris, signed on December 10, 1898, Spain sold its remaining colonies – the Philippines, Puerto Rico, Guam – to the United States for \$20 Million, marking the end of the once-sprawling Spanish Empire and the beginning of the American Empire. The treaty marks the beginning of US colonial control and an American military presence in the Philippines that lasted formally until 1946 and continues to this day. A bru-tal Philippine-American War followed from 1899-1913, in which the Philippine Republic battled US forces for control of the archipelago. One million Filipinas/os died in the Philippine-American War. Filipinos were classified as "nationals" and their entry was not restricted. This was the catalyst for the 20th century migration of millions of Filipinas/os across the American empire to Hawai'i, Guam, and the US mainland.

2018 is the 50th Anniversary of the establishment of Ethnic Studies at San Francisco State University, and at UC Berkeley and UC Davis, the result of student protests

in which Filipino Americans played a significant role. At San Francisco State University, the Pilipino American Collegiate Endeavor (PACE), joined with the Black Student Union, Latin American Student Organization, La Raza, Asian American Political Alliance, Pilipino American Collegiate Endeavor, and Native American Students Union at San Francisco State University to form the Third World Liberation Front (TWLF). Students' experiences were shaped by the civil rights, anti-war, and feminist movements. The student strike the TWLF organized that began on November 6, 1968 and ended in March, 1969, was the longest student strike in American history. Students demanded open admissions of students of color and a relevant, student-centered and communitybased curriculum which challenged the Eurocentric curriculum which reflected Western values and canons. At San Francisco State, these efforts resulted in the establishment of the nation's first College of Ethnic Studies and

the first Filipino American Studies courses. Parallel efforts at UC Berkeley and UC Davis resulted in the establishment of ethnic studies at those campuses. Ethnic Studies classes and programs now proliferate across the nation. The nowthriving discipline of Filipina/o/x American Studies was borne from the struggle for Ethnic Studies.

FANHS encourages organizations and communities across the United States to incorporate this theme in their Filipino Ámerican History Month events, to visit our website in late September for curriculum and lesson plan resources, and for all to share their stories of their family's stories of turning points at #FAHM2018 on Twitter, @ fanhs_national and our Facebook page @FANHSnatl.

Filipino Americans are the second largest Asian American group in the nation and the third largest ethnic group in California, after Latinas/os and African Americans. The celebration of Filipino American History Month in October commemorates the first recorded presence of Filipinos in the continental United States, which occurred on October 18, 1587, when "Luzones Indios" came ashore from the Spanish galleon Nuestra Senora de Esperanza and landed at what is now Morro Bay, California. In 2009, U.S. Congress recognized October as Filipino American History Month in the United States. Various states, counties and cities in the U.S. have have established proclamations and resolutions declaring observance of Filipino American History Month. The late Dr. Fred Cordova, along with his wife, FANHS Founder Dr. Dorothy Laigo Cordova, first introduced October as Filipino American History Month in 1992 with a resolution from the FANHS National Board of Trustees.

This year also marks the 36th anniversary of the Filipino American National Historical Society. Across the nation, the thirty-five FANHS Chapters, colleges and universi-ties, museums and community groups, will be commemorating Filipino American History Month with various activities and events to bring awareness of the significant role Filipinos have played in American history.

> In my brief research for this article, I came upon this important fact that the construction of this monument to immortalize the memory of Jose Rizal was conceptualized during the American regime in the Philippines in the early 1900s. It took more than twelve years for the monument to be unveiled in conjunction with his 17th death anniversary on December 30, 1913. This was one piece of information that surely was discussed during my high school years but had gone buried deep in my memory bank for I simply do not remember this detail at all. It was good to be informed about it once again.

I was really glad to visit the Rizal Monument and see the area albeit a short one. It was the first stop of our tour that day and as early as seven of that Thursday morning, we were on the road traversing the way and our saving grace (again) was Aleli Grace (no wonder her mom gave her that second name) because she's quite good behind the wheels. To alleviate the situation due to Manila's famous traffic conditions and with no available parking spot nearby, Lily and I decided to get off in front of the Rizal Monument to

accomplish my one big wish that day -a photo-op with Dr. Loss D. D. Dr. Jose P. Rizal. Of course, in this famous park being a tourist favourite, a professional photographer was in sight to accommodate our request that a picture of Lily and myself be taken by him using our own cell phone to which he readily obliged to do with the silent understanding that the next

snapshots would be through his own lenses for a fee. It was good all around because how could one say no to someone who was just trying to make an honest living? We walked away from it feeling upbeat and joyful and we had our pictures to prove our visit. It was really just all about life's simple pleasures.

It might sound trivial to most readers but having been away from the Philippines for so long, I did want to see that part of "Lu-

We toured the grounds first and it was like being in the olden times due to the structures from within although mostly in ruins now. Then as we entered the hallowed halls and corridors, we were easily taken into that era for the walls are peppered with Rizal's photographs, his writings and letters, poetry, books he wrote and those written about him. Some of his sculptural works are also on display together with his paintings.

On exhibit in a glass-encased cabinet in one of the rooms is his

complete attire of his customary shirt, jacket, pants, hat and his pair of shoes/boots. This whole ensemble was what Jose Rizal wore when he faced the firing squad of Filipino soldiers of the Spanish Army in 1896.

In one room, visitors are taken back in time when he was being tried for rebellion in a make-believe courtroom where they can listen to an audio recording of those men passing judgment on his fate. In another, there is a simulation of his cell, where a wax figure of his likeness is seated in a chair behind a wooden desk with pen in hand and a bottle of ink, a pad paper and a gas lamp on the table creating the illusion that he was writing his famous poem "Mi Ultimo Adios" on the eve of his execution.

There is so much in this museum that an afternoon is not enough if one is to get immersed in reading everything about Rizal. Regardless, it was a chance to have a more vivid and reflective appreciation of the kind of sacrifice a man of his stature as a polymath endured at the hands of colonial Spain. Rizal did his more than fair share in gaining the Philippines independence from Spain's tyrannical rule through his books and writings. He was a quiet revolutionary who chose his own death in order to save more of his people's lives. His death was the catalyst for the successful 1896 uprising by the Filipinos against colonial Spain after three centuries of sheer injustice exacted in all levels of the population.

I have no recollection whatsoever of visiting Fort Santiago before so this was a thoughtful idea once more on the part of the formidable mother and daughter team of Lily and Aleli. I'm aware though that this historic site lies within the Walled City in Intramuros for it's a familiar place to me when I was a student for four years at the Lyceum of the Philippines. Looking back now, I do wonder this time why I never bothered to visit this famous Rizal Shrine.

Another family member upon learning that I had visited Rizal Park and his museum in Fort Santiago suggested a trip to Calamba, Laguna to see his place of birth, his family homestead. Maybe next time around, I said.

Diabetes and It's Management





he first topic assigned to me to teach students under Master's Entry Program in Nursing of the Betty Irene Moore School of Nursing at the University of California Davis is blood glucose monitoring. This Fall Quarter 2018 we have 48 MEPN students at UC. These students were divided into six sections with eight students per section. 50-minute lecture was allocated for each section starting 9 am until 2:30 pm. After five long hours of mentally draining and vocal cord-irritating lecture my group of students and I proceeded to the hospital for unit orientation until 5 pm. Here is the summary of my lecture on diabetes.

Diabetes is the 7th leading cause of death in the United States. The US government spends \$245 billion annually for the treatment of diabetes. Forty percent of hospital budget is spent to treat patients with diabetes. The frequency of admission for person with diabetes is twice if compared with a person without diabetes. The length of hospital stay of diabetic patient is doubled the length of stay of non-diabetic patient. The government penalizes hospitals with high number of diabetes readmissions. There is an average of 10 years delay in the diagnosis of diabetes in the U.S. Some patients were diagnosed through incident findings who came with other chief complaints.

Diabetes is a disease in which the body is partially or completely unable to produce insulin or the body develop resistance to insulin causing alteration in the metabolism of carbohydrates which leads to high level of glucose in blood and urine.

There are two major types of diabetes. Type 1 or Insulin De-


betic retinopathy, diabetic nephropathy, and neuropathy of the fingers and toes with pain and discoloration. Nephropathy causes kidney injury which may lead to end stage renal disease (ESRD). The treatment for ESRD is either dialysis or kidney transplant. Macrovascular condition causes coronary problem or heart attack and cerbrovascular accident or stroke.

The treatment for Type 1 diabetes is insulin injection, diet, and exercise. The treatment for Type 2 diabetes is diet, exercise, and pharmacologic therapy. Remember that the pancreas does not produce insulin in Type 1 diabetes therefore insulin injection is the

first treatment while in Type 2 diabetes the pancreas par-tially produce insulin or the body resist the absorption of insulin therefore diet and exercise are given emphasis without ne-

glecting oral and subcutaneous injection of insulin as ordered by a physician.

Signs and symptoms of hyperglycemia are the following: increased thirst, headaches, trouble concentrating, blurred vision, frequent peeing, fatigue (weak, tired feeling, weight loss, and blood

sugar more than 180 mg/dL. Signs and symptoms of hypoglycemia are the following: hunger, tremor or trembling, sweating, anxiety, irritability, a pale face, heart palpitations, and accelerated heart rate.

Overdosage of insulin, less food intake and overexercise cause hypoglycemia or low blood sugar. It is advisable to take some bites of carbs prior to physical exercise to avoid hypoglycemia.

Financial effect of diabetes treatment is heavy. The cost of a single blood sugar strip is \$1 but my graduate school students at the University of California told me last Monday, October 1, 2018, that blood glucose strip now costa \$2 a piece. If a diabetic person checks his/her blood sugar before meals and at bedtime, that is four times a day. That is \$8 per day or \$240 a month for blood sugar strip only. An insulin syringe costs \$1 a piece. The use of sy-ringe is dependent on the result of blood glucose. If blood glucose is within normal limits, usually from 70 to 120 mg/dl, then a diabetic person don't need to inject insulin. The price of a vial of insulin ranges from \$100 to \$500. Once a vial is opened it must be used within 28 days. Some diabetic

person uses less insulin and some uses more insulin coverage based on their individual sliding scale.

There are 20 different kinds of insulin in the market but the most common ones are insulin, regular lispro, NPH, and lantus. Metformin tablet is famous among oral medication for diabetes intended for Type 2 but are being pre-

scribed for Type 1 diabetes. About 70% of diabetic people uses metformin. Other famous oral pharmacologic therapy is glipizide, glyburide, glucotrol, etc.


Self Monitoring of Blood Glucose (SMBG) plays a vital role in the management of diabetes. Glucometer is available in the market. A patient needs to learn the proper way of checking his/ her blood sugar. Techniques in SMBG must be transferred to the patients to save money, time, effort and energy. Patients must give return demonstration on the skills taught to make sure he/she is confident and doing it properly. My students were paired to check their blood sugar following the university standards on blood glucose monitoring. They are now confident to perform blood glucose monitoring and diabetic teaching to their patients.

In September 2017 the Food and Drug Administration approved FreeStyle Libre System developed by Abbott company is a state of the art glucose monitoring equipment. A devise is stick and wrap in the arm once every 14 days visa-vis traditional way of pricking fingers several times daily. Blood glucose can be checked anytime without sticking a finger.





SMBG and insulin injection along with proper diet and consistent exercise are the weakest links in the management of diabetes These three-pronged approach in diabetes management need to be strengthened to be successful. The strength in the management of diabetes is dependent on its weakest link.


