Gov't agencies offer loans, calamity assistance to 'Tisoy' victims

overnment financial rinstitutions have offered relief packages, including loan assistance, to the people affected by the onslaught of typhoon "Tisoy."

The calamity loans and other financial aid will be made available by the Government Service Insurance System (GSIS), Social Security System (SSS), Land Bank of the Philippines, and the Philippine Guarantee Corp. (PhilGuarantee) to help people recover from the latest typhoon.

SSS vice president Boobie Angela Ocay said members affected by the typhoon may apply for a Calamity Loan Assistance Program (CLAP) loan equivalent to their average monthly salary credit.

"Ang CLAP po, sa maikling term, ay isang buwang pautang sa lahat ng mga bonafide miyembro ng SSS. Ito po ay may term na 24 ing our emergency loan months at may interest rate na 10 percent (CLAP is a one-month loan package for bonafide SSS members. It is payable in 24 months with an interest rate of 10 percent)," Ocay said in a Palace press briefing.

Ocay said they will coordinate with the National Disaster Risk Reduction and Management Council to determine where the calamity areas are before offering the calamity assistance packages in those places.

Apart from CLAP, she said SSS members may also avail of the direct house repair and improvement loan while pensioners may get funds in advance up to three months of their pension.

GSIS members, meantime, can borrow P20,000 under the company's emergency loan program. The loan is payable in three years at 8 percent annual interest.

"As far as GSIS is concerned, we are still offer-

program. The emergency loan program is given to those who are residing or working in the affected areas of the calamity," GSIS senior vice president Joseph Andres said.

The loan may be availed of after presenting a state of calamity declaration issued by the NDRRMC or local government au-

Land Bank is also exrehabilitation tending loans to affected farmers and clients, according to the bank's first vice president Emily Tamayo.

The loans will come from the Calamity Rehabilitation Support Program (CARES), the bank's flagship calamity aid program.

DILG chief orders PNP: Go after vandals

nterior and Local Government Secretary Eduardo Año on Wednesday directed the Philippine National Police to go after vandals for disregarding the law and defacing government properities.

Año gave the order as he asserted that the arrest of four members of Panday Sining—including a minor—for painting over an LRT post last Bonifacio Day is "just and lawful."

The Department of the Interior and Local Gov-

ernment chief pointed out that the authorities already gave the group a warning when it painted Lagusnilad overpass last month, but the group went on with their protest art in different places in Manila.

"Instead of stopping, they went on defacing their sur-roundings. They are not listening to the authorities. This is too much. Enough,' Año said in Filipino.

Police in civilian clothes arrested the four members

of Panday Sining last Saturday. There were reports that that the activists were manhandled during the arrest, with "at least one was kicked in the chest during the process of arrest.'

Killing Bonifacio, 'Killing Patton'

ast Saturday, Nov. 30, was the 156th birth anniversary of Andres Bonifacio, better known as the "Father of the Katipunan," the secret society that brought about the Philippine Revolution against Spain in 1896.

"Supremo — The Story of Andres Bonifacio" by Syl-

via Mendez Ventura, provides us with a picture of his short career from birth in Tondo, Manila, to his death at age 34 in the mountain ranges of Maragondon, Cavite. His father Santiago Bonifacio, was a tailor and a minor municipal employee who was classified as an "indio" while his mother Catalina de Castro was listed as a "Spanish mestiza." Nov. 30, his birth date, is also the feast day of St. Andrew, so Bonifacio was baptized with the name Andres, the patron saint of Manila.

Bonifacio had, at best, a secondyear high school education but reports say that he was "astute and intelligent and spoke Tagalog fluently." Although his readings were limited to a few books, he possessed a vision of freedom and liberty for his people. Together with like-minded friends, Ladislao Diwa and Teodoro Plata, the three formed a secret society known as the Katipunan with the ultimate objective of separation from Spain. The Katipunan had two major factions, Magdiwang and Magdalo, and at the Tejeros Convention in March 1897, Emilio Aguinaldo was voted president of the revolutionary government. This was resented by Bonifacio who stormed out of the conference with his sup-

There are only two individuals who we honor by setting aside as a national holiday either the day of their birth or the day of their death. In the case of Jose Rizal, it is Dec. 30, 1896, the day he was executed

by firing squad at the Luneta. The firing squad was composed of Filipino riflemen under a Spanish captain. For Bonifacio, we remember him on his birth date, Nov. 30, 1863. Perhaps, it is best this way. His death is a painful reminder of our continuing weakness as a people, unable to go beyond tribal concerns and uniting for the common cause. Some sources say Bonifacio and his brother Procopio were executed by Maj. Lazaro Makapagal and his men on orders of the Aguinaldo Council of War headed by Mariano Noriel. Prior to their execution, Bonifacio had been arrested by Col. Agapito Bonzon and tried before a military court in Limbon, Cavite, where he was adjudged a traitor who conspired to overthrow the revoluionary government.

Filipino riflemen shot Rizal on orders of Spanish officials. Filipino soldiers executed Bonifacio on orders of fellow Filipinos. Filipino soldiers killed Gen. Antonio Luna whom an adversary considered as "the only general in the revolutionary army." When Filipinos stop killing Filipinos, only then would we be able to make meaningful progress as a nation.

In a pep talk with the men of the US Third Army just before the Normandy landings in June 1944, Gen. George S. Patton Jr. told his soldiers: "I don't want any messages saying, 'I am holding my position.' We are not holding a goddamn thing. We are advancing constantly and we are not interested in holding onto anything except the enemy's balls. We are going to twist his balls and kick the living shit out of him all of the time."

Considered the best US Army field commander in the European theater of operations during World War II, Patton was the one most feared by the Germans.

Throughout the course of the war, he made many enemies in part because of his brusque manner and outspoken nature. On two occasions, he slapped soldiers during hospital visits, suspecting them of malingering and cowardice. In December 1945, just a few days before he was to return to the United States, he died in a mysterious car collision in Mannheim, Germany, near the town of Heidelberg. In their book "Killing Patton," Bill O'Reilly, anchor of "The O'Reilly Factor," once the highest-rated cable news show in the United States, and author of several No. 1 bestselling books, and Martin Dugard, another best-selling author of history books, narrated how Patton's limousine was hit by a US Army truck going in the opposite direction. Patton was rushed to the US Army 130th Station Hospital at Heidelberg where he expired 12 days later.

The driver of the truck, Sgt. Robert Thompson, was not punished and vanished without a trace. No criminal charges were filed. The official accident report was lost. More than 30 years after Patton's death, OSS agent Douglas Bazata revealed that he was part of a hit team waiting to assassinate Patton. Many did not believe his story but he was a highly decorated officer.

The authors concluded that Patton's death should be reexamined by American military investigators. It has not happened.

It's no wonder that the Ombudsman recently junked that last plunder charges against Arroyo, and it's impossible not to think that Mr. Duterte had a hand in the decision. Evidently, the current administration has failed to give justice to the Filipino people and punish public officials who plundered the nation.Like Mr. Duterte, Arroyo should also be held accountable for imposing a fascist reign of terror through her counterinsurgency programs Oplan Bantay Laya 1 and 2. The human rights group Karapatan has documented 1,206 victims of extrajudicial killings (EJKs), and

thousands of illegal arrests and

other rights abuses, under these programs. And as we commemo-

rated last Tuesday the International Day of Solidarity with Political Prisoners, we likewise condemn the special treatment given to known plunderers and human rights violators like the Arroyos and Marcoses, who enjoy freedom and comfort while hundreds of political prisoners are languishing in inhumane conditions in jail under the Duterte administration.We also call for the immediate release of Jaime "Diego" Padilla, the 72year-old spokesperson of the New People's Army-Southern Tagalog, who was illegally arrested while seeking medical attention, in compliance with the Comprehensive Agreement on the Respect for Human Rights and International Humanitarian Law and the 1949 Geneva Conventions, which state that those hors de combat (outside the fight) should be treated with humanity. Furthermore, Padilla is protected by the Joint Agreement on Safety and Immunity Guidelines, or Jasig in his role as a peace consultant for the National Democratic Front of the Philippines.Jail the plunderers! Duterte won't pay P7-B compensation to Manila Water

Manila, Philippines—President Rodrigo Duterte will not pay the P7.39billion compensation the government was required to pay Manila Water Co. over a recent decision of the Singapore arbitration court.

"'Hindi ako magbayad ng P7 billion, letse ka. Pakain ko 'yung pera sa kanila [I won't pay the P7 billion, you idiot. I'll make them eat the money]," Duterte said Thursday during a situation briefing on Typhoon Tisoy's onslaught in Legazpi, Al-

The Permanent Court of Arbitration in Singapore earlier ordered the Philippine government to pay the Avala family-owned Manila Water P7.39 billion to compensate it for losses suffered between June 2015 to November 2019 for the nonimplementation of water rate hikes.

Last year, the government was also ordered to pay the Manny Pangilinan-led Maynilad P3.4 billion by the same Singaporean court due to the Philippines' refusal to allow it to increase prices from 2013 to 2017.

According to Duterte, owners of the two biggest water utilities in the country milked billions from the government and the people over their disadvantageous water contract with the

But a Department of Justice Duterte is not interested to (DOJ) review found out that a dozen of "onerous" provisions were stipulated in the deal.

The President vowed to go after those behind the contract, including the powerful businessmen behind the two firms, whom he accused of "economic plunder."

Earlier, Duterte's spokesman and legal counsel Salvador Panelo said the government is not inclined to

pay billions of pesos to the two water concessionaires despite the order from the Singapore-based arbitration court.

Both Manila Water and Maynilad have already expressed openness down with the government and find a "workable solution" on the arbitral award.

But according to Justice Secretary Menardo Guevarra, settle the arbitral award.

"The President is not interested to talk about any settlement of the arbitral award. What he wants is a new deal altogether, so that this situation will not arise again in the future." Guevarra told reporters in a text message.

Cayetano: Senate, Drilon to be blamed for SEA Games mess

Manila, Philippines House Speaker Alan Peter Cayetano concurs with another lawmaker that the mishaps being experienced in the country's hosting of the 30th Southeast Asian (SEA) Games was a result of the delay in the approval of its 2019 budget.

Cayetano echoed House Deputy Speaker Mikee Romero's earlier statement that the Senate, including Senate Minority Leader Franklin Drilon, is "partly to blame" for the delayed budget approval.

Cayetano pointed out that Drilon was the one who moved to cut the budget for the SEA Games and have it transferred to the Philippine Sports Commission (PSC).

"It was Senator Drilon who moved the budget of the SEA Games to the PSC and it was Senator Drilon who proposed cutting it by 33%..." Cayetano said on Monday, addressing military officers.

"Pero siya 'yung naglelead ng criticism. Siyempre nandoon ako sa Senate, alangan namang magbastusan kami. Nake-kwento ko lang yan in context na we need better communication," he added.

(But he's the one who's leading the criticism. Of course I was in the Senate and I don't want to be rude. I am just saying this in the context that we need better communication.)

Drilon earlier slammed

Romero's accusations as an "insult" to the leadership of the Senate and said the party-list lawmaker's claims were "misplaced" and "baseless."

He also said that the delay in the 2019 budget approval was due to unconstitutional insertions made by House members "in the budget to the tune of P95.3 billion worth of pork barrel funds.'

"To refresh Mr. Romero's memory, had it not been for the solution or compromise that I proposed, which enabled Senate President Vicente Sotto to sign and send the 2019 budget to Malacañang, we would not have resolved the 2019 budget impasse and we would have continued on a reenacted budget," Drilon said in a circulated in social media. statement.

The issues surrounding the SEA Games were highlighted after national football teams from four countries complained of getting messy receptions upon their arrival in Manila this weekend.

Players from Timor-Leste and Myanmar had to wait for hours at the airport when they arrived in Manila.

It also took several hours for Thailand's football players before they could exit the airport due to problems with securing their IDs and the accreditation of their support staff.

Meanwhile, members of the Cambodia team were seen sleeping on the floor and on chairs at a hotel's conference room in photos that

Pinoys' trust in China falls from 'poor' to 'bad' in September: SWS poll

Filipinos' trust in China has fallen to a new recent Social Weather Stations poll.

The September 27 to 30 survey of 1,800 adults showed that 54 percent of Filipinos had little trust in China, while 21 percent said they had much trust in China.

This resulted in "poor" net trust of -33, down by 9 points from the "bad" -24 in June 2019.

September's net trust rating is the lowest since June 2018's "bad" -35 rating. According to SWS, net

trust in China has been positive in only 9 out of 51 surveys since the first survey on the East Asian country in August 1994.

The highest net trust rating for China was a "moderate" +17 in June 2010, while the lowest was a "bad" -46 in

September 2015.

The rating comes amid warming ties between the low, according to a Philippine and Chinese governments despite unresolved disputes over the resourcerich South China Sea.

> In June, a Chinese ship rammed and sank a Filipino fishing boat near Recto (Reed) Bank in the West Philippine Sea, the country's exclusive economic zone in the South China Sea. The Chinese vessel abandoned 22 Filipino fishermen, who were later rescued by a Vietnamese vessel.

> In August, Chinese President Xi Jinping rejected the Philippines' July 2016 arbitral victory before a United Nations-backed tribunal, which invalidated Beijing's sweeping nine-dash line claim over nearly all of the disputed waters. This after President Rodrigo Duterte raised the ruling for the first time with the Chinese leader



during their meeting in Bei-

As relations between Manila and Beijing improved, there has been an influx of Chinese nationals in the Philippines, including workers in Philippine offshore gaming operators. China has also offered various loans to the Philippines, including infrastructure funding.

PINOYS TRUST US MORE

The same survey found that

80 percent of Filipinos had much trust in the US, the Philippines' treaty ally, with 8 percent having little trust, resulting in a net trust rating of +72.

The US has maintained its "excellent" rating from +73 in June 2019.

SWS said net trust in the US has been positive since the first survey in December 1994, with results ranging from a "moderate" +18 in May 2005 to an "excellent" +82 in December 2013.

the survey also showed that Australia and Japan maintained their "very good'

net trust rating at +37 and +35, respectively. Net trust rating for Singapore

stayed "moderate" at +26, while net trust for Vietnam fell to a "neutral" zero from a "moderate" +13 in December 2017.

The survey asked respondents about how much they trust select countries: China, US, Japan, Australia, Singapore and Vietnam.

The September survey had sampling error margins of ±2.3 percent for national percentages, ±4 percent each for Balance Luzon and Mindanao, and ±6 percent each for Metro Manila and

Meanwhile, the Visayas.

'NOT SURPRISED'

The Palace, in a statement released Thursday, said it was not surprised that China was polled as the least trusted country among Filipinos.

The survey was "foresee-able" and "understandable" because of the maritime dispute between China and the Philippines in the West Philippine Sea, presidential spokesperson Salvador Panelo said.

"It is in our belief, however, that China, like any other country, will be eventually appreciated by the Filipinos by reason of the President's independent foreign policy which has resulted in significant benefits favorable to the Philippines," he said. He added, "China could even become a role model of the Philippines in reducing, if not totally eradicating, poverty."

New Army chief named

MANILA, Philippines -The Philippine Army (PA) will have a new commander following President Duterte's designation of incumbent Lucena City-based Southern Luzon Command (Solcom) commander Lt. Gen. Gilbert Gapay to lead the country's main fighting force, replacing Lt. Gen. Macairog Alberto, who is retiring tomorrow.

Described by his peers and men as a cool and wellrounded officer, Gapay is the valedictorian of Philippine Military Academy (PMA) "Sinagtala" class of 1986, the same class of

former Philippine National Police (PNP) chief and incumbent Sen. Ronald dela

Solcom chief of civil-military operations Col. Ronaldo Dumawa said Gapay would take over the leadership of the 97,000-strong PA from Alberto in a turnover ceremony scheduled tomorrow.

Prior to his designation as the incoming Army chief, Gapay headed various army units following his graduation from the PMA. These assignments include being the commander of the 2nd Mechanized Infantry Brigade in Iligan City, deputy commander of the Davao City-based Eastern Mind-

anao Command and spokesman of martial law in Mindanao prior to his designation in Solcom.

Gapay also conceptualized a thorough civil-military campaign aimed at addressing the country's decadesold insurgency problem.

"The Armed Forces the Philippines (AFP) Campaign Plan 'Oplan Bayanihan' was anchored on Gen. Gapay's concept on how to effectively address the insurgency problem," Dumawa said.

As Solcom commander, Gapay also created the regional task force - the first in the AFP – aimed at ending the insurgency, an action used as basis

by Duterte in issuing Executive Order 70 that established the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC).

As incoming Army chief, Gapay, known for his brilliance in field administration and operations, is expected to make things easier for every member of the Army.

"He makes complicated things easy for everybody. Actually, he is a cool officer," a junior officer said.

Sources said a number of senior officers have been shortlisted to be Gapay's replacement as Solcom commander. The key contenders include Maj. Gen. Arnulfo Burgos, the commander of the Tanay-based 2nd Infantry Division, and Maj. Gen. Antonio Parlade Jr., the AFP deputy chief-of-staff for Civil-Military Operations (J7) and a key figure in the NTF-ELCAC



Looking Back

"Dear children, let us not love with words or speech but with actions and in truth." - 1 John 3:18

The devastation brought by series of powerful earthquakes to my hometown in Southern Philippines made me think of helping out my folks recover from the crumbles. Magnitude 6.6, 7, and 6.5 jolted my province of North Cotabato in the last two weeks of October 2019. Hundreds of aftershocks followed and are expected to last untill Christmas.

Disaster victims are in dire need of basic commodities like food, water, shelter, and clothings. Being thousands of miles away from my hometown made me think I'm helpless and cannot physically help my fellows whose houses were damaged and some were even covered by boulders and soil during the earthquake. Then I remembered I have a small water business in my town of Mlang and I thought of sourcing it to donate mineral and purified drinking water to the evacuees in my province as water supply in the provincial capitol city of Kidapawan was damaged by a landslide caused by intensity 7 earthquake tectonic in origin.

Upon talking to my elderly parents (father, 91, mother, 85) Who are by themselves in our ancestral house in Mlang I noticed their fear of the earthquake that shakes the house almost everyday. The earthquake damaged concrete portions of our house. This is a safety issue so I decided to go home so I filed a 10-day emergency leave from work to see my parents and to help out.

On my way to Cotabato province particularly in the boundary of Davao Del Sur and Cotabato the sight was heartbreaking as I saw hundreds of evacuees in and outside their "Tarapal (makeshift tents) Tents" lining the national highway from Mt. Carmel in Kinuskusan, Bansalan, Davao Del Sur down to Philippine Boy Scout Jamboree Camp in Bulatukan and in the succeeding public schools in Cotabato Province.

Travelers driving the route Davao-Cotabato high way gave packages of food and clothes to evacuees, including bystanders who were two (male and female) grade

just curious to see passersby doling-out stuffs.

So far, Makilala has the most number of evacuees and has major devastation in terms of landslides, damaged infrastructures like road networks and buildings. Public works personnel were seen along the highways performing survey, filling cracked roads with sand and

While driving home, my water refilling station manager told me a guy from Kidapawan came to our store in Mlang to buy purified water. We sell a 5-gallon bottle of mineral water at twenty pe-sos (P20). This guy sold the water to quake victims in the city at fifty pesos (P50) per bottle. That is 150% jack up from the price he bought. Too bad. Some people are so selfish to take advantage of the situation. Somebody reported this guy to DTI (Department of Trade and Industry), a government regulatory agency. DTI personnel went to this person, chastised and mug shots were taken.

In my one week stint in my province, my team distributed relief goods to the victims of Mindanao Quake in the towns of Mlang, Tu-lunan, Makilala, and Kidapawan City.

Lepaga, a village in Mlang, is one of the damaged villages of the town. An area in the village, where an earthquake fault was identified, cracked open and considered danger zone by government volcanology bureau. Locals of said village were evacuated to a safer place to temporarily stay. My team and I distributed relief goods to the evacuees of this village.

New Ezperanza is another village in Mlang where IP (Indigenous People) is mostly affecter by mountain landslides. My team and I distributed relief goods to the evacuees of this village.

Tulunan is the epicenter of the week-long trembler that caused damages to infrastructures. The local government of Tulunan was so far the most organized LGU in terms of disaster management. It provides local guides to disaster relief donors in going to places where the goods are distrib-

National High School. According to our male guide, during the first of the three major quakes in the 3rd week of October, he was taking course quiz at the 3rd floor of the school building when he felt the building was swinging side to side then the quake made the building floor bounced hard. Some high schoolers got dizzy and 32 students fainted as a result of that 6.6 intensity quake. They were then guided to go down the building and proceeded to the open field of the school. Based on our guides' account, they are taking quiz on Monday, November 11 when classes resume as they were unable to finish the quiz when the quake happened. My team and I distributed relief goods to the evacuees of this LGU.

8 students from Tulunan

Makilala is the most challenging area for relief distribution as we have to climb up and down the hills just to reach evacuation centers.

Several landslides happened my Kamalig Team, SBC in this town during the weeklong earthquake. My team and I distributed relief goods to the evacuees of this town.

Kidapawan City is the capital town of Cotabato Province. This is where big buildings collapsed during the earthquakes.

Eva Hotel is one of the structures that incurred major damage. My team distributed drinking water to earthquake victims in this local government unit.

Overall, recovery seems to take a longer period as the region experiences aftershocks at higher magnitude of 3 to 4. I experienced two aftershocks on my short stint of one week in Mlang.



People are tired of earthquake and they need our prayers.

Lastly, I would like to take this opportunity to thank

cisco International Airport in which I saved \$350 parking fee should I park at SFO Terminal for \$35 per day. The money I'm supposed to pay for parking fee was used to buy bags of rice, can goods, and food items for earthquake victims.


Then the Soviet Union collapsed in 1989, the Cold War ended too. Vladimir Putin was then a colonel in the KGB, the Soviet Union's spy agency. He was stationed in East Germany, which then dissolved and reunified with West Germany. In April 2005, Putin told the Russian parliament: "First and foremost it is worth acknowledging that the demise of the Soviet Union was the greatest geopolitical catastrophe of the century. As for the Russian people, it became a genuine tragedy. Tens of millions of our fellow citizens and countrymen found themselves beyond the fringes of Russian territory."

After the Cold War, the U.S. became the sole superpower. America had her way – the undisputed master of the world. However, Russia kept her nuclear arsenal to keep America at bay. But then president George W. Bush gave Putin, the new president of Russia, a pass. And while the detante was going on, Putin slowly rebuilt Russia's military strength.

Ukraine crisis

In 2014, Russian forces invaded Ukraine and waged a bloody war against Ukrainian forces in the Donbas region of eastern Ukraine. Russia also sent special forces to the Ukrainian peninsula of Crimea. The pro-Russian Crimeans organized an illegitimate referendum to join Russia. In March 2014, Russia formally annexed Crimea, which was denounced by the U.S. and her NATO allies. However, NATO did not do anything to prevent Russia's annexation of Crimea. The U.S. imposed economic sanctions against Russia but beyond that did nothing to reverse the situation in Ukraine.

In retrospect, many blamed then president Barack Obama for allowing Russia's takeover of Crimea. But what could Obama and his NATO allies have done otherwise? Invade Crimea or send NATO forces to east Ukraine? Ukraine's president Petro Poroshenko went to the U.S. and pleaded Obama to send weapons to Ukraine but Obama did not respond. Instead the U.S. sent \$53 million worth of non-lethal aid such as counter-mortar detection units, body armor, binoculars, small boats.

blankets and other gear for Ukraine's security forces and border guards. In a speech to the U.S. Congress, Poroshenko said, "Please understand me correctly. Blankets, night-vision goggles are also important. But one cannot win the war with blankets." He added: "Even more, we cannot keep the peace with a blanket." Drawing cheers from the lawmakers who want to arm the former Soviet state, Poroshenko declared his forces "need more military equipment, both lethal and non-lethal, urgently need."

Enter Trump and Zelensky

Five years later, President Donald Trump and his Ukrainian counterpart Volodymyr Zelensky got embroiled in scandal that threatened Trump with impeachment. At issue is the nearly \$400 million in security aid that the U.S. Congress has approved for Ukraine. However, Trump ordered the aid withheld until certain conditions are met.

Twelve government witnesses have testified that the security assistance, and a promised Zelensky visit to the White House, were held hostage to a demand for a public pledge by Zelensky that Ukraine would investigate 2020 Democratic presidential challenger Joe Biden and his son Hunter. The controversial arrangement has become to be known as the quid pro quo deal, which according to the Democrats on the House impeachment inquiry hearing, was tantamount to bribery and extortion, which are impeachable offenses. The House committee on impeachment inquiry had just finished its public hearing.

cy. It seems that his mishaps and miscalculations have diminished America's geopolitical standing vis a vis Russia, China, South Korea, North Korea, Turkey, Syria, Iran, NATO and others.

Leading the pack is Russia who has in the past two years gained substantial influence in world af-Vladimir Putin, the foxy Russian master spy has outsmarted Trump every which way Trump goes. Putin is now the dominant force in the Middle East, winning to his side Turkey, Syria, Iran. After Trump withdrew American forces from Syria, ISIS is growing with at least 50,000 armed men in Syria and Iraq. Russia filled the void created by Trump's retrenchment in Syria. Russian tanks have taken over the territory abandoned by the Americans. Now, they're patrolling a huge slice of the Turkey-Syria border. Russia is now the preeminent power in the Middle East. And she did it without firing a single shot.

Trade war

Trump is also waging a trade war with China. As a result, U.S. agriculture is suffering from low exports. Trump has to bail the farmers to the tune of \$28 billion and counting. It is not fully offsetting the loss of Chinese purchases and markets for U.S. soybeans, pork, and other agricultural products.

U.S. manufacturing fell deeper into a contraction or technical reces-

sion in the first six months of the year, and it appears to be getting worse, which could spill over into the rest of the U.S. economy.

Korean Peninsula

Meanwhile, all is not well on the Korean Peninsula. The 66-year old U.S.-South

Korea alliance is eroding. When Trump increased the defense burden-sharing cost for stationing 28,500 U.S. forces in South Korea to \$5 billion a year, an increase of 500% over last year's cost, it alarmed the South Koreans.

South Korea isn't happy by Trump's exorbitant charges. If Trump doesn't change the amount, it could lead to withdrawal of U.S. forces in the peninsula at a time when North Korea nuclear threat is increasing. And there is no indication that North Korea's leader Kim Jong-un would dismantle his nuclear warheads.

The question is: If U.S. forces withdraw from South Korea, what is going to happen to the 50,000 U.S. forces in Japan? Will Trump ask Japan to pay for the stationing of American personnel in Japan, which is quite substantial?

Withdrawal from South Korea and Japan amounts to the U.S. effectively abandoning Asia. Which makes one wonder: What will Japan do to protect her territory from Chinese threat? Well, Japan has an ace up her sleeves: Rokkasho Nuclear Fuel Reprocessing Facility has an annual capacity of 800 tons of uranium and 8 tons of plutonium, which are produced by reprocessing spent nuclear fuel. Although reprocessing spent nuclear fuel for civilian nuclear plants, is the primary goal, they can also provide the essential fissile ma-

terial for nuclear weapons. And surely, Japan is keenly aware of this capability, which she can do to provide her own nuclear umbrella in the event that the U.S. decides to withdraw from Asia.

Cuban missile crisis redux

Last February, a repeat of the 1962 Cuban missile crisis was imminent when Putin said that Russia is militarily ready for a Cuban Missile-style crisis if the U.S. wanted one and threatened to place hypersonic nuclear missiles on ships or submarines near U.S. territorial waters.

The Cuban Missile Crisis erupted in 1962 when Moscow responded to a U.S. missile deployment in Turkey by sending ballistic missiles to Cuba, sparking a standoff that brought the world to the brink of nuclear war. Half century later, tensions are rising again over fears that the U.S. might deploy intermediate-range nuclear missiles in Europe.

The crux of the matter is the Intermediate-range Nuclear Forces (INF) Treaty, which both sides are accusing the other of violating.

The INF pact bans Russia and the U.S. from stationing short- and intermediate-range land-based missiles in Europe. Washington announced on Feb. 1 it will withdraw from the treaty in six months unless Moscow ends its alleged violations.

Putin said he does not want an arms race but would have no choice but to act if Washington deployed new missiles in Europe, some of which he says could strike Moscow within 10 to 12 minutes.

Putin said Russia could strike the U.S. faster than U.S. missiles deployed in Europe could hit Moscow because the flight time would be shorter.

Obviously, Putin was bluffing. However, Russia does have the capability to strike the U.S. if Trump calls his bluff. For one thing, the U.S. doesn't have intermediaterange missiles; however, she can develop them since the U.S. has the technology.

But the problem is that Trump doesn't have what it takes to confront Putin. Simply put, he's scared of Putin. Trump is a bluffer and he knows that Putin has a better hand to play. With America's allies jumping ship, nobody is left to defend the U.S. in the event of war.

Indeed, America is under siege right now. Is Pax Americana coming to an end? (PerryDiaz@gmail.com)

My long journey to rehabilitation

n March 6, 2019, my life turned upside down. I was on top of the world when on that day. I fell ill and ended up in the hospital due to low blood pressure. I fainted while I was having dialysis treatment and was rushed to emergency room at Kaiser Hospital. I had no recollection of what happened next. But my wife Dolores told me a few days later that I had seven cardiac arrests in one day! I was given Cardiopulmonary Resuscitation (CPR) seven times in one day. The procedure broke four of my ribs.

They put me on liquid diet and inserted a tracheostomy breathing tube into a hole made in my neck and windpipe. The tube was attached to a ventilator that provided oxygen. I lost the ability to speak. I communicated with the use of pad and pencil.

Bedridden, for the first time in my life I felt helpless and hopeless. I was in and out of sleep. I asked my wife to call my brother Titus and have in come here to keep me company at the hospital. Titus arrived two days later from the Philippines. He stayed for two weeks. But I had no recollection of his visit. Nor do I remember my friends who visited me at the hospital. My mind was lost. All I remembered was my wife visiting me every day. But when night fell, I felt lonely... and frustrated.

A week later, I came down with pneumonia and was transferred to Folsom Mercy Hospital, which has an Intensive Care Unit (ICU). Miraculously, I recovered from pneumonia after a day. I was then moved back to Kaiser Hospital. The doctor said that it usually took two weeks to recover from pneumonia.

My wife gave me a book given by my brother when he visited me. The book was titled, "Healing is a Journey." Authored by Minx Boren, the book was uplifting. I started reading the book and found it helpful in my situation. It talked about hope and acceptance. It says: "Hope is a survival trait. Without it, we lose heart, and without heart, we become susceptible to despair. When we can no longer see any options, we are liable to give in or give up. To

keep hope alive is to hold a posivision for the future. Yet to be fully present in our own life, we must also be willing to be with what is true in the moment. If we are always waiting when – when I am stronger, pain-free, thinhealthier, wealthier, mardivorced, ried. hired, retired, etc. before we can

enjoy where we are right now or commit to something we are passionate about or dare to explore something different, then we may never experience newfound joys or reach beyond the status quo."

It was then that I realized to choose what my options were. Either I give up and consign myself to live for the rest of my life bedridden or get on my feet and walk again. I am not going to give up. First, I need to be able to speak again. At the hospital, I availed of the speech therapy given to people who have lost their voices. My happiest moment was when they remove the tracheostomy tube from my throat. Í began to talk again.

After a month I was discharged from Kaiser Hospital moved to Vibra Hospital to continue recovery. ter a month at Vibra, I was discharged and admitted to the Rosewood Post-Acute Rehabilitation. When I thought I was on the road to full recovery, I was rushed

to emergency room. My hemoglobin (blood) count decreased to 4.9, way below the acceptable level of 12. I needed blood transfusion. I was given two pints of blood. I was discharged and went back to the rehab center. But my hemoglobin didn't improve much. Once again, Î was rushed to the emergency room for another blood transfusion. My blood count improved to 8.4, which was barely enough to keep me out of harm's way. But what caused my blood count to drop? I took several tests and stayed in the hospital for several days. For the next three months, I went through physical therapy and occupational therapy. I was on wheelchair then. Learning how walk again was the biggest challenge during my stay

at Rosewood. I was discharged from Rosewood on September 3, 2019.

But that was not the end of my therapy. It was only the beginning. I continued the therapy at home with the help of home health nurses and therapists. The home health service ended on October 22, 2019. I was able to walk with the aid of a walker. I registered for outpatient physical therapy at Kaiser. I will continue my physical therapy in November. And God willing, I'll be able to walk without the aid of a walker before Christmas.

I never lost hope during my long journey to rehabilitation. My faith in God gave me the strength and determination to overcome the obstacles and challenges in the six months I was in the hospital and rehabilitation center. I never fell into depression.

Power of prayer

Throughout my stay in the hospital and rehab center, the fervent prayers of friends and relatives had miraculously given me a new breadth of life. I truly believe that God extended my stay on Earth. My fate is now in God's hand.

Minx Boren's book was enlightening. It taught me to persevere and never to give up hope. She said hope is a choice. And I chose hope.

She said: "There are thousands of things that can give us hope and just as many things that can take it away. Babies give me hope. Good teachers, good parents, and good citizenship give me hope. Simple acts of kindness and generosity give me hope. Technology gives me hope. There are breakthroughs happening in medicine and alternative energy resources that may one day save our bodies from the worst ravages of diseases and our planet from the more destructive activities of humankind.

"What is clear is that hope needs to be a choice we make again and again. I am aware that the half-full glass only appears to be so when I am disposed to declare it so and live as if it is so. And I am also certain that when I choose hope and lean toward optimism, possibility, and recovery, the great blessing is that healing happens on many levels and happiness shows up in my life in many ways."

Thanks to all who prayed and wished me well. God heard their prayers. I am on my way to full recovery. I plan to have kidney transplant by next year. And I hope that God will give me the strength to undergo the procedure. (PerryDiaz@gmail.com)



Christmas in the Philippines – The World's Longest Christmas Season

hey say nothing will ever dampen the Filipino spirit, more so, their Christmas spirit. Even if one is busy as a bee or money-strapped, Filipinos find a way to celebrate this season, which is oftentimes the highlight of the year.

Christmas in the Philippines may be the longest holiday celebration in the world1. As soon as the "ber"2 months kick in you see a transition to a more festive mood which lasts until January 6, the Feast of Epiphany or Three Kings. As early as September, colorful decorations line up the streets, Christmas carols start playing on the radio and everyone just brightens up with holiday cheer. Imagine being in this state for more than 4 months? There's nothing quite like it.

It will begin to look a lot like **Christmas**

A lot of the Christmas traditions in the Philippines are a fusion of the two cultures that influenced the country most – Spain and the USA. As someone described the Philippines, "it spent 300 years in a convent and 50 years in Hollywood.

Parol being sold on the streets normally signals the start of the season. Parol is a Spanish term for lantern lighting up homes during this holiday. The parol represents the Star of Betlehem, which guided the Three Kings to find the stable where Jesus Christ was born. This is an iconic Christmas symbol in the Philippines and it can range from a very simple 5-pointed star made from Japanese paper to elaborate designs with LED lights. To celebrate this, there is even a Giant Lantern Festival held annually on the last Saturday before Christmas Eve in San Fernando, Pampanga.

There is also the belen, the Spanish term for Betlehem. It is a tableau depicting the scene of Nativity with the baby Jesus, Joseph and Mary, the Three Kings and the animals at the stable are all present with the Star of Betlehem shining on them.

Although the Spanish influence is quite evident, one

customs are quite common too. A Christmas tree is a usual decoration in every Filipino home. In the absence of pine trees, most people use artificial trees adorned with plastic poinsettias and other colorful designs. Santa Claus is famous and well loved by the kids. You can see Santa with his elves in every mall. Oftentimes, children would line up to sit on Santa's lap and have a picture taken with






