# **Stop blaming Chinese for nCoV,** that's xenophobia - Duterte

MANILA, Philippines -President Rodrigo Duterte on Monday urged Filipinos to stop blaming the Chinese for the outbreak of the 2019 novel coronavirus (nCoV), calling it in bad taste.

"Blaming Chinese is xenophobia," Duterte said Monday in a press briefing held in Malacañang. "You hate anything that is Chinese, that is not good. China has been kind to us. We can

"Stop this xenophobia thing. They're blaming the also show the same favor to Chinese who came from

China. It can always incubate in some other places,' he added.

Duterte described social media posts urging that the Chinese be sent back home.

# **49ers lose Super Bowl 2020:**

Crucial pass interference, touchdown rulings go against team in tough loss

From George Kittle's OPI to the Chiefs' go-ahead TD, the 49ers felt snakebitten on Sunday

The San Francisco 49ers suffered an epic collapse in the late stages of Super Bowl LIV, holding a 20-10 lead halfway through the fourth quarter that turned into a deficit by the twominute warning and ended in a 31-20 loss to the Kansas City Chiefs. The incredible Chiefs comeback will be the story of the game, but a penalty late in the first half wound up being a crucial missed opportunity for the 49ers, and the butterfly effect of the call had potential hidden ramifications for the final result, especially coupled with another close call later in the game.

opportunity to take the lead over the Chiefs just before halftime of Super Bowl LIV. Jimmy Garoppolo threw a 42-yard pass to All-Pro tight end George Kittle that would have put the 49ers at the Chiefs' 13-yard line with six seconds to play. The play was called back, however, as Kittle was

called for offensive pass interference on Chiefs safety Daniel Sorensen that negated the team's longest pass play of the first half. The 10-yard penalty forced the 49ers to take a knee and go into halftime tied 10-10 with Kansas City.

Here was the pass interference play in question. NFL head of officiating Al Riveron gave his explanation on why the call was made, a quick reaction from the league on a play that cost San Francisco points.

Kittle, one of the best blocking tight ends in the NFL, rarely gets called for offensive pass interference.

In fact, before Sunday, Kittle had been called for offensive pass interference only once in his career, in Week 10 against the New York Giants in 2018.

The Chiefs used an epic fourth-quarter comeback to win their first Super Bowl title in 50 years, and there's a lot to go over. # **Coping with nCoV**

Yum yum... maybe you've seen the

One is of the woman eating bat soup, with a whole bat staring up like a creature from hell. Either she or the restaurant at least made some effort at presentation, artfully draping the bat on one side of the soup

More importantly, the bat was dead and looked cooked.

Not so the creature in another video clip, which could vie for gross-out video in this coronavirus season. This being the Lunar Year of the Rat, the video shows a man with a plate before him, again artfully laid out with sliced tomatoes and... are those moving baby mice?

Yes, they are. The man picks up one with chopsticks, dips the squirming gray bubwit in what looks like lemon butter sauce, and without hesitation pops the creature into his mouth, chews, and prepares to pick up another one.

Our resident singkit in the newsroom told us it must be a "honey mouse" – nearly bite-size mice fed with honey and eaten just a day or two after birth, although the usual color is white rather than mousy gray. Something similar to our day-old chick, except the day-old chick is of course from hens, and is deep-fried in boiling oil.

The Chinese woman in the bat video has since come out in public - after being bashed on social media for contributing to the transmission of the novel coronavirus to apologize and clarify that she ate the bat soup in Palau, not China, and it was in

We're still waiting for the guy eating the live mice to also come out - although he might see no need, since no one is linking rodents to the novel coronavirus, a.k.a. the 2019-nCoV. His meal venue is believed to be somewhere in China's Guangdong

I'm using a.k.a., a police term, because law enforcement is what comes to mind in describing suspected nCoV cases as PUIs -"persons under investigation."

You'll probably feel like a suspect, too, if you are a possible carrier of a virus with the potential to kill you, plus your family, friends and people you touch or who are within range of your sneeze and cough.

That possibility of harming other people should encourage self-reporting as nCoV spreads rapidly with no vaccine as yet available.

It should also encourage people to refrain from what scientists consider to be risky behavior at this point – such as eating exotic animals, especially live.

We must note that Filipinos also eat bats. Called kabog, the fruit-eating creatures have a wingspan of up to a meter and their torso can weigh about a kilo – much larger than the one in the video. The torso is cut up and thoroughly cooked, with the head and wings not part of the plating.

Field rodents are also eaten here, just like in China and other parts of Asia. But again our rat eaters prefer the animals cooked.

SARS, also from coronavirus, is believed to have originated from civets bought live for food from markets in China. We might sniff at this, but at least the Chinese eat the cat meat. We, on the other hand, eat their poop. OK, more accurately, we drink the pricey coffee processed from the beans that and I'm skipping kilawin.

the civets excrete with their poop after they feed on coffee berries. Still..

Snakes - another suspected source of nCoV are also eaten here, as well as monitor lizards, locusts, dogs, duck embryo, cats in siopao. So we can't be judgmental about the gustatory delights in other cultures.

But we can refrain from indulging our taste for exotic food - at least until a vaccine is developed and the nCoV threat sub-

This is one of the pieces of advice given by medical professionals and scientists to the public as the newest coronavirus strain gallops around the planet.

Contrary to the nCoV "infodemic" of fake news, it's still OK to eat sashimi, and I guess the Koreans can safely nosh on live baby octopus. With seafood, only the usual precautions are needed: it must be fresh and properly cleaned.

Wildlife is a different issue. You don't know where bats and civets have been or what they've eaten. Handling them alive and then slaughtering and preparing them for cooking can facilitate "zoonotic transmission" - the transfer of pathogens from animal to human.

This is according to microbiologist and infectious disease specialist Raul Destura, deputy director of the Philippine Genome Center at the University of the Philippines in Diliman.

"Anything that is (eaten raw), you by-pass the process of heat," Destura told 'The Chiefs" this week on Cignal TV's One News. "The sterilization process is not

So hold the bat soup and squirming honey mouse, for now.

Other precautions that people can take against killer pathogens, according to Destura and health professionals, are basic hygiene practices: regular hand washing with soap and water, observing sneezing and coughing etiquette, and keeping oneself

There's a photo also going around of an advisory supposedly from the World Health Organization. At the bottom of a to-do list it advises: "Avoid unprotected sex with live wild or farm animals.

It's a measure of the panic over nCoV that there are people who wonder if the advisory is authentic, considering that there are nutcases who engage in bestiality.

The panic is certain to increase following the confirmation of the Philippines' first nCoV case vesterday and the death of one of those being tested for the virus.

Albay 2nd District Rep. Joey Salceda, who is proposing the creation of a Center for Disease Control and Prevention, cautions against "silliness" and overreactions to the threat.

Salceda told The Chiefs that going to health centers over the most minor symptoms could overwhelm facilities. He has a point, but this must be reconciled with Destura's call for civic responsibility in "selfreporting" for those who believe they are possible nCoV carriers.

With no end to the deaths and with the infection numbers rising by about 1,000 a day in China alone – a much faster rate than SARS - it's becoming harder to draw the line between silliness and prudence in responding to the nCoV threat.

Already this sent fans reeling, as Kobe was an absolute superstar in the 20 years that he played for the Los Angeles Lakers. His reputation on the court is one of tenacity, discipline, speed and competitiveness, earning him the moniker "Black Mamba."



Off the court, he has been marred by controversy early in his career, being accused of rape (he settled out of court in a civil suit filed by his accuser).

Not long after, even more heartbreaking news arrived, that Kobe's 13-yearold daughter Gianna was killed along with him. She is almost exactly the same age as my little girl, so this news sucker-punched me hard.

Gianna wasn't just his daughter, but was also a basketball player. Numer-

ous videos online show just how gifted she was. How she seemed to carry the same tenacity and drive that marked her father's career, not to mention unreal shooting ability at such a young age (she was referred to as "Mambacita").

Given her talent, there was no doubt that she would enjoy a magnificent college career. after which she would head right into the WNBA, carrying on her father's storied

All over social media, fans, friends and former NBA players paid tribute to the man that cemented quite a legacy, inspiring so many others to follow the work ethic he applied to basketball into their own lives.

But perhaps the more painful part of this nightmare is that his daughter, the one being looked to as the carrier of that legacy, will no longer be able to fulfill it. Father and daughter shared a passion for the sport.

In the numerous photos and videos of them together on the court, he would break down the game for her. Coach her team from the sidelines. Upload a video of an amazing shot she'd make. And just be a proud dad.

Every single parent hugged their little ones more tightly in the last couple of days, knowing full well how fragile and unpredictable life can be. The Bryants left behind Vanessa (wife of Kobe and mother of Gianna), and Gianna's three sisters Natalia, Bianka and Capri. We express our sincerest condolences to them.

To you all, I ask you to love fully. We only get one shot at this; let's live life well.

# 'Son of God' couldn't stop FBI raid

Three administrators of the Philippinebased Kingdom of Jesus Christ (KOJC) Christian sect were arrested on Wednesday (Thursday in Manila) for participating in an immigration fraud scheme that brought followers to the United States to raise funds for an alleged bogus charity.

Church members were tricked into becoming fundraisers "and then arranged sham marriages and other illegal mechanisms" to keep them in the country, according to a US Department of Justice press statement.

The federal criminal complaint alleged that the church members solicited donations for the nonprofit Children's Joy Foundation USA, claiming they would benefit impoverished children in the Philippines.

Prosecutors said that instead of going to poor Filipino children, the money raised was used to finance church operations and the lavish lifestyle of church founder and leader Apollo Quiboloy, a self-proclaimed appointed son of God" who claimed last year that he had ordered an earthquake in Mindanao to "stop" shaking the ground to prevent further destruction.

The church claims a membership of 6 million people and it backed the 2016 candidacy of President Duterte, a close friend of Quiboloy.

Arrested were Guia Cabactulan, Marissa Duenas and Amanda Estopare. Cabactulan, 59, was described as a top church official "who maintained direct communication with KOJC leadership in the Philippines.'

Prosecutors said Duenas, 41, allegedly handled fraudulent immigration documents for the church workers. Cabactulan and Duenas were arrested at a church compound in Van Nuys, where they lived, about 27 kilometers northeast of downtown Los Angeles.

Van Nuys is in the San Fernando Valley and home to a large number of Filipino-Americans.

Estopare, 48, who allegedly enforced fundraising quotas for church workers,

was arrested in Virginia.

Federal agents raided the church compound in Van Nuys, the Children's Joy Foundation office in Glendale, and three other locations in the Los Angeles

Searches were also conducted at two locations linked to the church in Hawaii, and agents fanned out across the United States to interview witnesses as part of a larger investigation of alleged human trafficking.

Two years ago, a leader of a Hawaii branch of KOJC was arrested smuggling cash onto a private plane in Honolulu bound for the Philippines, according to court records.

Investigators said Felina

Salinas declared she was carrying \$40,000. But investigators said they discovered \$335,000 and \$9,000 in Australian currency stuffed in socks in her carry-on suitcase, according to documents filed in US District Court in Honolulu. US law requires travelers to declare currency in excess of \$10,000.

### **Sham marriages**

A total of 82 sham marriages had been arranged by the church administrators in the past 20 years, according to mmigration records summarized in the affidavit.

The affidavit alleged that the church established daily cash solicitation quotas for the church workers and if these quotas were not met, workers suffered abuse, according to victims who have fled KÖJC.

"Records show that KOJC accounts received approximately \$20 million in cash deposits from 2014 through mid-2019, ... [and] most of these funds appear to derive from street-level solicitaaccording to the aftion. fidavit, which noted that

Some of them described being sent across the United States to solicit donations, working long hours to reach their daily quotas, receiving little to no pay for their efforts, and participating in sending large sums of cash back to the Philippines on commercial and private

#### Conspiracy charge

The charge of conspiracy to commit immigration fraud carries a statutory maximum penalty of five years in federal prison.

The case is being prosecuted by Assistant United States Attorneys Daniel Ahn and Jake Nare of the Santa Ana (California) Branch Of-

In a statement in Davao City where he is based, Ouibolov denied the allegations, which he said had saddened

"Under no circumstances

does KOJC or its members engage in any act that violates the law," the statement

said.
"We are ready, able to show and prove the innocence of the administrators of the Kingdom," it said. "We will show to you that the (KOJC) administrators were just exercising the religious rights of spreading the Good News to the whole world. We will face these charges and we await our day in court.

His lawyer, Israelito Torreon, said the allegations were "nothing but a grand conspiracy of lies, concocted by former members of the Kingdom who struck an alliance with forces who had an axe to grind against Pastor Apollo C. Quiboloy.' Torreon did not identify who he was referring to.

They are into this grand conspiracy in order to put to shame Pastor Apollo C. Quiboloy and the Kingdom of Jesus Christ," he said.


MANILA, Philippines President Rodrigo Duterte said he hopes for stronger ties between the Philippines and China in his Chinese New Year 2020 message released on Saturday.

"The fact that we are celebrating this event and embracing it as one of our own reflects the strong and inseparable bond that has been forged through centuries of friendly and beneficial relations between the Philippines and China," read the president's message published on social media by PTV.

The president's pro-China statement comes barely a couple of days after his threat to terminate the Visiting Forces Agreement between the Philippines and the United States.

The Presidential Commission on Visiting Forces has since started processing the termination of the VFA.

Duterte has been criticized by the opposition for verbally using the said agreement as leverage for Sen. Bato dela Rosa's US visa, apparently only holding an anti-imperialist stance "when convenient" and not being as firm in foreign affairs related to

rising power China.

"As we open a new page in our shared history, may we foster even stronger bonds of friendship with those of Chinese descent all around the world through cooperation, investments, cultural exchanges, and people-to-people ties," Duterte said. The president also said he

hopes that the Chinese-Filipino community will continue to hold socio-civic and charitable acts "that will uplift the lives of our people, especially the power and the marginalized.

Together, these small acts of kindness shall create a ripple effect that will benefit not only those belonging to your community but also countless others, creating a much bigger wave of compassion that will eventually redound to the greater good of our country.

China has maritime dis-

putes in the resource-rich South China Sea with Philippines, Taiwan, Vietnam. Malaysia and Brunei. Over \$5 trillion in trade passes yearly through the waterway.

While the Hague decision had a legal basis and was ground on valid evidence, the Philippine government under the Duterte administration refuses to assert the findings with China.

## Chinese drug convict testifies vs De Lima

# 'Made in China': how Wuhan coronavirus spread anti-Chinese racism

s Singaporeans gathered over the Lunar New Year weekend, jokes were cracked about Chinese eating habits and how a propensity to eat "anything with four legs except the table and everything that flies except planes" had given rise to the Wuhan coronavirus.

last long because it was "made in China"

The jokes, tinged with racism, soon grew into a call for the city state to ban Chinese travellers from entering. A change.org petition started on January 26 had 118,858 signatures as of Wednesday afternoon. Among those calling for health to be prioritised over tourism dollars was Ian Ong, who wrote: "We are not rat or bat eaters and should not be made to shoulder their nonsense.

In Malaysia, there have been calls to block Chinese tourists and social media posts claiming the outbreak is "divine retribution" for China's treatment of its Muslim Uygur population. Some mosques in Malaysia have also closed themselves off to tourists.

In Japan, a shop in a mountain town prompted an apology from tourism authorities after it posted a sign saying: "No Chinese are allowed to enter the store. I do not want to spread the virus

From noon on Wednesday Singapore has blocked the entry of tourists who had visited Hubei province in the past 14 days, or who hold passports issued in the province. Malaysia has also stopped issuing visas to Chinese travellers from Hubei.

The Singapore government has said the travel ban was due to global trends showing that most of the infections were in people who had been to the province and the country wanted to minimise im-

port of the virus to Singapore.

The growing stigma has even reached European shores. Graduate student Sam Phan wrote in the British newspaper The Guardian about how a man on the bus in London had scrambled to get up as soon as Phan sat down. "This week, my ethnicity has made me feel like I was part of a threatening and diseased mass. To see me as someone who carries the virus just because of my race is, well, just racist," he wrote.

One meme said there was no need to worry – the virus would not BlogTO said a stigma was also attached to Chinese food, noting that a similar thing happened during the 2003 outbreak of severe acute respiratory syndrome (Sars). which infected 8,000 people globally and killed nearly 800. The website noted racist comments on its Instagram post about a new Chinese restaurant, which some posters urged diners to avoid because it "may have bat pieces in there or whatever else they eat".

The comments were in part a reference to a video of a Chinese social media influencer tucking into a bowl of bat soup. Some posters have claimed the video is evidence of "disgusting" Chinese eating habits, though the video was in fact filmed three years ago in Palau, a Pacific island nation where bat soup is a delicacy.

It is still unknown how the coronavirus made the jump from wildlife to humans, but early on in the outbreak the Huanan Seafood Market in the central city of Wuhan was widely assumed to be the origin of the disease. The market has a thriving wildlife trade, selling animals from foxes to wolf puppies, giant salamanders to peacocks and porcupines.

However, in recent days, research has emerged suggesting the market may not be the source of the virus.

The medical journal The Lancet on January 24 said that of the first clinical cases, 13 out of 41 had no link to the market.

The first patient showed symp-

toms on December 1, meaning human infections must have occurred in November 2019 given the two-week incubation period. Researchers said the virus could have spread in Wuhan before the cluster within the market was dis-

Similarly, the virus' genome has been sequenced but researchers are not sure if it comes from bats – as Sars did – or snakes. Still, experts said it is not so much about what meat is eaten, but how thoroughly it is cooked and the hygiene precautions taken during food prepa-

"The chef is at greatest risk," said infectious disease specialist Leong Hoe Nam, who was closely involved in Singapore's fight against Sars, which killed 33 people and infected 238 in the city state.

Leong said anybody could catch a virus from an animal.

"It is a case of the right person meeting the wrong virus at the wrong time. It could happen to anyone studying viruses, or meeting the bats in the most inopportune time," he said, referring to a case in Melaka, Malaysia, when a bat flew into a house and infected a 39-year-old man and his family.

Painting the coronavirus as a Chinese problem was like "dealing with the problem with a sledge hammer, implicating all Chinese nationals rather than dealing with bad food safety practices and diets", said National University of Singapore sociologist Tan Ern

Nanyang Technological Univer-

sity (NTU) sociologist Laavanya Kathiravelu said xenophobic social media posts were an extension of colonial-era stereotypes. "Chinese, in

these xenophobic accounts, are seen as taking resources away deserving from local populations, and having uncouth

behaviour. More broadly, this can also be seen as informed by older stereotypes of Chinese as dirty, having bad hygiene and undesirable culinary practices," she said.

Even Singapore government ministers have spoken out.

Minister for National Development Lawrence Wong, who cochairs a task force set up to deal with the virus, said on Monday: "I want to assure Singaporeans that the government will do everything we can to protect Singaporeans and Singapore but this does not mean overreacting, or worse, turning xenophobic.'

Singaporean playwright Zizi Azah, who is based in New York, said it was illogical to pin the virus on a race. "Illness knows no geographical or racial boundaries and it really is the luck of the draw, isn't it? Where something starts and where it gets to," she

Mohamed Imran Mohamed Taib, director of the Centre for Interfaith Understanding, cautioned against the effects of dehumanising Chinese people as uncivilised. "It is not due to 'Chinese-ness'; the fact that these people are Chinese is incidental, not the reason for the emergence and transmission of the virus. The virus could have emerged in any other part of the world, just as Ebola started in Congo and Middle East Respiratory Syndrome in Saudi Arabia,' he said.

Singapore's Minister for Education Ong Ye Kung on Monday called for empathy, saying that Singaporeans would not have liked it if during the Sars outbreak other countries had asked Singaporean expatriates to leave.

"We're an international hub, we can well be quite hard hit by such epidemics. So I'd say do not do unto others what you do not want others to do unto you. We all must tackle the problem objectively.

In Malaysia, Prime Minister Mahathir Mohamad clarified that any mosques that had closed themselves off to tourists had not done so on the government's advice.

"This is not a government policy and it is an irresponsible act," he said on Wednesday, warning the public against spreading fake news that could stir racial tensions.

"Even though we believe in freedom of expression, it does not mean we can be antagonistic and agitate the feelings of others.'



## It's time for Southeast Asia to stand together against China - with Indonesia leading the way

For the final weeks of 2019 and into the new year, China and Indonesia have been facing off over the sovereignty of waters around Jakarta's Riau Islands, in the South China Sea.

Jakarta's exclusive economic zone, a 200-nautical-mile zone within its afforded special rights to exploit marine resources, overlaps with China's capacious nine-dash line claim, under which Beijing asserts rights over nearly 90 per cent of the critical waterway.

That means the core of the ongoing dispute between the two countries boils down to resource exploitation rights within a section of the South China Sea northeast of the Natuna Islands.

While Indonesia's claim is founded in the United Nations Convention on the Law of the Sea – a convention both Beijing and Jakarta have signed and ratified – the Chinese claim dates back to questionable territorial assertions first made in the latter part of the first half of the 20th century.

Indonesia is not the Philippines - especially in the realm of material capabilities that it can bring to bear in pushing back on China - but it still stands to gain from asserting its rights under international law

Tripling down on its alienation of Indonesia amounts to a massive strategic miscalculation by China, ultimately. Instead of building a bridge to Jakarta at a time when the United States appears adrift in Asia, China is alienating what could otherwise be an important partner.

At a time when the Trump administration is vindicating the foreign policy instincts of many in Jakarta who see value in the country's middle-of-the-road, autonomous foreign policy, Beijing is giving cause for a rethink.

To be sure, Jakarta is far from bandwagoning with the United States when it comes to the South China Sea.

Ever careful to emphasise its position as a nonclaimant of territory in the disputed waters, Indonesia has made clear that it is in a position to push back on Chinese challenges to its maritime sovereignty independently.

For an archipelagic state like Indonesia, maritime boundaries are as good as national

The 2019-2020 round of tensions in the waters around the Natuna islands aren't Indonesia's first crack at dealing with Chinese coercion. Jokowi, during his first term, contended with multiple incidents in 2016 the same year the Philippines received a favourable judgment from The Haguebased international tribunal invalidating China's nine-dash line claim in the South China Sea.

Back then, Indonesia's former defence minister used an evocative metaphor to describe Jakarta's view of the challenge around the Natuna islands. Ryamizard Ryacudu called the islands a "front door" to Indonesia, warning that if it weren't guarded properly, the "thieves" would come in.

The premise of that metaphor was that Indonesia would need to find a way to deter China from asserting its claims to the southernmost extent of the nine-dash line by imposing costs, effectively practising a

strategy of deterrence by denial.

In the intervening years, Indonesia simply hasn't had enough capacity to implement such a strategy, even if the political will to defend the Natunas was there. Indonesia did build up its capacity in the area, including by deploying warships, fighters, and intelligence, surveillance and reconnaissance

None of Indonesia's options in dealing with the challenge from China are likely to be swiftly effective, but Jakarta does have recourse.

The most important will be for Indonesia to take its place as first among equals in Southeast Asia – particularly within the 10-member Association of Southeast Asian Nations (Asean) - and take a greater interest in collective regional resistance against Chinese revisionism.
Following the 2016 arbitral tribunal rul-

ing largely in the Philippines' favour, what should have become apparent is the value of international legal norms in helping weaker countries push back against China.

Manila, however, had just seen a change in leadership; President Rodrigo Duterte abandoned his predecessor's approach and began a period of rapprochement with Chi-

It's not yet too late for Indonesia to lead Southeast Asia back toward institutionalised solutions, especially as negotiations continue toward an Asean-China code of conduct for the South China Sea with an anticipated agreement by 2021.

The fact that Asean this year is chaired by Vietnam, which has been the most forward-leaning of the territorial claimants in the South China Sea against China in recent years, should facilitate matters, too. It's time for Southeast Asia to stand together against China; Indonesia can and should lead the way.

## Dead man lies on empty street at China's virus ground zero

'It's terrible,' a woman at the scene says. 'These days many people have died.'

WUHAN, China – A grey-haired man wearing a face mask lies dead on the pavement at ground zero of China's virus epidemic, a plastic shopping bag in one hand.

AFP journalists saw the body on Thursday morning, January 30, not long before an emergency vehicle arrived carrying police and medical staff in full-body protective suits.

The man lay straight on his back in front of a closed furniture store. Medical staff in blue

overalls gently shrouded his body with a blue blanket.

The ambulance left, and police stacked supermarket cardboard boxes to hide the

AFP could not determine how the man, who appeared to be aged in his 60s, had died. AFP contacted police and local health officials afterwards but could not get details on his case.

But the reaction of the police and medical staff in hazmat suits, as well as some of the bystanders, highlighted the fear pervading the city.

A woman standing near the man, wearing pink pyjamas and a Mao cap, said she believed he had died from the virus.

"It's terrible," she said. "These days many people have died."

Wuhan is the epicenter of the outbreak of the new coronavirus, which is believed to have jumped from wild animals at a city market into humans.

The virus, which emerged late last year, has claimed at least 213 lives and infected thousands in China, with at least 159 deaths in Wuhan alone.

With the virus spreading to other countries, the World Health Organization has declared the crisis a global health emergency.

Authorities have imposed an unprecedented lockdown of Wuhan, blocking off roads out of the city and banning flights, in a bid to stop the virus spreading.

Those who are trapped are enduring a tormenting wait for the lockdown to end, for a cure to be found, or even just for check-ups at overwhelmed hospitals.

AFP reporters in Wuhan have seen long queues at hospitals, with some patients saying they had queued for two days to see a doctor.

Many brought their own chairs for the

With most traffic banned, people who venture outside have to walk or bike everywhere in the huge city.

The dead man on the street on Thursday lay one block from the Wuhan Number Six Hospital, one of the main medical centers for treating those with virus symptoms.

A team of forensic experts who examined him were immediately sprayed with disinfectant by colleagues after removing their hazardous material suits.

One man smoking near the scene was told sharply by police to put out his cigarette and don a face mask.

He quickly followed their orders.

In the two hours that AFP observed the scene, at least 15 ambulances passed by, attending other calls.

Finally, a white van with blacked-out windows arrived to take away the man.

The body was zipped into a yellow surgical bag, and carried into the van on a

Staff immediately began to clean the ground as the van drove away, disinfecting the streets where the body had lain.

## **Thousands denied entry at NAIA**

• Impose a mandatory 14-day quarantine for Filipinos and Permanent Resident Visa holders coming from any place in China

and its Special Administrative Regions;

• Temporarily ban Filipinos from travel to China and its Special Administrative Regions; and

Establish a repatriation and quarantine facility.

Accordingly, all heads of departments, agencies, offices and instrumentalities of the government, government-owned and controlled corporations, government financial institutions, state universities and colleges, and local government units are hereby directed to adopt, coordinate and implement the guidelines, and such other guidelines which the task force may subsequently issue on the matter, consistent with the respective agency mandates and relevant laws, rules and regulations, until the threat is over.

# Duterte's threat to end defense agreement could harm US efforts to deter China in South China Sea, experts say

hilippine President Rodrigo Duterte's latest anti-American rant could do real damage to the longtime Pacific allies' defense relationship, some security experts say.

Duterte, who began his term in 2016 by insulting U.S. leaders and stating his intention to move closer to China and Russia, last week threatened to terminate the Visiting Forces Agreement that governs the deployment of U.S. troops to his country. The U.S. Embassy in Ma-

But Jeffrey Ordaniel, assistant professor of international security studies at Tokyo International University, said in an email from Manila on Tuesday that all military exercises in the Philippines would have to be reviewed and likely need a new legal framework to back them up if Duterte follows through

on his threat.
"Washington will also [be] less likely to continue to commit to Philippine defense in the South China Sea, given that there was no way for its troops to be in Filipino territory," he said.

U.S. counterterrorism assistance, which might also be impacted, is irreplaceable, according to Patricio Abinales, a Philippines expert at the University of Ha-

waii.

Duterte's threat to terminate the agreement came in response to the U.S. revoking its visa for one of his closest political allies, Sen. Ronald "Bato" Dela Rosa. Thousands of extrajudicial killings took place during a bloody drug war while Dela Rosa was chief of the Philippines National Police from 2016-18.

Despite the quick defense by Riveron, reactions to the flag in real-time were mixed, and the call certainly felt in the moment like it would be costly for the 49ers, wiping potential points off the board and preventing the team the chance to double up by scoring to open the second

If the second half goes the same, the 49ers then find themselves behind just one point after the Chiefs scored to take the lead with less than three minutes left. If that's the case, perhaps they punt on fourth-and-10 from midfield, then try and get the ball back around the same spot with about one minute remaining no

timeouts left needing 15-20 yards for a potential gamewinning field goal.

But let's rewind a minute to that Chiefs go-ahead touchdown. On third-and-5, Patrick Mahomes hit Damien Williams flaring out toward the sideline, and the running back muscled through an attempted tackle to score the biggest touchdown of his career. Or did he?

Williams stepped out of bounds either right before or right after he reached the ball across the goal line, and after replay, the officials couldn't find anything to reverse the call, so it stood as a touchdown. Which is fair -- you could look at the replay 100 times and not be perfectly sure one way or the other.

But if the ruling is that he

stepped out short, the call would have likely stood as well. That would have left the Chiefs to choose whether to kick a field goal from fourth-and-inches to tie the game, or go for the dagger. What would they have done? We'll never know.

If the 49ers had their extra field goal from the first down, the call for the Chiefs would obviously be to go for the touchdown to take a one-point lead with the extra point. And if the 49ers defense makes a stand, they're likely Super Bowl championship.

Football truly is a game of inches and close calls, and the 49ers know that all too well after Sunday.



# Duterte threatens to scrap VFA

hilippine president Rodrigo Duterte warned the U.S. last January 24, 2020 that he would scrap the Visiting Forces Agreement (VFA) if Washington did not reinstate the visa of Sen. Ronald dela Rosa, Duterte's political ally.

Dela Rosa is a former Philippine National Police (PNP) Chief who is now a senator. When he was PNP Chief, dela Rosa, led the government's anti-drug campaign, Oplan Tokhang, which claimed the lives of more than 5,000 drug users and pushers that human rights advocates say were denied due process. Human rights watchdogs, however, said the death toll in the drug war could be as high as 27,000. They also said many were defenseless

As a result, dela Rosa has been targeted by the U.S. for the extrajudicial killings (EJK) and human rights violations. Dela Rosa was sanctioned by the U.S. and his U.S. visa was revoked and assets and properties in the U.S. frozen.

The Philippines said that imposing sanctions is tantamount to meddling in Philippine internal affairs. However, advocates claim it is the sovereign prerogative of the sanctioning country to impose sanctions. Besides, the Philippines is a United Nations member; thus, it is committed to honor universal human rights. With the adoption of the Global Magnitsky Human Rights Accountability Act by the U.S. Congress, a lot of people suspected of corruption and human rights violations are at risk of being sanctioned.

#### **Duterte's ultimatum**

The visa revocation angered Duterte and he demanded that the U.S. restore dela Rosa's visa; otherwise, he will terminate the VFA. He gave the U.S. government a one-month ultimatum.

The VFA, signed in 1998, gave legal status to thousands of U.S. troops who were rotated in the country for regular military exercises and humanitarian operations. It replaced a previous agreement that allowed American naval and

air bases in the Philippines.
The US and the Philippines conduct between one to two joint military exercises annually. In October 2019, there were an estimated 1,400 US Marines who participated in a military exercise with 600 Filipino troops. If VFA is terminated, the joint exercise known as Balikatan (shoulder-toshoulder) will no longer be held. All other military assistance and

training will be discontinued. Since 2002, U.S. has deployed about 250 Special Forces troops

to the southern Philippines. They have been working quietly alongside Philippine troops spread throughout the region. They are part of a counterterrorism campaign.

### **Bsttle for Marawi**

During the five-month battle for Marawi in 2017, the Pentagon played down the American military's role, stating that troops there provided only support and assistance. However, officials said Marine commandos helped break the siege by training Philippine snipers who were struggling to defeat expert marksmen among the extremists who proved difficult to target within the city's concrete

U.S. Special Forces have been working quietly alongside Philippine troops spread throughout the country's southern region. The United States Army's only Special Operations civil affairs team in the

Philippines is also helping the villages around Marawi, where security concerns prevent State Department officials from traveling.

Military aid
The U.S. also provided at least P2.84 billion in assistance, which included advanced weapons and two C-208 Cessna aircraft to the Philippine Air Force. The surveillance aircraft were used to help in fighting against the rebels in Marawi City.

With the impending termination of VFA, the question is: What happens to the U.S. military aid? Most probably the U.S. will continue providing military weapons to the Philippines. But it's interesting to see if Duterte would accept them since he would look hypocritical to accept them after terminating VFA.

#### Military agreements

Then there is the question of three other military agreements between the U.S. and the Philippines: Mutual Defense Treaty (MDT), Enhanced Defense Cooperation Agreement (EDCA) and tual Logistics Support Agreement

The MDT calls for the U.S. to come to the defense of the Philippines if it's attacked by a foreign power. However, both countries' defense secretaries have recently said that the MDT needs to be reviewed to reflect current security threats, including an increasingly

powerful China.

But the MDT cannot be invoked and get immediate response from the U.S. It has several stipulations, which require some time before the U.S is ready to send its forces to defend the Philippines. First, "Armed attack and all measures taken as a result thereof

shall be immediately reported to the Security Council of the United Nations. Such measures shall be terminated when the Security Council has taken the measures necessary to restore and maintain international peace and security."

The United Nations would most likely seek

a cease-fire between the Philippines and China. If it failed to achieve a cease-fire, then the second article is invoked, that is, "Each Party recognizes that an armed attack in the Pacific Area on either of the Parties would be dangerous to its own peace and safety and declares that it would act to meet the common dangers in accordance with its constitu-tional processes." Constitutional processes mean that the U.S. Congress shall convene for the purpose of declaring war against the country attacking the Philippines.

Realistically, the U.S. Congress would not declare war against the attacking country, particularly China. It would probably seek a cease-fire. But by the time cease-fire is in place, China would have secured and occupied a large chunk of territory.

## **Different scenario**

But it would have been a different scenario if the Philippines did not kick out the U.S. bases in 1992. With a huge airbase and naval base on Philippine territory, China wouldn't dare attack the Philippines because U.S. response would be immediate. The U.S. forces on Philippine territory would have to defend themselves; thus, no US congressional approval is needed by the US forces.

EDCA is an agreement between the U.S. and the Philippines signed in 2014. It is intended to bolster the U.S.-Philippine alliance. And without a fully implemented EDCA, the Philippines lost its maritime rights in the South China Sea to China. The United States is seen as a paper tiger unable to protect its allies or defend freedom of the seas.

The MLSA is used to allow U.S. forces on training engagements to turn over military equipment and ammunition expeditiously to the Armed Forces of the Philippines (AFP). The timely transfers greatly enhance the AFP's counterterrorism efforts.

Through the MLSA, the AFP is able to receive select munitions and equipment from U.S. military

stock in an accelerated process reserved for allies and close partners of the U.S.

### **End of American presence**

With an MDT that is on the brink of obsolescence, a VFA that is terminated, an EDCA that is hopelessly inutile, and an MLSA that would probably be scrapped as a consequence to VFA's termination, what is left of the once vaunted US-Philippine military alliance, the most powerful military partnership in Asia? Sad to say, it's moribund and could die anytime. And how is Duterte going to defend Philippine territory from China or homegrown militants? Don't expect the U.S. to come to the aid of Philippine troops in Mindanao needing special forces support, sophisticated airborne monitoring, and advanced weapons. With an air force with no warplanes, a navy with no warships, and undertrained military personnel, the Philippines would be unable to defend its vast territorial waters.

With Duterte's threat to end VFA



## Couple Reunited After Suspected DUI Driver Crashed Into Home, Killing Loved One

RANCHO COR-(CBS13) DOVA - The cuts, bruises and casts aren't the only reminders of a horrific day for Daniel Williams and his wife Lorrie. The couple was watching football with family when the unthinkable happened.

Ring cameras on the Williams' family home captured the scene of the crash mere seconds after the car careened into their living room.

"He was going so fast that by the time the capture aperture opened he was in my house," Daniel Williams said.

The car plowed into Daniel's baseball, San Francisco 49er and dog-loving mother, Jan, killing her.

"I wish she was here. I still wish I could have protected her better. I just miss her," Daniel Williams said. "It was almost surreal that my mom was gone."

The man the Sacramento and Lorrie saw County Sheriff's Office says was drunk and behind the wheel, Gary Circle, was also caught on the family's surveillance camera as he searched for one of the two kids that were inside the car at the time of the crash.

"In this day and age, to be that selfish and that mindnumbingly stupid to have children in your vehicle,' Lorrie Williams said.

"I don't know why anybody would do that; to endanger





## 'Better safe than sorry': How Sacramento residents are preparing for coronavirus

Novel Coronavirus reaches the United States: What you should know

No known cases of the novel coronavirus have shown up in Northern That's not California. stopping people in Sacramento from being prepared.

Some people are even trying to help.

The virus, which was first identified in Wuhan, China, and has no specific antiviral treatment recommended for patients, now has more than 7,000 confirmed cases and a death toll of 170 in the country. On Thursday, the World Health Organization declared the outbreak a "public health emergency of international concern.'

A Sacramento organization on Wednesday announced the postponement of a Lunar New Year celebration scheduled in early February. The announcement came two days after the city of Elk Grove canceled its Lunar New Year celebration that was scheduled for Friday.

However, many locals say they are not sweating about the virus yet.

Michelle Liu, owner of Yong Tai Ginseng, a Chinese herbal store on Stockton Boulevard, said she does not sense panic in the community, although more people came in and asked for antiviral herbs or products to boost their immune systems.

According to Liu, many inquired for the isatis root electuary beverage, a dietary supplement that some feel is effective in strengthening the immune system and preventing the flu.

"Everyone was asking for it, and it was sold out in the past two days," Liu said in Cantonese. "Many of them don't necessarily have the habit of drinking it. They drink it now just

While the electuary beverage packet is out of stock at the store, the isatis root herbal plant is available.

Liu believes customers aren't panicking, but are taking precautionary mea-

Although her store does not sell face masks, she

# 3 new cases of coronavirus confirmed in Northern California;

U.S. cases jump to 11

Public health officials confirmed three new cases of coronavirus in Northern California - including an adult woman in Santa Clara County and a husband and wife in San Benito County – bringing the number of cases of the disease in the United States to 11. In California, according to the CDC, six people are now sickened by the virus.

"I understand that people are concerned, but based on what we know today, the risk to general public remains low," said Sara Cody, the health officer for the Santa Clara County Public Health Department. "A second case is not unexpected. With our large population and the amount of travel to China for both personal and business reasons, we will likely see more cases, including close contacts to our cases.

The Santa Clara case involves a woman who came there Jan. 23 from the Wuhan area of China to visit her family, Cody said, and except to seek medical treatment, she has isolated herself at her family's home. Wuhan is where the new coronavirus outbreak originated, and the vast majority of the cases have been diagnosed there and in the surrounding Hubei province.

This is a mild case of the disease, Cody said, and the traveler has only made contact with family members since her arrival. The patient's family also is currently isolated at their home, the health officer said, and will not be leaving in order to prevent possible spread of the illness.

This patient has no connection to the other case of coronavirus that Santa Clara officials announced Friday. In addition to the two Santa Clara County cases, public health officials also have announced one case in Los Angeles County and another in Orange County.

In San Benito County, officials Sunday told the San Jose Mercury News that a 57year-old man, who recently traveled to Wuhan, had contracted the illness, and passed it onto his 57-year-old wife, who did not travel, according to a news release.

Both individuals have not left their home since returning from China, according to San Benito County officials.

Public health officials with the U.S. Centers for Disease Control and Prevention have said they expect to see more cases of new coronavirus, a respiratory illness that

and shortness of breath, as travelers come to the United States from China.

To house individuals who are displaying symptoms, the U.S. Department of Health and Human Services asked Pentagon leaders to set aside housing at four U.S. military bases where overseas travelers can be quarantined for 14

days. The U.S. Department of Defense announced Saturday that four bases, including two in California have been selected. They are: Fairfield's Travis Air Force Base, just 32 miles from Sacramento; Marine Corps Air Station, Miramar, near San Diego; the Army's Fort Carson, Colorado, 168th Regiment Regional Training Institute; and Lackland Air Force Base, near San Antonio. Texas.

The Pentagon announcement means there could be as many as three military installations in California housing people with the new coronavirus. March Air Reserve Base in Riverside already is housing U.S. government employees evacuated out of Wu-

Originally, public health officials said the government evacuees would be quarantined for only 72 hours, but they changed that to 14 days after the World Health Organization declared a public health emergency out of concern of the potential spread of the illness. Shortly after the WHO announcement, the U.S. government made a similar declaration in the United States. Three U.S. airlines — American, Delta and United have suspended service to China.

Pentagon officials said that military personnel and their families will have no contact with the quarantined individuals. Rather, HHS staff or contractors will be take care of caring for them.

As announcement of new U.S. cases trickle in and federal officials open up quarantine sites, Americans have become anxious about the potential for human-to-human transmission. To date, there has been only one such case in the United States, and that individual was the spouse of a Chicago traveler who had returned from the Wuhan

have been stocking up on face masks out of a belief that the devices will help them ward off infection. Public health officials note that, although surgical masks provide some protection against spray of

bodily fluids, airborne germs can still penetrate through the sides of the mask and into the respiratory system.

No public health agency recommends face masks for public use. Health workers do use N95 respirator masks and other types of face masks for protection, but they have been fitted for the devices and trained in how to use them effectively.

To cope with anxiety, psychologist Lynn Bufka of the American Psychological Association recommended some foundational steps you can take to maintain your emotional stability: Get regular sleep, adequate amounts of physical activity and decent nutrition. You can also seek social support from friends, Bufka said. Sometimes it's good to checking in with a friends to see whether concerns are realistic, but be careful which one you choose, she said, because sometimes a friend will actually contribute to anxiety.

There are also everyday precautions that people can take to prevent cold and flu, and they're recommended by the CDC:

- Wash your hands often with soap and water for at least 20 seconds. If you really can't get to soap and water, then use a hand sanitizer that has at least 60 percent alco-
- Can't wash your hands right away? Avoid touching your mouth, nose and eyes as these are areas where the pathogens can
- Do not stand close to people who are sick. That may mean taking the stairs rather than an elevator.
- If you take an elevator, try not to touch buttons with your fingers. That's also true for other objects or surfaces that other people may touch. Clean and disinfect those areas if you can. Otherwise, avoid touching
- Cover your mouth when you cough or

sneeze, either using a tissue or your elbow. Throw used tissues in the trash right away.

• If you are sick, stay at home. If you have traveled to China or have been on an international flight with others from Wuhan in the last two weeks, you may wish to seek medical treatment for any symptoms. Call ahead to let them know why you're coming. They may wish to admit you into an isolated unit.

### **Investigating the illness**

Public health officials still are investigating how and when this new coronavirus spilled over into humans, but that can take months or years to determine. What they do know is that, like severe acute respiratory syndrome and Middle East Respiratory Syndrome, this new respiratory virus originated with

So far, data shows that this illness has not been as deadly as either SARS or MERS. About two in every 100 people have died from new coronavirus, according to the reported data. With MERS, 30 to 40 out of every 100 people died and with SARS, the mortality rate was about nine of every 100. Epidemiologists said that, judging by what they know of MERS, they believe the new coronavirus has an incubation period of two to 14 days.

About 300 people have died after contracting new coronavirus, and more than 14,500 cases have been reported since December when the disease leapt into headlines after an outbreak was linked to a market in China. However, researchers at the University of California, Davis, have said that the illness likely had been circulating among a small number of people in China for months — or even years — before this but that those individuals had not sought treatment because they thought they had cold or flu.

Over the last 10 years, UC Davis has

been leading a global investigation into coronaviruses and other pathogens that can be transmitted to humans. They have done the work with grant funding from the U.S. Agency for International Development, using community health workers to do surveillance and and sampling on more than 145,000 animals and humans to learn how these diseases get transmitted and how to minimize that risk.



# The Darker Life of Juan Luna:

# The life of Juan Luna is decorated with triumphs

extbooks have always painted a positive image of the life of Juan Luna: an ilustrado, a part of the Propaganda Movement, and the Philippines' foremost master painter. And yet we gloss over the most glaring, terrifying, and tragic event that haunted Luna all throughout his life and beyond: He killed his wife and her mother.

In 1886, when Luna was 29 years the arrival of one old, he married the love of his life, Maria de la Paz Pardo de Tavera, or simply Paz. After marrying, they sailed to Europe, making sure to stop by Venice and Rome before finally settling in Paris. Two years earlier, Luna had created the "Spoliarium," which won one of several gold medals at the Exposición Nacional de Bellas Artes.

Luna and Pardo de Tavera lived happily for the first few years of their marriage. They had a son, Andres, who would later become one of the Philippines' most discerning architect in the pre-war period. One of his most notable projects is the Crystal Arcade building, which was erected in 1932. Luna and Pardo de Tavera also had a daughter, Maria, who died during childbirth.

The couple came from respected families, were both well-off, and had plenty of things in common, including a close friendship with Jose Rizal. If photographs and Luna's paintings of Pardo de Tavera offered clues, they'd tell a story of a content and happy relationship came enraged. between the couple.

Monsieur Dussaq into the life of Juan Luna and Paz Pardo de Tavera. In 1892, four years into their marriage, Luna and Pardo de Tavera's marriage was already on the rocks. Luna's temper, like his brother Antonio's, was not one to be toyed with for he had very poor control over emotions. For Luna, anger and jealousy were two deadly tempests that also made him crazy.

Earlier in the year, Pardo de Tavera made the mistake of speaking to Luna quite fondly of a certain man whom she had met in Mont-Dore, a mountainous vacation destination in central France. Luna did not like what he heard. Months later, on September 4, 1892, Dussag called on the Luna residence looking for Pardo de Tavera. Luna be-

Luna threatened Pardo de Tavera Life in Paris was romantic, until that he would harm her if she

continued to speak to other men, especially Dussaq. When he was not convinced of her fidelity, he made good on his threat, eventually assaulting and beating her. As if those were not enough, Luna also destroyed Pardo de Tavera's clothes, prompting her to leave him and seek refuge elsewhere.

surreptitiously followed Luna Pardo de Tavera and discovered that Dussaq was also in the house where she escaped to. Deranged

and convinced that Pardo de Tavera was lying and having an affair, he returned to the house the following day and beat her with his cane.

Luckily, Doña Juliana, Pardo de Tavera's mother, heard the commotion and immediately summoned her sons

to protect her daughter from Luna, who threatened to shoot them with his revolver.

#### **HOW JUAN LUNA MURDERED HIS WIFE** AND MOTHER-IN-LAW

Weeks later on September 22, 1892, Pardo de Tavera's brothers Trinidad and Felix came to visit and check on her and her son, who was sick at the time. The visit was brief, because the brothers decided to get breakfast at a nearby café.

Doña Juliana and Pardo de Tavera decided that they did not want to be left alone in the house, so they went downstairs and made their way to the café. But in the doorway, they saw Luna holding a gun. He fired multiple times at Pardo de Tavera and her mother, who screamed and ran back upstairs and locked themselves in the bathroom.

Meanwhile, Trinidad and Felix heard the gunshots and ran back to the house immediately. Luna

was prepared for them, and also fired at them, seriously wounding both brothers. Afterward, he went upstairs and looked for the two women, whom he found cowering on the bathroom floor.

He pointed his revolver at Doña Juliana and killed her with one shot to the head. Then, he turned his gun on his wife, and also shot her in the head. Somehow, she survived the gunshot, but eventually died in the hospital 11 days later.

#### LIFE OF JUAN LUNA: HOW HE GOT **AWAY WITH MURDER**

Five months after Luna murdered his wife and mother-in-law, a fact that he admitted to doing, he was acquitted by the court. It was a time when criminal and civil laws in Paris greatly favored men. In just one day of session, the court dismissed the charges against Luna on the grounds of temporary insanity caused by passion.

Apart from being found to have had temporary insanity when he killed his wife and her mother, an unwritten law in France at that time allowed husbands to punish or kill their wives who were found to commit adultery. In the end, the most punishment Luna was made to pay was a price of 40 francs, which was the cost of court documentation. Five days after his acquittal, he moved to Madrid with his son, where he spent the next 17 years.

The Pardo de Tavera family shunned Luna forever, for they never received the justice for the deaths of Doña Juliana and Paz Pardo de Tavera. Her brother, Trinidad Pardo de Tavera, who would become a respected historian, doctor, and statesman, blackened out the face of Juan Luna in every family photograph where Luna was present.

Search online to expand your understanding. And use your critical thinking in decision making. Master the skills you learn from nursing laboratory as you will surely use them in your clinical. The head-to-toe assessment is one of the important skills as you will use it wherever nursing unit you work - it may be at medical-surgical, telemetry, ICU, ED, OR, PACU, OB-Gyn, NICU, clinic, home health, etc. Remember to properly use your thermometer, sphygmomanometer and stethoscope. These three-basic medical equipment plus good bedside manners are vital in the success of your profession.

Job Opportunities. Once you become registered nurse you can freely apply where to work. You may apply at private or public hospital, locally or abroad or pursue higher education. The choice is yours. Please put into consideration the short- and long-term benefits offered by those institutions. A Salary Grade 15 for Philippine government nurses under Department of Health has been affirmed by the Supreme Court with starting monthly pay of thirty thousand five hundred pesos (P30,500.00) while military nurses under the Armed Forces of the Philippines has monthly base pay of fortyeight thousand eight hundred twenty-nine pesos (P48,829.00) plus allowances such as subsistence, clothing, combat, cold weather, loneliness pay, flight nurse, and other fringe benefits. If you desire to work abroad you will be receiving much higher pay. For example, a new graduate nurse at student nurse you have all the time Kaiser Permanente in Sacramen-

Health Teaching. Health teaching is one major link that will break or make the continuum of care. In fact, it is one of the weakest links. The strength of an organization is dependent on its weakest link. We need to make sure the patient and their significant others understand our teaching. Advise to Nursing Students. My advice to all of you is to strengthen your foundation in nursing and your Christian education at CPU.

not be afraid to ask. As the Chinese proverb says, "He who asks a question is a fool for five minutes, he who does not ask a question remains a fool forever." This is the best time for you to ask all the questions in your mind while you are still at school under the tutelage of excellent nursing professors who are available to answer your queries and are duty bound to guide you in the right path of nursing education.

At the clinical, it is important for you to plan for the day. Read your patient's history, the reason why they came to the hospital, and the plans for them. When you get report during change of shift, listen attentively to the endorsement of outgoing nurse as there are vital information shared during that very moment. Take vital signs to include pain assessment and encode it to EMR (Electronic Medical Record) as soon as possible as the physicians and other members of the health care team are waiting for it. Review your patient's laboratory results. Perform proper HTT assessment as soon as possible. Before the end of shift do rounds to your patients and ask them if

they are okay and if the need anything. If they do, address it before your shift ends. That is the glimpse of the day's shift. As you adjust to your hospital work, you can develop your own style that works for you. As an old adage say, "You can skin the cat in different ways.' And please go beyond what is expected of you.

My last important advice to you is to avoid wasting your time on social media. Facebook and Instagram are addicting. Don't waste your precious time on social media. Sometimes you know more on what's going on with that viral post than your nursing subjects. Use your time wisely. Don't live a sedentary lifestyle. Be productive and know your lessons by heart.

We may not have known Kobe Bryant personally, but the grief some of us feel over his death is still very real.

It's November, 1996, and I'm 13 years old. My father and I are sitting court-side at the Los Angeles Forum as the Lakers take position.

"Keep an eye on this kid," my dad says, nudging me to glance up from my hot dog and peanuts. "He's gonna be

Dad is talking about Kobe Bryant, the 18-year old wunderkind who, standing only about five feet from where I sit, looks to be about three times my size.

"Just out of high school," Dad continues. "Can you believe it?'

No, I can't believe it. Bryant's magnificent height and build make him look older to me, but his face is boyish and sweet, bearing a puckish grin. The crowd is going crazy and suddenly, so is my heart: it dawns on me that Kobe is the most beautiful boy (for I cannot yet see him as a "man") I've

I actually don't remember much of Bryant's first game, performance-wise; but I do remember how his sweat laced around his temples, and glistened on his cheekbones and that, at one moment, he was so close to me, I felt the hot wind surge off his body. I also remember (though admittedly, this I never met Kobe Bryant,

may have happened later that season) that another player soared over me after the ball and, with his enormous foot, conked me right on the head. As people in nearby seat huddled around me asking if I was OK, my sole concern was whether Kobe had seen the embarrassing incident.

but I felt like I knew him, in fact, felt like I loved him, and when I learned that he died (along with 8 others, including his 13-yearold daughter, Gianna), my stomach lurched with the bad kind of butterflies and my eyes welled. I spent much of the day in bed, reading story after horrific story on the helicopter crash that snatched those beautifrom where I was lounging around like it was any old Sunday morning in Los An-

Kobe Bryant was an inspiration to many — but not all. We can't ignore why.

I was surely not alone in my despair as people around the globe took to social media to share their shock and dismay. Gay L. Polk-Payton, an attorney and judge in Mississippi who named her 21-year old son Gaybriel Jekobe (French for "I Kobe") Payton, after Kobe Bryant had hardly gotten out of bed since she heard the news.

"I lost it when I found out he died," Polk-Payton tells me, choking up. "And then when I found out Gianna was with him, his baby girl he nurtured so much and who idolized him, I just lost it all over again. I had to take [Monday] off of work. I've been in the same clothes for two days. I'm just a mess." This grief is valid and the worst thing you can do is from a distance." deny it

ful lives away but an hour Polk-Payton is giving herself the time she needs to mourn and accepting that this is a real loss. Her way is the healthy and healing way to go about it, according to therapists.

> A loss must be grieved whether it is a personal relationship or whether it is a relationship from a distance.

"This loss is very real because Kobe Bryant was a real person whom we all feel like we knew at some level,' says Tami Frye, a licensed master social worker and faculty member for Walden University's Master of Social Work program. "He met a need for most of us by providing entertainment and by giving us joy. We pulled for him when we watched him play and we were saddened when we saw him lose. We felt in some way we were part of his life and he was part of ours. Now that part is over. An ending like this must be grieved. A loss must be grieved whether it is a personal relationship or whether it is a relationship




